### Hawaii National Guard Bids Farewell to Governor Waihee

The Hawaii National Guard will honor its outgoing Commander in Chief, Governor John Waihee, during a farewell parade inside Diamond Head Crater at 10:00 a.m., Sunday, October 16th. A dress rehearsal will be held at 1:00 p.m., Saturday, October 15th.

The farewell parade will include the Governor's review of major Hawaii Army and Air Guard units, accompanied by Maj. Gen. Edward V. Richardson, state adjutant general; a 19-gun salute using 105 millimeter howitzers; and a helicopter flyby.

### Combined Federal Campaign

The State Department of Defense is spearheading this year's Combined Federal Campaign (CFC) fund drive.

Maj. Gen. Edward V. Richardson, the adjutant general, is this year's CFC chairman.

The federal employees kick-off rally was held on October 7, at the Ft. Ruger Armory/Gym (the original rally at Aloha Stadium was scheduled for October 4th but was canceled due to the tsunami alert).

The campaign will run through November 3. The goal of \$4.52 million to be raised by 65 federal agencies will provide funding to more than 100 local organizations.

The Hawaii National Guard's goal is to raise \$117,000 from more than 1,250 employees.

## COMMANDER'S CORNER

When it comes to complaint resolution, a new avenue for help is available. When individuals feel the need to file a complaint, it usually means they've exhausted ways to solve their problem. When that happens and your chain of command has been unsuccessful, the 154th Group's Inspector General may be your next stop.

Colonel Clinton R. Churchill, the 154th Group's new Vice Commander serves as the 154th Group's Inspector General (IG). His responsibilities include our IG Complaint/Fraud, Waste, and Abuse (FWA) Program. This program enables people to get help quickly and fairly on matters that they have been unable to otherwise resolve through their chain of command.

Filing a complaint or submitting a FWA disclosure can be accomplished at any level within the IG system. It can be done without fear of retaliatory actions being taken against the person filing the complaint or FWA disclosure. However, if a policy directive or instruction provides a specific means of appeal, you must exhaust those appeal procedures first. Mere dissatisfaction with the outcome of an appeal is not sufficient basis for an IG review or investigation.

If a problem can't be resolved, AFI 90-301 provides guidance on how to make a complaint or how to submit a FWA disclosure and whom you should talk.

## Quality News

### Chinese Quality

BEIJING — Eighteen factory managers were executed for poor product quality at Chien Bien Refrigerator Factory on the outskirts of the Chinese capital. The managers — 12 men and six women — were taken to a rice paddy outside the factory and shot to death as 500 plant workers looked on.

Minister of Economic Reform spokesperson Xi Ten Huan said that the action was required for committing unpardonable crimes against the people of China. He blamed the managers for ignoring quality and forcing shoddy work, saying the factory's output of refrigerators had a reputation for failure. For years, factory workers complained that component parts did not meet specification and the end product did not function as required. Compressors were cracked, leaked Freon, and the electrical components were sub-standard. Complaining workers quoted the plant manager as saying, "Ship it."

Customers, who waited up to five years for their appliances were outraged, he said. "It is understandable our citizens would express shock and outrage when managers are careless in their attitudes towards the welfare of oth-

ers." Refrigerators are among the most sought-after consumer items in the People's Republic of China. "Managers in charge of production and engineering failed to perform any useful corrections to the quality problems for the last 20 years," Huan said. "Our soldiers are justified in wishing to bring proper justice to these errant managers."

## First HIANG Female Pilot Graduates

A young officer with the 203rd Air Refueling Squadron (203 ARS) has demonstrated that the sky's the limit for women in the Guard.

2nd Lt. Heidi Kunichika has become the first female pilot in Hawaii Air National Guard history. She graduated from Undergraduate Pilot Training (UPT) at Columbus AFB, Mississippi, on September 28 and is now training to fly KC-135s. Kunichika understands she is a role model, showing that opportunities in the cockpit are available to women, but said she doesn't think that being the first female pilot in the HIANG is that big of a deal. "I just think that I'm one of the guys", said Kunichika. "I don't think that I should be treated differently from anyone else, and at school I wasn't."

Kunichika was back in Hawaii for just a short break before leaving October 9 for four months of KC-135 training at Castle AFB, California and Altus AFB, Oklahoma. After survival school, which will last several weeks, she's planning to rejoin the 203 ARS as a drill-status pilot in April.

Kunichika credits her father, Col. Ritchie Kunichika (Ret.) former 154

GP/DO, with first getting her interested in aviation.

2nd Lt. Kunichika said she would eventually like to fly for one of the major airlines.

- \* people are accustomed to convenience and to separate waste is an inconvenience.


- \* people are accustomed to throwing things "away".



## Epilepsy Foundation of Hawaii Touches Air Force Family

Air Force Tech. Sgt. Bruce McGilvery knows first hand the anxiety associated with coming to terms with a child's illness. For the same reason he also knows the importance of contributing to organizations like the Combined Federal Campaign, which funds more than 100 organizations locally.

When doctors suspected that his son, Christopher, 10, had epilepsy two years ago, he didn't want to believe it.

"You don't want to accept it at first, you want to challenge it," he said describing the initial diagnostic period as a difficult time for him and his wife, Bernardita.

Doctors at Tripler Army Medical Center made the diagnosis after a seizure that Chris experienced at school in February 1992, and a subsequent seizure he experienced six months later.

The diagnosis spurred McGilvery, who serves as an active duty technical advisor to the Hawaii Air National Guard's 201st Combat Communications Group, to read and learn as much as he could about

the disorder. In the meantime, Chris was undergoing a battery of tests, which turned out negative reinforcing his father's suspicions that the disorder may not have been epilepsy.

But after Chris experienced two seizures at home and some abnormalities were detected by doctors in his EGG, his parents decided that he should take medication to treat the disorder. Since going on the doctor's prescribed medication, Chris has been seizure-free. The anxiety that McGilvery experienced up until his son was positively diagnosed with epilepsy was his main catalyst for contacting the Epilepsy Foundation of Hawaii.

"The phone call led us to realize that there is somebody out there to help you," McGilvery said.

The foundation not only offered support to the family by providing information and education, but helped Chris come full circle with the disorder by introducing him to other kids with epilepsy at a special summer camp. He also served as the organization's "Winning Kid."

This celebrity status did not go to his head, but opened doors for him to serve as a role model for other individuals with the disorder.

If anyone understands the importance of supporting such organization's as the CFC, which contributes

to numerous local agencies, it's McGilvery. This year, he intends to designate his CFC contribution directly for the Epilepsy Foundation. This year's CFC campaign runs until November 3rd. The theme is: "People helping people, share your rainbow."

All in all, Chris and his family have accepted and adjusted to his condition. His seizures are well-controlled with medication. Seemingly, it hasn't stopped him from living a normal life that includes bicycle riding with his sisters Irene, 11, and Heather, 5. He also enjoys playing baseball, soccer, bike riding, gymnastics and swimming, which he does under close supervision.
