TRAFFIC CRACKDOWN

As a means of identifying habitual offenders and keeping dangerous drivers off the base, a new traffic point system went into effect on September 1 at all PACAF BASECOM bases.

The system calls for mandatory assessment of points against the records of persons-military, family and civilians--authorized to drive on base.

# DR\*LL MAKE-UP

Of interest to all personnel is HANG Regulation 50-02 (22 July 59) which prescribes equirements and proures for appropriate

\_\_ty make-up.

The regulation stipulates that you are required to attend all scheduled training periods unless excused by proper authority. If you are unable to attend a scheduled drill, you must notify Sq Hqs no later than two days prior to the drill period. You may be excused due to sickness, injury, employment, not physically on Oahu, emergency, or other circumstances beyond your control.

At the time of your request to be absent, you must also establish the time and date for Cont'd on Page 4)

When 12 points are accumulated, the driver's on-base driving privilege will be suspended for six months or, in some instances, it may be revoked permanently.

Points accumulated after a two year period will be deleted and the driver starts again with

a clean record.

Some offense assessments are: driving under the influence of intoxicating liquor--12 points; leaving the scene of an accident involving death or personinjury without rendering aid or information--12 points; 1-19 mph over posted speed limit--2-3; 20 mph or more over posted speed limit--4-5; failure to obey traffic signs or signals or instructions of traffic officer -- 2-4: other moving violations-2-4 points. uneamoni-moonavamanamen

### THE LACS CRISTS

Again a small, independent nation s being attacked by the Communists and is asking for help.

This time it is LACS, a 91,000 square mile kingdom with 1,700,000 people living in the giant peninsula that juts south from the Asian mainland toward Indonesia.

Its loss to the free world if swallowed by the Chinese Communists would be a shattering blow to the hopes for a more peaceful world. Laos is a key to the defense of Southeast Asia.

Bordering Red China in the north, Laos has Burma and Thailand on its western border, Cambodia to the south, and Communist North Viet-Nam and Free South Viet-Nam to the east.

This peninsula is called the rice bowl of Asia. India and Japan get a large amount of their food there. If the Communist bloc had control of the rice bowl of Asia, they would have a powerful weapon that would tend to expand their control into Japan and India.

On Saturday, September 5, 1959, the United States Government issued a statement on Laos of vital interest to every member of the Armed Forces. The implications in its last paragraph, quoted below, should be clear to every Air Force member--understanding as he does that the Air Force stands always ready to support the interests of the United States and the Free World.

"The latest attack upon the Lao Army, in Sam Neua Province," says the statement, "has resulted in an appeal by the Royal Lao Government for United Nations assistance. It is appropriate that this matter be thus brought to the world's attention. It is obvious that any further augmentation of the

invading forces or continued material support thereof by the Communists in North Viet-Nam will require a major change in the nature and magnitude of the Royal Lao Government's need for support. The United States is confident that the Free World would recognize such a new danger to peace and would take the action necessary. For its part, the United States supports that view." (AFNS)

## PROMOTION CRITERIA FOR SQUADRON

Here is the latest "poop" regarding eligibility requirements to be met before you may be considered for promotion, according to ANG Regulation 39-29 (20 July 1959). Three categories are considered; namely, Position Vacancy, Air Force Specialty (AFS), and Time-in-Grade and Total Military Service requirements.

First, Position Vacancy: there must be a unit vacancy in the AFS at the same or higher grade to be promoted. Vacancies are computed cumulatively, based on authorized strength by AFS minus assigned strength by primary or duty AFS.

Second, Air Force Specialty: you must have an awarded AFS appropriate to the next higher grade as established in AFM 35-1. The AFS may be primary or additional; however, to be eligible for promotion in an additional AFS, you must have been assigned such duty for at least 90 days prior to consideration.

Third, Time-in-Grade and Total Military Service requirements:

To E-9: 12 months in E-8 and 10 years total enlisted service;

To E-8: 24 months in E-7 and 10 years total service, of which eight years must have been in enlisted grades;

To E-7: 24 months in E-6;

To E-6: 21 months in E-5; To E-5: 18 months in E-4 and

four years total military service; To E-4: 12 months in E-3; and To E-3: 6 months in E-2.

## NEWS FROM THE AIR FORCE ACADEMY

Capt Theodore Soong, Communications OIC, just received a letter from a former member of his section who is now at the Air Force Academy.

Cadet Allen K. Watt gives a neat description of life at the Academy. Excerpts from his letter follow.

"...there is very little free time to ourselves around here. The training is really rugged and it can't compare to that of Lackland, which was a picnic. Most of the time we're double timing or marching at a brace. The food over here is excellent if you get enough to eat. This is due to the fact that we eat at attention, but it isn't too bad. Everyday we have conditioning where we run 3 to 4 miles so I'm in pretty good shape. ... The grounds cover 18,000 acres and I've seen a good portion of it while running around here. Of course the upper classmen are on your back all the time but if you let half of it go in one end and come out the other, everything is fine."

your appropriate duty performance.

If an officer or airmen arrives later than 15 minutes past the hour scheduled for the assembly, he will be required to perform four hours appropriate duty training, unless the cause for such lateness is acceptable and approved by the commander. If approved, make-up will be at the end of the scheduled drill.

Absences due to sickness or injury must be substantiated by a certificate from your doctor.
