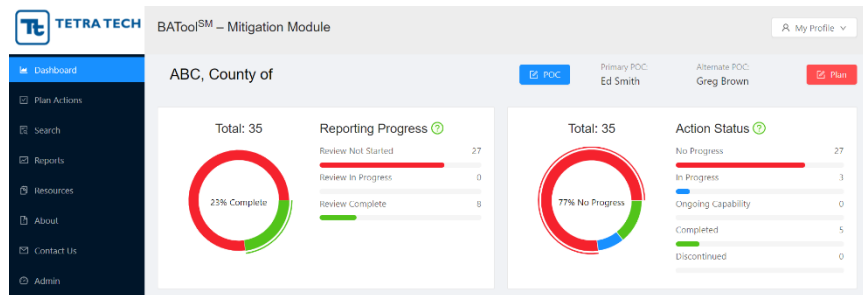


MITIGATION ACTION PROGRESS REPORTING



The Baseline Assessment Tool, or BAToolSM, is Tetra Tech's web-based mitigation action progress reporting program. It will help the state manage mitigation actions and track project success over time.



Actions from the 2018 Hawai'i State Hazard Mitigation Plan need to be reconciled by indicating what progress has been made to date, whether an action has been completed or should be discontinued, and whether the action needs to be carried forward to the 2023 plan update. This is a FEMA requirement.
