## ADDENDUM NO. 2 BUILDING 306, HURRICANE HARDENING, STATE OF HAWAII, DEPARTMENT OF DEFENSE, JOB NO. CA-1324-C

The items listed hereinafter are hereby made a part of the contract for the above mentioned project and shall govern the work taking precedence over previously issued contract documents governing the items mentioned. Receipt of this addendum is to be acknowledged on page OF-5 of the proposer's packet.

Please make the following changes:

- **A. CHANGES TO SPECIFICATIONS:** The following pages of the Solicitation Documents are revised:
  - 1. SPECIAL NOTICE TO BIDDERS CONSTRUCTION, add the following paragraph to page SN-10:
    - "BUILDING PERMIT A Building Permit Application for this project has been submitted for approval. The Contractor is responsible to pick-up and pay for the Building Permit upon its approval."
  - 2. GENERAL CONDITIONS (Issued via Addendum No. 1 dated May 16, 2014): The Contractor is advised that compliance with Davis-Bacon Wage Schedule does NOT apply to this project. For the applicable "Prevailing Wages" refer to Section 7.7.
  - 3. SECTION 011000 PROJECT REQUIREMENTS:
    - a. Paragraph 1.05 B. 6.: Add the following Item:
      - "c. The Contractor is cautioned that there are existing windows that are partially obstructed by existing furniture. The Contractor is responsible for moving such furniture as necessary to perform the work, and to reinstall the furniture at the completion of work."
    - b. Paragraph 1.05, C. 1.: At the end of the paragraph, insert the following:
      - "The Contractor shall consult and work with the Project Contact Person in the development of the Project Schedule, in particular, the scheduling and progression of window and door replacement. Changes to the Contractor's schedule shall be at no addition cost to the State."
    - c. Paragraph 1.05, C. 2.: Delete the paragraph in its entirety and insert the following:
      - "2. Once the work to remove and replace an individual window or door has started, the work shall proceed without interruption, until the work to install the new window or door has been completed."

- d. Paragraph 1.05 D. 1.: Add the following item:
  - "g. The Contractor is cautioned that there may be occasional dates and times, unknown at the time of this solicitation, during which the Contractor will not be permitted to work (e.g. during visits by international dignitaries, etc.). The DOD will notify the Contractor of such dates and times as soon as they are known. Therefore, the Contactor shall accommodate 10-days of such potential stoppages in the cost proposed and in the work schedule."
- e. Paragraph 1.05 D. 1. D. 4): Add the following room to the listing of rooms:
