ADDENDUM NO. 1

Refuse Collection and Disposal Services for the Hawaii Air National Guard at Joint Base Pearl Harbor-Hickam and Kalaeloa State of Hawaii, Department of Defense, Hawaii Air National Guard Job No. CA-202114

The items listed hereinafter are hereby made a part of the contract for the abovementioned project and shall govern the work taking precedence over previously issued contract documents governing the items mentioned. Receipt of this addendum is to be acknowledged on page OF-5 of the proposer's packet.

BID OPENING CHANGES

The bid opening date has been changed to July 8, 2021 at 2:00 PM.

In keeping with Governor Ige's emergency declaration regarding COVID-19, Department of Defense (DoD), Engineering Office is temporarily altering the process to be used for bid openings to adhere to the requirement to avoid unnecessary gatherings.

Bids will not be opened in public. After 2:00 PM, bids will be opened by two DoD, Engineering Office personnel. Following the bid opening, the bid tabulation will be posted on the DoD website, http://dod.hawaii.gov/hieng/. Additionally, DoD will email to each bidder PDF files providing scans of all pages for each of the three apparent lowest bids received. This service is intended to replace the prior practice of permitting bidders to photograph competitors' bid packages.

Below are the answers to the questions submitted prior to the due date of June 17, 2021.

- 1. For the three 30 yd open tops, can you provide last year's tonnages?
 - a. Tonnages are not available. Please bid on the frequency of pick-up. Frequency will be monthly pickups or as requested by the customer. Request tonnage to be reported for the single 30CY dumpsters, Wood, Metal, Cardboard.

- 2. You have wood separated, where is it currently being tipped/processed?
 - a. Processing location is up to the Contractor.
- 3. In your campaign contributions, does it apply to personal contributions?
 - a. No. If awarded a contract in response to this solicitation, offeror agrees to comply with HRS §11-355, which states that campaign contributions are prohibited from a State and County government contractor during the term of the contract if the contractor is paid with funds appropriated by the legislative body between the execution of the contract through the completion of the contract.
- 4. Requirement for contractors licensing classification: Our business license with the City & County of Honolulu is for Garbage and or Rubbish collection, will that suffice?
 - a. Yes

<u>Note:</u> JBPHH requires commercial vendors to have DBIDS-Defense Biometric Identification System registration process. (Once a vendor is awarded the contract, they will be provided a checklist to register for DBIDS).

- 5. Pg. SN1: Special Notice to Bidders: What is your "Standard Questionnaire and financial Statement for Bidders", and does it apply to this bid?
 - a. No.
- 6. Pg. AGC-5: Price Adjustments for Goods and Services: Is there a provision if the landfill increases their rates?
 - a. No. However, rates can be adjusted annually, and increases can be negotiated at those times.
- 7. Scope of Work: As discussed in the pre-bid, true tonnage reports are not possible because the trash is commingled with other trash. 6cy's do not need wheels and lockable spring-loaded hinge tops are not required. Can this be deleted from the bid?
 - a. Yes, understand tonnage cannot be reported to 3CY and 6CY containers, but can be for the 30CY containers. Wheels are not required for 6 CY and they do not need lockable hinge tops but must have closable lids and painted brown IAW contract specs.
- 8. What is the current pricing?
 - a. Submit a request to access government record by filling up the Office of Information Practices (OPI) forms at https://oip.hawaii.gov/forms/

9. What were the last bid results?

- 10. What happens if City and County / Covanta increases their disposal rates? Are we allowed to pass thru the incremental price adjustment?
 - a. Not during contract duration. However, rates may be adjusted annually, and increases can be negotiated at those times. Any cost change shall be processed as a supplement to the contract.
- 11.As Hawaii Air National Guard (HIAING) and Hawaii Army National Guard (HIARNG) are both from the Department of Defense and the scope of work for the refuse collection services are very similar in nature to each other, can both the HIAING Job No. CA202114 and HIARNG Job No. CA-202112 Refuse Collection Services Bids be due on the same date? As it stands now bidders may adjust their HIARNG bid prices up or down based upon the bid results from the HIAING bid opening, which is two days earlier on 7/6/21.
 - a. This addendum #1 changes the bid opening date for the Hawaii Air National Guard (HIANG), Job No. CA-202114. Bid opening is scheduled for July 8, 2021 at 2:00 PM for both HIANG Job No. CA-202114 and Hawaii Army National Guard (HIARNG) Job No. CA-202112.
