

PRIVACY ACT STATEMENT

AUTHORITY: ALARACT 100-2016, Attaining and Maintaining National Registry of Emergency Medical Technicians (NREMT) Eligibility for 68W MOS Qualification (interim change to AR 40-68, para. 4-3) and References cited therein; AR 600-20, Army Command Policy.

PURPOSE: The purpose for collecting this information is to obtain facts which your commander is required to report that might affect your continued eligibility for NREMT certification and recertification and your continued qualification to serve in the 68W MOS, Health Care Specialist.

ROUTINE USES: This information may be reported to the NREMT for adverse action on certification, if circumstances warrant.

DISCLOSURE IS MANDATORY: This information is mandatory because of the need to identify, report, investigate and document occurrences affecting your qualifications to continue serving in the 68W MOS related to the requirement that you be certified and eligible for recertification by the NREMT.

STATEMENT OF NREMT CERTIFICATION ELIGIBILITY

I _____, state to the best of my knowledge, understanding and belief:

(1) I understand that I am required to remain eligible for National Registry of Emergency Medical Technicians (NREMT) certification and recertification in order to obtain and maintain the 68W MOS, Health Care Specialist, in the Army.

(2) I understand that the NREMT terms of certification requires notification by me within 30 days of any facts bearing on NREMT eligibility or certification. Among the occurrences and conduct which would bear on NREMT eligibility and certification are certain criminal convictions, felony and misdemeanor, listed in the NREMT's policies.

(3) I understand that military commanders are required to monitor and report matters that *might* affect my NREMT certification pursuant to ALARACT 100-2016 for investigation and determination by the appropriate military authority whether my NREMT eligibility for certification has been affected.

(4) By adding my initials to the applicable boxes below, I make the following representations relating to my NREMT certification eligibility:

(a) I have not been convicted in a civilian court (state or federal) of any crime that constitutes a felony. A conviction includes any civilian criminal proceeding resulting in imposition of punishment or fine, supervised or unsupervised probation, pretrial probation or diversion, deferred judgment, deferred adjudication, deferred prosecution, deferred sentencing, suspended adjudication, suspended prosecution, suspended sentencing or suspended judgment.

(b) I have not been formally charged in a civilian court (state or federal) with any crime that constitutes a felony under the laws of the United States or any State or Territory.

(c) I have not been convicted in a civilian court (state or federal) of any crime that constitutes a misdemeanor of the following types: (i) any crime involving weapons, ammunition, explosives or arson; (ii) any illicit drug activity that includes using, possessing, manufacturing, importing, exporting, buying, selling, distributing, or introducing illegal drugs into an installation; (iii) any illicit drug activity that includes abusing, using, possessing, manufacturing, importing, exporting, buying, selling, or distributing prescription medications or drugs; (iv) spouse abuse, child abuse or physical violence/harm to other persons, property or animals; and (v) sexual misconduct of any kind (including, but not limited to rape, sexual assault, and indecent exposure). A conviction includes any civilian criminal proceeding resulting in

imposition of punishment or fine, supervised or unsupervised probation, pretrial probation or diversion, deferred judgment, deferred adjudication, deferred prosecution, deferred sentencing, suspended adjudication, suspended prosecution, suspended sentencing or suspended judgment.

(d) I have not been formally charged in a civilian court (state or federal) with any crime that constitutes a misdemeanor of the following types: (i) any crime involving weapons, ammunition, explosives or arson; (ii) any illicit drug activity that includes using, possessing, manufacturing, importing, exporting, buying, selling, distributing, or introducing illegal drugs into an installation; (iii) any illicit drug activity that includes abusing, using, possessing, manufacturing, importing, exporting, buying, selling, or distributing prescription medications or drugs; (iv) spouse abuse, child abuse or physical violence/harm to other persons, property or animals; and (v) sexual misconduct of any kind (including, but not limited to rape, sexual assault, and indecent exposure

(e) I have not been notified of nor do I have any knowledge of any disciplinary action by the NREMT against me.

(f) I have not had my NREMT certification restricted, suspended, revoked nor have I been denied NREMT certification.

(5) If I did not initial each of the boxes in statements 4(a) through 4(f) above, then by my signature below I represent that I have notified my commander about all such occurrences.

(6) I understand that this document will continue during the course of my 68W MOS service, so if in the future my status changes such that the representations I make today become no longer accurate, then I must notify my commander and execute a new eligibility statement.

(7) I understand that the representations made by me in this document may affect my NREMT eligibility for certification and recertification and my ability to hold the 68W MOS.

(8) I understand that providing false or misleading representations in this document may lead to action against me under the Uniform Code of Military Justice and/or adverse administrative actions.
