#### Dear Governor Waihee:

The State Department of Defense fully tested the capabilities of its Army and Air National Guard divisions to mobilize and deploy for their Federal missions. Throughout Fiscal Year 1990, our units trained successfully in demanding scenarios and adverse weather conditions, proving once more that they are ready and proficient to perform any task.

The Hawaii Army National Guard's 29th Infantry Brigade (Separate) completed three major deployments overseas and to the mainland. In March, the brigade deployed 950 soldiers and organic equipment to the Republic of Korea for Team Spirit '90. It was the largest movement of personnel and military hardware to a foreign country for the brigade. In the summer, the 29th's infantry and artillery battalions trained in Oregon and Washington in unfamiliar terrain and weather.

The Hawaii Air National Guard's 154th Composite Group deployed aircraft and crew to Guam and the Philippines. The 154th also activated a tactical control squardron on Kauai. The unit, with 24 full-time and 90 military positions, was filled primarily by personnel displaced during the reorganization of the 150th Aircraft Control and Warning Squadron. The 201st Combat Communications Group, meanwhile, conducted a very productive operational readiness inspection.


The Office of Veterans Services expanded its operations on the islands of Oahu, Maui, Kauai and Hawaii, greatly increasing its effectiveness to deliver services to approximately 120,000 veterans in the State. Construction for the Hawaii State Veterans Cemetery is also on schedule for the first interment in 1991.

Through your leadership, a Federal disaster was declared for Puna residents on the Big Island. This measure provided immediate relief and assistance for the beleaguered victims of more than seven years of seemingly relentless volcanic destruction.

As we confront the many uncertainties and challenges of the last decade of the 20th century, the State Department of Defense remains steadfast in its commitment to serve, protect and defend the people of our great State and nation.

## **Department of Defense**

#### Mission

The mission of the State of Hawaii Department of Defense is to assist authorities in providing for the safety, welfare and defense of the people of Hawaii. The department continuously strives to maintain its readiness to respond to the needs of people in the event of war or disasters, whether natural or human-caused. Upon activation by the Governor of the State of Hawaii, the department is prepared to provide professional personnel, quality services and well-maintained equipment to assist during emergencies.

The Hawaii Army and Air National Guard also trains to prepare to meet their Federal missions should they receive a Presidential call to duty in times of national emergency.

The Office of Veterans Services (OVS) serves as the single point of contact in State government for veterans' services, policies and programs. The OVS also oversees the construction and administration of the Hawaii State Veterans Cemetery.

#### **Personnel**

Compared to other State departments, the full-time force of the De-

partment of Defense represents a varied mixture of Federal, State, active duty and drill-status National Guard members. This force includes 1,181 full-time Federal employees, 145 State employees, and more than 5,703 drill-status Army and Air National Guard members.

#### Organization

The State Department of Defense is made up of three major divisions, one inactive division, six key staff offices and the Office of Veterans Services.

The three major divisions are the

Hawaii Army National Guard, Hawaii Air National Guard and State Civil Defense.

A fourth division, which is currently inactive, is the Hawaii State Defense Force. Under current State laws, the Hawaii State Defense Force may be activated should the need arise.

The six key staff offices provide support services to the three active divisions and other activity centers within the department. The key staff offices include the Administrative Services Office, U.S. Property and Fiscal Office, Support Personnel Management Office, Engineering Office, Staff Judge Advocate Office, and Public Affairs Office.

The special staff includes the Senior Army Advisor, Senior Enlisted Advisor, Inspector General, Director of Information Management, and Family Action Program Coordinator.

The adjutant general is the executive head of the department. In addi-

tion to being a member of the governor's cabinet, the adjutant general is the commander of both military divisions and the director of State Civil Defense.

#### **Hawaii National Guard**



#### State Civil Defense




# Office of Veterans Services

The Office of Veterans Services (OVS), which was administratively attached to the Department of Defense in July 1988, serves as the primary State agency responsible for developing and managing veterans' programs, policies and activities. The OVS is also charged with planning, establishing and operating the Hawaii State Veterans Cemetery on Oahu, which is scheduled for initial opening in 1991 and full completion in 1993.




Hawaii National Guard soldiers and airmen pass in review at Diamond Head Crater.







# Hawaii Army National Guard

#### Mission

The Hawaii Army National Guard continually trains to maintain its readiness for State or Federal active duty. It is prepared for local or global assignments should the Governor or President order it to active duty.

#### **Personnel**

The Hawaii Army National Guard's authorized personnel strength increased from 4,154 to 4,237 in Fiscal Year 1990. As of Sept. 30, 1990, the assigned personnel strength of the Hawaii Army National Guard was at 3,578 or 84.4 percent fill of authorized positions. The full-time staff consisted of 24 Active Guard/Reserve (AGR) officers, 212 enlisted AGR soldiers, 283 technicians, 52 State employees and 17 temporary employees.

#### Organization

The Hawaii Army National Guard is commanded by the adjutant general. The organization consists of the State Area Command, the 29th Infantry Brigade (Separate), the Troop Command, the 111th Army Band, and the 117th Public Affairs Detachment. In Fiscal Year 1990, the Army National Guard reorganized the Headquarters and Headquarters Company of the 29th Infantry Brigade (Separate), which deleted the aviation section and organized the 451st Aviation Detachment, which is located on the island of Hawaii

#### 29th Infantry Brigade (Separate)

The mission of the Brigade is the destruction of enemy forces and the

control of land areas, including population and resources. The Brigade's assigned strength as of June 30, 1990, was 2,521. This included 178 officers, 28 warrant officers and 2,315 enlisted members.

The Brigade is organized with a headquarters company, two infantry battalions, a field artillery battalion, and a support battalion. The Brigade's separate units include a combat engineer company, a cavalry troop, and a signal detachment.

Units of the Brigade are located throughout the State with elements of the two infantry battalions on the islands of Hawaii, Maui, Kauai, and Molokai. Other units are located on Oahu at Fort Ruger, Wahiawa, Pearl City and Kaneohe.

#### **Troop Command**

The Troop Command is headquartered at Waiawa Armory in Pearl City on Oahu. It is the other major command within the Hawaii Army National Guard. The Troop Command includes a combat aviation battalion at Wheeler Air Force Base, a combat service support battalion headquartered at the Wahiawa Armory, and an engineer detachment at Fort Ruger.

The units within the Troop Command provide a broad spectrum of combat support and combat service support. The aviation battalion provides aerial reconnaissance and aerial fire support, while the supply and service battalion stores and issues supplies, repairs and rebuilds military equipment, and maintains vehicles, weapons, helicopters and sophisticated electronic equipment. The organization also provides field services which include laundry and bath, graves registration, baking, and renovation of light textiles. The engineer detachment provides utilities repair and maintenance.

# Highlights and Significant Events

The reorganization of the combat service support battalion in September 1989 added a Personnel Service Company to the organization.

The eight maintenance facilities located throughout the State were staffed by 93 full-time employees. These employees worked in excess of 190,000 hours to ensure that the combat readiness of the Army Guard is maintained. The spectrum of work is diverse; from simple routine services, to repair operations; to the installation of new components and equipment modifications to keep the Army National Guard's equipment abreast of the modern Army.

The Army Guard continued to expand its combat capability with the receipt of new equipment funded by

the military's force modernization program. The force modernization program requires the maintenance personnel as well as the users receive extensive training and updates. Both full-time and part-time Army Guard soldiers participated in local as well as mainland schools.

In addition, maintenance support is provided to the Army Reserve when requested.

The Hawaii Army National Guard's aviation units included the Headquarters State Area Command aviation section, the 193rd Aviation Battalion (Attack), and the recently activated 451st Aviation Detachment. Hawaii Army National Guard's aircraft inventory included 15 AH-1S Cobra attack helicopters, 6 UH-1H Huey utility helicopters, 21 OH-58A Kiowa Scout helicopters, and a U-21D Ute, twin-engine, fixed-winged aircraft. The aviation units flew a total of 4,950 hours which represents 100 percent of their annual flying hour program. These flight hours were used to accomplish mis-

sion support, proficiency training, individual aircraft qualification, unit training, and support to civil authorities.

The two Army Aviation Support Facilities (AASF) assigned to the Hawaii Army National Guard served as fixed training bases for Hawaii Army National Guard's training programs. These programs included aircraft qualifications, nap of the earth qualifications, aerial gunnery training, unaided night qualification, and night vision goggle qualification.

The Hawaii Army National Guard continued to support civil authorities for law enforcement purposes. Again in FY 1990, Federal funds were provided to the National Guard for its enhanced role in drug enforcement support. To support law enforcement agencies, National Guard personnel are placed on Active Duty Special Work, Title 32, U.S.C., status which must be performed over and above normal training. Since the receipt of Federal resources to support drug enforcement operations, the Hawaii Army National Guard continued to provide helicopter support to each county for the marijuana eradication program "Operation Green Harvest." The Hawaii Army National Guard also participated in a Drug Enforcement Administration-led marijuana eradication project, "Operation Wipeout." In FY 1990, as many as 20 Hawaii Army National Guard personnel were placed on active duty to provide assistance and support to the U.S. Customs Service. They assisted customs inspectors in the inspection and search of foreign arrival cargo containers, aircraft, postal mail and packages.

#### **Training**

During Fiscal Year 1990, the Brigade participated in several community action projects. The 1st and 2nd Battalions, 29th Infantry hosted the annual American Lung Association's "Super Kids" competi-

tion on the islands of Hawaii, Maui, and Kauai. The Brigade units provided support to the U.S. Customs Service; the 129th Signal Detachment supported the Diamond Head clean-up committee. Other highlights for the Brigade included the completion and the dedication of the Hanapepe Armory on Kauai, Jan. 27, 1990, which is home to Company A, 1st Battalion of the 299th Infantry.


Federal Fiscal Year 1990 was another challenging one for units of the Hawaii Army National Guard. A 950-person task force of the 29th Infantry Brigade (Separate) deployed to the Republic of Korea to participate in Exercise Team Spirit. This was the largest number of Hawaii Guard personnel to participate in this exercise. Also, during this exercise, the concept of the 24-hour Family Assistance Center proved to be very beneficial to both the soldiers overseas and to the families back home. The Family Assistance Center provided the vital communication link that was effectively implemented during this exercise.

The 1st Battalion of the 299th In-

fantry deployed to Camp Rilea, Ore., to perform their annual training during Aug. 18-Sept. 1, 1990. All their training was conducted on northwestern beaches and mountains, on World War II vintage maneuver areas and firing ranges. They performed such operations as Military Operations on Urbanized Terrain Training (MOUT), river crossings across pure, fast-running streams and Pacific headlands, air assault operations and live firing exercises.

The 1st Battalion, 487th Field Artillery, deployed to Yakima, Wash., July 14-28, 1990. They conducted a 180-mile road march from Oregon to Washington, field artillery fire support missions, air assault operations, aerial observation missions, and also participated in a Combined Arms Live Fire Exercise (CALFEX) in which they supported the Marines with illumination missions.

Other significant deployments involved brigade and battalion cells participation in Exercise Yama Sakura (Sendai, Japan); and in Exercise Pacific Reserve (an exchange pro-

gram with the Australian Army in Toowoduba, Australia).

In November 1989, 10 soldiers from the 117th Public Affairs Detachment deployed to Panama where they performed their annual training.

On June 3, 1990, the Hawaii National Guard (both Army and Air) assembled together in Diamond Head Crater for a Commander in Chief's Review hosted by Maj. Gen. Alexis T. Lum. This was to honor the Governor of Hawaii and the Commander in Chief of the Hawaii National Guard. the Honorable John Waihee. There were 240 Army soldiers in formation. The Army Guard provided three OH-58 Kiowas and three AH-1S Cobras for a flyby as well as a salute battery of six howitzers which provided a 19-gun salute for the Commander in Chief.

The units of the Troop Command completed annual training (AT) at various locations during Training Year 1990. Units trained at three different locations within the State.

The Headquarters and Headquarters Detachment, 297th Supply and Service Battalion and 12th Personnel Service Company performed AT-90 at Bellows Air Force Base/Schofield Barracks, South Range from July 21 through Aug. 4, 1990.

The 292nd Supply and Service Company (Direct Support) performed its annual training in the Republic of Korea, participating in Exercise Team Spirit. Unit members were deployed to Korea in three increments beginning from Feb. 28 to March 24, 1990. The unit provided a variety of combat service support to units in the field. Training included aspects of airlifting rations to units in the field, supporting units with shower facilities, and bakery products such as bread to supplement their rations.

The 291st Maintenance Company (Heavy Equipment) performed its annual training at Bellows AFB and Schofield Barracks. The unit performed general support level maintenance and repair and also underwent an Army Training Evaluation.

The 1st Battalion, 193rd Aviation, performed its annual training at the Pohakuloa Training Area on Hawaii, from July 21 to Aug. 4, 1990. The unit conducted aerial gunnery training, combat support operations, and aviator and aircrew training.

The 298th Engineer Detachment performed its annual training at Keaukaha Military Reservation located at Hilo, Hawaii, from July 21 to Aug. 4, 1990. The unit performed facilities maintenance of carpentry and electrical rewiring of Keaukaha Military Reservation and Kilauea Military Camp.

The Hawaii Military Academy graduated and commissioned eleven officer candidates during the year. The Distinguished Graduate was 2nd Lt. Richard Shuman. The Most Improved Award and the Honor Award went to 2nd Lt. Wesley Tanji. 2nd Lt. David Kikau received the Leadership Award while the Academic Award went to 2nd Lt. Mark Inouye. 2nd Lt. Gwen Le Bourdias earned the Physical Training Award.

Twenty-one Army National Guard soldiers completed the First Sergeant Course, 13 completed the Advanced Noncommissioned Officer Course and 51 graduated from the Primary Leadership Development Course. These courses were designed to enhance the leadership skills of enlisted personnel.

Thirty-two Army National Guard company-grade officers completed the Company-size Unit Commander's Course, designed to train junior officers who are selected for company command and other leadership positions.

## **Hawaii Air National Guard**

#### Mission

The State mission of the Hawaii Air National Guard is to defend the State of Hawaii and its people from mass violence originating from either human or natural causes. Its Federal mission is to provide trained units and qualified individuals to be available for active duty in the United States Air Force in time of war or national emergency or at such other times as the national security requires.

#### **Personnel**

The assigned strength of the Hawaii Air National Guard as of Sept. 30, 1990, was 211 officers and 1,911 enlisted personnel for a total of 2,122 members. This was 95.1 percent of the total 2,232 authorized positions.

## Organization

The Hawaii Air National Guard is directed by the commander, Hawaii Air National Guard. The command encompasses the Headquarters, Hawaii Air National Guard, 154th Composite Group (154th COMPGP), 201st Combat Communications Group (201st CCGP), and 199th Weather Flight.

#### 154th Composite Group

The 154th COMPGP is the largest of the Hawaii Air National Guard organizations, which includes a head-quarters squadron, a tactical fighter squadron, a consolidated maintenance squadron, two aircraft control and warning squadrons, a tactical control squadron, and seven other support units.

Responsibility for the air defense of the State of Hawaii rests primarily with the units of the 154th COMPGP. The tactical fighter squadron, located at Hickam Air Force Base (AFB), is equipped with the F-15A/B Eagle and provides the fighter-interceptor capability for the air defense system.

The aircraft control and warning squadrons operate two radar sites

located on Kokee Air Force Station (AFS), Kauai, and Mount Kaala AFS, Oahu. The radars are linked to the Hawaii Region Operations Control Center at Wheeler AFB, which provides for the 24-hour-a-day radar surveillance for the entire island chain.

# 201st Combat Communications Group

The units of the 201st CCGP are located on Hawaii, Maui, Oahu, and Kauai. They are trained to provide combat communications, air traffic control facilities and services in support of tactical air force requirements. The members of the 201st CCGP are prepared to deploy anywhere in the world with their equipment and continuously train to meet this requirement.

## 199th Weather Flight

The 199th Weather Flight provides meteorological support primarily to the 29th Infantry Brigade (Separate) and secondarily to the active military and reserve components of the Army and Air Force. Located at Wheeler AFB, they provide information to the worldwide meteorological network operated jointly by the Air Force's Air Weather Service, National Weather Service, and the World Meteorological Organization.

# Highlights and Significant Events

This year has been characterized by growth and change. Due to the combined efforts of the Headquarters of the Hawaii Air National Guard (HIANG), Pacific Air Forces, and the National Guard Bureau, the year was highlighted by the activation of the 154th Tactical Control Squadron (154th TCS) on Kauai. Timing for the activation of this new unit was critical due to the reorganization of the 150th Aircraft Control and Warning Squadron (150th ACWS) in October 1989 which resulted in loss of 28 full-time and 133 military manpower authorizations. The 154th TCS, with its 24 full-time and 90 military positions, provided many members of the 150th ACWS the opportunity to continue their careers with the HIANG.

Other significant events included the leadership changes of the two largest components of the Hawaii Air National Guard. In December 1989, Col. John S.W. Lee retired as the commander of the 154th COMPGP. During the change of command ceremony, Brig. Gen. Edward V. Richardson, commander, HIANG, announced that the 154th COMPGP had been selected to receive an unprecedented fifth Air Force Outstanding Unit Award. Also, Col. Ernest T. Shima retired as commander of the 201st CCGP after 33 years of military service in March 1990.

Military construction presented some of the most obvious changes at Hawaii Air National Guard facilities in the fiscal year. The "Hush House", a facility designed to test F-15 engines without adding to the State's environmental noise pollution, was completed and is now fully operational. Additional construction includes work on the Composite Avionics/Weapons Release facility and Munitions Maintenance facility. Work on these projects are well over 75% complete and are expected to be operational early next year.

Hawaii Air National Guard units hosted several distinguished guests throughout the fiscal year including senior military officials from Pacific Rim nations as well as visits by the U.S. Secretary of Defense, Dick Cheney; Secretary of the Air Force, Donald Rice; and the Chairman of the Joint Chiefs of Staff, General Colin Powell. Foreign dignitaries who visited the HIANG included Air Vice Marshal Chanin Chandrubeksa, director of intelligence, Royal Thai Air Force; Air Marshal Jagdish Kumar Seth, air officer commander-in-chief, Training Command, Indian Air Force Academy; and Manjunath Sadanand, commandant, Indian Air Force Academy.

Tests of mission readiness and management effectiveness were again a part of this year's activities. In September 1989, the 201st CCGP successfully passed its Unit Effectiveness Inspection (UEI) when evaluated by the Air Force Communications Command Inspector General's team. The 199th Weather Flight was also put to the test when it successfully passed a crucial inspection of its wartime readiness as the Military Airlift Command conducted a UEI in June 1990. The inspection reviewed all equipment, training and procedures required of the unit to fulfill its wartime mission.

To increase the preparedness of Guard families, Headquarters, Hawaii Air National Guard continued to encourage the creation of Family Support Groups (FSG). During the past year, a total of six FSGs were chartered through the State Family Action Office. This increased the total number of support groups to 12. All of the FSGs continued their education program for families on preand post-mobilization preparedness and ensured unit cohesiveness through the use of "Family Day" events.

Each of the Hawaii Air National Guard units continues to support the community at large by participating in numerous charitable and community service projects. From direct financial contributions through organizations such as the Combined Federal Campaign, Aloha United

Way, March of Dimes, and Muscular Dystrophy, to volunteer support of events such as the Special Olympics, Great Aloha Run, and annual Kolekole Pass Half Marathon, the members of the Hawaii Air National Guard continued to play a vital role in the community it serves.


#### **Training**

Training goals for the Hawaii Air National Guard were designed to ensure that units were able to perform their tasks as required by State and Federal missions. To accomplish this, units focused on training to retain the ability to survive and operate under wartime or general emergency situations. Training keyed on elements such as shelter operations mobility exercises, chemical defense training, combat aircraft turn-around, terrorist attacks, power and communications outages, and many other scenarios.

In February, members of the 199th Tactical Fighter Squadron (199th TFS) began to train in "hot-pit" refueling, which will allow jet fighters to get back in the air in a fraction of the time normally used to ready an aircraft using conventional refueling techniques. The 199th TFS pilots also began to train for longer range intercepts to expand the depth of their air defense and air superiority tactics.

Deployments this year included taking six F-15s and 146 Guard members to Guam during the first week in October 1989. The deployment was hampered by very bad weather conditions that tested the versatility and skills of everyone involved. The second fighter deployment was to the Philippines for "Combat Sage", which involved live missile firing, and "Cope Thunder", a large-scale joint forces training exercise designed to realistically simulate wartime conditions in a deployed posture.

Members of the 154th Civil Engineering Squadron, 154th Services Flight, and the 154th Mission Sup-

port Squadron deployed to Kadena, Okinawa in June 1990 to hone their skills at Base Recovery After Attack Training.

The 154th COMPGP hosted three Air National Guard units who came to train and share information and tactics. In December 1989, the New Mexico Air Guard deployed to Hickam AFB with six A-7 Corsairs from the 150th Tactical Fighter Group. They were closely followed by a mixed fighter deployment consisting of F-16 Falcons and F-4D Phantoms from the 184th Tactical Fighter Group, Kansas Air National Guard. In June, six F-16s and four A-7s from the 162nd Tactical Fighter Group,

Arizona Air National Guard, added an international touch to their deployment by bringing two Dutch foreign-exchange pilots who gave their version of F-16 tactics.

The emphasis for training within the 201st CCGP was centered on preparation for the operational readiness inspection scheduled for August 1990. The 12-day inspection by the Air Force Communications Command Inspector General tested the group's combat readiness to deploy, and provide communications and air traffic control services to deployed air forces worldwide.

To prepare for this rigorous inspection, the 201st CCGP planned


and executed two operational readiness exercises (OREs). These exercises were shorter in length but addressed specific graded portions of the inspection. Evaluation teams critiqued the units' abilities to deploy and provide combat communications and air traffic control services. The first ORE was performed on two separate training weekends in October 1989. Units deployed and set up their communications and air traffic control equipment at both Upolu Point and Barbers Point Naval Air Station (NAS), Barbers Point. The second ORE was conducted in March 1990. The 9-day exercise again deployed units to Upolu Point and NAS Barbers Point. An interisland communications net and long haul communications link to Clark Air Base in the Philippines and NAS Yokosuka in Japan were added as exercise requirements.

As with the 201st CCGP, the 199th Weather Flight's training was geared towards preparing for the Unit Effectiveness Inspection in June 1990. The 199th Weather Flight actively participated in several field training

and command post exercises during the year. Six members of the flight deployed to Korea with the 29th Infantry Brigade (Separate) to provide tactical weather support during Exercise Team Spirit 1990. This provided the opportunity to test mobility plans and operating instructions. Additionally, the weather flight personnel supported the 20th Weather Squadron, 1st Weather Wing in the Keen Edge Exercise in Yama Sakura, Japan. Experiences gained through training undoubtedly contributed to the 199th Weather Flight's success during the June inspection.

## State Civil Defense

#### **Mission**

The mission of State Civil Defense is to plan, prepare for, and respond to actual or pending disaster. These actions are applied to protect life and property, restore essential services, ensure continuity of government, and coordinate management of resources and operations to speed recovery.

Available resources must combat a range of hazards stemming from natural and technological sources, as well as war-related hostilities. Hazard management is accomplished via the four integrated phases below:

**Mitigation.** Measures to reduce or eliminate the impact of emergencies or disasters.

**Preparedness.** Developing plans and procedures, training and equipping personnel, and informing the public on hazard awareness and preparedness.

**Response.** Warning the community and reaction to the crisis by emergency services and volunteer agencies.

**Recovery.** Long- and short-term efforts for restoring the social and economic structure of a community following a disaster.

State Civil Defense plans and programs also support Federal Emergency Management Agency (FEMA) strategies, emphasizing the Integrated Emergency Management System. This is a system of identifying all hazards facing a community, analyz-

ing the community's capabilities to manage those hazards, and developing programs to overcome shortfalls.

#### Personnel

State Civil Defense is authorized 30 full-time State employees during non-crisis periods. During a crisis, staffing is increased by mobilizing other government agencies and volunteer organizations. The adjutant general serves as the director of civil defense, while the vice director oversees day-to-day operations and staff supervision. When the director is out-of-state, the vice director assumes the responsibilities of the director.

#### Organization

The civil defense system is comprised of all private and public organizations charged with emergency management responsibilities. State departments and agencies all have civil defense coordinators appointed for specific civil defense tasks. By law, each County is an essential element of the civil defense system. Normally, County mayors are appointed as deputies by the director to manage local civil defense responsibilities.

State Civil Defense supports the statewide civil defense system by managing Federal funds and disaster assistance programs. State Civil Defense also aids in County plans and programs development, provides technical assistance, and conducts professional training and exercises. In major emergencies, if the required response and relief assistance is beyond that available within the County affected, request for additional resources is forwarded to the State through State Civil Defense. If the required relief is beyond that available within the State, a request for additional resources is made to the Federal government through the Federal Emergency Management Agency.

The State Civil Defense Advisory Council is made up of seven members appointed by the Governor. The council meets quarterly to discuss programs and projects conducted by State Civil Defense. Serving on the advisory council during this reporting period were:

# Highlights and Significant Events

Kilauea declared major disaster in 1990. Since the eruption began in

1983, lava from Kilauea's Pu'u O'o and Kupaianaha vents has affected over 35 square miles of land in the Puna District, destroying or endangering nearly 250 residences and buildings and burying 2,500 houselots. In seven years, lava has been responsible for more than \$61 million in private and public property losses. Pumping out approximately 650,000 cubic yards daily, the Kupaianaha vent continues to pose an active threat to lands adjacent to Kalapana.

Property losses took a sharp upswing in the early months of 1990, as lava converged on the Kalapana community.

At the Governor's request, the President declared the Puna District a disaster area, leading the way for Federal disaster aid. On May 23, a Disaster Application Center was opened in Pahoa, providing a single site for Federal, State and County assistance programs for victims of the lava flow.

The Federal Emergency Management Agency (FEMA) approved the State's proposal to establish a disaster incident period covering the entire eruption phase dating to January 1983. The incident period will remain open until the current eruption ceases. The State of Hawaii is seeking ways to mitigate the impact of lava flows on the area. The Governor has appointed the Kalapana Task Force to consider mitigation measures for the long term, such as relocation, housing and land use.

Emergency Information, Tsunami Evacuation Maps readied for Telephone Directories. In 1990, the white pages of phone directories statewide carried revised civil defense emergency information. The CD section now includes important information on planning and preparation, in addition to emergency instructions.


New tsunami evacuation maps were readied for publication also. A replacement for maps first published in 1960, the new maps give more precise details on street locations and landmarks in relation to evacuation zones. The new tsunami evacuation maps are slated for publication in 1991 phone directories.

Earthquake Hazard Preparedness Committee formed. State Civil Defense took the initiative to sponsor a special committee for Hawaii earthquake preparedness. Drawn from public, private and academic sectors, the committee brings together geotechnical, earthquake engineering and design experts, as well as seismologists, emergency managers and environmentalists. The Earthquake Hazard Preparedness Committee serves as an advisory group for short- and long-range hazard reduction plans and programs.

**Emergency Information Sys**tems expanded in 1990. Since 1986 automation has progressed considerably. In 1990, there were 19 computer workstations active on the local area network in the Emergency Operating Center. Two geomapping terminals are also an important part of the Integrated Emergency Management Information System. County Emergency Operating Center were linked with the State **Emergency Operating Centers** through a toll-free interisland data system. County EOC's have access to the State's Integrated Emergency Management Information System, including the geographic information system and connectivity with FEMA regional and national offices.

The system also provides County EOC's the ability to access tsunami and storm system gauges recently installed in critical locations within their Counties.

Emergency Broadcast System improvements for Neighbor Islands. New Multichannel EBS receivers provided by the State of Hawaii were installed by the EBS pri-

mary stations on Kauai and Maui to improve emergency radio relays. Also, a direct EBS link for the State Emergency Operating Center EBS studio was installed to radio station KIPA on the Big Island using the State/Federal Microwave System. Three new Remote Transceiver Pickup Units were placed in operation by KGU in Honolulu.

#### **Training**

Training and exercises are a key factor in maintaining readiness for Hawaii's emergency management system. A total of 14 exercises were conducted statewide in 1990, including exercise design assistance for Department of Transportation, Airports Division, annual program. State Civil Defense also hosted a FEMAsponsored seminar on earthquake

hazard mitigation for hospitals and other healthcare facilities. Over 60 participants from major local hospitals and healthcare agencies attended the two-day event.

Field courses on emergency management and planning, radiological monitoring and instrument calibration, as well as a variety of special seminars rounded out the 1990 training agenda.

## Office of Veterans Services

#### **Mission**

The Office of Veterans Services is the principal State office responsible for the development and management of policies and programs related to veterans, their dependents and/or survivors.

#### Personnel

The Office of Veterans Services is authorized 12 full-time State employees. The Hawaii State Veterans Cemetery Branch has been authorized five full-time State employees, to be filled in FY 1991.

#### Organization

The Oahu Office of Veterans Services, as the centralized administrative agency, consists of the director, administrative and office services staff, and veterans services staff. Each Office of Veterans Services staff on Hawaii, Kauai, and Maui consists of a veterans services counselor and a clerk typist.

#### Highlights and Significant Events

The Office of Veterans Services was established by Act 115/88 of the State Legislature effective July 1, 1988. The first year was dedicated to organization of offices, staff, and services. The seven-member Advisory Board on Veterans Services, was sworn in on Sept. 7, 1989, and began to advise the director on issues and program development. The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts was appointed and met throughout the year to select a common site and works of art for memorials honoring casualties of those conflicts.

During fiscal year 1990, the Office of Veterans Services began a program to raise its visibility and make its services known to the veteran population. A wide variety of activities were undertaken to publicize services.

A series of presentations were made to groups of veterans, retirees, and active duty personnel. Over 700 individuals were advised of the benefits to which they may be entitled.

Outreach activities were wideranging and included, but were not limited to, meeting with Mayor Bernard Akana and Big Island veterans to discuss establishing a veterans cemetery in West Hawaii.

The director also accompanied Lieutenant Governor Ben Cayetano and Medal of Honor awardee Sgt. Maj. Allan J. Kellogg Jr. on a visit to Tripler Army Medical Center during Salute to Hospitalized Veterans Week.

Cooperative activities with other organizations included co-hosting, with the Department of Veterans Affairs Regional Office, a POW/MIA orientation at the State Capitol. Veterans services counselors serve as advisors to the Kauai Veterans Association, Big Island Veterans Association, Maui Mayor's Advisory Committee, the Oahu Mayor's Annual Memorial Day Program Committee and Veterans Day Committee. The counselors cooperate with vet-

erans organizations and schools to collect leis for Memorial Day. They also participate in Veterans Day Candlelight and Stand-Down ceremonies.


As the primary advocate for veterans, the director represented the Governor at the Massing of the Colors at the National Memorial Cemetery of the Pacific on Veterans Day, the Big Island Veterans Day dinner, ANZAC Day, Loyalty Day, at State conventions for the Disabled American Veterans, Veterans of Foreign Wars and the American Legion and at the ceremony for the repatriation of remains of Korean War casualties at Hickam. The director also accompanied the Secretary of Veterans Affairs, Edward Derwinski, on his courtesy visit to Governor Waihee.

The director was appointed by the Governor to the Waimano Master Plan Task Force to represent veterans in deliberations about the choice of a site for the future veterans hospital. He is also the representative for events being planned for the 50th Anniversary of the attack on Pearl Harbor, and serves as a member of the Homeport Task Force for the USS Missouri.

The director performed public service activities such as judging the American Legion Speech Contest, serving on the Board of the Hawaii Veterans Memorial Fund.

The veterans services coordinator chaired the Honolulu Community Housing Resource Board, served as a member of the Department of Veterans Affairs Native Hawaiian Programs Committee and attended a conference on homelessness.

During the 1990 fiscal year the Veterans Services staff concentrated on outreach activities. The staff made monthly on-site visits to veterans on the islands of Molokai and Lanai, as well as serving veterans and dependents in the non-urban areas of each county. The outreach efforts resulted in a 21% increase in the number of veterans and dependents served in FY 90.

The staff developed Standing Operating Procedures that define services offered to veterans, describe general office procedures and policies, and present the counselor's Code of Ethics. New intake and contact record forms were developed to gauge frequency and extent of services delivered to veterans.

The Office of Veterans Services defines a veteran as any person who has honorably served in any of the Armed Services of the United States, or any person who is now a citizen of the United States who has served in any of the Armed Services of any country which was an ally of the United States in any war or campaign in which the United States was also engaged.

A primary focus throughout the year was the Hawaii State Veterans Cemetery. On Sept. 15, 1989, a groundbreaking ceremony was held at the site in Kaneohe. Construction proceeded on schedule and on May 16, 1990, the Governor held a final inspection of Phase 1A.

The Advisory Board on Veterans Services met monthly to advise the director and testified before the 1990 Legislature. The Board was hosted by the Big Island Veterans Association in March to review concerns about the Department of Veterans Affairs' Primary Care Clinic and Vet Center and other local issues.

The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts was appointed to select a common site and art works for memorials honoring Hawaii's casualties of the Korean and Vietnam Conflicts. Governor Waihee's 1989 Veterans Day Proclamation announced that the memorials would be sited on the State Capitol grounds.

A two-stage open competition was held among local residents to select designs for the Memorials. A jury of seven was selected to judge the entries. The members of the jury were: Brig. Gen. Irwin K. Cockett Jr., Mr. Thomas M. Klobe, Mr. Vladimir Ossipoff, Ms. Juli M. Kimura Walters and three members of the Commission, Mr. Lawrence Ebesugawa, Mr. Lester Higa and Mr. George M. Matsumoto.

On June 7, 1990, the jury provided its unanimous recommendation to the Commission. By unanimous vote, the Commission adopted the recommendation of the jury on June 13, 1990, and forwarded it to the Governor.

The winning design was submitted by a team of two individuals, Mr. Benjamin B. Lee and Ms. Elaine M. Murphy. The design uses three triangular pylons surmounted by clear triangular prisms that cast patterns of light in colors of the rainbow. The triad and the triangular shape of the prisms are intended to represent the universal symbols for family, life and God. They are also a symbolic reminder of the triangular form of the folded flag presented to the family at all military funerals.

#### **Training**

Staff development was another area emphasized this fiscal year. All staff took the opportunity to train in areas associated with their work, ranging from general orientation, clerical routines, and benefit counseling to CPR, ethics, and cultural sensitivity.





## **Administrative Services Office**

#### **Mission**

The Administrative Services Office (ASO) provides military and State administrative support to the Office of the Adjutant General. It coordinates and controls all planning, programming, budgeting and execution of departmental programs as directed by the Adjutant General.

#### Personnel

The Administrative Services Office is authorized 17 full-time State employees.

#### Organization

The Administrative Services Office is comprised of three primary staff elements. These are the executive support, personnel and financial management services sections.

#### **Executive Support**

The ASO provides centralized office services and communications management, to include the monitoring, review, distribution and filing of communications received from Federal, State, local governments and the civilian community. The ASO is also responsible for maintaining close liaison with Hawaii's congressional delegation and legislature, and for administering all legislation affecting departmental programs. The office prepares correspondence and testimony concerning various legislative proposals. The military component of the ASO provides executive support services to the Adjutant General and coordinates the activities of the Adjutant General's military staff, which is composed of members of the Hawaii National Guard.

# Personnel Management Services

The State personnel management services staff administers the State employee personnel program which includes recruitment and placement, classification, salary, leave, employee performance, employee relations, out- and in-service training, personnel records, occupational safety and health, and maintenance of workers' compensation.

# Financial Management Services

The State financial management services staff administers and controls State general fund appropriations, State-administered Federal funds and matching fund grants under the Federal Emergency Management Assistance Program. The staff also provides centralized control and accounting of all State property assigned or issued to the department.

#### Highlights and Significant Events

There were 166 permanent State positions authorized during the year, of which 161 were filled by June 30, 1990. Additionally, 25 temporary positions were authorized and 19 were filled as of the end of the fiscal year.

During the fiscal year, the following types and number of personnel actions were taken:

With regard to performance ratings, 55 individuals representing 31 percent of the State work force received very satisfactory ratings. Of these, nine sustained superior performance awards were submitted and approved during the fiscal year. The average monetary award amounted to \$200.

The 1990 recipient of the Adjutant General's Award for Distinguished State Service was Mr. Alan Uyeda, the administrative officer with the State Civil Defense Division.

The 1990 Department of Defense nominee for the State Manager of the Year Award was Mr. Roy C. Price, the vice-director of Civil Defense.

During fiscal year 1990, there were 17 reportable cases of work-related injuries involving State employees. This figure reflects a 63 percent reduction of reportable cases from the previous fiscal year. There was a

total of 78 lost workdays or average of five workdays per injury, an 89 percent reduction in lost workdays.

Additionally, there were two other workers' compensation injuries involving drill status National Guard personnel. The total compensation payment for the year amounted to \$7,953, an 88 percent reduction from the previous fiscal year.

The Administrative Services Office, through its fiscal staff, administered and controlled \$8,913,817 in State general fund appropriations and \$1,583,493 in Federal fund appropriated receipts. Restricted as efficiency savings was \$145,128 of the original general fund appropriation.

The net general fund appropriation of \$8,913,817 was a composition of \$6,976,387 from the DEF 110, departmental operating program; \$437,430 from the DEF 112, Services to Veterans Program; and \$1,500,000 from Act 194, which increased the ceiling for Major Disasters from \$750,000 to \$1,000,000 per disaster and provided an additional \$1,000,000 solely for the purpose of matching Federal disaster relief funds.

The total expenditures and encumbrances, less unallotted disaster funds in DEF 110, amounted to \$8,050,737 for an expenditure rate of 97.1 percent, leaving a general fund lapsing balance of \$23,545. The Federal fund expenditures and encumbrances amounted \$1,410,465, leaving a reversion balance of \$173,028. The balances were due in part to several unfilled positions and lower federal fund receipts than originally projected and appropriated for the Civil Defense accounts. Table 5 in the Appendix depicts the distribution of general fund appropriation, appropriated receipts and expenditures by programs, organizations and cost elements.

Additionally, the fiscal staff administered three Federal fund hold-

ing and disbursing accounts. Table 6 in the Appendix reflects the status of these accounts as of June 30, 1990.

The department's cash receipts for the year amounted to \$3,205,613. Of this amount, \$833,892 was credited to the State general fund; \$53,433 to the general fund operating account; and \$2,318,288 to the special (Federal) fund operating accounts. The sources and fund accounts to which they were credited are depicted in Table 7 of the Appendix.

In administering the State finances for the year, the fiscal staff processed 3,798 purchase orders, 759 summary warrant vouchers, 42 payroll vouchers, 72 bills for collection, 65 Federal fund claims invoices, 91 treasury deposit slips, and 1,053 petty cash checks.

The department administered and accounted for State program funds under an in-house developed system and the statewide Financial Accounting and Management Information System (FAMIS). Information is transmitted to the Department of Accounting and General Services through FAMIS via direct on-line terminals.

Federal funds for Civil Defense program activities amounting to \$755,949 were received as 50-50 matching fund grants under the Federal Emergency Management Assistance Program (Public Law 85-606) and Civil Defense Maintenance and Service Program (Public Law 920), and as 100 percent Federal funded contract grants for radiological instrumentation/maintenance and calibration, emergency management training, disaster improvement, population protection planning, earthquake preparedness, and radiological defense planning and development.

Federal funds for the Hawaii Army and Air National Guard amounting to \$940,458 were received under five separate cost reimbursable operations and maintenance service contracts negotiated between the National Guard Bureau and the State Department of Defense. These contracts provided for reimbursements of 100 percent, 80 percent, and 75 percent of the authorized costs to operate and maintain buildings and grounds occupied by the Federally-supported activities of the Hawaii National Guard. Funds received under these contracts are deposited into the State treasury as appropriated receipts or as refunds of fringe benefit payments advanced by other State agencies.

During the year, the department added to its inventory of property

253 items of equipment valued at \$412,245 and disposed and declassified 121 line items of surplus or unserviceable property valued at \$67.073.

The fiscal staff also administered the short-term use and rental of departmental facilities by coordinating and processing 64 separate applications for use of armories and grounds located throughout the five major islands. The rental fees and utilities reimbursements collected amounted to \$43,471. The department's property inventory as of June 30, 1990 is provided below.

# U.S. Property and Fiscal Office

#### Mission

The mission of the United States Property and Fiscal Office for Hawaii is to receive and account for all funds and property of the United States in possession of the Hawaii National Guard; ensure that Federal funds are obligated and expended in conformance with applicable statutes and regulations; ensure that Federal property is maintained and utilized in accordance with National Guard Bureau directives; manage the Federal logistics systems for Hawaii; and provide the support necessary for the transition of mobilized units to active duty status.

#### Personnel

The United States Property and Fiscal Office for Hawaii is authorized 79 full-time Federal technicians.

## Organization

The United States Property and Fiscal Office is organized as follows: Administration Office, Data Processing Installation, Analysis and Internal

Review Division, Resource Management Division, Purchasing and Contracting Division, and Logistics Division.

#### **Administration Office**

This office performs administrative services in support of the United States Property and Fiscal Office operations by maintaining a centralized filing system, providing reproduction services, receiving and processing office mail, and providing typing and stenographic services.

# Data Processing Installation

The Data Processing Installation provides services to the United States Property and Fiscal Office, Hawaii Army National Guard, State Maintenance Office, Support Personnel Management Office, Standard Installation/Division Personnel System Branch, and the Army Aviation Support Facilities. The installation operates a Burroughs B1955 and two UNISYS 5000/80 main-

frames. Application software is slowly being migrated from the Burroughs to the UNISYS system and should be completed by late 1992. Major changes include the installation of a Defense Data Network and an electronic mail capability, which would enable worldwide communication and data transfer.

# Resource Management Division

Federal funds allotted to the Hawaii National Guard from Congressional appropriations are managed by this division. Separate offices administer funds assigned to Army and Air operations.

The Army Guard office, located in the Diamond Head Crater, is composed of the Budget, Staff Accountant, Fiscal Accounting, and Pay and Examination Branches.

An Assistant United States Property and Fiscal Officer for Air (Fiscal) controls funds allocated for support of the Hawaii Air National Guard. This office is located at Hickam Air Force Base.

# Analysis and Internal Review Division

Internal reviews are conducted by this division to ensure Federal resources are properly managed and utilized. Emphasis is placed on evaluating the effectiveness of internal controls and determining whether the Hawaii National Guard is operating efficiently and economically.

# Purchasing and Contracting Division

Purchasing and contracting services are provided by this office to all activities of the Hawaii National Guard by sealed bids, competitive proposals, and small purchase procedures in accordance with Federal Acquisition Regulation. Purchases are made from commercial vendors located throughout the State of Hawaii and continental United States.

#### **Logistics Division**

This division, organized into Stock Control, Supply and Traffic Branches, provides logistical support and guidance to the Hawaii Army National Guard.

An Assistant United States Property and Fiscal Officer for Air (Property) provides logistical support and guidance to the Hawaii Air National Guard. This office is located at Hickam Air Force Base.

A full-time Scheduled Airlines Traffic Office (SATO), established within the Traffic Branch, provides the entire array of transportation services: making plane and hotel reservations, writing airline tickets, handling air freight and other travel requirements.

#### Highlights and Significant Events

Federal funds used by the Army National Guard during the Federal fiscal year totaled \$40,454,390.

Federal funds used by the Air National Guard amounted to \$42,434,708.

Table 4 of the Appendix reflects Federal dollars used between Oct. 1, 1989, and Sept. 30, 1990.

Military payrolls for the Army and Air Guard totaled \$32,048,622 this Federal fiscal year.

During Federal FY 1990, local purchases and contracting support of Hawaii National Guard units and activities totaled \$3,018,635. Of this total, \$817,918 represented architectural-engineering services and construction contracts.

A total of \$4,597,198 was spent to procure supplies and equipment for the Hawaii Army National Guard. The Logistics Division maintained an inventory of \$4,532,180, including wartime contingency stocks valued at \$3,393,242.


The Air National Guard received \$3,553,478 for supplies. The base supply operation processed 456,458 transactions in Federal FY 1990, averaging 38,038 transactions per month. The in-house inventory value was \$57,709,980 at the beginning of the Federal fiscal year, and

the stockage effectiveness rate was 86.19 percent. At year's end, the inventory value was \$71,227,600, with stockage effectiveness rate at 83.80 percent.

The Traffic Branch arranged transportation for 6,517 individuals, 1,383 military interisland airlifts, 1,346 commercial trips to the continental U.S., and 3,788 commercial interisland trips. A total of 3,493 tons of cargo was shipped: 1,762 tons for annual training, 128 tons to mainland destinations, and 1,603 tons to interisland destinations. The total spent to transport personnel and equipment is shown in Table 4 (Appendix). The use of SATO provided an estimated savings of \$983,084 for Federal FY 1990.

Two UNISYS 5000/80 computer systems have been installed in the Data Processing Installation. The UNISYS brings new technology and challenges to the staff and to future users of the system. The UNISYS will completely replace the Burroughs within two to three years.

A total of six reviews and three follow-up reviews were completed by the Analysis and Internal Review Division during Federal FY 1990.

# **Support Personnal Management Office**

#### Mission

The Support Personnel Management Office is a consolidated office through which the adjutant general fulfills his responsibilities for administration of the Hawaii Army and Air National Guard full-time support personnel programs. The office is centrally located; all records and authorized staff are co-located to provide a single point of contact for personnel. A Federal technician provides limited services to the Hawaii Air National Guard full-time personnel employed at Hickam Air Force Base.

#### **Personnel**

The Support Personnel Management Office is authorized a staff of 15 Federal technicians and three Active Guard/Reserve (AGR) soldiers.

#### Organization

A standard National Guard structure prescribes that the personnel office be organized with the following operating sections: Personnel Management, Employee Services, Military Duty Management, Military Duty Services, Equal Employment Opportunity, and Labor Relations.

#### Personnel Management Section

The Personnel Management Section staff develops policy recommendations, procedures, and plans in compliance with U.S. Office of Personnel Management and National Guard Bureau directives. The section is responsible for major program areas such as position management and classification, manning control, staffing, training, em-

ployee relations, performance management and recognition, incentive awards, disciplinary and adverse actions, grievances and appeals, and personnel management evaluation. It furnishes technical advice and assistance to management officials, individuals, and staff personnel.

# **Employee Services Section**

This section provides a wide range of services for technicians throughout their employment life cycle. Beginning with employment processing and new technician orientations, this section's staff furnishes information on employee benefits, processes personnel actions, maintains individual technician personnel records, ensures proper pay administration, administers the Federal Workers' Compensation Program, and processes retirements. It is also responsible for maintaining the State's technician information management system on the National Guard's master database in Maryland.

#### Military Duty Management Section

Army AGR enlisted personnel career management and tour retention processes, recruitment, and advisory services take up much of this section's time. Unlike their staff counterparts who administer the Army and Air National Guard technician programs in compliance with common directives, the AGR management staff administers the military programs based on policies and procedures established by the Army, Air Force, and the separate National Guard directorates.

#### Military Duty Services Section

This section is the point of contact for commanders, supervisors, and individuals for AGR administrative services and assistance pertinent to pay, benefits, and entitlements. The addition of a medical administrative specialist has vastly improved coordination with military and civilian medical care providers for AGR personnel and their dependents on Oahu and the neighbor islands.

# **Equal Employment Opportunity Section**

The equal employment manager plans, develops and administers programs for all employees (to include State employees) relative to equal employment. Significant time and effort were devoted to presenting prevention of sexual harassment training to all employees. Other programs are affirmative employment, equal opportunity complaints processing, and discrimination investigations.

#### Labor Relations Section

This section provides Federal labor relations services within the department. Two locals of national labor organizations are exclusive representatives of non-supervisory technicians in three bargaining units. Typical tasks are: contract administration, advisory services to management officials, point of contact for union representatives and other Federal agencies' labor relations representatives, labor-management relations training, and management's representative in dispute resolution and contract negotiations.

#### Highlights and Significant Events

Federal technician and AGR personnel assigned strengths for the Army and Air National Guard at the beginning and end of the State's fiscal year were:



Federal full-time support personnel authorizations, based on unit priorities, are excellent. Assigned strengths are slightly lower because of funding constraints. Federal fiscal austerity promises only limited, if any, manpower resource growth in the foreseeable future.

Four Army National Guard and 15 Air National Guard technicians received merit pay increases under the Performance Management and Recognition System. Wage grade increases were effected for 138 Army and 310 Air National Guard technicians in November 1989; 148 Army and 250 Air National Guard general schedule technicians received salary increases in January 1990.

Sixty-six Army National Guard fulltime personnel attended training at the National Guard Professional Education Center in Little Rock, Ark. The center provides a curriculum to meet training needs on a centrallyfunded basis, cost-free to the State.

# **Engineering**

#### **Mission**

The Engineering Office provides the entire spectrum of professional engineering services to the Army National Guard, Air National Guard, Civil Defense and Office of Veterans Services divisions as well as departmental staff sections to enable them to carry out their statewide programs.

The major responsibilities are to plan for, administer, and supervise the following:

- Capital improvement projects;
- Major and minor construction projects;
- Consultant contract services;
- Maintenance and repair projects;
- Janitorial/custodial and ground maintenance;
- Real property management;
- Environmental and energy conservation programs.

#### Personnel

The Engineering Office is authorized 48 State, seven Federal and two Active Guard and Reserve (AGR) positions.

#### Organization

The Engineering Office consists of seven major staff responsibilities: Office Services, Contracting and Engineering Services, Maintenance Services, Air National Guard Engineering Services, Army National Guard Engineering Services, State Civil Defense Engineering Services and Office of Veterans Services.

# Repair and Maintenance Projects Awarded

Recurring minor maintenance, repair and modification of facilities are accomplished by in-house maintenance personnel on a time-and-materials basis or by formal and informal construction contracts. This program is supported by Federal, State or joint Federal/State matching funds through separate Army and Air Service Contracts or Army National Guard Training Site Contracts. # Minor Construction Projects

Minor construction projects include all projects for minor construction or major repair, maintenance or modification of facilities. This program is supported by Federal funds, State funds or joint Federal/State matching funds. Ongoing minor construction projects during this fiscal year amounted to \$775,000 for HIARNG (backlog maintenance, environmental engineering training, and various minor construction projects). Recurring Preventive Maintenance projects (HIANG) amounted to \$180,000.

# **Staff Judge Advocate Office**

#### **Mission**

The Staff Judge Advocate (SJA) provides legal support to the adjutant general, staff elements, subordinate units of the Hawaii National Guard, and the United States Property and Fiscal Office. In performing its mission, the SJA provides the following services:

- Prepares legal opinions on issues of Federal law.
- Serves as Federal litigation point of contact.

- Represents the adjutant general in Federal labor-management proceedings.
- Reviews Federal contracts relating to procurement and acquisitions and serves as the Federal Claims Officer for the Hawaii National Guard.
- Participates as legal advisor or counsel in administrative board proceedings.
- Acts on behalf of the convening authority in National Guard courts-martial.

#### Personnel

The Staff Judge Advocate Office consists of a judge advocate supported by a shared clerk-typist for the Special Staff.

#### Organization

The SJA reports directly to the adjutant general and works closely with Guard members on legal issues relating to the mission of the National Guard.

## **Public Affairs Office**

#### Mission

The Public Affairs Office plans, develops, directs and administers the department's community relations, public and internal information programs. In accomplishing its mission, the office performs the following:

- Preparing and distributing news releases, photographs and videotapes on departmental activities to civilian and military news media locally and on the mainland.
- Responding to queries from the news media, public, and other State and Federal agencies.

- Providing briefings for civilian and military officials, community groups and new departmental employees to inform them of the diverse missions of the department and the economic and educational contributions it makes to the State.
- Publishing a quarterly newspaper, Pupukahi, for distribution to present and retired Hawaii National Guard members, numerous State and Federal agencies, and other individuals interested in the department's activities.
- Consolidating, editing and publishing the department's annual report.

 Preparing speeches and reports for the adjutant general.

#### Personnel

The office consists of a public affairs officer, an information specialist, and a clerk-typist. All personnel are full-time State employees.

#### Organization

The public affairs officer advises the adjutant general and staff members on public affairs matters relating to the department. The office also works closely and coordinates its activities with public affairs officers from the department's major units/ divisions and active military services to carry out its programs.

# **Senior Army Advisor**

#### Mission

The Senior Army Advisor is responsible for providing advice, counsel, and assistance to the adjutant general and his staff in order to strengthen the Hawaii Army National Guard's (HIARNG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities include:

- Serving as military advisor to the adjutant general.
- Representing and acting as a spokesperson for the active Army in all HIARNG matters under the purview of U.S. Army Western Command (WESTCOM).
- Rendering professional military advice to HIARNG commanders in military matters concerning the

- organization, operation, training and readiness of units.
- Monitoring the use and assisting in the management of Federal resources in support of the HIARNG.
- Directing, assisting, or providing guidance to other advisors of administrative personnel when so designated by WESTCOM.

## **Senior Enlisted Advisor**

#### Mission

The State Command Sergeant Major serves as the senior enlisted advisor for the Hawaii Army National Guard and is responsible to the adjutant general for a variety of matters pertaining to policies and actions relative to enlisted Hawaii Army National Guard soldiers.

The State Command Sergeant Major also accomplishes the following:

- Advises the adjutant general on all enlisted matters.
- Assists the inspector general in servicing enlisted problems.
- Works with the recruiting and retention office.

 Participates on boards related to enlisted soldiers to include: promotion, Active Guard and Reserve (AGR) continuation, selective retention and the U.S. Army Pacific Non-Commissioned Officer and Soldier of the Year.  Attends various conferences both locally and on the mainland.

#### Personnel

The CSM's Office consists of a command sergeant major supported

by a shared clerk-typist for the Special Staff.

#### Organization

The CSM reports directly to the adjutant general and works closely with Guard members.

## **Inspector General**

#### Mission

The Inspector General (IG) is assigned to assist the adjutant general in assessing and reporting, in an unbiased, objective manner, on matters affecting mission performance, the state of efficiency, economy, discipline, morale, esprit de corps, and readiness throughout the Hawaii Army National Guard. The IG also performs such other duties as required by law and regulations, or as directed by the adjutant general. This mission is accomplished using the concept of a full service IG, which includes the following functions:

- Providing assistance to organization members, their dependents, and the public in responding to real or perceived problems involving the Hawaii Army National Guard.
- Acting on TAG directives, conducting inquiries and investigations.
- Managing staff/special inspection program throughout all subordinate elements of command.
- Acting in a teaching and training mode wherever and whenever appropriate while performing other funcitons.

#### Personnel

The IG's Office is staffed by an active Army lieutenant colonel and is supported by a shared clerk-typist for the Special Staff.

#### **Organization**

The IG reports directly to TAG and is a member of his staff. This relationship between an IG and his commander has been referred to as one in which the commander places "extraordinary trust and confidence" in the IG to be the eyes, ears, and conscience of the commander.

# **Director of Information Management**

#### Mission

The Information Management Office plans, programs, and manages Army National Guard automation (less the Data Processing Installation, United States Property and Fiscal Office for Hawaii) and telecommunications resources. In accomplishing its mission, the office performs the following:

- Provides technical advice to the adjutant general, staff elements, United States Property and Fiscal Office, and units of the Hawaii Army National Guard.
- Develops and administers state information systems objectives,

policies, plans and projects for supported organizations.

- Develops and administers an automation security policy.
- Assists users in obtaining and using automation and telecommunications resources.
- Determines automation training needs and coordinates appropriate user training with various training sources.

#### **Personnel**

The Information Management Office consists of a director of information management, a computer systems programmer, a communications management specialist, and a computer assistant. All personnel are full-time Federal technicians.

#### Organization

The Director of Information Management (DOIM) serves as the principal information management advisor on present and future requirements for automation and communications to the adjutant general and Hawaii Army National Guard officials. The office works with the National Guard Bureau's Information Management Agency as well as with the other 53 Information Management Offices nationwide to perform its mission.

## State Family Action Office, Hawaii National Guard

#### **Mission**

The State Family Action Office manages programs designed to increase the overall preparedness of Hawaii National Guard families to cope with the unique realities of Guard service.

#### **Personnel**

This office consists of a coordinator, which is the only paid staff position. The coordinator is provided clerical support by the shared clerktypist for the Special Staff. The coordinator is assisted by a State Volunteer Representative in managing the activities of volunteer participants in the program throughout the State.

# Highlights and Significant Events

The program seeks to take direct steps to prepare the Guard family for the likelihood of Federal (or State) mobilization for service in which a forced family separation would become a necessity. All actions that can be taken by the Guard member and his or her family before mobilization such as the preparation of wills, powers of attorney, arrangements for child care, etc., are emphasized in the program, so as to make the family's transition to a forced separation from the Guard member as smooth as possible.

The Family Program undertakes to sponsor programs and activities to increase and enhance the day-to-day wellness of the Guard family. It also informs family members directly on the obligations, benefits, and privileges of Guard service so that apprehensions may be reduced and misunderstandings cleared up, thereby assisting to retain trained, skilled members in the National Guard. The program also attempts to involve the family in Guard activities and ensure the legal and efficient utilization of Federal funds.

Family Support Groups, organized by volunteer family members, form the core of the involvement objective. Currently, 37 such groups exist throughout the State, on every island where the Guard has members. The potential exists for 40 such groups. The groups range in size from 15 to 50 active members. Membership is rapidly increasing as the program continues its positive momentum. These groups organize and sponsor programs of an informational and social nature which seek to enhance and increase the wellness and preparedness of their members and to entice others to volunteer and become involved.

During 1990, a State-level action and advisory council, called the STATE TEAM, was organized to increase family member involvement in the upper levels of program management. The STATE TEAM is made up of nine volunteer family members representing Army and Air Guard families from throughout the State.

The Hawaii National Guard Family Action Program is a Federally funded activity. During 1990, more than \$50,000 in Federal monies were spent in direct support of Guard families in the State.
