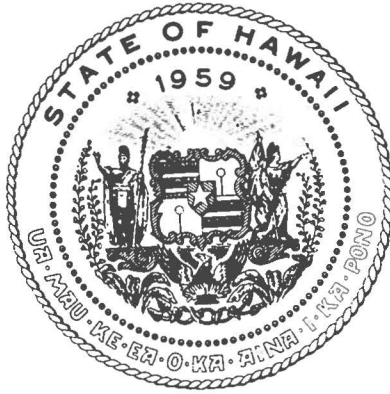
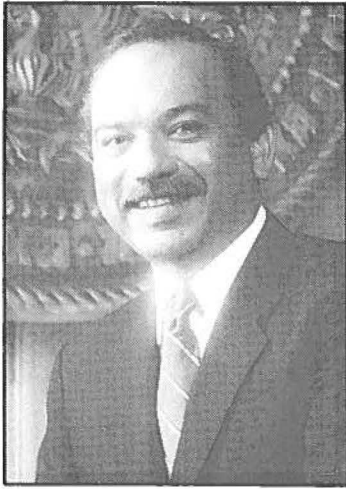

ANNUAL REPORT Fiscal Year 1991



Dear Governor Waihee:

This past year has been a dynamic and increasingly challenging period for the State Department of Defense. The department's timely response to events of international, national and local significance demonstrate our capabilities to carry out our state and federal missions.

The Hawaii National Guard (HING), like many other U.S. military organizations, did not directly participate in Operations Desert Shield and Desert Storm. However, the HING supported the effort by providing C-130 air transportation for the "Coral Run" to Johnston and Midway Islands. Following the February 27 ceasefire, the department led a statewide effort to personally greet 8,500 service members returning from the Persian Gulf. HING units also participated in numerous welcome home parades and celebrations throughout the state. In August, four Army medical specialists were sent to Saudi Arabia to treat American and allied military personnel.

In September, the Hawaii National Guard Association (HNGA) hosted the 113th National Guard Association of the United States annual conference. More than 3,000 persons attended the three-day event that culminated five years of planning, coordination and hard work by HNGA officers, staff, spouses and friends.

State Civil Defense continued to monitor the eight-year eruption of Kilauea Volcano which destroyed homes and covered Kaimu Bay and Kalapana Black Sand Beach in the Puna district on the Big Island. More than \$2.6 million has been approved for public assistance projects in the district. Heavy rains flooded the north windward shores and south central portions of Oahu in March, forcing the opening of evacuation shelters and disaster application centers. In June, the Guard and State Civil Defense assisted Maui county officials in extinguishing a fire which destroyed 12,500 acres on Molokai.

The Office of Veterans Services expanded its outreach services, increasing the number of veterans and dependents served by 11 percent. The long-awaited Hawaii State Veterans Cemetery was officially opened on July 31 in Kaneohe. The cemetery will provide a final resting place for more than 80,000 Hawaii veterans upon its completion in 1993.

As always, we look forward to meeting the challenges ahead, confident that our proven abilities, professionalism and performance will serve us well as we move through the last decade of the century. We remain ever ready and vigilant to defend and serve our great state, the people of Hawaii and our nation.

Department of Defense

Mission

The mission of the State of Hawaii Department of Defense is to assist authorities in providing for the safety, welfare and defense of the people of Hawaii. The department continuously strives to maintain its readiness to respond to the needs of people in the event of war or disasters, whether natural or human-caused. Upon activation by the Governor of the State of Hawaii, the department is prepared to provide professional personnel, quality services and well-maintained equipment to assist during emergencies.

The Hawaii Army and Air National Guard also trains to prepare to meet their federal missions should they receive a Presidential call to duty in times of national emergency.

The Office of Veterans Services (OVS) serves as the single point of contact in state government for veterans' services, policies and programs. The OVS also oversees the construction and administration of the Hawaii State Veterans Cemetery.

Personnel

Compared to other state departments,

the full-time force of the Department of Defense represents a varied mixture of federal, state, active duty and drill-status National Guard members. This force includes 1,194 full-time federal employees, 134 state employees, and more than 5,534 drill-status Army and Air National Guard members.

Organization

The State Department of Defense is made up of three major divisions, one inactive division, six key staff offices and the Office of Veterans Services.

The three major divisions are the

Hawaii Army National Guard, Hawaii Air National Guard and State Civil Defense.

A fourth division, which is currently inactive, is the Hawaii State Defense Force. Under current state laws, the Hawaii State Defense Force may be activated should the need arise.

The six key staff offices provide support services to the three active divisions and other activity centers within the department. The key staff offices include the Administrative Services Office, U.S. Property and Fiscal Office, Support Personnel Management Office, Engineering Office, Staff Judge Advocate Office and Public Affairs Office.

The special staff includes the Senior Army Advisor, Senior Enlisted Advisor, Inspector General, Director of Information Management and Family Action Program Coordinator.

The adjutant general is the executive head of the department. In addition to being a member of the governor's cabinet, the adjutant general is the commander of both military divisions and the director of State Civil Defense.

Hawaii National Guard

The Hawaii Army National Guard and Hawaii Air National Guard collectively form the Hawaii National Guard. Under the banner of the Hawaii National Guard, the Army and Air National Guard divisions maintain, in a style unique to their military institutions, a history rich in traditions, contributions, sacrifices and high marks of excellence.

State Civil Defense

State Civil Defense has two important missions. The first is to minimize loss of life, reduce property damage and restore essential public services and facilities devastated by natural or human-caused disasters. The second mission is to provide for the welfare and safety of citizens, ensure the continuance and/or reconstitution of state government and mobilize and manage state resources in the event of war.

Office of Veterans Services

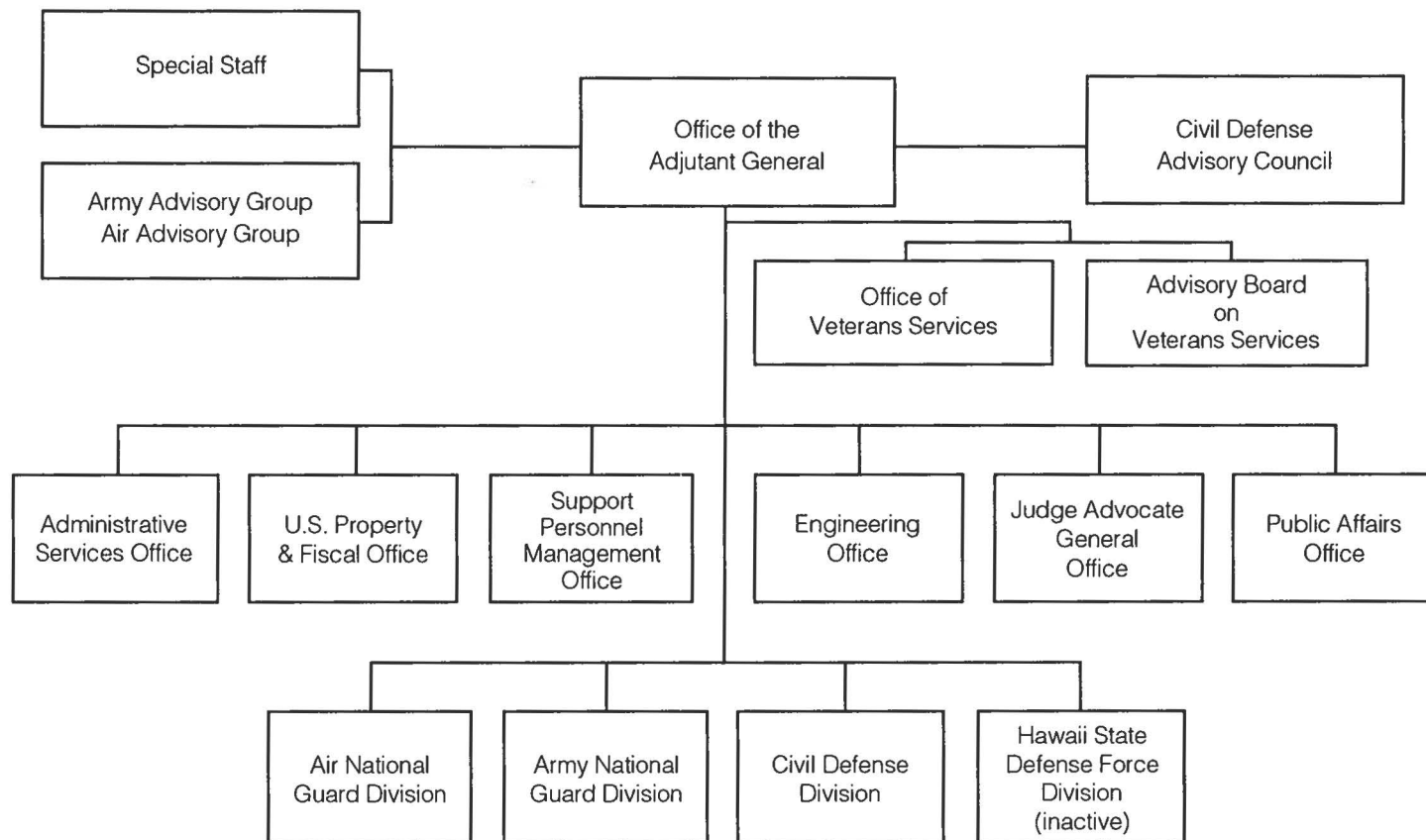
The Office of Veterans Services (OVS), which was administratively attached to the Department of Defense in July 1988, serves as the primary state agency responsible for developing and

managing veterans' programs, policies and activities. The OVS is also charged with planning, establishing and operating the Hawaii State Veterans Cemetery on Oahu, which opened Aug. 1 and is scheduled for full completion in 1993.



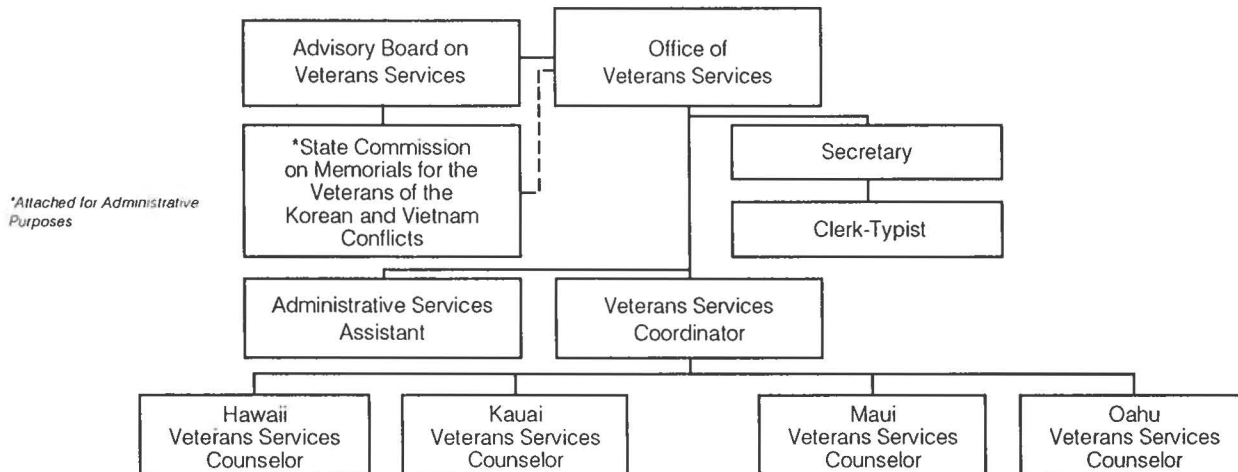
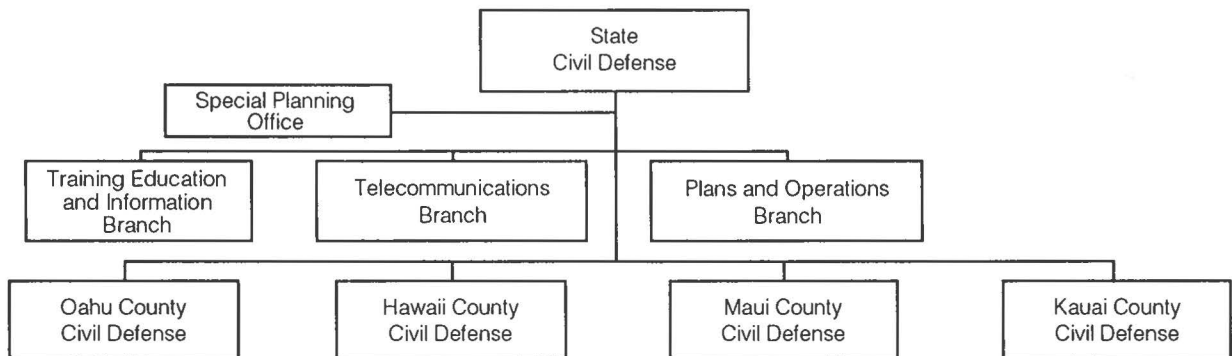
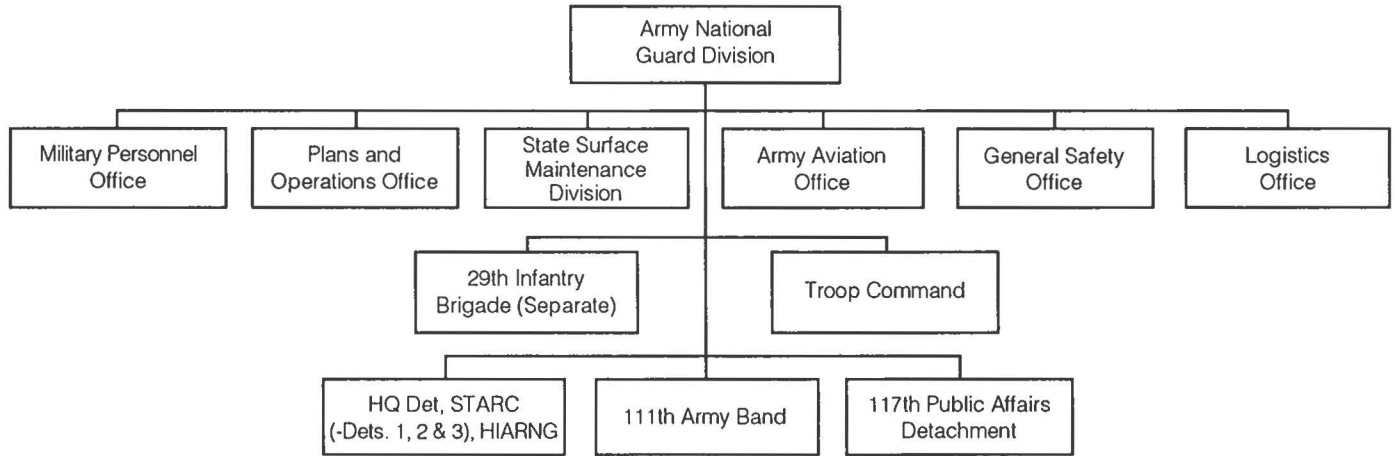
State Department of Defense volunteers welcome Kaneohe-based Marines returning from the Persian Gulf War.

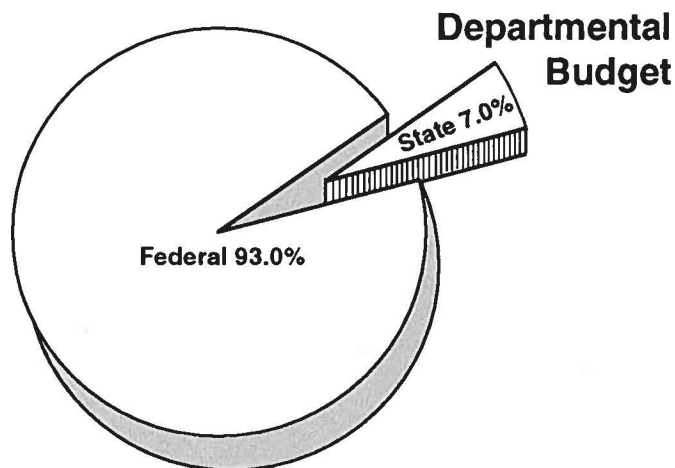

Hawaii Army National Guard

Mission

The Hawaii Army National Guard (HIARNG) continually trains to maintain its readiness for state or federal active duty. It is prepared for local or global assignments should the Governor or President order it to active duty.

Personnel

The Hawaii Army National Guard's authorized personnel strength increased from 4,237 to 4,252 in fiscal year 1991. As of Sept. 30, 1991, the assigned personnel strength of the Hawaii Army National Guard was at 3,547 or 83.42 percent fill of authorized positions.

Organization

The Hawaii Army National Guard consists of the Headquarters, State Area Command; 29th Infantry Brigade (Separate); Troop Command; 111th Army Band and 117th Public Affairs Detachment.

29th Infantry Brigade (Separate)

The mission of the brigade is the destruction of enemy forces and the control of land areas, population and resources. The brigades assigned strength as of Sept. 30, 1991, was 2,450.

This included 190 officers, 15 warrant officers and 2,245 enlisted members.

The brigade is organized with a headquarters company, two infantry battalions, a field artillery battalion and a support battalion. Separate units include a combat engineer company, cavalry troop, and signal detachment.

Units are located throughout the state, with elements of the two infantry battalions on the islands of Hawaii, Maui, Kauai, Oahu and Molokai. Other units are located on Oahu at Fort Ruger, Wahiawa, Pearl City and Kaneohe.

Troop Command

The Troop Command is headquartered at Waiawa Armory in Pearl City on Oahu. It is the other major command within the Hawaii Army National Guard. The Troop Command includes a combat aviation battalion at Wheeler Air Force Base, a combat service support battalion headquartered at the Waiawa Armory, two aviation detachments based at Hilo's aviation support facility, and an engineer detachment at Fort Ruger.

The units within the Troop Command provide a broad spectrum of combat support and combat service support. The aviation battalion provides aerial reconnaissance and aerial fire support. The aviation detachment provides a trained pool of qualified replacement aviators. The supply and service battalion stores and issues supplies, repairs and rebuilds military equipment and maintains vehicles, weapons, helicopters and sophisticated electronic equipment. The organization also provides field services, including laundry and bath, graves registration, baking and renovation of light textiles. The engineer detachment provides utilities repair and maintenance.

Divisions/Sections Staff

The mission of the maintenance division of the HIARNG is to provide services and repair support for all types of ground surface equipment issued to HIARNG.

The maintenance division has 85 full-time federal technicians housed at eight support facilities located on five islands. An additional seven soldiers in Active Guard Reserve (AGR) status provide supply support for maintenance programs throughout the Guard. These soldiers support 47 different units and 21 activities.

Employees of this division have worked over 200,000 hours and installed more than a million dollars of repair parts in providing repairs and services to maintain the equipment of HIARNG.

The effectiveness of the maintenance program has allowed the HIARNG to exceed the Department of the Army maintenance readiness standard of 90 percent.

With the receipt of new equipment during the year, the maintenance program was able to keep abreast of the force modernization program. An aggressive education program and the implementation of a computer-assisted program in fiscal year 1992 will continue to move the full-time maintenance program forward.

The aviation division is comprised of the Headquarters State Area Command aviation section, 193rd Aviation Battalion (Attack), and 451st Aviation Detachment, Combat Enhancing Capability Aviation Team (CECAT). Another CECAT, the 452nd, was activated on Oct. 1, 1991. HIARNG's current aircraft inventory includes 15 AH-1S Cobra attack helicopters, six UH-1H Huey utility helicopters, 13 OH-58A Kiowa Scout helicopters and a U-21D Ute fixed-wing aircraft. HIARNG aviation units flew a total of 4,358 flight hours representing

100% of the annual flying hour program. These flight hours were used to accomplish mission support, proficiency training, individual aircraft qualification, unit training, and support to civil authorities.

There are two Army Aviation Support Facilities (AASF) assigned to the HIARNG. One is located at Wheeler Air Force Base, Oahu, and the other at General Lyman Field, Hawaii. These AASFs serve as a fixed training base for HIARNG's training programs. These programs include nap of the earth qualification, aerial gunnery training, unaided night qualification, and unaided night vision goggle qualification.

Highlights and Significant Events

The HIARNG continues to support civil authorities for law enforcement purposes. Again in fiscal year 1991, federal funds were provided to the National Guard for its enhanced role in drug interdiction support. To support law enforcement agencies, National

Guard personnel are placed on Active Duty Special Work, Title 32, United States Code status, which must be performed over and above normal training.

Since the receipt of federal resources to support drug enforcement operations in 1989, the HIARNG has provided helicopter and refueling support to the State Department of Land and Natural Resources and county police departments for the U.S. Drug Enforcement Agency's marijuana eradication program, Operation Wipeout. In Fiscal Year 1991, as many as 20 Army Guard and five Air Guard personnel were placed on active duty to assist the U.S. Customs Service. Working with customs inspectors, the soldiers and airmen searched foreign arrival cargo containers, aircraft, packages and mail for illegal drugs and contraband.

The Hawaii Air National Guard continues to provide C-130 support to law enforcement agencies by transporting personnel and equipment.

In fiscal year 1991, the 29th Brigade continued to provide support to communities throughout the state. Brigade units assisted with the American Lung Association's Superkids competition on Hawaii, Kauai and Maui. Units on all islands were actively involved in Desert Storm welcome home parades and ceremonies. Brigade soldiers were activated in July to assist the Hawaii and Maui county governments during the solar eclipse and in August to help fight the Molokai fire.

Training

The majority of Hawaii Army National Guard units conducted their annual training at various locations in Hawaii, July-August. Brigade units also trained in Australia and Fort Lewis, Wash.

In March, 55 soldiers from Company A, 1st Battalion, 299th Infantry, deployed overseas to Adelaide, South Australia, for Exercise Pacific Reserve. They trained for two weeks at the Australian jungle warfare school with reserve soldiers from the Australian Army. The Big

Island's 2nd Battalion hosted a reciprocal visit by the Australians in July.

Most of the brigade conducted annual training at Pohakuloa Training Area in July with emphasis on live fire and battalion and brigade level training.

The 1st Battalion, 299th Infantry, traveled to the Pacific Northwest in August and trained at Fort Lewis and Yakima Training Area. Training included river crossing operations Military Operations on Urban Terrain (MOUT) and live fire exercises.

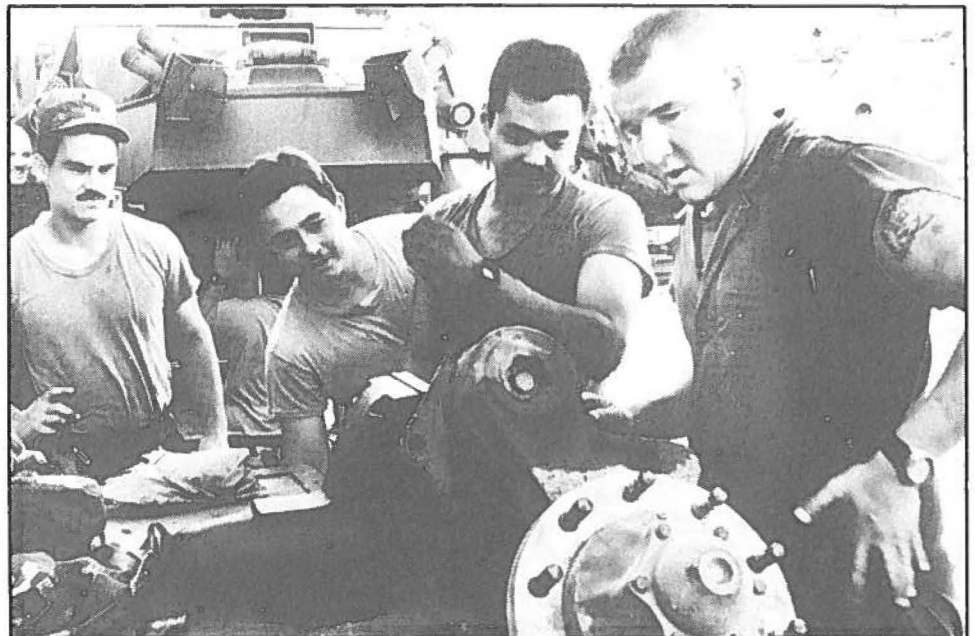
The units of the Troop Command completed annual training at three locations in the state during training year 1991.

The Headquarters and Headquarters Detachment, 297th Supply and Service Battalion, and 292nd Supply and Service Company trained at Pohakuloa Training Area, July 20-Aug. 3.

The 291st Maintenance Company (General Support) and 12th Personnel Company performed annual training at their home stations on Oahu, Aug. 10-24. The 291st provided a variety of maintenance support to HIARNG units and the 1st Marine Expeditionary Force, including tank turret and track repair for

equipment returning from Operation Desert Storm. The 12th Personnel Service Company provided personnel and administrative support to HIARNG units.

The 1st Battalion, 193rd Aviation, conducted its annual training at Wheeler Air Force Base and Pohakuloa Training Area, July 20-Aug. 3. The unit conducted aerial gunnery training, combat support operations and aviator and aircrew training.

The 298th Engineer Detachment performed its annual training at Fort Ruger, Oahu, July 20-Aug. 3. The unit performed facilities maintenance and installed playground equipment at the Honolulu Stadium Park.

The 451st Aviation Detachment (CECAT) performed its annual training at its home station in Hilo, July 20-Aug. 3. The unit provided general aviation support to HIARNG units training on the island.

The 117th Public Affairs Detachment

deployed seven soldiers overseas to participate in Exercise Cobra Gold in Thailand during the period May 6 through 28. The unit performed public affairs duties in support of the U.S. Army Pacific Command, Public Affairs Office.

The Hawaii Military Academy (HMA) provided training for the Hawaii Army National Guard as well as U.S. Army Reserve soldiers in the Pacific area. The academy conducts training in four major areas: Officer Candidate School (OCS), Noncommissioned Officer Education System (NCOES), Non-prior Service Personnel Training Program (NSP-TP) and Military Occupational Specialty Qualification (MOSQ) courses.

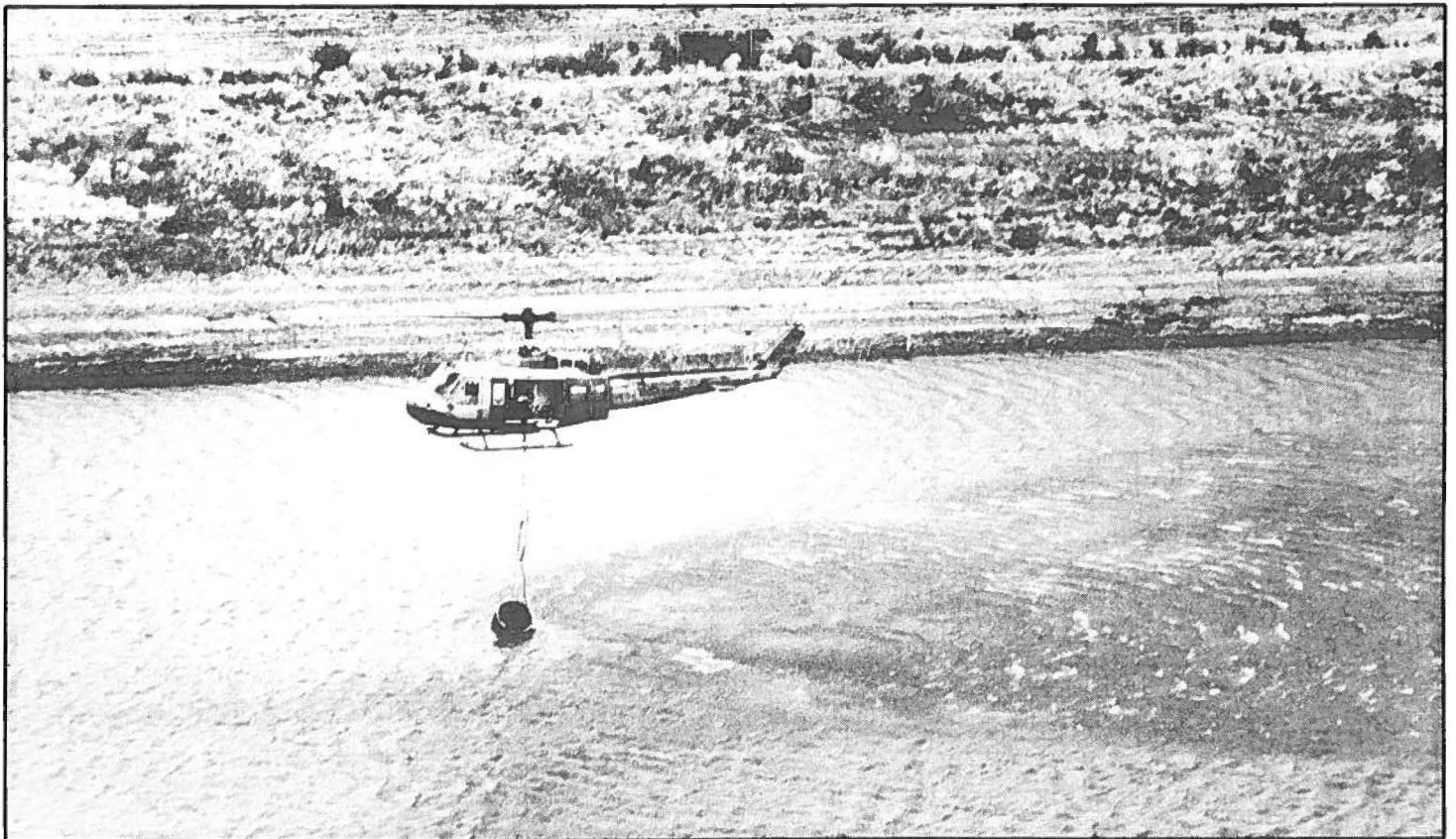
In 1991, the academy graduated 11 officer candidates. The candidates completed their final two weeks of intensive training at Fort Huachuca, Ariz., in conjunction with the state military academies of Arizona and Utah.

HMA conducted four Basic NCO courses and one Advanced NCO course during the year, graduating more than 75 NCOs. A First Sergeant Course trained 17 senior NCOs from Hawaii and Guam.

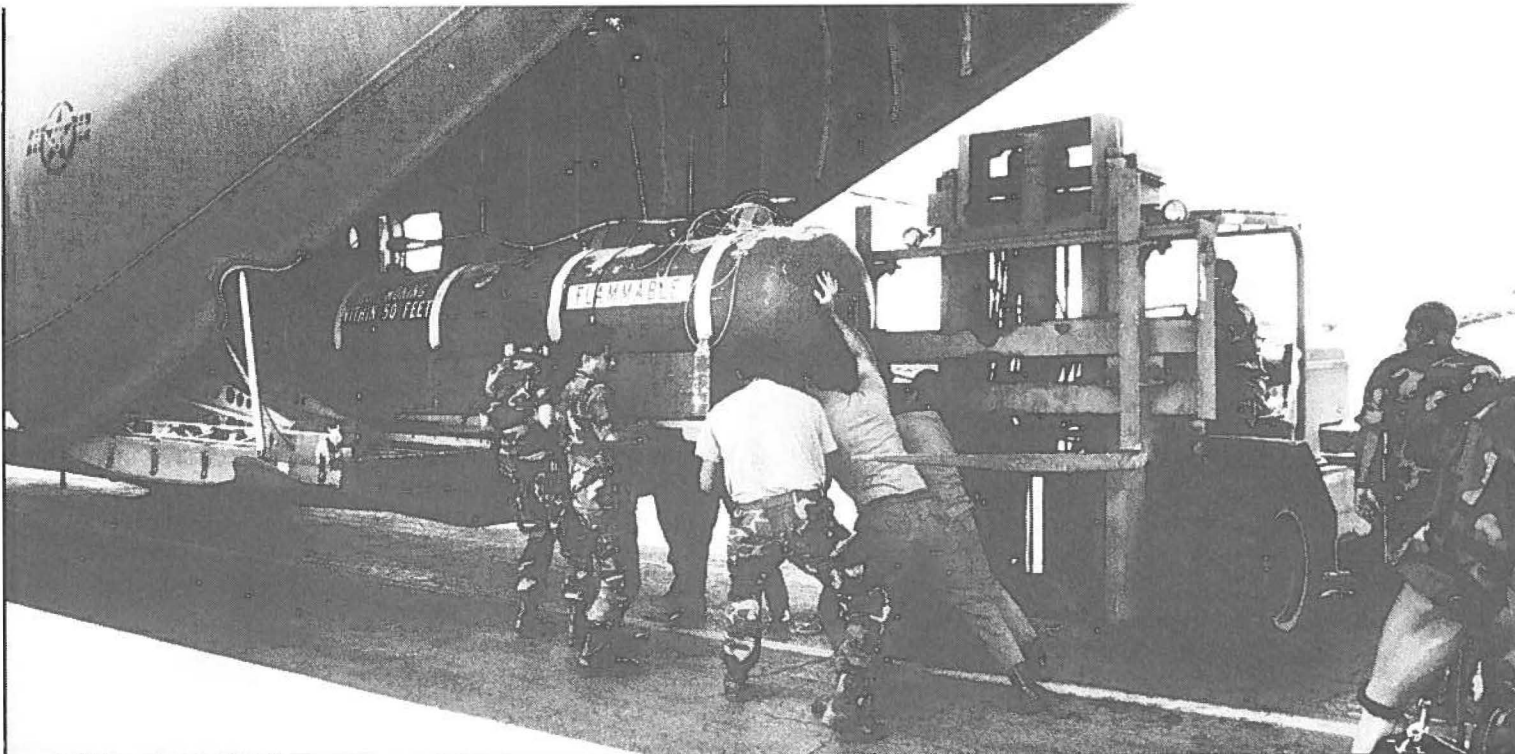
The academy also provided training for 45 enlistees without prior military service, preparing them for the rigors of basic training at mainland training centers.

HMA conducted four MOSQ courses. In June 1991, twenty-seven soldiers graduated in the military police course and 17 soldiers in the chemical operations specialist course. One month later, three soldiers completed the fire support specialist course. In September, HMA trained 65 soldiers from Hawaii, Alaska, Guam and American Samoa in the infantryman course.

In addition to the four major programs, the academy held courses for lieutenants in physical security, supply/food service, training and personnel.

Hawaii Air National Guard

Mission

Like its continental counterparts, the Hawaii Air National Guard (HIANG) serves dual missions. Its state mission is to defend Hawaii and its residents from mass violence resulting from natural or human-caused disasters. As a federal organization, it is responsible for providing trained units and individuals for active duty in the U.S. Air Force in time of war, natural emergency or as required by national security.

Personnel

As of Sept. 30, 1991, the assigned strength of the HIANG was 205 officers and 1,883 enlisted personnel. The total of 2,088 members is 94.0 percent of the 2,221 positions authorized.

Organization

The HIANG is directed by the commander, Hawaii Air National Guard, and is comprised of the Hawaii Air National Guard Headquarters, 154th Composite Group, 201st Combat Communications Group and 199th Weather Flight.

154th Composite Group

The 154th Composite Group (154th COMPG) is the largest of the HIANG organizations. It includes a headquarters squadron, a tactical fighter squadron, a consolidated maintenance squadron, two aircraft control and warning squadrons, a tactical control squadron and seven additional support units.

Responsibility for the state's air defense belongs primarily to the 154th COMPG. Located at Hickam Air Force Base (AFB), its tactical fighter squadron is equipped with F-15A/B Eagles to provide fighter-interceptor capability for the air defense system.

The group's two aircraft control and warning squadrons operate radar sites at Kokee Air Force Station (AFS), Kauai, and Mt. Kaala, Oahu. The two radars are linked to the Hawaii Regional Operations Control Center at Wheeler AFB, Oahu, and provide 24-hour surveillance of the entire Hawaiian island chain.

201st Combat Communications Group

Located on the islands of Hawaii, Kauai, Maui and Oahu, the units of the 201st Combat Communications Group (201st CCGP) train to provide combat communications and air traffic control facilities and services to support tactical air force requirements. Its members are prepared to deploy anywhere in the world with their equipment.

199th Weather Flight

The 199th Weather Flight provides meteorological support primarily to the Hawaii Army National Guard's 29th Infantry Brigade (Separate) and secondarily to active and reserve components of the Army and Air Force. Located at Wheeler AFB, the unit provides weather information to the joint, worldwide meteorological network operated by the Air Force's Air Weather Service, National Weather Service and World Meteorological Organization.

Highlights and Significant Events

Change and challenge characterized this past fiscal year, largely due to unforeseen developments in local, national and international environments.

Change began at the top, with the February appointment of Brig. Gen. Edward V. Richardson, HIANG commander, as the state adjutant general. Brig. Gen. Kenji Sumida, HIANG chief of staff, assumed command of the HIANG.

Two aircraft changes were announced during the year. On April 15, the HIANG announced the planned activation of a KC-135R tanker organization, to be known as the 203rd Aerial Refueling Squadron (203rd AREFS). Scheduled for activation in 1993, the new unit will give fighter pilots the "legs" they need to quickly deploy to any combat theater in the world. Also, the HIANG's present F-15s will be exchanged for slightly newer models which were modified under the Air Force's multi-stage improvement program. The upgrade will enhance the fighters' avionics and weapons capabilities.

The Hawaii Air National Guard, like military organizations everywhere, felt the impact of the events which transpired in the Persian Gulf. While HIANG units were not activated for Operations Desert Shield or Desert Storm, some helped to fill the voids left by deployed forces.

In January, the 154th Composite Group took over aircraft runs to Johnston and Midway Islands for the Air Force's 834th Airlift Division. Dubbed "Coral Run," the mission provided channel airlift three times a week to the South Pacific islands. Between January and March, the C-130 aircrew logged more than 126 hours and transported 995 passengers and 485,096 pounds of cargo.

Security at American military bases around the world was stepped up during this period, and the 154th Security Police Flight was called on to secure

HIANG aircraft at Hickam AFB. Active-duty military police, who would have usually provided this support, had been deployed to the Middle East.

The formation of the 154th Tactical Control Squadron (154th TCS) is well underway with the transfer of three officers and 57 enlisted members from the 150th Aircraft Control and Warning Squadron. The 154th TCS is scheduled for initial operational capability in 1993.

The construction of a composite avionics/weapons release facility and munitions maintenance facility was completed and blessing ceremonies were conducted in August 1991.

During its annual training exercise, the 199th Weather Flight established interisland weather communication with its active counterpart for the first time using the Goldwing communication system.

The family support group (FSG) program gained momentum this year, its importance underscored by events in

the Middle East. Group education focused on helping families to prepare for members' possible activation, covering topics such as pre- and post-mobilization requirements and benefits.

More than 1,200 people visited the 154th Composite Group this year, ranging from senior military officials to elementary school students. Dignitaries included the chief of staff of the Indian Air Force and several general officers from Korea. In December, the 154th COMPG hosted a Christmas Party, complete with Santa Claus and gifts, for handicapped students from Lanakila School.

Always cognizant of its role as a community leader, the Hawaii Air National Guard annually supports numerous community and charity activities. These events include the Hawaii Special Olympics, Great Aloha Run, American Lung Association's Superkids Competition, and American Cancer Society's Kolekole Pass Half-Marathon. Mem-

bers also make private donations to the Combined Federal Campaign and Aloha United Way.

As an additional community service, the HIANG provides instructors and guest speakers to local high schools and the University of Hawaii.

Training

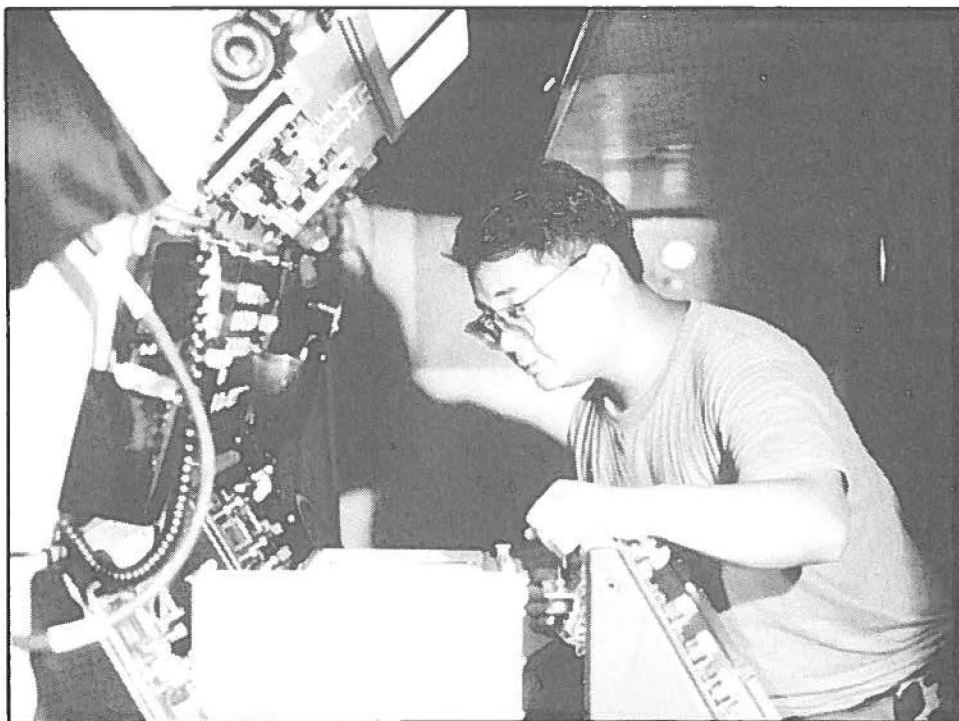
Training goals for the Hawaii Air National Guard are designed to ensure that units are able to perform their tasks as mandated in state and federal missions. To accomplish this, units train to retain the ability to survive and operate under wartime or general emergency situations. Training keys on elements such as shelter operations, mobility exercises, chemical defense training, combat aircraft turn-around, terrorist attacks, and power and communications outages.

The Hawaii Air National Guard, like U.S. military organizations everywhere, was required to cut back on training during Operations Desert Shield and Desert Storm.

For the 154th Composite Group, the Middle East build-up made it difficult to find air-refueling tankers to bring units to Hawaii for the dissimilar air combat training (DACT) necessary for maintaining peak qualification air-to-air refueling skills. Kaneohe Marine Corps Air Station fighters, favorite sparring partners of HIANG's 199th Tactical Fighter Squadron, left behind few training adversaries when the Marines were sent to the Gulf. Training resumed after the cease-fire, with returning Marine fighters eager to share lessons learned in the Gulf.

Renewed availability of tankers enabled 199th Tactical Fighter Squadron pilots to take part in Exercise Red Flag at Nellis AFB, Nev., in July, and several units were able to come to Hawaii for DACT. Six fighters and support units deployed to Pacific Missile Range Facility (PMRF) Barking Sands, Kauai, for mobility and dispersal training in August.

In May, airmen of the 154th Tactical

The 154th Civil Engineering Squadron (CES) and the Hickam-based 15th CES conducted joint training, July 13-14. The squadrons were supported by the 154th Service Flight which prepared hot meals using its new mobile kitchen trailer unit.

In January, the 154th Composite Group received a rating of excellent during a limited unit effectiveness inspection.

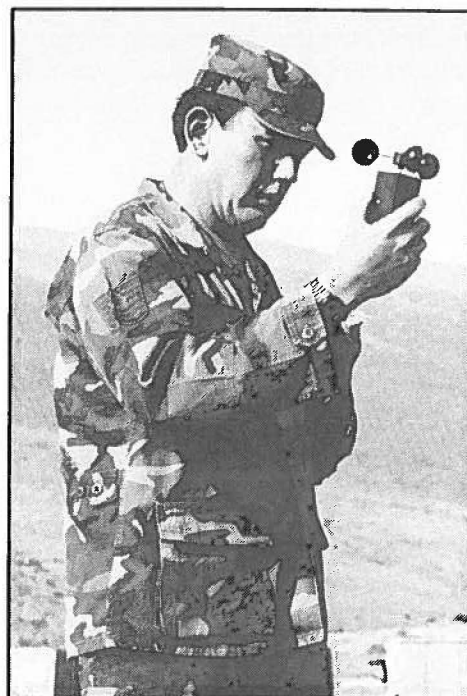
The 201st Combat Communications Group's participation in Exercise Team Spirit '91 was limited by the Persian Gulf conflict. Although the scope of the exercise was cut drastically, HIANG airmen who did deploy were once again recognized by their active counterparts for outstanding work.

The group's two combat communications squadrons conducted an operational readiness exercise in July. The first phase of training focused on initial response or how quickly the squadrons could be ready for war. The second, "in the field" phase required the

units to deploy and set up communications at Upolu Coast Guard Station, Hawaii, and Barbers Point Naval Air Station (NAS), Oahu. An interisland communications net and long-haul communication links to Stockton Defense Communications Station, Calif., and Yokosuka NAS, Japan, were added requirements.

To increase controller proficiency, the air traffic control flights of the 201st conducted an operational readiness exercise at the PMRF Barking Sands, Kauai.

Throughout the year, the 199th Weather Flight focused on improving the receipt and transmission of weather data via electronic equipment. The unit established interisland weather communication using the Goldwing system for the first time during annual training at Pohakuloa Training Area, Hawaii. It is also adjusting to the disestablishment of the 1st Weather Wing and its reassignment to the Pacific Air Forces upon mobilization.

State Civil Defense

Mission

The mission of State Civil Defense is to plan, prepare for, and respond to actual or impending disaster. These actions are applied to protect life and property, restore essential services, ensure continuity of government and coordinate resource management to speed recovery.

Available resources must combat a wide range of hazards stemming from natural and technological sources, as well as war-related hostilities. Hazard management is accomplished via four integrated phases:

Mitigation. Takes measures to re-

duce or eliminate the impact of emergencies or disasters.

Preparedness. Develops plans and procedures, trains and equips personnel and informs the public on hazard awareness and preparedness.

Response. Warns the community and reacts to the crisis with emergency services and volunteer agencies.

Recovery. Implements long- and short-term efforts for restoring the social and economic structure of a community following a disaster.

State Civil Defense also supports Federal Emergency Management Agency (FEMA) strategies, emphasizing the Integrated Emergency Management System.

The system identifies all hazards facing a community, analyzes capabilities to manage those hazards and develops programs to overcome shortfalls.

Personnel

State Civil Defense is authorized 30 full-time employees during non-crisis periods. During emergencies, staffing is increased by mobilizing other government agencies and volunteer organizations. The adjutant general serves as the director of civil defense while the vice director oversees system operations and provides staff supervision. When the director is out of state, the vice director assumes the responsibilities of the director.

Organization

The civil defense system is comprised of all private and public organizations charged with emergency responsibilities. All state departments and agencies have civil defense coordinators appointed for civil defense tasks. By law, each county is an element of the civil defense system. County mayors typically serve as deputy directors of civil defense for their respective counties, maintaining the county's civil defense infrastructure and operational capability.

State Civil Defense supports the statewide civil defense system by managing federal funds and disaster assistance programs. State Civil Defense also develops county plans and programs, provides technical assistance and conducts professional training and emergency exercises. If an emergency should deplete county resources, the county may seek assistance through State Civil Defense. If disaster impact escalates beyond state resource capabilities, the state requests federal assistance through the Federal Emergency Management Agency.

State Civil Defense Advisory Council. Made up of seven members appointed by the Governor, the council meets quarterly to discuss programs and projects conducted by State Civil Defense.

Hawaii State Earthquake Advisory Board. Formed in August 1990, the volunteer 13-member board meets quarterly to identify priorities for earthquake probabilities, hazard mitigation and preparedness. The board draws its expertise from the scientific, academic, engineering and emergency management communities.

Highlights and Significant Events

Kilauea eruption continues. Kilauea's Kupaianaha vent continued to erupt throughout the year with a

steady flow of approximately 650,000 cubic yards of lava per day. The lava moved into the Kaimu area, destroying homes, filling in Kaimu Bay and covering the famous Black Sand Beach. The lava flow later cooled and stopped its eastward advance, sparing remaining homes. Lava tubes in the Kalapana area continued to drain lava into the ocean.

The disaster incident period for the Puna District remained in effect throughout the fiscal year. The district had been declared a federal disaster on May 18, 1990. By the close of the year, 262 applicants had registered for disaster aid, with the Temporary Housing Program providing \$500,000 to 182 applicants and the Individual and Family Grant Program distributing over \$1 million to 119 applicants. The Small Business Administration approved 52 applications totaling nearly \$3,000,000 in low-interest federal loans. More than \$2.6 million was approved for public assistance projects and an additional \$5.3 million for future public projects. Unemployment assistance continued, as did the State Disaster Loan Program.

State legislation provided an additional source of low-interest loans to disaster victims. Legislation was also drafted to set aside lands for the reloca-

tion of qualified applicants of Hawaiian ancestry.

Heavy rains, floods hit Oahu.

Twelve days of drenching rains in March were followed by extensive flooding on the north windward shores and south central portions of the island, Mar. 19-23. Several evacuation shelters were opened as flood waters drove people from their homes, blocked roads and isolated residents.

An emergency declaration was signed on March 22. Heavy rains continued and the Red Cross opened disaster assistance centers in Waipahu and Laie. The Governor proclaimed a disaster on March 26 and requested federal assistance from the Small Business Administration.

Disaster application centers were opened at Waipahu Recreation Center and Brigham Young University, Apr. 3-9. Staffed by federal, state and county agencies, the centers provided one-stop service for disaster assistance programs.

By the end of the fiscal year, the Small Business Administration had approved 81 individual and business loans totalling nearly \$1.2 million. State disaster assistance to the city and county of Honolulu amounted to \$315,000 for public projects

New tsunami evacuation maps published. White pages of all county telephone directories contain updated tsunami evacuation maps. Published in early 1991, the maps use familiar landmarks for easy identification of evacuation routes and boundaries. Funded by special legislative appropriation, the mapping project was a cooperative effort of the Joint Institute for Marine and Atmospheric Research (JIMAR) and county civil defense agencies. The maps use information from coastal inundation studies and county evacuation plans.

Emergency broadcasts on cable TV. In 1990, Oceanic and Chronicle cable television systems on Oahu acquired technology to air emergency broadcast information. As part of Oceanic's franchise agreement with the state, the company has the capability to display supertext on all channels and carry the Emergency Broadcast System audio on a dedicated channel. Chronicle Cable serves as a relay agent for Oceanic broadcasts. Oceanic's franchise agreement also requires the installation of video link for live broadcasts from the State Emergency Broadcast Studio by 1992, giving neigh-

bor island subscribers access to similar cable services.

1990 hurricane season. The season was ushered in by Tropical Storm Aka, the first cyclone to develop in the central North Pacific, Aug. 7. Hurricane Marie entered Hawaiian waters on Sept. 14, and U.S. Air Force reconnaissance and satellite imagery followed this system as it weakened on a westward track south of Hawaii. On Oct. 1, a weakening Tropical Storm Polo crossed into central North Pacific waters and soon dissipated southeast of Hawaii.

Training

Training and exercises are key factors in maintaining the readiness of Hawaii's emergency management system. In 1991, two-hundred thirteen participants attended professional development courses aimed at familiarizing agencies, local businesses, and volunteer organizations with the civil defense system and sharpening performance skills. In a crisis, successful performance depends on skill, experience and how well response teams have prepared, trained and exercised for the reality.

A total of 18 exercises were conducted in 1991. Included in the count were actual events involving flooding on Oahu, island wide power outages and Molokai wildfires.

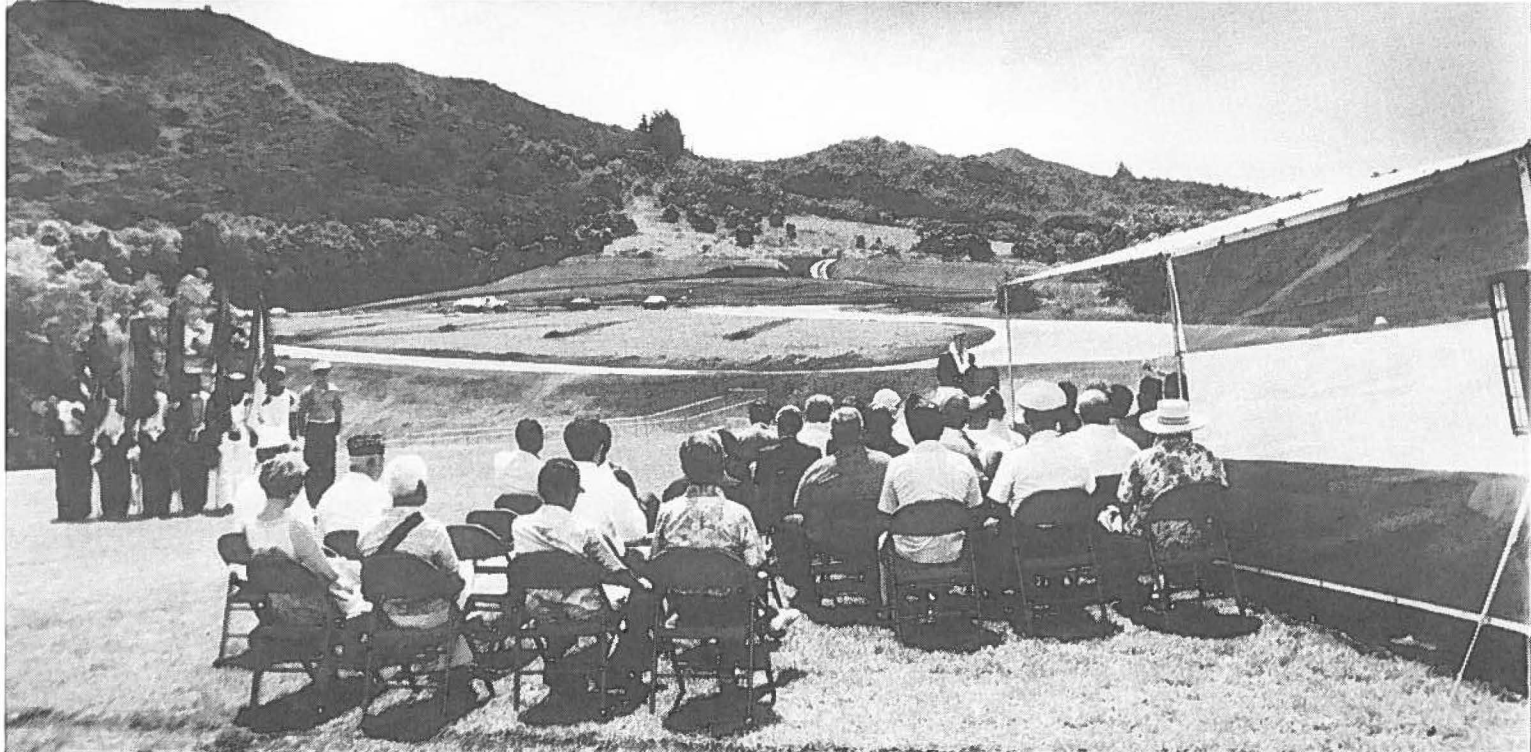
A fullscale 2-day exercise was conducted at the start of hurricane season, with participants numbering in the hundreds. Joining state and county agencies were the military services, U.S. Coast Guard, National Weather Service, local businesses, and American Red Cross.

The county of Kauai participated in a hazardous materials exercise sponsored by the San Francisco office of the Environmental Protection Agency in May.

More than 2,000 persons participated in civil defense natural and hazardous materials exercises this year.

Office of Veterans Services

Mission

The Office of Veterans Services (OVS) is the principal state office responsible for the development and management of policies and programs related to veterans, their dependents and/or survivors.

Personnel

The Office of Veterans Services is authorized 17 full-time state employees. An additional two full-time positions were authorized for the Hawaii State Veterans Cemetery Branch and will be filled in fiscal year 1992.

Organization

Formal restructuring of the Office of Veterans Services was completed in 1990 when Governor John Waihee approved a reorganization proposal that incorporated the Hawaii State Veterans Cemetery as a branch within the Office of Veterans Services. The Oahu Office of Veterans Services, as the centralized

administrative agency, consists of the director, veterans services branch staff and administrative and office services staff. The staff of OVS units on Hawaii, Kauai and Maui consists of a veterans services counselor and a clerk typist. The Hawaii State Veterans Cemetery is presently staffed by a superintendent, an operations assistant, a secretary and two general laborers.

Highlights and Significant Events

The 1990 Legislature, prompted by concerns for the aging veterans population and coordination of veterans programs, requested the Legislative Auditor to conduct a study on programs and services to veterans. "Study of Programs and Services for Veterans: A Report to the Governor and the Legislature of the State of Hawaii," examined current services and programs and made recommendations on cooperative efforts, action plans and coordination. The study will provide substantial support as the

Office of Veterans Services continues to enlarge and expand its services.

The Office of Veterans Services continues to raise program visibility and to publicize veterans services. An extensive series of presentations was made to veterans groups, retirees and active duty personnel. Statewide outreach activities included participation in transition assistance programs; presentations to home health care, aging, mortuary, and University of Hawaii at Hilo personnel on veterans benefits and issues; and assistance to organizations working with Desert Storm veterans and dependents. The Veterans Services Branch staff continued monthly visits to the islands of Molokai and Lanai, as well as servicing veterans and dependents in rural areas of each county.

Purchase of vehicles was authorized by the 1991 Legislature and will expand future outreach services. Outreach efforts resulted in an 11 percent increase in the number of veterans and dependents served in 1991.

Joint, cooperative projects enabled the Office of Veterans Services to work closely with the Department of Defense's Engineering Office to develop the Hawaii State Veterans Cemetery and to create plans for the Korean and Vietnam conflicts memorial and Kauai Veterans Center; with the Department of Veterans Affairs to establish the Spark M. Matsunaga Medical Center; with local agencies to provide support to Desert Storm dependents; with schools, veterans organizations and military groups to provide leis for the National Memorial Cemetery of the Pacific on Memorial Day; and with veterans organizations to honor veterans of all conflicts.

Veterans services counselors serve as advisors to the Mayor's Veterans Advisory Committees, Councils/Committees on Aging, Kauai Veterans Association, Big Island Veterans Association and Maui Veterans Council.

As the primary state advocate for veterans, the director represented the Governor at a variety of ceremonies and conferences, such as Massing of the Colors, Native American Warrior Veterans Pow Wow and Memorial Service, Australia and New Zealand Army Corps (ANZAC) Day and the American Legion, Disabled American Veterans and Veterans of Foreign Wars conferences.

The director also performed public service activities such as judging an oratorical contest for the American Legion, co-chairing Family Sunday at the Bishop Museum for senior citizens, and speaking to the Toastmasters Group, Senior Companions and City and County Elderly Affairs Division's community service aides. The veterans services coordinator chaired the Honolulu Community Housing Resource Board and veterans services counselors spoke to community organizations in their counties.

Notable organizational changes included the retirement of the Oahu counselor and hiring of his replacement, addition of the cemetery branch, and

new offices on Kauai and Oahu. The staff continued to review Standing Operating Procedures in order to better define services offered to veterans and describe general office procedures and policies. A computer-based information system, Office of Veterans Services Information System (OVSIS), was developed by a team of University of Hawaii software engineering students to enable registration and tracking of veterans and services.

The Office of Veterans Services agreed to participate in the demonstration period of HAWAII FYI (for your information), a gateway service for access to interactive databases, some of which describe the services of state agencies.

A primary focus throughout the year is the development of the Hawaii State Veterans Cemetery. In the spring, work included extensive grading, laying of drainage, sewers and roads and construction of the administration and maintenance buildings. Cemetery positions

were reviewed and approved by the Department of Personnel Services in December and a superintendent of cemetery operations was hired in March.

With the National Memorial Cemetery of the Pacific (Punchbowl) scheduled to close on July 31, 1991, the staff accelerated its efforts to establish rules of practice and procedure, hire staff, arrange for services, utilities, and temporary office space and purchase equipment.

The Advisory Board on Veterans Services met monthly to advise the director and testified before the 1991 Legislature. In August, the board met on Kauai to discuss the island's veterans center and other local concerns. A meeting was held on Maui in November for Maui veterans.

The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts continued to advocate for a site and the winning design submitted by Mr. Benjamin B. Lee and Ms. Elaine M. Murphy. A series of meetings and

hearings was held to obtain information and solicit comments from the public. The memorials are scheduled to be completed by Veterans Day 1992.

The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts included:

Chair, David Price (resigned February 1991), Lawrence Ebesugawa, Lester Higa, John Keliiholokai, George Matsumoto, Mildred McColgan, Yoshio Sugino and Larry Tamanaha.

Training

Staff trained in areas associated with their work, with topics including post-traumatic stress disorder, effective communication methods and writing, data management and desktop publishing.

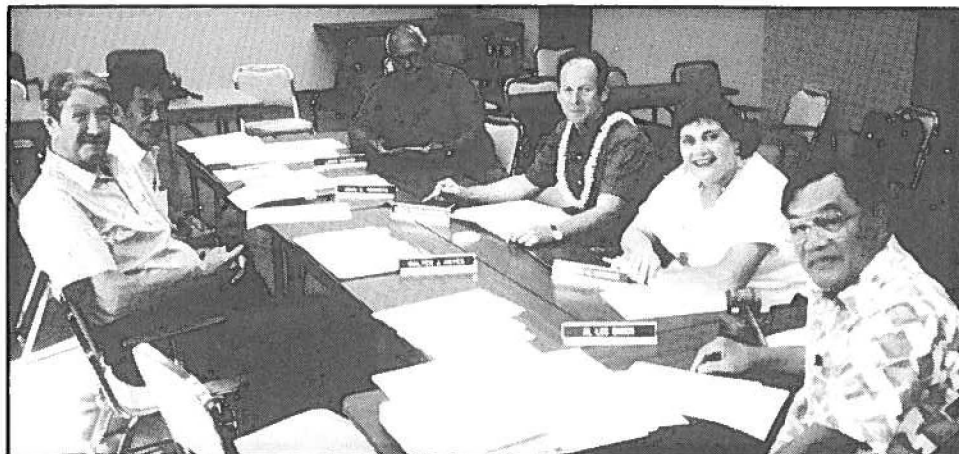

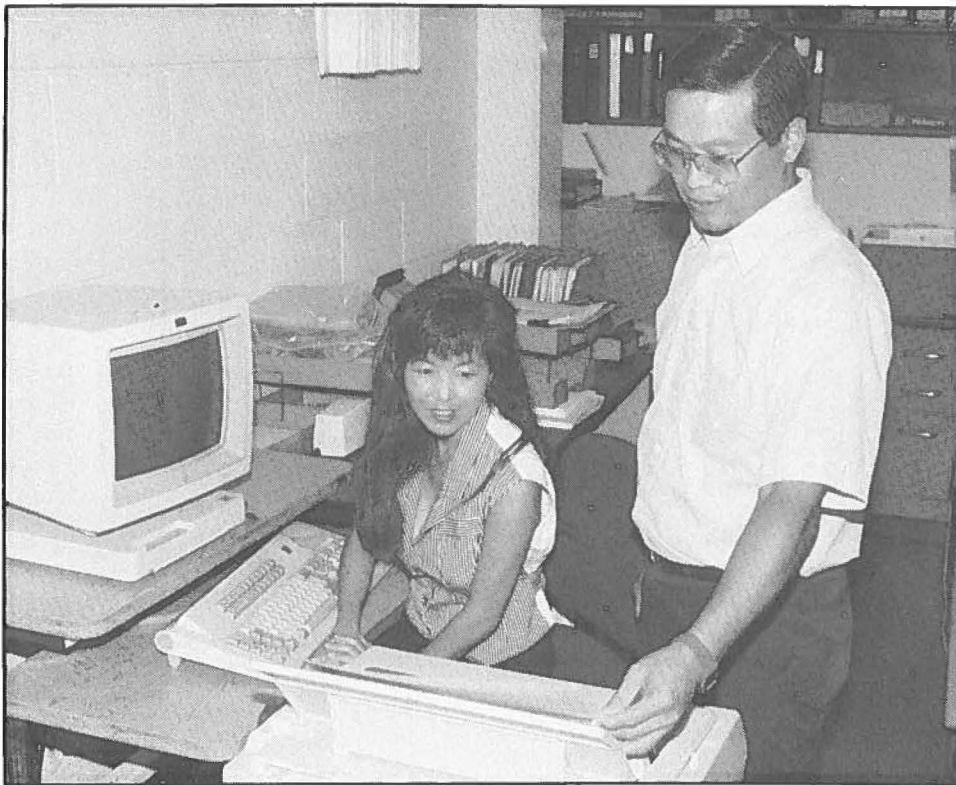

Administrative Services Office

Mission

The Administrative Services Office (ASO) provides military and state administrative support to the Office of the Adjutant General. It coordinates and controls all planning, programming, budgeting and execution of departmental programs as directed by the adjutant general.

Personnel

The Administrative Services Office is authorized 17 full-time state employees.

Organization

The Administrative Services Office is comprised of three primary staff elements. These are the executive support, personnel management services and financial management services sections.

Executive Support

The ASO provides centralized office services and communications management, to include the monitoring, review, distribution and filing of communications received from federal, state and local governments and the civilian community. The ASO is also responsible for maintaining close liaison with Hawaii's congressional delegation and legislature, and for administering all legislation affecting departmental programs. The office prepares correspondence and testimony concerning various legislative proposals. The military component of the ASO provides executive support services to the adjutant general. It also coordinates the activities of the adjutant general's military staff, composed of members of the Hawaii National Guard.

Personnel Management Services

The personnel management services staff administers the state employee personnel program, including recruitment and placement, classification, salary, leave, employee performance, employee relations, out- and in-service training, personnel records, occupational safety and health and workers' compensation.

Financial Management Services

The financial management services staff administers and controls state general fund appropriations, state-administered federal funds and matching fund grants under the Federal Emergency Management Assistance program. The staff also provides centralized control and accounting of all state property assigned or issued to the department.

Highlights and Significant Events

There were 172 permanent state positions authorized during the year, of which 153 were filled by June 30, 1991. Twenty-six temporary positions were authorized, and 19 were filled at the end of the fiscal year.

With regard to performance ratings, 62 individuals, 36 percent of the state work force, received very satisfactory ratings. From there, 10 Sustained Superior Performance Awards were submitted and approved during the fiscal year. The average monetary award amounted to \$200.

The 1991 recipient of the Adjutant General's Award for Distinguished State Service is Mrs. Dorothy Rodrigues, a clerk-typist with the Hawaii Army National Guard on the island of Maui.

There were 21 reportable cases of work-related injuries involving state employees, reflecting a 24 percent increase in reportable cases. A total of 199 lost workdays, or an average of 9 workdays per injury, reflects a 39 percent increase of lost workdays.

Additionally, there were 10 workers' compensation injuries involving drill-status National Guard personnel, an increase of eight cases. Total compensation payment for the year amounted to \$8,775, a 10 percent increase over last year.

The Administrative Services Office, through its fiscal staff, administered and controlled \$9,114,043 in state general fund appropriations and \$1,567,105 in federal fund appropriated receipts. Restricted as efficiency savings was \$225,321 of the original general fund appropriation.

The net general fund appropriation of \$9,114,043 was a composition of \$7,053,775 from the DEF 110 (departmental operating program), \$560,268 from the DEF 112 (services to veterans program) and \$1,500,000 from Act 194, which increased the ceiling for major disasters from \$750,000 to \$1,000,000 per disaster and provided an additional \$1,000,000 solely for the matching of federal disaster relief funds.

Total expenditures and encumbrances, less unallotted disaster funds in programs DEF 110 and DEF 112, amounted to \$8,211,518 for an expenditure rate of 99.9 percent, leaving a general fund lapsing balance of \$7,478, of which \$6,494 was from the Office of Veterans Services. Federal fund expenditures and encumbrances amounted to \$1,411,287, leaving a reversion balance of \$155,818. The federal reversion balance was due to lower than projected federal fund receipts for the State Civil Defense accounts. Table 5 in the Appendix depicts the distribution of general fund appropriation, appropriated receipts and expenditures by programs, organizations and cost elements.

Additionally, the fiscal staff administered three federal fund holding and disbursing accounts. Table 6 in the Appendix reflects the status of these accounts as of June 30, 1991.

The department's cash receipts for the year amounted to \$2,950,399. Of this amount, \$275,753 was credited to the state general fund; \$52,050 to the general fund operating account; and \$2,622,591 to the special (federal) fund

operating accounts. The sources and fund accounts to which they were credited are depicted in Table 7 in the Appendix.

In administering the state finances for the year, the fiscal staff processed 3,854 purchase orders, 840 summary warrant vouchers, 45 payroll vouchers, 83 bills for collection, 60 federal fund claims invoices, 111 treasury deposit slips, and 1,005 petty cash checks.

The department administered and accounted for state program funds under an in-house developed system and the statewide Financial Accounting and Management Information Systems (FAMIS). Information is transmitted to the Department of Accounting and General Services via the department's direct on-line terminals.

Federal funds for civil defense program activities amounting to \$845,821 were received as 50-50 matching fund grants under the Federal Emergency Management Assistance program (Public Law 85-606) and Civil Defense Maintenance and Service program (Public Law 920); and as 100 percent federal funded contract grants for radiological instrumentation/maintenance and calibration, emergency management training, disaster improvement, population protection planning, earthquake preparedness and radiological defense planning and development.

Federal funds for the Hawaii Army and Air National Guard amounting to \$1,040,792 were received under five separate cost reimbursable operations and maintenance service contracts negotiated between the National Guard Bureau and the State Department of Defense. These contracts provided for reimbursements of 100 percent, 80 percent, and 75 percent of the authorized costs to operate and maintain buildings and grounds occupied by the federally-supported activities of the Hawaii National Guard. Funds received under these contracts are deposited

into the state treasury as appropriated receipts or as refunds of fringe benefit payments advanced by other state agencies.

During the year, the department added to its inventory or property 251 items valued at \$6,526,839, and disposed and declassified 141 line items of surplus or unserviceable property valued at \$116,065.

The fiscal staff also administered the short-term use and rental of departmental facilities by coordinating and processing 64 separate applications

for use of armories and grounds located on the five major islands. Rental fees and utilities reimbursements col-

lected amounted to \$19,892. The department's property inventory as of June 30, 1990, is provided below.

U.S. Property and Fiscal Office

Mission

The mission of the U.S. Property and Fiscal Officer (USPFO) for Hawaii is to receive and account for all funds and property of the United States possessed by the Hawaii National Guard, ensure that federal funds are obligated and expended in conformance with applicable statutes and regulations, ensure that federal property is maintained and utilized in accordance with National Guard Bureau directives, manage the federal logistics systems for Hawaii, and provide the support necessary for the transition of mobilized units to active duty status.

Personnel

The U.S. Property and Fiscal Office for Hawaii is authorized 83 full-time federal technicians.

Organization

The U.S. Property and Fiscal Office is organized as follows: Administration Office, Data Processing Installation, Analysis and Internal Review Division, Resource Management Division, Purchasing and Contracting Division, and Logistics Division.

Administration Office

This office performs administrative services in support of the U.S. Property and Fiscal Office operations. The office maintains a centralized filing system, receives and processes office mail, and provides reproduction, typing and stenographic services.

Data Processing Installation

The Data Processing Installation provides services to the U.S. Property and Fiscal Office, Hawaii Army National Guard, State Maintenance Office, Support Personnel Management Office, Standard Installation/Division Personnel System Branch and Army Aviation Support Facilities. The installation operates a Burroughs B1955 and two UNISYS 5000/80 mainframes. Application software is slowly being migrated from the Burroughs to the UNISYS system and should be completed by late 1992. Installation of a Defense Data Network and electronic mail capability will enable worldwide communication and data transfer.

Resource Management Division

Federal funds allotted to the Hawaii

National Guard from Congressional appropriations are managed by this division. Separate offices administer funds assigned to Army and Air operations.

The Army Guard office, located in the Diamond Head Crater, is composed of the budget officer, staff accountant, fiscal accounting branch and pay examination branch. An assistant U.S. Property and Fiscal Officer for Air (fiscal) controls funds allocated for support of the Hawaii Air National Guard. This office is located at Hickam AFB.

Purchasing and Contracting Division

Purchasing and contracting services are provided by this office to all activities of the Hawaii National Guard by sealed bids, competitive proposals and small purchase procedures in accordance with Federal Acquisition Regulations. Purchases are made from commercial vendors located throughout the state of Hawaii and continental United States.

Logistics Division

This division, organized into Stock

Control, Supply, and Traffic Branches, provides logistical support and guidance to the Hawaii Army National Guard. An assistant U.S. Property and Fiscal Officer for Air (property) provides logistical support and guidance to the Hawaii Air National Guard. This office is located at Hickam AFB.

A full-time Scheduled Airlines Traffic Office, established within the Traffic Branch, provides the entire array of transportation services, including making plane, car and hotel reservations, writing airline tickets, handling air freight, and other travel requirements.

Highlights and Significant Events

Federal funds used by the Army National Guard during the federal fiscal year totaled \$46,985,154.

Federal funds used this year by the Air National Guard amounted to \$49,441,694.

Table 4 in the Appendix reflects federal dollars used between Oct. 1, 1990, and Sept. 30, 1991.

Military payrolls for the Army and the Air Guard totaled \$32,424,082 this federal fiscal year.

During federal fiscal year 1991, local purchases and contracting support of Hawaii National Guard units and activities totaled \$6,692,996. Of this total, \$3,456,426 represented architectural-engineering services and construction contracts. A total of 3,200 contracting actions were processed.

A total of \$5,370,082 was spent to procure supplies and equipment for the Hawaii Army National Guard. The Logistics Division maintained an inventory of \$6,584,100, which included wartime contingency stocks valued at \$3,736,017 and repair parts valued at \$941,462.

The Air National Guard received \$4,747,409 for supplies. The base supply operation processed 523,198 transactions in federal fiscal year 1991, a monthly average of 43,600. The in-house inventory value was \$57,062,681

at the beginning of the federal fiscal year; the stockage effectiveness rate was 85.7 percent. At year's end, the inventory value was \$54,027,331, with stockage effectiveness rate at 78.7 percent.

The Hawaii Army National Guard Traffic Branch arranged transportation for a total of 7,066 individuals: 988 military interisland airlifts, 1,705 commercial trips to the mainland and 4,373 commercial interisland trips. A total of 3,875 tons of cargo was shipped during the fiscal year: 2,460 tons for annual training, 117 tons to the mainland and 1,298 tons to interisland destinations. The total spent to transport personnel and equipment is shown in Table 4 (Appendix). The use of the Scheduled Airlines Traffic Office provided an estimated savings of \$2,077,889 for federal fiscal year 1991.

The Hawaii Air National Guard Traffic Branch arranged transportation for a total of 1,475 individuals: 612 commercial trips to the mainland, 53 foreign trips and 810 commercial interisland trips. A total of 640.4 tons of cargo was shipped during the fiscal year: 640 tons to interisland destinations and .04 ton to the mainland. The use of the Scheduled Airlines Traffic Office provided an estimated savings of \$654,046 for federal fiscal year 1991.

Two UNISYS 5000/80 computer systems have been installed in the Data Processing Installation. The UNISYS brings new technology and challenges to the staff and to future users of the system. The UNISYS will completely replace the Burroughs within two years.

A total of six reviews were completed by the Analysis and Internal Review Division during federal fiscal year 1991.

Support Personnel Management Office

Mission

The Support Personnel Management Office (SPMO) is a consolidated office that provides personnel and manpower management administrative support services for all federal full-time personnel programs. This office serves as the adjutant general's single point of control for managing and administering Hawaii Army and Air National Guard personnel programs.

Personnel

The Support Personnel Management Office is authorized a staff of 15 federal technicians and three Active Guard/Reserve (AGR) soldiers.

Organization

A standard National Guard structure prescribes that the personnel office be organized with the following operating sections: personnel management, employee services, military duty management, military duty services, equal employment opportunity and labor relations. The office is centrally located and all records and authorized staff are collocated to provide a single point of contact for personnel.

Personnel Management Section

Section staff members develop policy recommendations, procedures and plans in compliance with U.S. Office of Personnel Management and National Guard Bureau directives. The section is responsible for major program areas such as position management and classification, manning control, staffing, training, employee relations, performance management and recognition, incentive awards, disciplinary and adverse actions, grievances and appeals, personnel management evaluation and

maintenance of the personnel data system. It furnishes technical advice and assistance to management officials, individuals and staff personnel.

Employee Services Section

This section provides a wide range of services to technicians throughout their employment life cycle. Beginning with employment processing and new technician orientations, the staff furnishes information on employee benefits, processes personnel actions, maintains individual technician personnel records, ensures proper pay administration, administers the Federal Workers' Compensation Program and processes retirements.

Military Duty Management Section

Army Active Guard/Reserve (AGR) enlisted personnel career management and tour retention processes, recruitment and advisory services take up much of this section's time. Unlike their staff counterparts who administer the Army and Air National Guard technician programs in compliance with common directives, the AGR management staff administers military programs based on policies and procedures established by the Army, Air Force and separate National Guard directorates.

Military Duty Services Section

This section serves as the point of contact for commanders, supervisors and individuals seeking AGR administrative services and assistance pertinent to pay, benefits and entitlements. The addition of a medical administrative specialist has vastly improved coordination with military and civilian medical care providers who treat AGR personnel and their dependents on Oahu and the neighbor islands.

Equal Employment Opportunity Section

The equal employment manager plans, develops and administers programs for all employees (to include state personnel) relative to equal employment. Programs administered include the affirmative employment programs with special emphasis on women and other minority issues, equal opportunity complaints processing, discrimination investigations and training for departmental personnel.

Labor Relations Section

This section provides federal labor relations services within the department. Two locals of national labor organizations are exclusive of non-supervisory technicians in three bargaining units. Typical tasks include contract administration, labor-management relations training and management advisory services. The section also serves as point of contact for union representatives, and as management's representative in dispute resolution and contract negotiations.

Federal full-time support personnel authorizations, based on unit priorities, are excellent. Despite federal fiscal austerity programs, assigned strengths are slightly higher than last year.

Eight Army National Guard and 13 Air National Guard technicians received merit pay increases under the Performance Management and Recognition System. Wage grade increases were effected for 149 Army and 429 Air National Guard technicians in November 1990; 128 Army and 249 Air National Guard general schedule technicians received salary increases in January 1991.

Eighty-nine Army National Guard full-time soldiers attended training at the National Guard Professional Education Center in Little Rock, Ark. The center's curriculum meets training needs on a centrally funded basis, cost-free to the state.

The U.S. Office of Personnel Management, Hawaii Joint Training Board, and private sector vendors trained 73 Army and 153 Air National Guard technicians in a variety of work-related subjects.

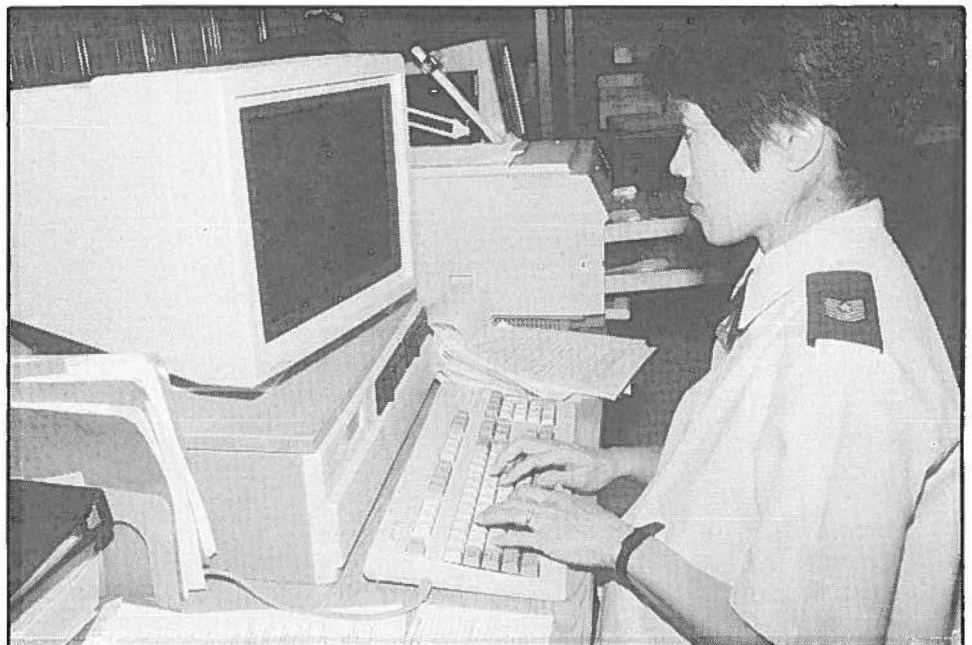
Approximately \$87,700 in federal funds was expended for full-time personnel training.

Engineering Office

Mission

The Engineering Office provides the entire spectrum of professional engineering services to the Hawaii Army and Air National Guard, State Civil Defense and Office of Veterans Services divisions as well as departmental staff sections to enable them to carry out their statewide programs.

The major responsibilities are to plan for, administer and supervise the following:

- Capital improvement projects
- Major and minor construction projects
- Consultant contract services
- Maintenance and repair projects
- Janitorial/custodial and ground maintenance
- Real property management
- Environmental and energy conservation programs

Personnel

The Engineering Office is authorized 48 state, seven federal and two Active Guard/Reserve (AGR) positions.

Organization

The Engineering Office consists of seven major staff responsibilities: Office Services, Contracting and Engineering Services, Maintenance Services, Air National Guard Engineering Services, Army National Guard Engineering Services, State Civil Defense Engineering Services and Office of Veterans Services.

Repair and Maintenance Projects Awarded

Recurring minor maintenance, repair and modification of facilities are accomplished by in-house maintenance personnel either on a time-and-materials basis or by formal and informal

construction contracts. This program is supported by federal, state or joint federal/state matching funds through separate Army and Air Service Contracts or Army National Guard Training Site Contracts. A total of \$725,000 of state operations and maintenance (O&M) funds were expended to support department programs. An additional \$170,000 of state O&M funds were expended for special State Civil Defense projects.

Minor Construction Projects

Minor construction projects include all projects for minor construction or major repair, maintenance or modification of facilities. This program is supported by federal funds or joint federal/state matching funds. Ongoing minor construction projects during this fiscal year amounted to \$201,850 for the HIARNG (backlog maintenance, environmental engineering training and various projects) and \$2,112,780 for the HIANG (recurring preventive maintenance design and construction).

Staff Judge Advocate Office

Mission

The Staff Judge Advocate (SJA) provides legal support to the adjutant general, staff elements, subordinate units of the Hawaii National Guard, and the United States Property and Fiscal Office. In performing its mission, the SJA serves to:

- Prepare legal opinions on issues of federal law.
- Serve as federal litigation point of contact.

- Represent the adjutant general in federal labor-management proceedings.
- Review federal contracts relating to procurement and acquisitions and serve as the Hawaii National Guard's federal claims officer.
- Participate as legal advisor or counsel in administrative board proceedings.
- Act on behalf of the convening authority in National Guard court-martial.

Personnel

The Staff Judge Advocate Office consists of a judge advocate supported by a shared clerk-typist for the Special Staff.

Organization

The SJA reports directly to the adjutant general and works closely with Guard members on legal issues relating to the mission of the National Guard.

Public Affairs Office

Mission

The Public Affairs Office plans, develops, directs and administers the department's community relations and public and internal information programs. In accomplishing its mission, the office performs the following:

- Prepare and distribute news releases, photographs and videotapes on departmental activities to civilian and military news media locally and on the mainland.
- Respond to queries from the news media, public, and other state and federal agencies.

- Provide briefings for civilian and military officials, community groups and new departmental employees to inform them of the department's mission and its economic and educational contributions to the state.
- Publish the quarterly newspaper for distribution to present and retired Hawaii National Guard members, state and federal agencies, and other parties interested in departmental activities.
- Consolidate, edit and publish the department's annual report.
- Prepare speeches and reports for the adjutant general.

Personnel

The office consists of a public affairs officer, an information specialist and a clerk-typist. All personnel are full-time state employees.

Organization

The public affairs officer advises the adjutant general and staff members on public affairs matters relating to the department. The office works closely and coordinates its activities with public affairs officers of the department's major units/divisions and active military services to carry out its programs.

Senior Army Advisor

Mission

The Senior Army Advisor (SRAA) is responsible for providing advice, counsel and assistance to the adjutant general and his staff in order to strengthen the Hawaii Army National Guard's (HIARNG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to the adjutant general.

- Represent and act as a spokesperson for the active Army in all HIARNG matters under the purview of U.S. Army Support Command, Hawaii (USASCH).
- Render professional military advice to HIARNG commanders in military matters concerning the organization, operation, training and readiness of units.
- Monitor the use and assist in the management of federal resources in support of the HIARNG.
- Direct, assist or provide guidance to

other advisors of administrative personnel when so designated by USASCH.

Personnel

The office is staffed by an active Army colonel.

Organization

The SRAA reports directly to the adjutant general and works closely with Guard members on federal military missions and issues.

Senior Enlisted Advisor

Mission

The State Command Sergeant Major (CSM) serves as the senior enlisted advisor for the Hawaii Army National Guard and is responsible to the adjutant general for a variety of matters pertaining to policies and actions relative to enlisted

Hawaii Army National Guard soldiers.

The State Command Sergeant Major accomplishes the following:

- Advise the adjutant general on all enlisted matters.
- Assist the inspector general in servicing enlisted problems.

- Work with the recruiting and retention office.

- Participate on boards related to enlisted soldiers to include promotion, Active Guard/Reserve (AGR) continuation, selective retention and U.S.

Army Pacific Non-Commissioned Officer and Soldier of the Year.

- Attend various conferences both locally and on the mainland.

Personnel

The CSM's Office consists of a command sergeant major supported by a shared clerk-typist for the Special Staff.

Organization

The CSM reports directly to the adjutant general and works closely with Guard members on enlisted issues.

Inspector General

Mission

The Inspector General (IG) is assigned to assist the adjutant general in assessing and reporting in an unbiased, objective manner on areas affecting mission performance, the state of efficiency, economy, discipline, morale, esprit de corps and readiness of the Hawaii National Guard. The IG also performs other duties as required by law and regulations or as directed by the adjutant general. The mission is accomplished using the concept of a full service IG to:

- Provide assistance to Guard members, their families, and the public in response to real or perceived issues involving the Hawaii National Guard.
- Act on adjutant general directives to conduct investigations and inquiries.
- Manage the staff/special inspection program throughout the Hawaii National Guard.
- Act as a teacher or trainer when and where possible while performing other functions.

Personnel

The IG's office is staffed by an active Army lieutenant colonel and supported by a shared clerk-typist for the Special Staff.

Organization

The IG reports directly to the adjutant general and is a member of his staff. The relationship between an IG and his commander has been referred to as one in which the commander places extraordinary trust and confidence "to be the eyes, ears and conscience of the commander."

Director of Information Management

Mission

The Information Management Office plans, programs and manages Army National Guard automation (less the Data Processing Installation, U.S. Property and Fiscal Office for Hawaii) and telecommunications resources. In accomplishing its mission, the office performs the following:

- Provide technical advice to the adjutant general, staff elements, U.S. Property and Fiscal Office and units of the Hawaii Army National Guard.
- Develop and administer state information systems objectives, policies,

plans and projects for supported organizations.

- Develop and administer an automation security policy.
- Assist users in obtaining and using automation and telecommunications resources.
- Determine automation training needs and coordinate appropriate user training with various training sources.

Personnel

The Information Management Office consists of the Director of Information

Management, a computer systems programmer, a communications management specialist and a computer assistant. All personnel are full-time federal technicians.

Organization

The Director of Information Management (DOIM) serves as the principal advisor on automation and communications requirements to the adjutant general and Hawaii Army National Guard officials. The office works with the National Guard Bureau's Information Management Agency and the other 53 Information Management Offices nationwide.

State Family Action Office, Hawaii National Guard

Mission

The State Family Action Office manages programs designed to increase the overall preparedness of Hawaii National Guard families to cope with the unique realities of Guard service.

Personnel

The office consists of a coordinator who is the only paid staff members. A state volunteer representative assists the coordinator in managing the activi-

ties of program volunteers throughout the state. Clerical support is provided by a shared clerk-typist for the Special Staff.

Organization

The state family action coordinator reports directly to the adjutant general. The coordinator works closely with the State Team, a volunteer action and advisory council, and family support groups throughout the state.

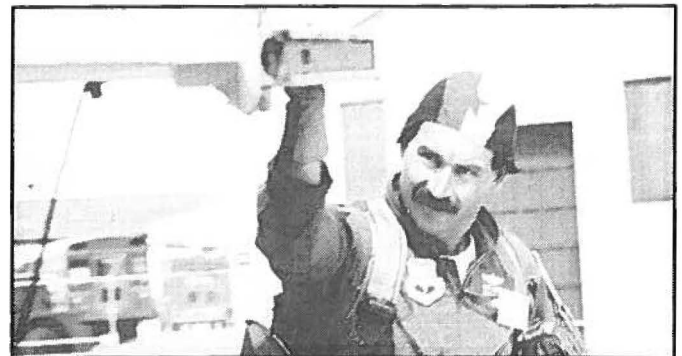

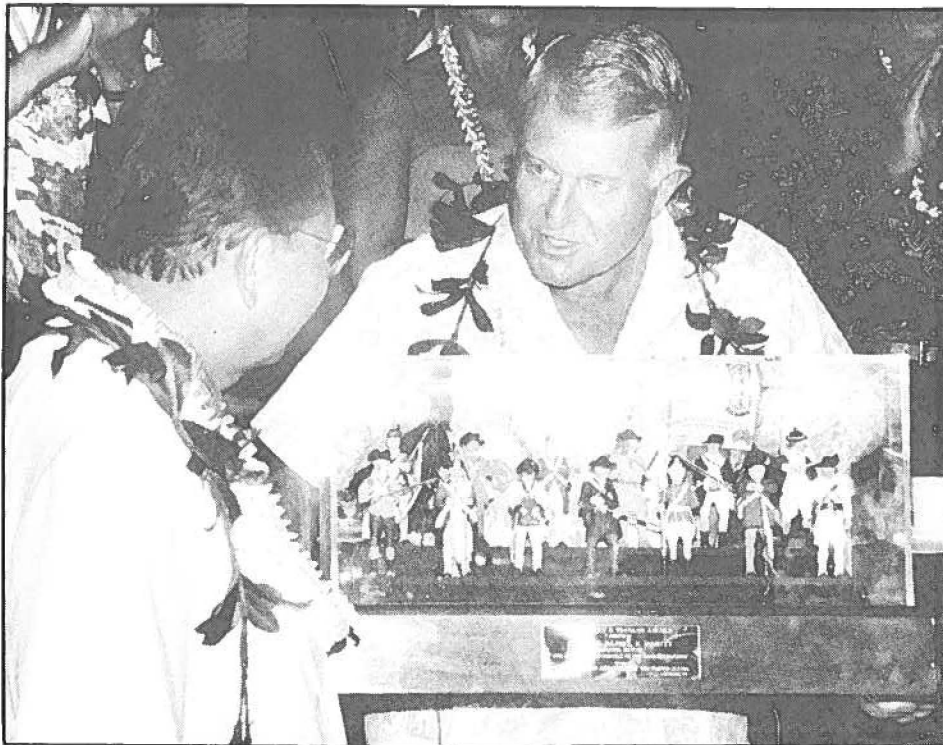
