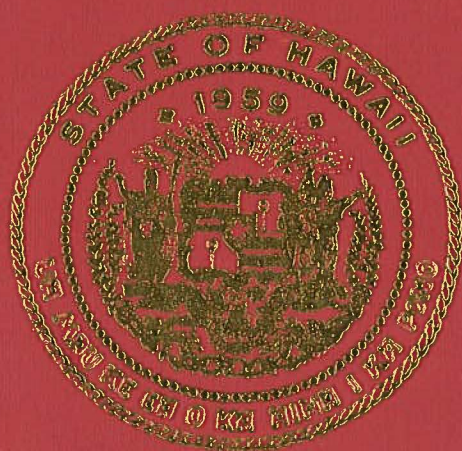

## ANNUAL REPORT Fiscal Year 1992



Dear Governor Waihee:

*Fiscal Year 1992 was a noteworthy period for the State of Hawaii Department of Defense. We expanded and greatly enhanced our ability to conduct joint operations involving our Hawaii Army and Air National Guard divisions, State Civil Defense and Office of Veterans Services. These capabilities were tested during training exercises, commemorative activities and real-world missions.*

*Our first joint endeavor was the dedication ceremony for the Hawaii State Veterans Cemetery in Kaneohe on July 31, 1991. In December 1991, we participated in the 50th anniversary commemoration of the attack on Pearl Harbor and organized remembrance activities for the State. Within a week, the department assisted Kauai County Civil Defense following the flood in Anahola. We also helped load and transport 46,000 pounds of relief goods to Samoa following Cyclone Val in January 1992.*

*The Hawaii Air National Guard celebrated its 45th anniversary in November 1991 and began conversion of its F-15 Eagle fighters to more improved versions under the multi-stage improvement program (MSIP). Planning and staffing of a new air refueling squadron with KC-135R Stratotankers progressed on schedule. Meanwhile, the arrival of the Hawaii Army National Guard's new 18-passenger C-26 Fairchild turboprop aircraft in June 1992 increased transport capability and flexibility for the entire department.*

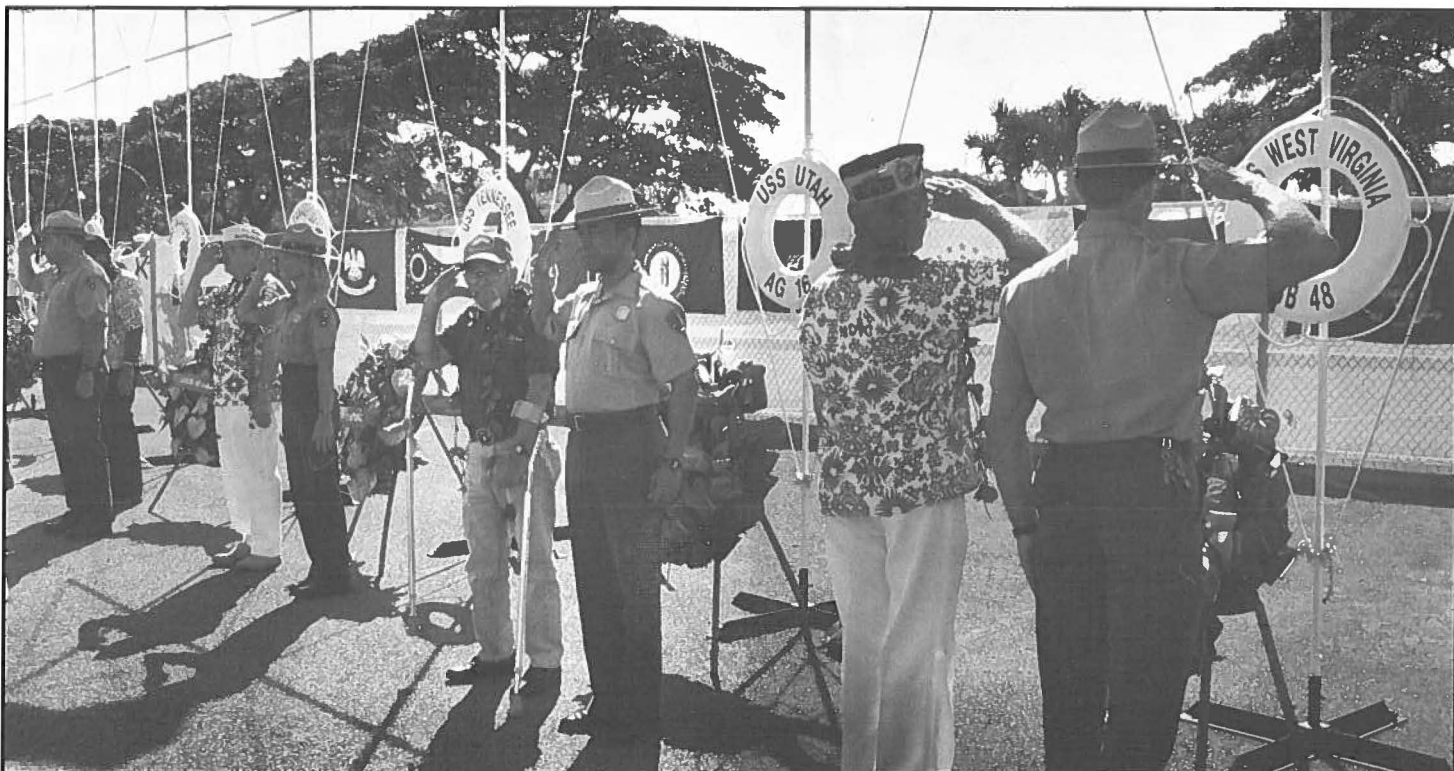

## Department of Defense

### Mission

The mission of the State of Hawaii Department of Defense is to assist authorities in providing for the safety, welfare and defense of the people of Hawaii. The department continuously strives to maintain its readiness to respond to the needs of people in the event of war or disasters, whether natural or human-caused. Upon activation by the Governor of the State of Hawaii, the department is prepared to provide professional personnel, quality services and well-maintained equipment to assist during emergencies.

The Hawaii Army and Air National Guard also trains to meet their federal missions should they receive a Presidential call to duty in times of national emergency.

The Office of Veterans Services (OVS) serves as the single point of

contact in state government for veterans services, policies and programs. The OVS also oversees the construction and administration of the Hawaii State Veterans Cemetery.

### Personnel

Compared to the other state departments, the full-time force of the Department of Defense represents a varied mixture of federal, state, active duty and drill-status National Guard members. This force includes 1,198 full-time federal employees, 153 state employees, and more than 5,628 drill status Army and Air National Guard members.

### Organization

The State Department of Defense is made up of three major divisions,

one inactive division, six key staff offices and the Office of Veterans Services.

The three major divisions are the Hawaii Army National Guard, Hawaii Air National Guard and State Civil Defense.

A fourth division, which is currently inactive, is the Hawaii State Defense Force. Under current state laws, the Hawaii State Defense Force may be activated should the need arise.

The six key staff offices provide support services to the three active divisions and other activity centers within the department. The key staff offices include the Administrative Services Office, U.S. Property and Fiscal Office, Support Personnel Management Office, Engineering Office, Staff Judge Advocate Office and Public Affairs Office.

The special staff includes the Senior Army Advisor, Senior Enlisted Advisor, Inspector General, Director of Information Management and Family Action Program Coordinator.

The adjutant general is the executive head of the department. In addition to being a member of the governor's cabinet, the adjutant general is the commander of both military divisions and the director of State Civil Defense.

### Hawaii National Guard

The Hawaii Army National Guard and Hawaii Air National Guard collectively form the Hawaii National Guard. Under the banner of the

Hawaii National Guard, the Army and Air National Guard divisions maintain, in a style unique to their military institutions, a history rich in traditions, contributions, sacrifices and high marks of excellence.

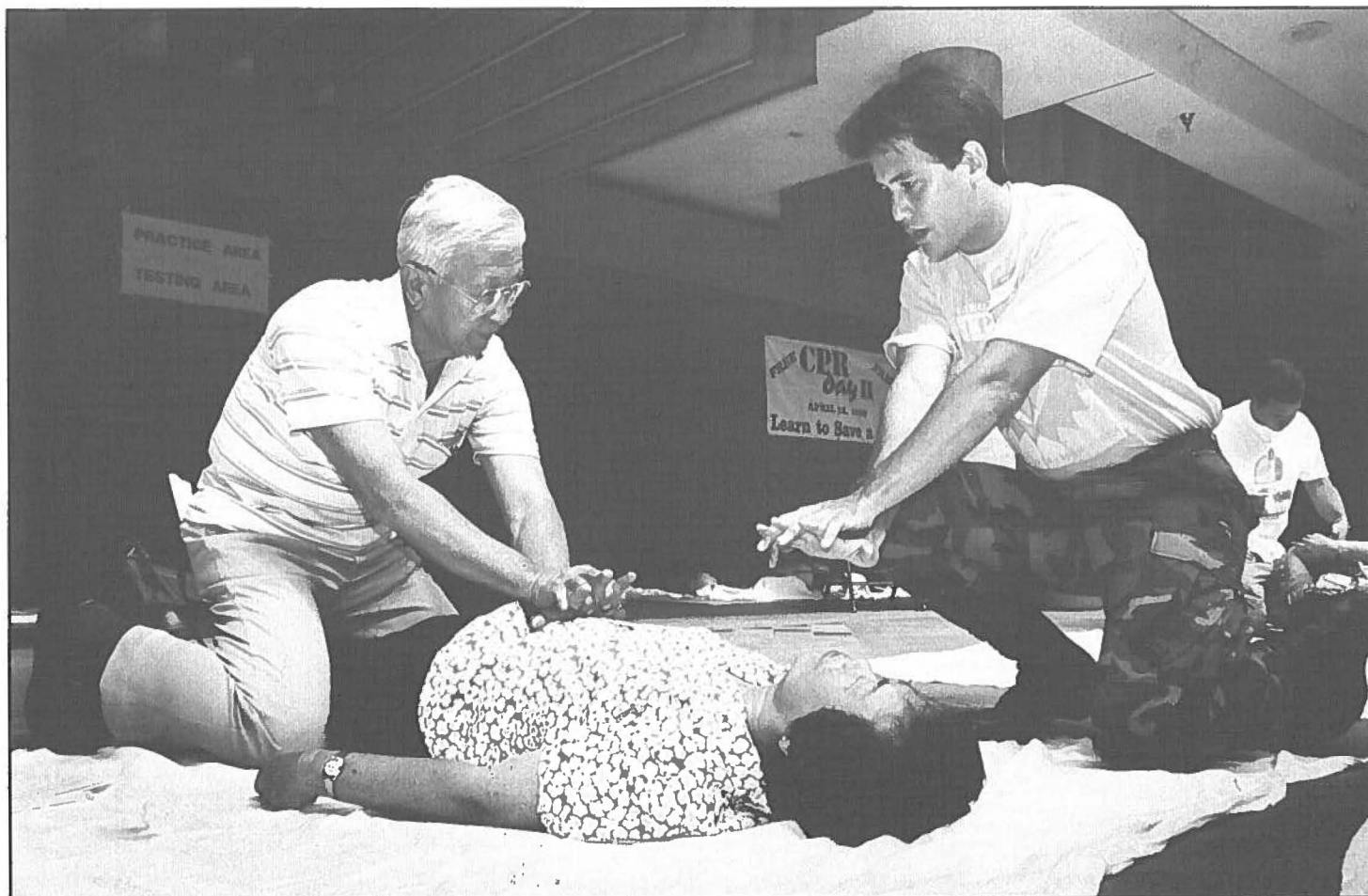
### State Civil Defense

State Civil Defense has two important missions. The first is to minimize loss of life, reduce property damage and restore essential public services and facilities devastated by natural or human-caused disasters. The second mission is to provide for the welfare and safety of citizens, ensure the continuance

and/or reconstitution of state government and mobilize and manage state resources in the event of war.

### Office of Veterans Services

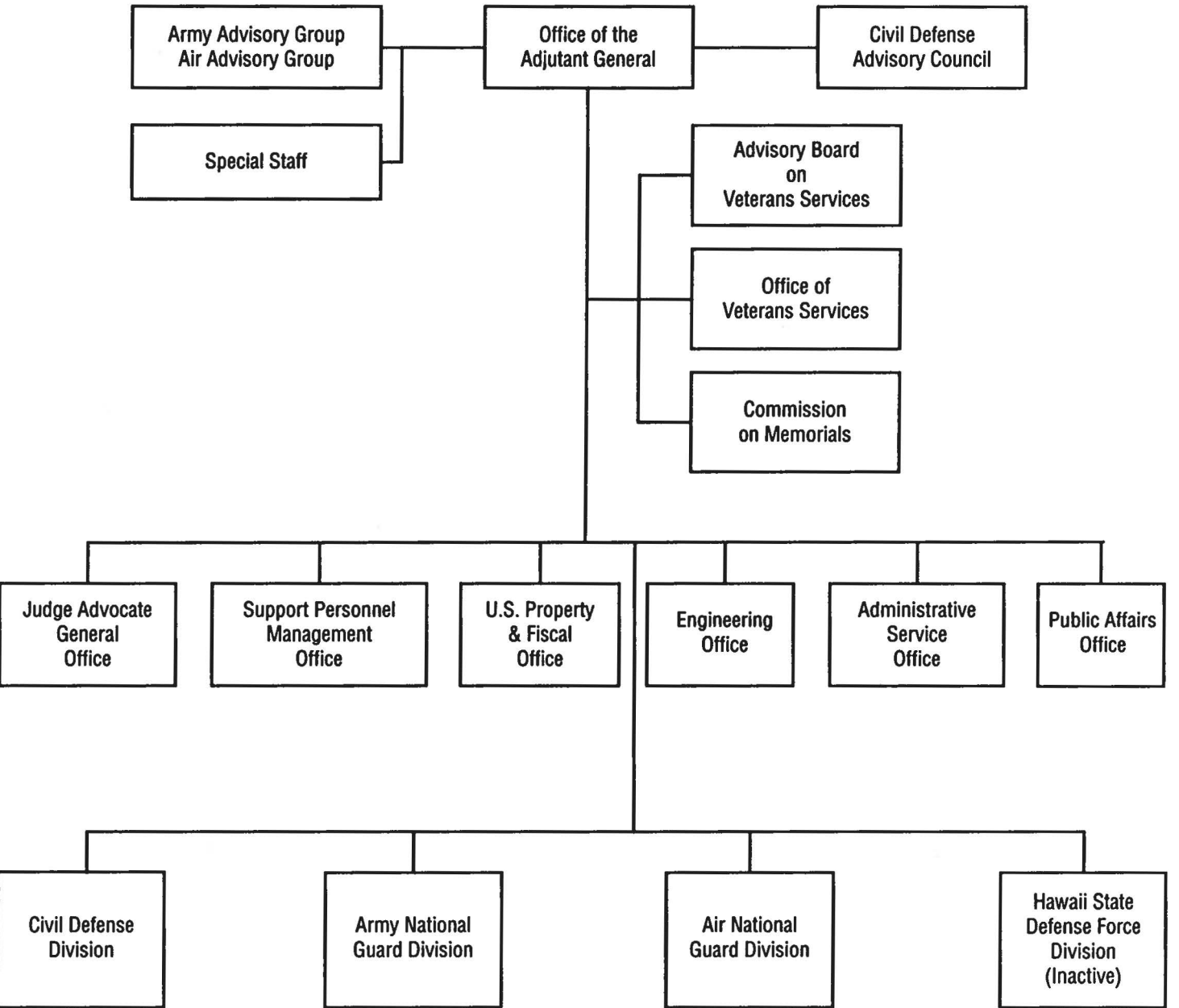
The Office of Veterans Services (OVS), which was administratively attached to the Department of Defense in July 1988, serves as the primary state agency responsible for developing and managing veterans' programs, policies and activities. The OVS is also charged with planning, establishing and operating the Hawaii State Veterans Cemetery on Oahu, which opened Aug. 1, 1991 and is scheduled for full completion in 1993.



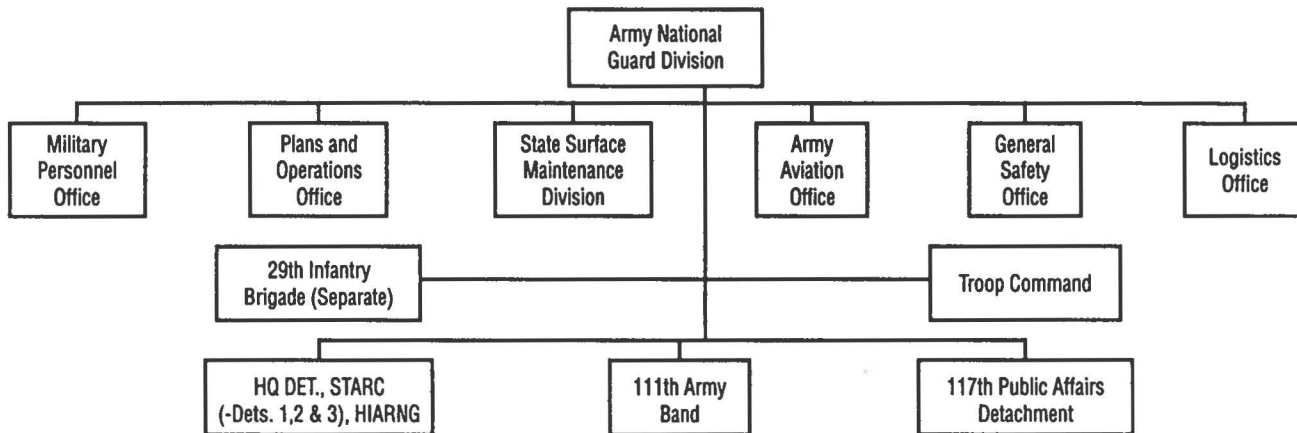
*A Hawaii National Guard volunteer demonstrates how to administer the abdominal thrust to a unconscious victim at CPR Day II in April.*



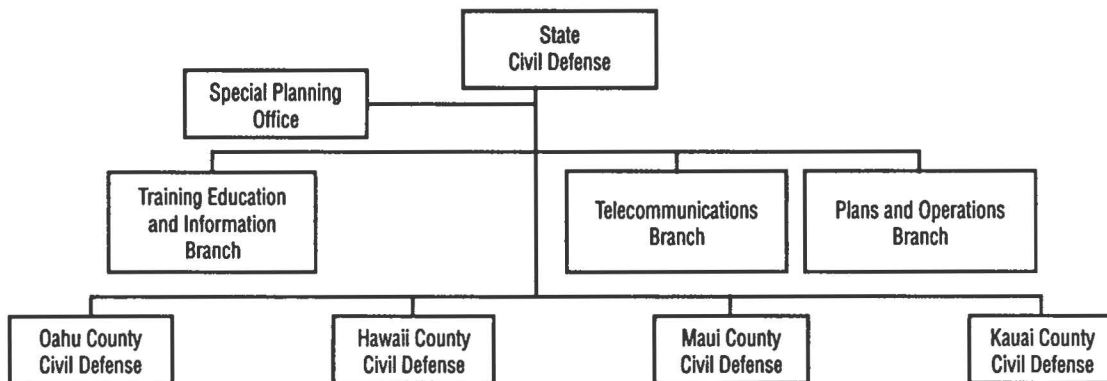

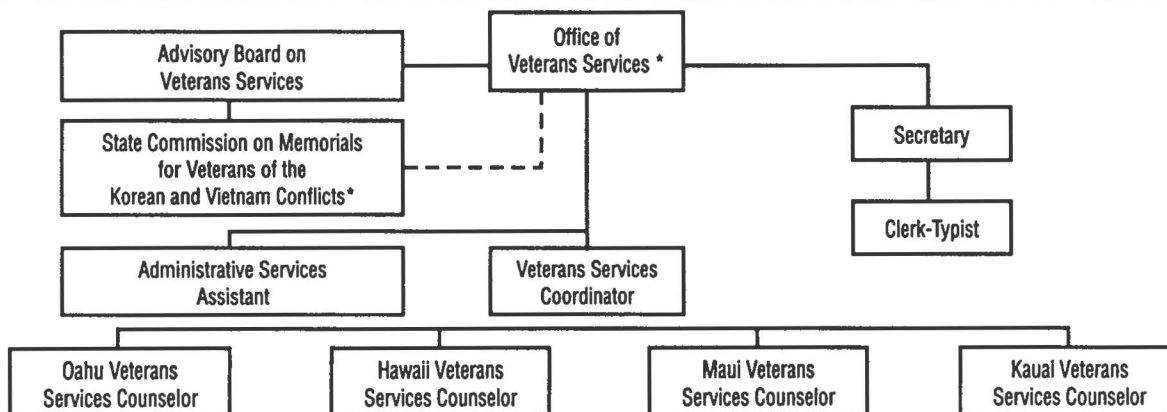

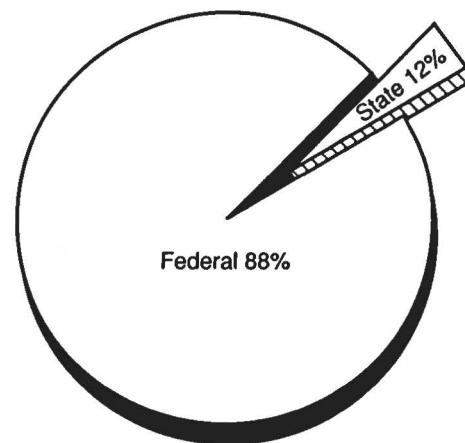

## Hawaii Army National Guard

### Mission

The Hawaii Army National Guard (HIARNG) continually trains to maintain its readiness for state or federal active duty. It is prepared for local or global assignments should the Governor or President order it to active duty.

### Personnel

The authorized strength of the HIARNG increased from 4,252 to 4,258 as a result of the reorganization of some HIARNG units. The assigned strength of the HIARNG stood at 3,500 at the end of fiscal year 1992, a decrease of 54 members from the previous fiscal year and 82.2 percent of the authorized 4,258 positions. This number includes 335 commissioned officers, 115 warrant officers and 3,050 enlisted personnel.

### Organization

The Hawaii Army National Guard consists of the Headquarters, State Area Command, 29th Infantry Brigade (Separate), Troop Command, 111th Army Band and 117th Public Affairs Detachment.

### 29th Infantry Brigade (Separate)

The largest unit in the Hawaii National Guard, the brigade is organized with units on the islands of Oahu, Molokai, Kauai and Hawaii. The federal mission of the brigade is to provide a combat-ready force in the event of a national emergency. As of Sept. 30, 1992, its assigned strength was 2,425 soldiers. This included 189 officers, 17 warrant officers and 2,219 enlisted members.

The brigade is comprised of a headquarters company, two infantry battal-

ions, a field artillery battalion and a support battalion. In addition, separate units include a ground cavalry troop, an engineer company and a signal detachment. This mix of units and equipment provides commanders with a variety of options when employing the brigade for federal or state missions.

### Troop Command

The mission of the Troop Command is to provide command and control over its assigned units. The command's assigned strength, as of Sept. 30, 1992, was 719. This includes 56 officers, 73 warrant officers and 590 enlisted members.

The Troop Command is headquartered at Waiawa Armory in Pearl City on Oahu. It is one of the two major commands within the Hawaii Army

National Guard. The Troop Command includes a combat aviation battalion at Wheeler Army Airfield, a combat service support battalion headquartered at the Wahiawa Armory, two aviation detachments based at Hilo's aviation support facility, a division level tactical rear operations cell at Waiawa Armory and an engineer detachment at Fort Ruger.

The units within the Troop Command provide a broad spectrum of combat and combat-service support. The aviation detachments provide a trained pool of qualified replacement aviators. The supply and service battalion stores and issues supplies, repairs and rebuilds military equipment and maintains vehicles, weapons, helicopters and sophisticated electronic equipment. The organization also provides field services, including laundry and bath, grave registration, baking and renovation of light textiles. The division rear operations cell provides support of division rear operations. The engineer detachment provides utilities repair and maintenance.

### Divisions/Sections Staff

The maintenance division has 86 full-time federal technicians housed at eight support facilities located on five islands. An additional seven soldiers in Active Guard Reserve (AGR) status provide supply support for maintenance programs throughout the Guard. These soldiers support 48 different units and 21 activities.

Employees of this division worked over 200,000 hours during the fiscal year and installed more than a million dollars of repair parts in providing repairs and services to maintain the

equipment of HIARNG. The effectiveness of the maintenance program allowed the HIARNG to exceed the Department of the Army maintenance readiness standard of 90 percent.

The maintenance program was able to keep abreast of the force modernization program. An aggressive education program and the implementation of a computer-assisted program in fiscal years 1992-93 will continue to move the full-time maintenance program forward.

The Hawaii Army National Guard's aviation units include the Headquarters State Area Command aviation section, the 1st Battalion, 193rd Aviation (Attack), and the 451st and 452nd Aviation Detachments. Aircraft inventory includes 15 AH-1S Cobra attack helicopters, 9 UH-1H Huey utility helicopters, 13 OH-58A Kiowa scout helicopters and a C-26B Metroliner, twin-engine, fixed-wing aircraft. The aviation units flew a total of 4,942 hours which represents 100 percent of their annual flying hour program. These flight hours were used to accomplish

mission support, proficiency training, aircrew qualification, unit training and support to civil authorities.

The C-26B Metroliner is a recent addition to the Army National Guard's aviation fleet. It arrived in Hawaii on June 8, 1992, and is capable of transporting 18 passengers and cargo. The C-26B replaced the U-21D Ute fixed wing aircraft which will be relocated to another Army National Guard organization on the mainland.

The two Army Aviation Support Facilities (AASF) assigned to the Hawaii Army National Guard serve as fixed training bases for its training programs. These programs include aircraft qualification, nap-of-the-earth qualification, aerial gunnery training, unaided night qualification and night vision goggle qualification.

### Highlights and Significant Events

The HIARNG continued to support the community through both state and

federally funded programs. The federally funded drug interdiction and eradication program continued and expanded. Added federal dollars allowed for support of the U.S. Customs maritime program. HIARNG soldiers were used to maintain vessels, freeing Customs personnel for direct law enforcement roles. HIARNG also provided administrative and data processing support to the Department of Land and Natural Resources, freeing additional state law enforcement personnel for direct enforcement.

A drug demand reduction program was implemented with federal funds. HIARNG soldiers worked with the Honolulu Police Department's Juvenile Crime Prevention Division in anti-drug and anti-gang programs.

HIARNG soldiers were used to evacuate civilians and to assist in clean-up efforts on Kauai when major flooding occurred in the Anahola area. Procedures and training that were developed earlier in the year to address such disasters were validated at that time.

Other ongoing programs were continued, including the 29th Infantry Brigade's support of the American Lung Association's Superkids competition on Hawaii, Kauai and Maui.

### Training

Hawaii Army National Guard units participated in numerous training activities throughout the year. Headquarters, 29th Infantry Brigade, participated in staff training exercises, including Cascade Peak at Fort Lewis, Washington, and Yama Sakura at Hokkaido, Japan. In May, the 117th Public Affairs Detachment

sent a team to provide video coverage of Exercise Cobra Gold in Thailand. In addition, 38 members of the 111th Army Band travelled to Fiji, Tonga and Tuvalu in June to provide music for military ceremonies during the World War II Commemoration.

In February, 55 soldiers from the scout platoon of Headquarters Company, 2nd Battalion, 299th Infantry, deployed to Australia for Exercise Pacific Reserve. They trained with reserve soldiers from the Australian Army for two weeks at the Australian jungle warfare school in Adelaide, South Australia.

In March, 110 Soldiers from Company A, 2nd Battalion, 299th Infantry, with a platoon from the 1st Battalion, 299th Infantry, flew to Fort Greeley, Alaska, and trained for two weeks with the Alaska Army National Guard.

The remainder of the 29th Infantry Brigade conducted annual training at Schofield Barracks, July 11-25. This year, the brigade units trained on

squad, section and platoon operations. Training also included live-fire exercises and a logistics exercise for the brigade and battalion staffs.

Units of Troop Command completed annual training at two locations during the year.

In June, 80 soldiers from the 291st Maintenance Company deployed to Sagami Army Depot in Japan and provided maintenance support to the U.S. Army, Japan.

The 297th Supply and Service Battalion and the 1st Battalion, 193rd Aviation, trained at Pohakuloa Training Area, July 11-25. The aviation battalion conducted battalion field training exercises which included aerial gunnery training.

The 298th Engineer Detachment completed repair and maintenance projects at Keaukaha Military Reservation in Hilo and at the Mauna Kea State Park, July 11-25.

The 451st Aviation Detachment performed its annual training at Schofield Barracks, Aug. 1-15. The unit pro-

vided aviation support for the Hawaii Military Academy during the Consolidated Officer Candidate School training.

### Hawaii Military Academy

The Hawaii Military Academy (HMA) provided training for Army National Guard units from Hawaii, Alaska and Guam in addition to U.S. Army Reserve soldiers in the Pacific area. The HMA conducted training in five major areas: Officer Candidate School (OCS), Noncommissioned Officer Education System (NCOES), Non-prior Service Personnel Training Program

(NPS-TP), Military Occupational Specialty Qualification (MOSQ) courses and Regional Training Site-Maintenance (RTS-M) courses. In 1992, HMA graduated ten candidates who were then commissioned as second lieutenants. Officer candidates from Hawaii and the state military academies of Arizona and Utah conducted their final two weeks of intensive training at Schofield Barracks, Hawaii, in conjunction with the state military academies of Arizona and Utah.

HMA conducted three basic NCO courses and one advanced NCO course, graduating over 60 NCO's.

HMA conducted two MOSQ courses. The staff trained nine soldiers and qualified them as indirect fire support specialists. It also trained 48 soldiers from Hawaii, Alaska and Guam as infantrymen.

Other courses taught at HMA included the pre-command course for future commanders and the instructor training course for unit trainers.

The RTS-M was recently established at Pearl City, Hawaii, and offers maintenance courses for National Guard, U.S. Army Reserve, and active military soldiers in the Pacific area.

## Hawaii Air National Guard

### Mission

Like its continental counterparts, the Hawaii Air National Guard (HIANG) serves dual missions. Its state mission is to defend Hawaii and its residents from mass violence resulting from natural or human-caused disasters. As a federal organization, it is responsible for providing trained units and individuals for active duty in the U.S. Air Force in time of war, natural emergency or as required by national security.

### Personnel

As of Sept. 30, 1992, the assigned strength of the HIANG was 224 officers and 1,941 enlisted personnel. The total of 2,165 members is 97.4 percent of the 2,222 positions authorized.

### Organization

The HIANG is directed by the commander, Hawaii Air National Guard, and is comprised of the Hawaii Air National Guard Headquarters, 154th Composite Group, 201st Combat Communications Group and 199th Weather Flight.

### 154th Composite Group

The 154th Composite Group (154th COMPG) is the largest of the HIANG organizations. It includes a headquarters, a fighter squadron, a consolidated aircraft maintenance squadron, two aircraft control and warning squadrons, an air control squadron and seven additional support units.

Responsibility for the state's air defense belongs primarily to the 154th COMPG. Located at Hickam Air Force Base (AFB), its fighter squadron is

equipped with F-15A/B Eagles to provide fighter-interceptor capability for the air defense system.

The group's two aircraft control and warning squadrons operate radar sites at Kokee Air Force Station (AFS), Kauai, and Mt. Kaala, Oahu. The two radars are linked to the Hawaii Regional Operations Control Center at Wheeler Army Airfield, Oahu, and provide 24-hour surveillance of the entire Hawaiian island chain.

### 201st Combat Communications Group

Located on the islands of Hawaii, Kauai, Maui and Oahu, the units of the 201st Combat Communications Group (201st CCGP) train to provide command and control communications and air traffic control facilities and services to support air force require-

ments. Its members are prepared to deploy within 24 hours to anywhere in the world with their equipment.

### 199th Weather Flight

The 199th Weather Flight provides meteorological support primarily to the Hawaii Army National Guard's 29th Infantry Brigade (Separate) and secondarily to active and reserve components of the Army and Air Force. When deployed, services provided include continuous 24-hour per day staff weather services, forecasting, observing, and climatological support to the 29th Brigade's tactical operations center and a brigade airfield, drop zone, or helipad. Located at Wheeler Army Airfield, the unit provides weather information to the joint, worldwide meteorological network operated by the Air Force's Air Weather Service, National Weather Service and World Meteorological Organization.

### Highlights and Significant Events

The past fiscal year was characterized by many significant challenges and accomplishments.

With the August retirement of Brig. Gen. Kenji Sumida, Col. Allen M. Mizumoto, the former Deputy Commander for Maintenance, 154th Composite Group, assumed command of the HIANG.

Also in August 1991, Col. Jeffrey H. Okazaki became the commander of the 201st CCGP. He replaced Col. Melvin C. Morris, who was assigned to the 154th Composite Group. That same month, Maj. Barry J. Castellano assumed command of the 293rd Combat Communications Squadron (CCSQ). In April 1992, Maj. Robert H. Maglasang assumed command of the

292nd CCSQ, replacing Lt. Col. Louis S. Macknik, who retired.

In December 1991, in commemoration of the 50th Anniversary of Pearl Harbor, Hawaii Air National Guard personnel participated in various activities that marked this historic occasion honoring those who sacrificed to maintain freedom.

The 154th COMPG focused on the future with the planned activation of the 203rd Air Refueling Squadron (ARS). The first KC-135R Stratotanker aircraft is expected to be on station by the end of 1992. In the interim, 203rd ARS aircrew members and maintenance personnel are being hired and sent to training schools on the mainland. Those aircrew members that are "current" in their flight training try to maintain their flight status with visiting TDY mainland Guard, Reserve and active units. Formal activation will occur in 1993.

Also new on the horizon will be the search and rescue squadron that will become part of the 154th COMPG. Initial work was started this past year that will see activation of the new unit

within two years. The unit will add a whole new dimension to the role that the HIANG plays in service to the nation and Hawaii.

The transition to F-15 Eagles with the Multi-Stage Improvement Program (MSIP) conversion was completed this year. These newer aircraft have superior avionics and weapon systems that further enhance the ability to control the skies.

In recognition of the 154th COMPG's ability to perform, the unit received two "safety" awards in 1991. These were the Air Force Explosive Safety Plaque and the National Guard Bureau Maj. Gen. John J. Pesch Flight Safety Award.

The 199th Weather Flight underwent a crucial restructure of its wartime readiness training in March. An internal combat readiness inspection conducted by the Director of Weather, Pacific Air Forces, reviewed the equipment, training, and procedures the flight would need to fulfill its wartime mission. The inspection was completed successfully, and the weather flight was declared fully combat ready.



### Training

The 154th COMPG's flying mission was greatly enhanced with the deployments of various Air Guard and active duty fighter units from the mainland in support of Dissimilar Aircraft Combat Training (DACT). Numerous air refueling sorties with visiting mainland tanker units further extended flight time and training. The 154th COMPG successfully participated in Air Force, Navy and "Joint" Forces exercises such as RIMPAC in July.

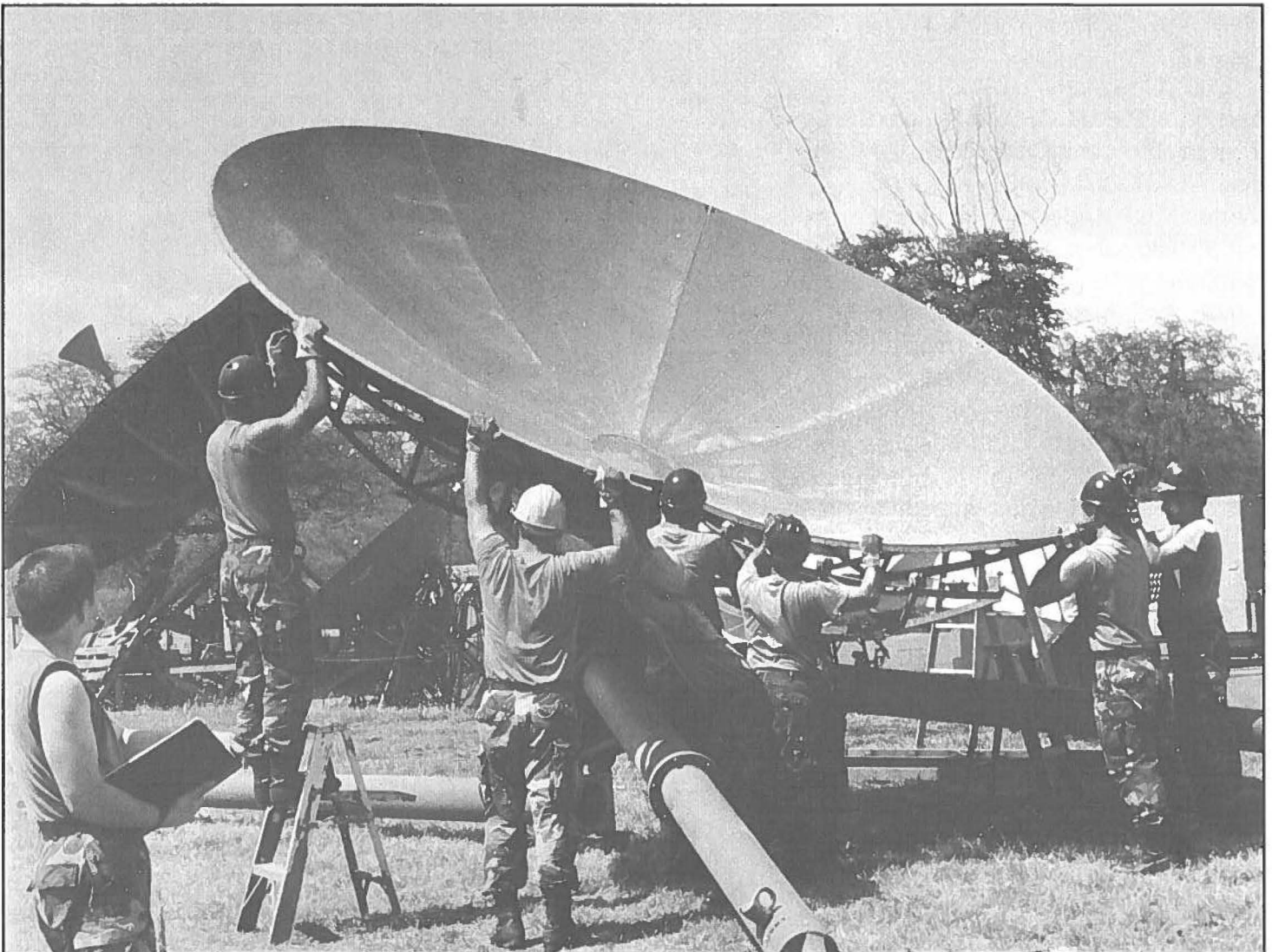
The 154th Civil Engineering Squad-

ron had an "on station" bivouac in February involving Prime BEEF and Prime RIBS field training. The 154th Resource Management Squadron (154th RMS) and the 154th Services Flight (154th SVF) also participated. The 154th SVF sent personnel on deployment to Kulis ANGB, Alaska, for training in June. Accompanying them were personnel from the 169th Aircraft Control and Warning Squadron and the 154th Mission Support Squadron.

The 154th Tactical Hospital deployed to Japan for annual training in

June. There they honed their medical skills in a field environment.

201st CCGP personnel fulfilled an extremely busy training schedule in FY 1992. In July 1991, two dozen 201st CCGP personnel deployed to Ulupalakua, Maui, for systems training as part of a Communications-Electronic Management Staff (CEMS). Sixteen members of the 201st CCGP trained as systems controllers on the TSQ-111, part of the TRI-TAC communications system, during three separate weekends in October and

November 1991 and January 1992. The training gave personnel who are usually not tech-controllers experience with the TRI-TAC equipment.

In January 1992, 21 members of the 201st CCGP graduated from the 201st CCGP Mobility-Survivability School. The course is used to prepare those who are new to Combat Communications or those who want a refresher in surviving under wartime conditions. The course was taught by instructors from the 1820th Reserve Advisor Squadron and the 201st CCGP. Students from other Air National Guard and active duty Air Force units also participated.

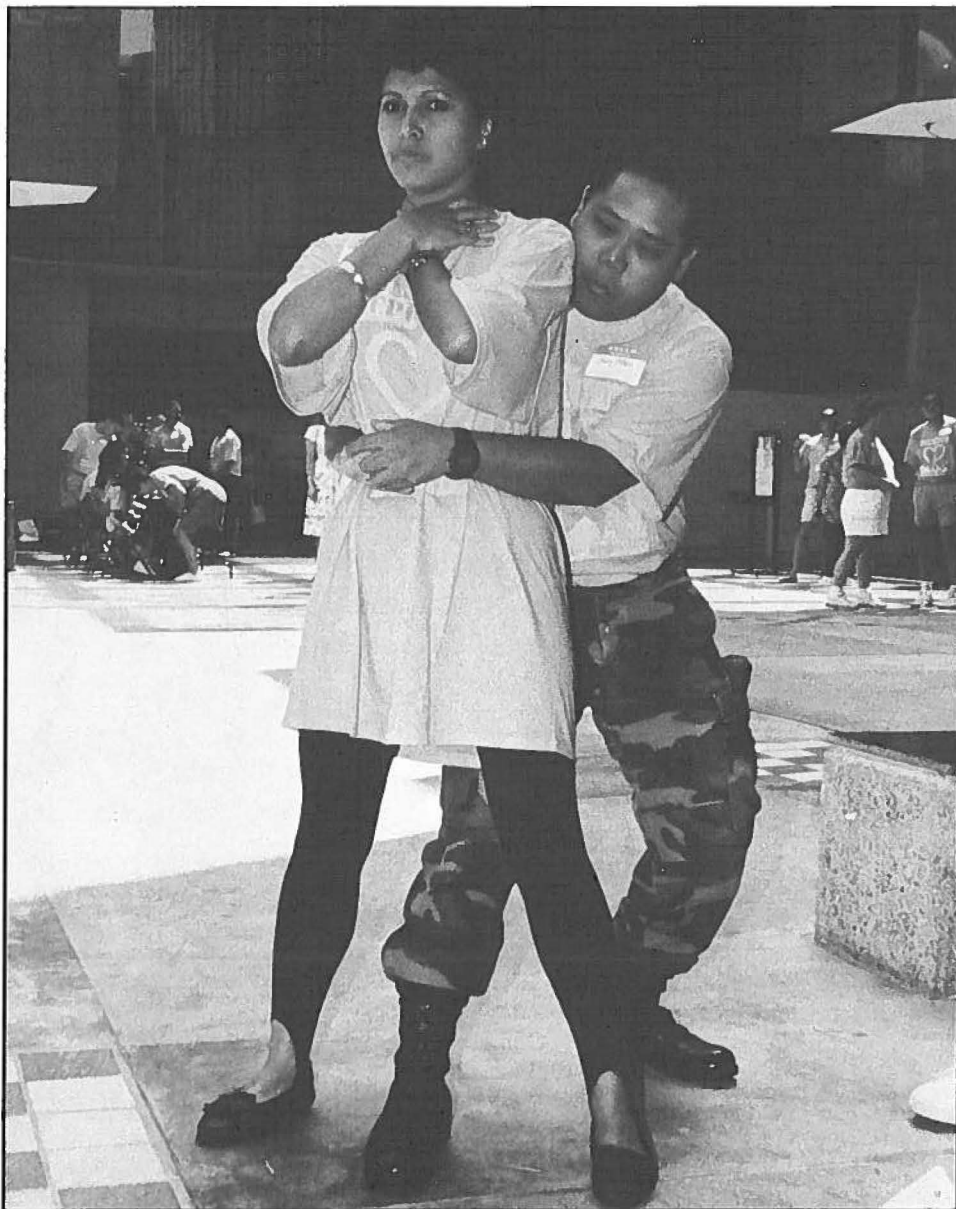
During the March UTA, 20 members of the 293rd CCSQ participated in a satellite communications exercise. A SATCOMM signal was sent to the 4th CCGP, Anderson AFB, Guam, and relayed back to the 293rd CCSQ.

In April 1992, the 201st CCGP deployed the first of 108 personnel to Thailand for Cobra Gold '92. It marked the first time the 201st CCGP had ever deployed that many members to a Cobra Gold exercise, and it was also the first time the 201st CCGP had deployed in such large numbers in support of U.S. Marine forces. Cobra Gold is a combined/joint exercise with the Royal Armed Forces of Thailand.

Also, in April and May of 1992, three 201st CCGP personnel deployed to Honduras for Fuertes Caminos '92. The 201st CCGP personnel were temporarily attached to the 251st CCGP, Ohio Air National Guard. They were assigned as Air Traffic Controllers to the Systems Control Facility. Fuertes Caminos is a joint exercise involving construction of roads and bridges in Honduras.

The 199th Weather Flight actively participated in several field training and command post exercises this past year. Five members of the flight deployed to Pohakuloa Training Area, Hawaii, to provide tactical weather support to the 193rd Aviation, Hawaii Army National Guard, during their field evaluation. Additionally, the weather flight sent five of its members to Japan to participate in Exercise Yama Sakura/

Keen Edge to support the 20th Weather Squadron, PACAF, and the U.S. Marines 3rd Expeditionary Force. Cascade Peak '92 rounded out the year with weather support to the U.S. Army's IX Corps. The weather flight has acquired approximately 95 percent of the tactical equipment necessary to effectively support field operations and conduct rapid comprehensive training.

## State Civil Defense

### Mission

The mission of State Civil Defense is to plan, prepare for, and respond to actual or impending disaster. These actions are applied to protect life and property, restore essential services, ensure continuity of government and coordinate resource management to speed recovery.

Available resources must combat a wide range of hazards stemming from natural and technological sources, as well as war related hostilities. Hazard management is accomplished via four integrated phases:

**Mitigation.** Measures which reduce or eliminate the impact of emergencies or disasters.

**Preparedness.** Plans and procedures for disaster response and recovery, staff training, community information on hazard awareness and

preparedness.

**Response.** Community warning, coordination and application of agency resources for crisis response.

**Recovery.** Short- and long-term efforts to restore the social and economic structure of a community following a disaster.

State Civil Defense also supports Federal Emergency Management Agency (FEMA) strategies, emphasizing the Integrated Emergency Management System. This system identifies all hazards facing a community, analyzes capabilities to manage those hazards, and develops programs to overcome shortfalls.

### Personnel

State Civil Defense is authorized 30 full-time employees during non-crisis periods. During emergencies, staffing is

increased by mobilizing government and volunteer support agencies. The adjutant general serves as the director of civil defense, while the vice director oversees system operations and staff supervision. The vice director also assumes the responsibilities of the director when the director is out-of-state.

### Organization

The civil defense system is comprised of all public and private organizations charged with emergency responsibilities. All state departments and agencies have civil defense coordinators appointed for civil defense tasks. By law, each county is an element of the civil defense system. County mayors typically serve as deputy directors of civil defense for their respective counties, maintaining their county's civil defense infrastructure and operational capability.

State Civil Defense supports the statewide civil defense system by managing federal funds and disaster assistance programs. State Civil Defense also develops county plans and programs, and provides technical assistance and staff training. If an emergency depletes county resources, the county may seek assistance through State Civil Defense. If disaster impact escalates beyond state resource capabilities, the state requests federal assistance through the Federal Emergency Management Agency.

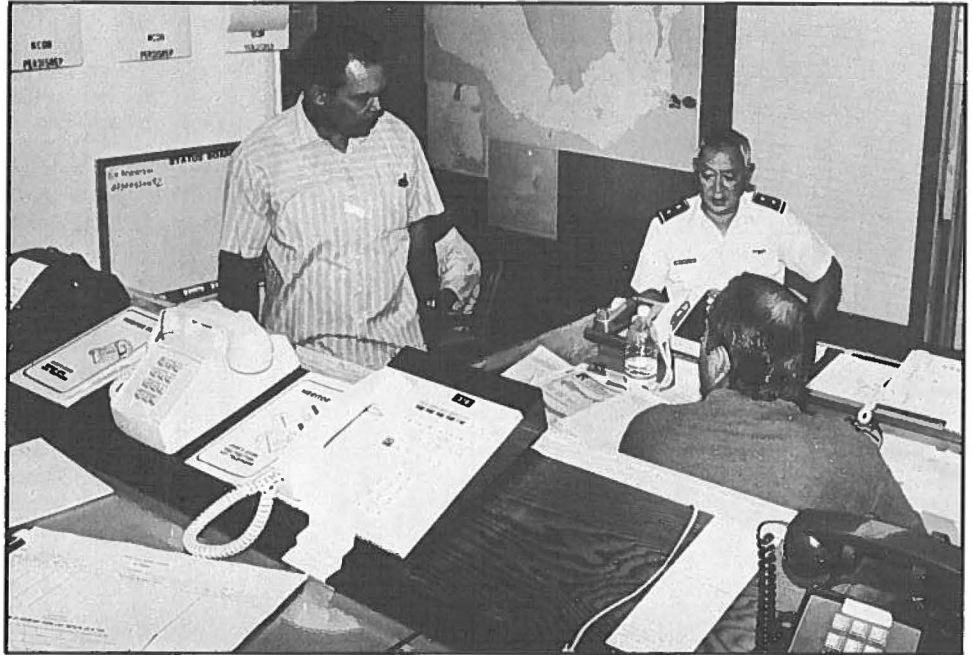
**State Civil Defense Advisory Council.** Made up of seven members appointed by the Governor, the council meets quarterly to discuss programs and projects conducted by State Civil Defense. Serving on the Advisory Council for 1992 were Reuben Yoshida, chair, Sherman Thompson, Gabe Kilakalua Jr., Richard Yonezaki, Frank T. S. Kim, Alfred O. Souza Sr., and Tadao Okimoto.

**Hawaii State Earthquake Board.** Formed in August 1990, the volunteer 13-member board meets quarterly to identify priorities for earthquake probabilities, hazard mitigation and preparedness. The board draws its expertise from the scientific, academic, engineering and emergency management communities.

### Highlights and Significant Events

**Fire outbreak on Molokai.** The wildland fire was one of the worst recorded for the island of Molokai. The fire started on June 21, 1991.

It was contained for three days before flaring up again. Sporadic winds fanned its spread, and by the time the

fire was extinguished on June 28, nearly 13,000 acres of land had burned, including nearly 6,000 acres of forest and game preserves. A total of 37 fire fighters battled the blaze for seven days, aided by military and civilian helicopters. Military assistance included Hawaii National Guard troops, Army Guard helicopters and Air Guard C-130 cargo aircraft.

**Heavy rains, flooding dampen holidays for Kauai.** On Dec. 13 - 14, 1991, local rains and flooding resulted in four casualties and caused over \$7 million dollars in property damage on Kauai. Flash floods struck suddenly in the early morning hours of Dec. 13, causing the Anahola stream to override its banks. Heavy rains and flooding were also reported at other sites around the island. A Disaster Application Center was open from Dec. 27 to Jan. 4, to aid Kauai flood victims. In addition to state and county programs, Small Business Administration loans were made available. The Red Cross was immedi-

ately on scene, aided by other volunteer agencies, to care for critical family needs. The Kauai community, including Hawaii Army and Air National Guard troops, turned out in force to help friends and neighbors. Over 287 applications for disaster assistance were taken and Small Business Administration loans topped \$270,000.

**Kilauea claims more homes.** In late October 1991, upslope lava from Kilauea's Kupaianaha vent claimed the last remaining homes in the Royal Gardens subdivision. The subdivision, severely damaged by earlier flows, had been largely vacant for two years.

October's loss was the first since early January 1991, and the 180th structure claimed by lava since the beginning of the eruption. Active since January 1983, the Kilauea eruption has overrun an estimated 2,500 house lots and caused over \$60 million in property damage in the Big Island's Puna District. The area was declared a federal disaster in mid-



1990, with an incident period retroactive to January 1983. The declaration remains open for possible future claims as the lava flow remains active in the Kalapana area.

**Rainfall Information System to help monitor heavy rains.** The Rainfall Information System is the result of conclusions reached by the Hazard Mitigation Task Force formed after the 1987 New Year's Flood on Oahu. A key recommendation involves increasing local capability to monitor heavy rainfall for improved decision making and response.

Once the system is installed, the rainfall data will be telemetered from designated rain gauges to the central weather office and into the civil defense system. The system will also be programmed for automatic notification of appropriate CD agencies when set total rainfall limits are reached or rainfall rates are exceeded. The rain gauge network will also complement National Weather Service advisories, providing pre-indication of changing rainfall conditions.

The statewide rainfall and flood information system will be a mix of new

rain data gauges and improvements to existing National Weather Service data collection and reporting equipment. A total of 14 rain gauges are being installed at sites selected by the counties.

**Hardware, software upgrades help improve information systems.** Major emphasis in 1992 focused on map database upgrades to improve mapping accuracy, and added programming for hazardous materials management. The Integrated Emergency Management Information System (IEMIS) is used to track resources,

services and infrastructure which can be readily called up and displayed for emergency use. Map layers added in 1991-92 included tsunami evacuation zones, outdoor siren sites, in-ground fuel storage tanks, shelter locations, road and highway systems, coastlines, airports and other infrastructure. The geo-information system is installed in all counties for planning and operational use.

State Civil Defense purchased the CHIEF program in fiscal year 1992 to install a fully integrated system to manage accidental release of hazardous materials. A product of Westinghouse Corporation, CHIEF was originally developed as an off-site planning tool for nuclear power plants and expanded to chemical release applications. After successful in-house project demonstrations, a hazardous materials database will be installed for use by emergency operations staffs and first responders statewide.

**State CD hosts Pacific Region Conference.** Over 50 emergency management officials convened in Honolulu, Sept. 18 - 19, 1991, for the Pacific Insular States Earthquake and Hurricane Conference. The two-day agenda focused on hazard risk and analysis and preparedness factors. Representatives from FEMA, the Hawaii Volcano Observatory, National Weather Service, Pacific Tsunami Warning Center, Joint Typhoon Warning Center and the University of Hawaii addressed program issues and perspectives on earthquakes, tsunamis and hurricanes.

Participating insular states included Guam, the Northern Marianas, Palau, the Marshall Islands, the Federated States of Micronesia and American Samoa. This group is also part of a consortium formed in Honolulu in 1988 to consolidate issues and strengthen representation in national and regional emergency management arenas.

September's conference proved timely. From late November through mid-December, several Pacific islands saw four tropical cyclones enter local waters with devastating results.

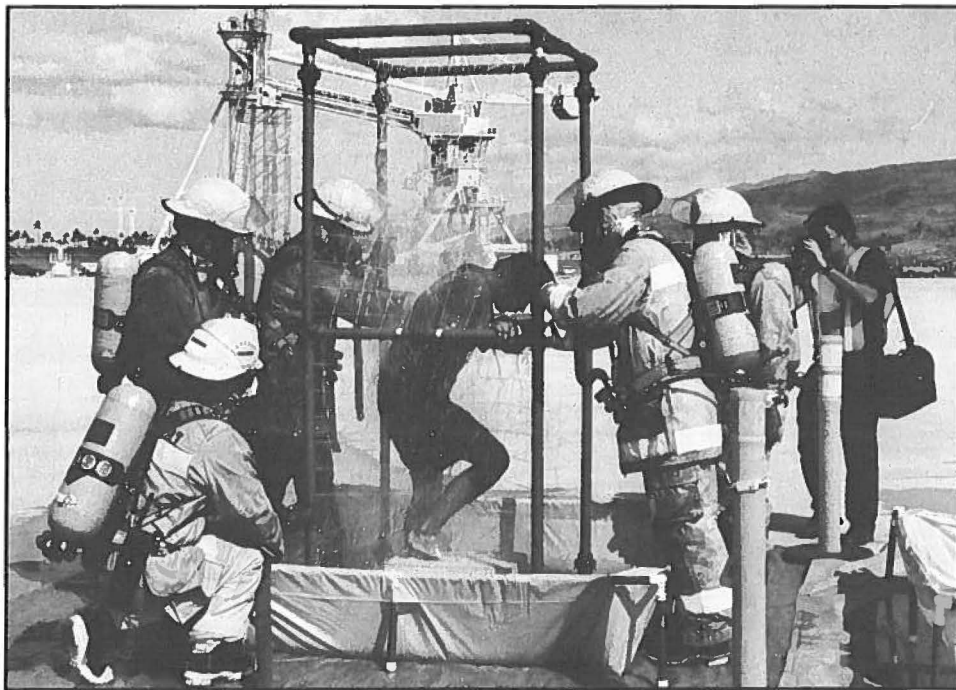
### Training

Training and exercises are key factors in maintaining the readiness of Hawaii's emergency management system. In 1992, 348 participants attended professional development courses aimed at familiarizing government agencies, local businesses and volunteer organizations with the civil defense system and sharpening performance skills. A total of 15 training sessions were conducted in all counties during the fiscal year.

Exercises also play a major part in readiness and response skills. Last year, 10 exercises were conducted statewide focusing on natural and technological hazards. A full-scale exercise using a tsunami scenario was conducted mid-year to evaluate response plans and procedures. Involving hundreds of participants, the annual event gave hands-on training to people who would be called upon to respond to an actual tsunami threat.

Added to the training agenda in 1992 was the acquisition of the statewide Hazardous Materials Training Program, formerly under the State Department of Health. Official transfer to State Civil Defense was completed in early November.

The training program is designed for frontline responders to oil and hazardous materials incidents. Local police, firefighters, public works and transportation crews are usually the first called to the scene.

## Office of Veterans Services

### **Mission**

The Office of Veterans Services (OVS) is the principal state office responsible for the development and management of policies and programs related to veterans, their dependents and/or survivors.

### **Personnel**

The Office of Veterans Services is authorized 19 full-time state employees. An additional full-time position for the Oahu OVS and two full-time positions for the Hawaii State Veterans Cemetery (HSVC) have been authorized and will be filled in fiscal year 1993.

### **Organization**

The Office of Veterans Services consists of the director, staffs of the

Veterans Services branch and the Hawaii State Veterans Cemetery branch, and administrative and office services staff. The Hawaii State Veterans Cemetery, located in Kaneohe, Oahu, is staffed by a cemetery operations manager, cemetery operations coordinator, secretary, tractor operator and three general laborers. Veterans Services units on Hawaii, Kauai, and Maui consist of a veterans services counselor and a clerk typist. The Oahu veterans services staff consists of a veterans services coordinator and veterans services counselor.

### **Highlights and Significant Events**

The Hawaii State Veterans Cem-

etry became operational on July 31, 1991, with a ribbon cutting ceremony attended by the Governor and representatives from state and county government, the National Cemetery System, the armed forces, and veterans of all wars. The first interment was conducted the next day on August 1, 1991. Administration and operations of the HSVC were directed from a temporary office trailer while permanent buildings were under construction.

The 1992 session of the legislature, prompted by concerns about needs to identify, contact, register and track Hawaii's 119,256 veterans, approved funding for full installation of the Office of Veterans Services Information System (OVSIS) and for the publication of a quarterly veterans newsletter.

## Office of Veterans Services

Presentations to veterans' groups, retirees, and active duty personnel continued to be the major means of raising visibility and publicizing veterans services. Outreach activities throughout the state included, but were not limited to, presentations at the transition assistance programs, career and college fairs, senior citizen organizations, and many veterans' groups on veterans' benefits and issues, and participation in the 50th anniversary commemoration of the attack on Pearl Harbor. The staff also continued monthly visits to the islands of Molokai and Lanai, as well as the non-urban areas of each county.

In 1992 there was a 20% increase in the number of veterans and dependents served, partly due to a high level of activity with the transition assistance programs.

The Office of Veterans Services worked with: the department's Engineering Office to continue to develop the Hawaii State Veterans Cemetery, upgrade neighbor island veterans cemeteries, plan for the design and construction of memorials for the casualties of the Korean and Vietnam conflicts and the Kauai Veterans Center; the Department of Land and Natural Resources on construction of the Maui Veterans Center; the Department of Veterans Affairs on establishment of the Spark M. Matsunaga Medical Center and the Pacific Center for Post Traumatic Stress Disorder; local agencies to provide support to Filipino veterans seeking U. S. citizenship; schools, veterans' organizations and military groups to provide leis for Punchbowl on Memorial Day; veterans organizations to honor veterans of all conflicts; the West Hawaii Veterans Association on the establishment of a West Hawaii Veterans Memorial Cemetery at

Pu'u O'o; and HAWAII INC., to develop a database of veterans services.

Veterans services counselors serve as advisors to the Mayor's Vet-

erans Advisory Committees, Councils/Committees on Aging, Kauai Veterans Association, Big Island Veterans Association and Maui Veterans Council.

As the state's primary advocates for veterans, the director and the veterans services coordinator represented the Governor at a wide variety of ceremonies, including Memorial Day and Veterans Day services and parades, groundbreaking for the Kauai Veterans Center, and the American Legion, Disabled American Veterans and Veterans of Foreign Wars conferences. They also appeared before the Legislature to testify for needed services.

During the year OVS staff used the state's Video Conference Center for a staff meeting, thus saving travel time and money; purchased a modem for interactive searches on legislative databases, e-mail, etc.; installed OVSIS on the new Oahu OVS office computer; received legislative approval to purchase computers for the other OVS sites; and attended numerous hands-on hardware and software training sessions.

With closure of the National Memorial Cemetery of the Pacific (Punchbowl) for first time casket burials, the Hawaii State Veterans Cemetery received numerous requests for interment services. During fiscal year 1992, 331 veterans and dependents were interred. It was a period of rapid growth and learning as procedures were established, equipment purchased, staff hired, oriented and trained, and public hearings held throughout the state to receive public feedback before finalizing "Hawaii State Veterans Cemetery Rules of Practice and Procedure."

OVS volunteer efforts were recognized at the 16th Annual First Lady's Outstanding Volunteer Awards Program. Mike & Da Mekaniks, the team of University of Hawaii software engi-

neers who designed the Office of Veterans Services Information System (OVSIS), and James Ishii, a loyal OVS volunteer from Kauai, were acknowledged.

The Advisory Board on Veterans Services convened monthly to advise the director. The Board met in each county during the year and, in response to public demand, held its first evening meeting on Oahu. Advisory Board members included: Louis Kaoiwi, John K. Iwamoto, Walter J. Hayes, Alfred Los Banos, Raymond Sumikawa (deceased), Barbara Ann O'Connor, and Judith H. Worobe (Chair).

The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts continued to advocate for memorial sites and designs. A series of meetings and hearings was held to gather public comment. Towards the end of its session, the 1992 Legislature voted to reopen the design competition, specifying the location of the memorials and establishing guidelines for the height and proportion of the design.

## Training

State development was emphasized this fiscal year. Staff trained in areas related to their work, including supervision management, suicide prevention, team building, landscape and grounds management, ethics, and database management.

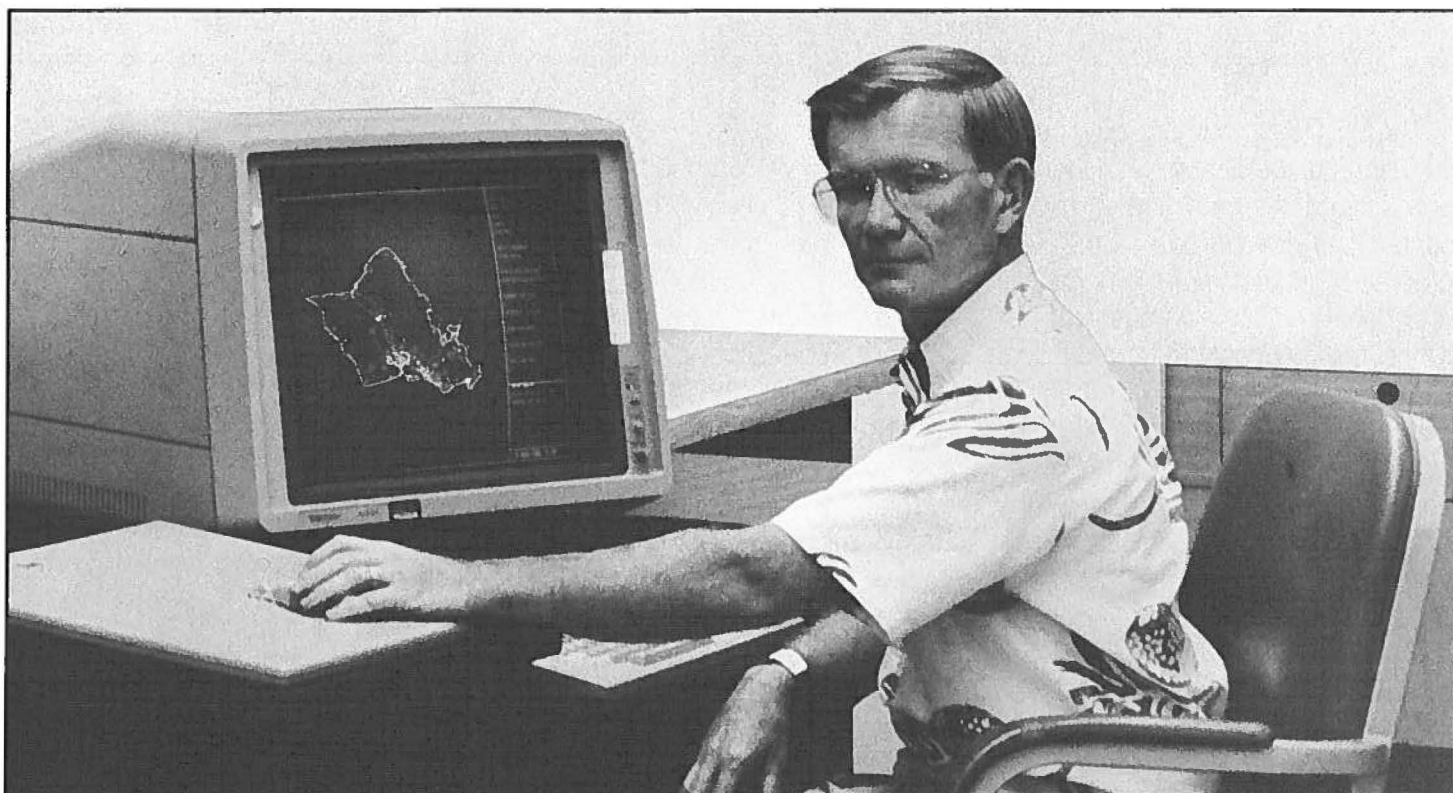

## Administrative Services Office

---

### **Mission**

The Administrative Services Office (ASO) provides military and state administrative support to the Office of the Adjutant General. It coordinates and controls all planning, programming, budgeting and execution of departmental programs as directed by the adjutant general.

### **Personnel**

The Administrative Services Office is authorized 18 full-time state employees.

### **Organization**

The Administrative Services Office is comprised of three primary staff elements. These are the executive support, personnel and financial management services sections.

### **Executive Support**

The ASO provides centralized office services and communications management, to include the monitoring, review, distribution and filing of communications received from federal, state and local governments and the civilian community. The ASO is also responsible for maintaining close liaison with Hawaii's congressional delegation and legislature, and for administering all legislation affecting departmental programs. The office prepares correspondence and testimony concerning various legislative proposals. The military component of the ASO provides executive support services to the adjutant general. It also coordinates the activities of the adjutant general's military staff, composed of members of the Hawaii National Guard.

### **Personnel Management Services**

The state personnel management services staff administers the state employee personnel program which includes recruitment and placement, classification, salary, leave, employee performance, employee relations, out- and in-service training, personnel records, occupational safety and health, and maintenance of workers' compensation.

### **Financial Management Services**

The state financial management services staff administers and controls state general fund appropriations, state administered federal funds and matching fund grants under the Federal Emergency Management Assis-

tance Program. The staff also provides centralized control and accounting of all state property assigned or issued to the department.

### Highlights and Significant Events

There were 178 permanent state positions authorized during the year, of which 163 were filled by June 30, 1992. Additionally, 29 temporary positions were authorized and 23 were filled as of the end of the fiscal year.

During the fiscal year, the following types and number of personnel actions were taken:

With regard to performance ratings, 60 individuals received very satisfactory ratings representing 32 percent of the state work force. From these, six sustained superior performance awards were submitted and approved during the fiscal year. The average monetary award amounted to \$200.

The 1992 recipient of the Adjutant General's Award for Distinguished State Service is Mr. William F. Norris, assistant civil defense planner for the State Civil Defense Division.

During the fiscal year, there were 25 reportable cases of work-related injuries involving state employees which reflect a 19 percent increase of reportable cases. There was a total of

301 lost workdays, or an average of 12 workdays per injury, which reflects a 33 percent increase of lost workdays.

Additionally, there were 17 other workers' compensation injuries involving drill status National Guard personnel. This is an increase of seven cases over the previous fiscal year. The total compensation payment for the year amounted to \$7,282, a 17 percent decrease in cost.

The Administrative Services Office, through its fiscal staff, administered and controlled \$10,117,184 in State general fund appropriations and \$1,821,913 in Federal fund appropriated receipts. Restricted as efficiency savings was \$196,177 of the original general fund appropriation.

The net general fund appropriation of \$10,117,184 was comprised of \$6,002,137 from the DEF 110 (departmental operating program), \$1,475,047 from the DEF 112, (services to veterans program), and \$2,640,000 for major disasters, \$1,000,000 of which is solely for matching federal disaster relief funds.

Total expenditures and encumbrances, less unallotted disaster funds in both programs DEF 110 and DEF 112 amounted to \$7,313,361 for an expenditure rate of 97.8 percent, leaving a general fund lapsing balance of \$163,823. Federal fund expenditures and encumbrances amounted to \$1,665,539, leaving a reversion balance of \$156,374. The federal reversion balance was due to lower than projected federal fund receipts for State Civil Defense accounts. Table 5 in the Appendix depicts the distribution of general fund appropriation, appropriated receipts and expenditures by programs, organizations and cost elements.

Additionally, the fiscal staff administered three Federal fund holding and disbursing accounts. Table 6 in the Appendix reflects the status of these accounts as of June 30, 1992.

The department's cash receipts for the year amounted to \$5,628,869. Of this amount, \$24,800 was credited to the State general fund, \$68,704 to the general fund operating account, and \$5,535,365 to special (Federal) fund operating accounts. The sources and fund accounts to which they were credited are depicted in Table 7 of the Appendix.

In administering the state finances for the year, the fiscal staff processed 4,335 purchase orders, 1,011 summary warrant vouchers, 69 payroll vouchers, 77 bills for collection, 80 Federal fund claims invoices, 110 treasury deposit slips, and 930 petty cash checks.

The department administered and accounted for state program funds under an in-house developed system and the statewide Financial Accounting and Management Information System (FAMIS). Information is transmitted to the Department of Accounting and General Services via the department's direct on-line terminals.

Federal funds for civil defense program activities amounting to \$913,545 were received as 50-50 matching fund grants under the Federal Emergency Management Assistance Program (Public Law 85-606) and Civil Defense Maintenance and Service Program (Public Law 920); and as 100 percent federal funded contract grants for radiological instrumentation/maintenance and calibration, emergency management training, disaster improvement, population protection planning, earthquake preparedness and

radiological defense planning and development.

Federal funds for the Hawaii Army and Air National Guard amounting to \$1,146,261 were received under five separate cost reimbursable operations and maintenance service contracts negotiated between the National Guard Bureau and the State Department of Defense. These contracts provided for reimbursements of 100 percent, 80 percent, and 75 percent of the authorized costs to operate and maintain buildings and grounds occupied by the federally-supported activities of the Hawaii National Guard.

Funds received under these contracts are deposited into the state trea-

sury as appropriated receipts or as refunds of fringe benefit payments advanced by other state agencies.

During the year, the department added to its inventory of property 372 items valued at \$1,727,350 and disposed and declassified 126 line items of surplus or unserviceable property valued at \$142,632.

The fiscal staff also administered

the short-term use and rental of departmental facilities by coordinating and processing 55 separate applications for use of armories and grounds located throughout the five major islands. The rental fees and utilities reimbursements collected amounted to \$14,951. The department's property inventory as of June 30, 1992, is provided below.

## U.S. Property and Fiscal Office

### Mission

The mission of the U.S. Property and Fiscal Office (USPFO) for Hawaii is to receive and account for all funds and property of the United States in possession of the Hawaii National Guard, ensure that federal funds are obligated and expended in conformance with applicable statutes and regulations, ensure that federal property is maintained and utilized in accordance with National Guard Bureau directives, manage the federal logistics systems for Hawaii, and provide the support necessary for the transition of mobilized units to active duty status.

### Personnel

The U.S. Property and Fiscal Office for Hawaii is authorized 83 full-time federal technicians.

### Organization

The U.S. Property and Fiscal Office is organized as follows: Administration Office, Data Processing Installation, Analysis and Internal Review Division, Resource Management Division, Purchasing and Contracting Division, and Supply and Services Division.

### Administration Office

This office performs administrative services in support of the U.S. Property and Fiscal Office operations by maintaining a centralized publication library, providing reproduction services, receiving and processing office mail, and providing typing and word processing services.

### Data Processing Installation

The Data Processing Installation

provides services to the U.S. Property and Fiscal Office, Hawaii Army National Guard, State Maintenance Office, Support Personnel Management Office, Standard Installation/Division Personnel System Branch, and Army Aviation Support Facilities. The installation operates a Burroughs B1955 and two UNISYS 5000/80 mainframes. Application software is slowly being migrated from the Burroughs to the UNISYS system and should be completed in 1993. Installation of a Defense Data Network and an electronic mail capability enables worldwide communication and data transfer.

### Analysis and Internal Review Division

Internal reviews are conducted by this division to ensure federal resources are properly managed and utilized. Emphasis is placed on evaluating the



effectiveness of internal controls and determining whether the Hawaii National Guard is operating efficiently and economically.

### Resource Management Division

Federal funds allotted to the Hawaii National Guard from Congressional appropriations are managed by this division. Separate offices administer funds assigned to Army and Air operations.

The Army Guard office, located in the Diamond Head Crater, is composed of the budget officer, staff accountant, fiscal accounting branch, and pay and examination branch.

An assistant USPFO for Air (fiscal) controls funds allocated for support of the Hawaii Air National Guard. This office is located at Hickam Air Force Base.

### Purchasing and Contracting Division

Purchasing and contracting services are provided by this office to all activities of the Hawaii National Guard by sealed bids, competitive proposals, and small purchase procedures in accordance with federal acquisition regulations. Purchases are made from commercial vendors located throughout the state of Hawaii and continental United States.

### Supply and Services Division

This division, organized into Stock Control, Supply and Traffic Branches, provides logistical support and guidance to the Hawaii Army National Guard.

An assistant USPFO for Air (Property) provides logistical support and guidance to the Hawaii Air National Guard. This office is located at Hickam Air Force Base.

A full-time Scheduled Airlines Traffic Office, established within the Traffic Branch, provides the entire array of transportation services, i.e., making plane and hotel reservations, writing airline tickets, handling air freight, arranging car rental reservations and other travel requirements.

### Highlights and Significant Events

Federal funds used by the Army National Guard during the federal fiscal year totaled \$44,242,430.

Federal funds used this year by the Air National Guard amounted to \$50,656,374.

Table 4 of the Appendix reflects federal dollars used between Oct. 1, 1991, and Sept. 30, 1992.

Military payrolls for the Army and the Air Guard totaled \$34,736,864 this federal fiscal year.

During federal fiscal year 1992, local purchases and contracting support of Hawaii National Guard units and activities totaled \$6,441,027. Of this total, \$3,636,844 represented architectural engineering services and construction contracts.

A total of \$6,215,348 was spent to procure supplies and equipment for the Hawaii Army National Guard. The Logistics Division maintained an inventory of \$6,068,535, which included wartime contingency stocks valued at \$3,968,428.

The Air National Guard received \$2,523,815 for supplies. The base supply operation processed 490,891 transactions in federal fiscal year 1992, a monthly average of 40,907. The in-house inventory value was \$54,246,074 at the beginning of the federal fiscal year; the stockage effectiveness rate was 78.7 percent. At

year's end, the inventory value was \$61,298,475, with stockage effectiveness rate at 86.55 percent.

The Traffic Branch arranged transportation for a total of 7,148 individuals: 3,204 for military interisland airlifts, 982 for commercial trips to the mainland, and 2,962 for commercial interisland trips. A total of 2,385 tons of cargo was shipped during the fiscal year: 1,095 tons for annual training, five tons for the mainland, and 1,285 tons for interisland destinations. The total spent to transport personnel and equipment is shown in Table 4 (Appendix). The use of the Scheduled Airlines Traffic Office provided an estimated savings of \$1,727,574 for federal fiscal year 1992.

Two UNISYS 5000/80 computer systems have been installed in the Data Processing Installation. The UNISYS brings new technology and challenges to the staff and to all future users of the system. The UNISYS will completely replace the Burroughs within two to three years.

A total of three reviews were completed by the Analysis and Internal Review Division during federal fiscal year 1992.

## Support Personnel Management Office

---

### Mission

The Support Personnel Management Office (SPMO) is a consolidated office that provides personnel and manpower management administrative support services for all federal full-time personnel programs. The office serves as the adjutant general's single point of control for managing and administering Hawaii Army and Air National Guard personnel programs.

### Personnel

The Support Personnel Management Office is authorized a staff of 16 federal technicians and three Active Guard/Reserve (AGR) soldiers.

### Organization

A standard National Guard structure prescribes that the personnel office be organized with the following operating sections: personnel management, employee services, military duty management, military duty services, equal employment opportunity, labor relations and personnel data systems. The office is centrally located and all records and authorized staff are co-located to provide a single point of contact for personnel.

### Personnel Management Section

Section staff members develop policy recommendations, procedures, and plans in compliance with U.S. Office of Personnel Management and National Guard Bureau directives. The section is responsible for major program areas such as position management and classification, manning control, staffing, train-

ing, employee relations, performance management and recognition, incentive awards, disciplinary and adverse actions, grievances and appeals, personnel management evaluation and maintenance of the personnel data system. It furnishes technical advice and assistance to management officials, individuals and staff personnel.

### Employee Services Section

This section provides a wide range of servicing to technicians throughout their employment life cycle. Beginning with employment processing and new technician orientations, the staff furnishes information on employee benefits, processes personnel actions, maintains individual technician personnel records, ensures proper pay administration, administers the Federal Workers' Compensation Program and processes retirements.

### Military Duty Management Section

Army Active Guard/Reserve (AGR) listed personnel career management and tour retention processes, recruitment and advisory services take up much of this section's time. Unlike their staff counterparts who administer the Army and Air National Guard technician programs in compliance with common directives, the AGR management staff administers the military programs based on policies and procedures established by the Army, Air Force and separate National Guard directorates.

### Military Duty Services Section

This section is the point of contact for commanders, supervisors and individuals seeking AGR administrative services and assistance pertinent to pay, benefits and entitlements. The addition of a medical administrative specialist has vastly improved coordination with military and civilian medical care providers who treat AGR personnel and their dependents on Oahu and the neighbor islands.

### Equal Employment Opportunity Section

The equal employment manager plans, develops and administers programs for all employees (to include state personnel) relative to equal employment. Programs administered include the affirmative employment programs with special emphasis on women and other minority issues, equal opportunity complaints processing, discrimination investigations and related training to departmental personnel.

### Labor Relations Section

This section provides federal labor relations services within the department. Two locals of national labor organizations are exclusive representatives of non-supervisory technicians in three bargaining units. Typical tasks include contract administration, management advisory services and labor management relations training. The section also serves as point of contact for union and other federal labor relations representatives, and as management's representative in dispute resolution and contract negotiations.

## Personnel Data Systems

The National Guard Personnel Data System (civilian) was recently installed to provide automated data processing and storage for technician personnel actions. This table-driven, on-line system has the ability to process and store information on personnel actions, establish and monitor suspenses and produce reports.

## Highlights and Significant Events

Federal full-time support personnel authorizations are based on unit priorities. Although Army National Guard authorizations were reduced slightly, the personnel management section has been hard at work filling the full-time authorizations for an Air National Guard refueling squadron to be activated in the next fiscal year.

Ten Air National Guard technicians received merit pay increases under the Performance Management and Recognition System. Wage grade increases were effected for 152 Army and 333 Air National Guard technicians in November 1991; 145 Army and 256 Air National Guard general schedule technicians received salary increases in January 1992.

Fifty-seven Army National Guard full-time personnel attended training at the National Guard Professional Education Center in Little Rock, Ark. The center meets training needs on a centrally funded basis, cost-free to the state.

The U.S. Office of Personnel Management, Hawaii Joint Training Board, and private sector vendors trained 91 Army and 120 Air National Guard technicians in a variety of work-related subjects this year. Approximately \$72,415 in federal funds were expended for full-time personnel training.

Retirement and service awards luncheons were held in August 1991 and January 1992 to honor and recognize 26 retirees, 11 length of service awardees and the recipient of the Adjutant General's Award (Department of Defense State Employee of the Year).

## Engineering Office

### Mission

The Engineering Office provides the entire spectrum of professional engineering services to the Army Na-

tional Guard, Air National Guard, State Civil Defense and Office of Veterans Services divisions as well as departmental staff sections to enable them to

carry out their statewide programs.

The major responsibilities are to plan for, administer and supervise the following:

- Capital improvement projects
- Major and minor construction projects
- Consultant contract services
- Maintenance and repair projects
- Janitorial/custodial and ground maintenance programs
- Real property management
- Environmental and energy conservation programs

### **Personnel**

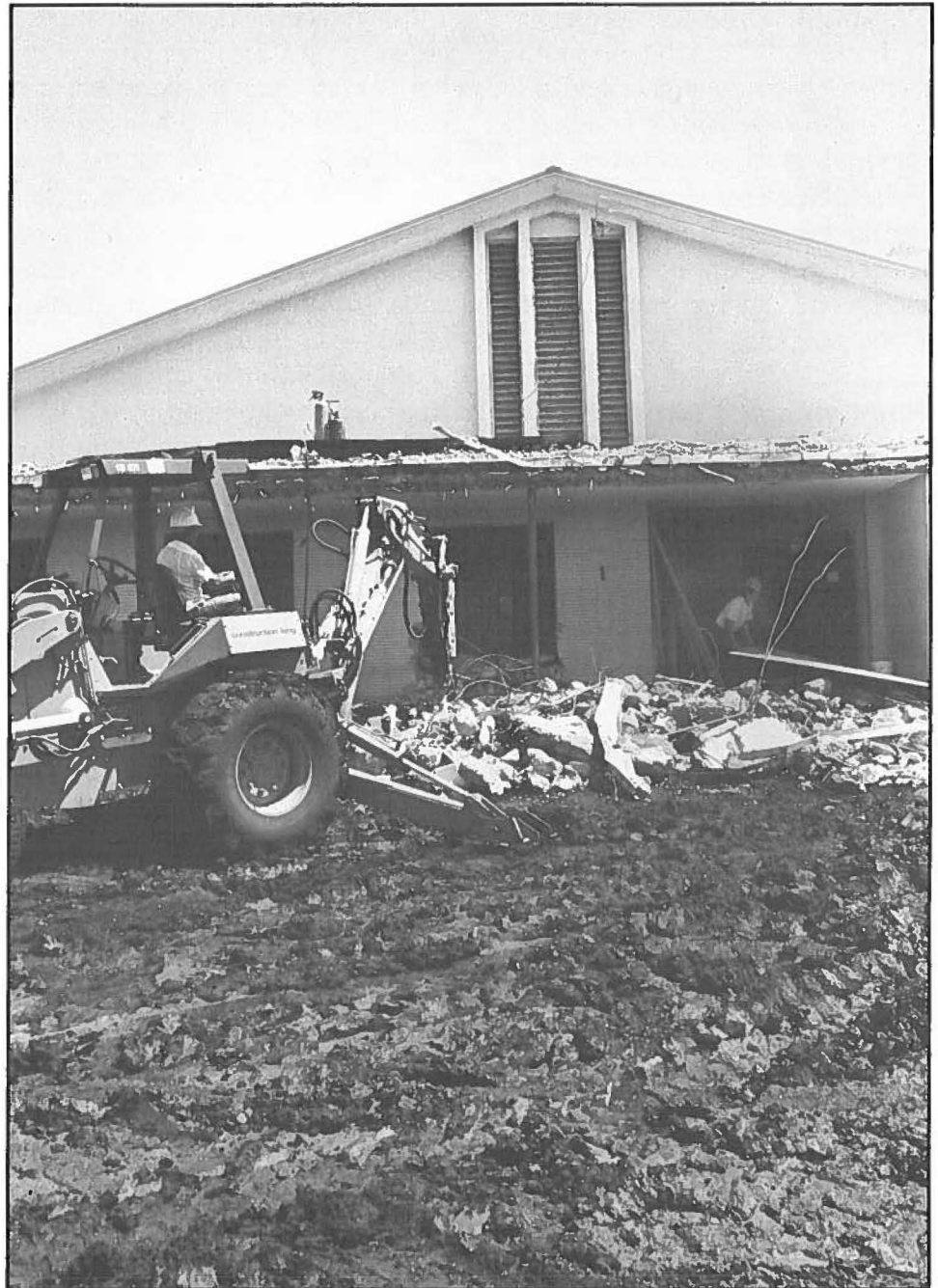
The Engineering Office is authorized 48 state, seven federal and two Active Guard and Reserve (AGR) positions.

### **Organization**

The Engineering Office consists of seven major staff responsibilities: Office Services, Contracting and Engineering Services, Maintenance Services, Air National Guard Engineering Services, Army National Guard Engineering Services, State Civil Defense Engineering Services and Office of Veterans Services.

### **Repair and Management Projects Awarded**

Recurring minor maintenance, repairs and modifications of facilities are accomplished by in-house maintenance personnel on a time-and-materials basis, or by formal and informal construction contracts. This program is supported by federal, state or joint federal/state matching funds through separate Army and Air Service Contracts or Army National Guard Training Site Contracts. The federal contracts under the Service and Training Site Contracts for federal fiscal year 1992 were:

A total of \$956,000 of state operations and maintenance (O&M) funds



were expended to support departmental programs. An additional \$61,000 of state O&M funds were expended for special State Civil Defense projects and \$117,603 for various Hawaii State Veterans Cemetery projects.

### Minor Construction Projects

Minor construction projects include all projects for minor construction or major repair, maintenance or modification of facilities. This program is supported by federal funds, state funds or jointly with federal/state matching funds. Ongoing minor construction projects during this fiscal year amounted to \$409,000 for the Hawaii Army National Guard 100% federal funds (backlog maintenance, environmental engineering training and various projects).

## Staff Judge Advocate Office

### Mission

The Staff Judge Advocate (SJA) provides legal support to the adjutant general, staff elements, subordinate units of the Hawaii National Guard, and the United States Property and Fiscal Office. In performing its mission, the SJA serves to:

- Prepare legal opinions on issues of federal law.
- Serve as federal litigation point of contact.

- Represent the adjutant general in federal labor-management proceedings.
- Review federal contracts relating to procurement and acquisitions and serve as the Hawaii National Guard's federal claims officer.
- Participate as legal advisor or counsel in administrative board proceedings.
- Act on behalf of the convening authority in National Guard courts-martial.

### Personnel

The Staff Judge Advocate Office consists of a judge advocate supported by a shared clerk-typist for the Special Staff.

### Organization

The SJA reports directly to the adjutant general and works closely with Guard members on legal issues relating to the mission of the National Guard.

---

## Public Affairs Office

---

**Mission**

The Public Affairs Office plans, develops, directs and administers the department's community relations and public and internal information programs. In accomplishing its mission, the office performs the following:

- Prepare and distribute news releases, photographs and video-tapes on departmental activities to civilian and military news media locally and on the mainland.
- Respond to queries from the news media, public, and other state and federal agencies.
- Provide briefings for civilian and military officials, community groups and

new departmental employees to inform them of the department's mission and its economic and educational contributions to the state.

- Publish the semi-quarterly newspaper for distribution to present and retired Hawaii National Guard members, state and federal agencies, and other parties interested in departmental activities.
- Publish the quarterly newsletter for the Office of Veterans Services for distribution to veterans and veterans' organizations.
- Consolidate, edit and publish the department's annual report.
- Prepare speeches and reports for the adjutant general.

**Personnel**

The office consists of a public affairs officer, two information specialists and a clerk-typist. All personnel are full-time state employees.

**Organization**

The public affairs officer advises the adjutant general and staff members on public affairs matters relating to the department. The office works closely and coordinates its activities with public affairs officers of the department's major units/divisions and active military services to carry out its programs.

---

## Senior Army Advisor

---

**Mission**

The Senior Army Advisor (SRAA) is responsible for providing advice, counsel and assistance to the adjutant general and his staff in order to strengthen the Hawaii Army National Guard's (HIARNG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to the adjutant general.

- Represent and act as a spokesperson for the active Army in all HIARNG matters under the purview of U.S. Army Pacific (USARPAC).
- Render professional military advice to HIARNG commanders in military matters concerning the organization, operation, training and readiness of units.
- Monitor the use and assist in the management of federal resources in support of the HIARNG.

**Personnel**

The office is staffed by an active Army colonel.

**Organization**

The SRAA reports directly to the adjutant general and works closely with Guard members on federal military missions and issues.

---

## Air Force Senior Advisor

---

**Mission**

The Air Force Senior Advisor (AFSA)

is responsible for providing advice, counsel and assistance to the adjutant gen-

eral and his staff in order to strengthen the Hawaii Air National Guard's (HIANG)

readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to the adjutant general and his senior staff.
- Represent and act as a spokesperson for the active Air Force in all HIANG matters under the purview of Pacific Air Forces (PACAF).
- Maintain liaison with senior counterparts on the PACAF staff and ensure representation of HIANG issues, priorities, and perspectives.
- Render professional military advice to HIANG commanders in military matters concerning the organization, operation, training and readiness of units.
- Maintain Instructor Pilot status and fly operational and training missions with one of HIANG's flying units.
- Oversee and coordinate activities of all active Air Force advisors assigned to the HIANG.

### Personnel

The office is staffed by an active Air Force lieutenant colonel currently qualified in one of HIANG's aircraft.

### Organization

The AFSA reports directly to the adjutant general and works closely with PACAF counterparts and Guard members on federal military missions and issues.

## Senior Enlisted Advisor

### Mission

The State Command Sergeant Major (CSM) serves as the senior enlisted advisor for the Hawaii Army National Guard and is responsible to the adjutant general for a variety of matters pertaining to policies and actions relative to enlisted Hawaii Army National Guard soldiers. The State Command Sergeant Major's responsibilities are to:

- Advise the adjutant general on all enlisted matters.
- Assist the inspector general in servicing enlisted problems.
- Work with the recruiting and retention office.
- Participate on boards related to enlisted soldiers to include promotion, Active Guard/Reserve (AGR) continuation, selective retention and U.S. Army Pacific Non-Commissioned Officer and Soldier of the Year.
- Attend various conferences both locally and on the mainland.

### Personnel

The CSM's Office consists of a command sergeant major supported by a shared clerk-typist for the Special Staff.

### Organization

The CSM reports directly to the adjutant general and works closely with Guard members on enlisted issues.

## Inspector General

### Mission

The Inspector General (IG) is assigned to assist the adjutant general in assessing and reporting in an unbiased, objective manner on areas affecting mission performance, the state of efficiency, economy, discipline, morale, esprit de corps and readiness of the Hawaii National Guard. The IG also performs other duties as required by law and regulations or as directed

by the adjutant general. The mission is accomplished using the concept of a full service IG to:

- Provide assistance to Guard members, their families, and the public in response to real or perceived issues involving the Hawaii National Guard.
- Act on adjutant general directives to conduct investigations and inquiries.
- Manage the staff/special inspection

program throughout the Hawaii National Guard.

- Act as a teacher or trainer when and where possible while performing other functions.

### Personnel

The IG's office is staffed by an active Army lieutenant colonel and supported by a shared clerk-typist for the Special Staff.



**Organization**

The IG reports directly to the adjutant general and is a member of his

staff. The relationship between an IG and his commander has been referred to as one in which the com-

mander places extraordinary trust and confidence "to be the eyes, ears and conscience of the commander."

---

**Director of Information Management**

---

**Mission**

The Information Management Office plans, programs and manages Army National Guard automation (less the Data Processing Installation, U.S. Property and Fiscal Office for Hawaii) and telecommunications resources. In accomplishing its mission, the office performs the following:

- Provide technical advice to the adjutant general, staff elements, U.S. Property and Fiscal Office and units of the Hawaii Army National Guard.
- Develop and administer state information systems objectives, policies, plans and projects for supported organizations.

- Develop and administer an automation security policy.
- Assist users in obtaining and using automation and telecommunications resources.
- Determine automation training needs and coordinate appropriate user training with various training sources.

**Personnel**

The Information Management Office consists of the Director of Information Management, a computer systems programmer, a communications management specialist and a computer

assistant. All personnel are full-time federal technicians.

**Organization**

The Director of Information Management (DOIM) serves as the principal advisor on automation and communications requirements to the adjutant general and Hawaii Army National Guard officials. The office works with the National Guard Bureau's Information Management Agency and the other 53 Information Management Offices nationwide.

---

**State Family Action Office, Hawaii National Guard**

---

**Mission**

The State Family Action Office manages programs designed to increase the overall preparedness of Hawaii National Guard families to cope with the unique realities of Guard service.

**Personnel**

The office consists of a coordinator who is the only paid staff member. A state volunteer representative assists the coordinator in managing the activities of program volunteers throughout the state. Clerical support is provided by a shared clerk-typist for the Special Staff.

**Organization**

The state family action coordinator reports directly to the adjutant general. The coordinator works closely with the State Team, a volunteer action and advisory council, and family support groups throughout the state.
