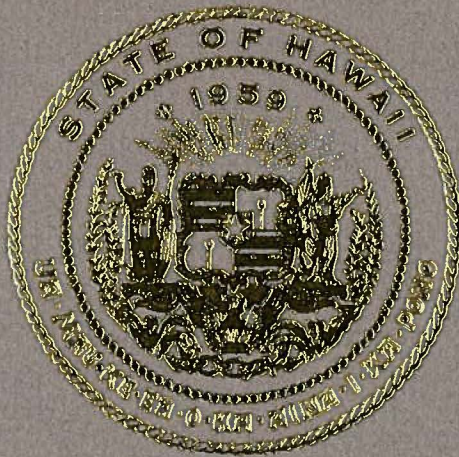

ANNUAL REPORT Fiscal Year 1993



Dear Governor Waihee:

Fiscal Year 1993 was both an extremely challenging and rewarding year for the State of Hawaii Department of Defense. Hurricane Iniki literally swept us from 1992 into 1993. As our department responded to the devastation caused by the storm, we drew on many of the capabilities we had worked on during the previous year and, thanks to the cooperation and coordination among the state, federal and county agencies involved in the effort, Operation Iniki emerged as one of the most successful disaster responses in our nation's history.

Despite the disruption caused by Iniki, our units kept the ball rolling in all of our department's other ongoing projects. Our joint operations included establishment of a burial detail in which Hawaii Army and Air Guard aircraft transport active military honor guards to the neighbor islands to provide burial honors for veterans.

The activation of the 203rd Air Refueling Squadron in February added tremendous capability to the Hawaii Air National Guard. Also this year we completed conversion of our F-15 fighters under the Multi-Stage Improvement Program and began installing chaff and flare dispensers on these aircraft. Meanwhile, the Hawaii Army National Guard began preparations for the receipt of sixteen CH-47s for its new medium lift unit on Oahu and four UH-60 Blackhawk helicopters for a medical helicopter unit on the Big Island. We also continued to work toward activation of an aviation intermediate maintenance facility on Oahu.

One of our greatest challenges in the immediate future continues to be maintaining a viable force structure during the drawdown of the nation's military forces. We have taken important steps to adjust our forces to meet new requirements and ensure that we retain the ability to perform both our state and federal missions. With your support, I feel we will continue to have the capability to respond to state emergencies such as Hurricane Iniki, while maintaining our readiness for a federal call to duty.

Department of Defense

Mission

The mission of the State of Hawaii Department of Defense is to assist authorities in providing for the safety, welfare and defense of the people of Hawaii. The department continuously strives to maintain its readiness to respond to the needs of people in the event of war or disasters, whether natural- or human-caused. Upon activation by the governor of Hawaii, the department is prepared to provide professional personnel, quality services and well-maintained equipment to assist during emergencies.

The Hawaii Army and Air National Guard also trains to meet its federal mission, should it receive a presidential call to duty in times of national emergency.

The Office of Veterans Ser-

vices (OVS) serves as the single point of contact in state government for veterans' services, policies and programs. The OVS also oversees the construction and administration of the Hawaii State Veterans Cemetery and neighbor island cemeteries.

Personnel

Compared to the other state departments, the full-time force of the Department of Defense represents a varied mixture of federal, state, active duty and drill-status National Guard members. This force includes, as of Sept. 30, 1,198 full-time federal employees, 173 state employees and more than 5,413 drill-status Army and Air National Guard members.

Organization

The State Department of

Defense is made up of three major divisions, one inactive division, six key staff offices and the Office of Veterans Services.

The three major divisions are the Hawaii Army National Guard, Hawaii Air National Guard and State Civil Defense.

A fourth division, which is currently inactive, is the Hawaii State Defense Force. Under state laws, the Hawaii State Defense Force may be activated should the need arise.

The six key staff offices provide support services to the three active divisions and other activity centers within the department. The key staff offices include the Administrative Services Office, U.S. Property and Fiscal Office, Support Personnel Management Office, Engineering Office, Staff Judge Advocate Office and Public Affairs Office.

The special staff includes the Senior Army Advisor, Air Force Senior Advisor, Senior Enlisted Advisor, Inspector General, and State Family Program Coordinator.

The adjutant general is the executive head of the department. In addition to being a member of the governor's cabinet, the adjutant general is the commander of both military divisions and the director of State Civil Defense.

Hawaii National Guard

The Hawaii Army National Guard and Hawaii Air National Guard collectively form the Ha-

waii National Guard. Under the banner of the Hawaii National Guard, the Army and Air National Guard divisions maintain, in a style unique to their military institutions, a history rich in traditions, contributions, sacrifices and high marks of excellence.

State Civil Defense

State Civil Defense has two important missions. The first is to minimize loss of life, reduce property damage and restore essential public services and facilities devastated by natural- or human-caused disasters. The

second mission is to provide for the welfare and safety of citizens, ensure the continuance and/or reconstitution of state government and mobilize and manage state resources in the event of war.

Office of Veterans Services

The Office of Veterans Services (OVS), which was administratively attached to the Department of Defense in July 1988, serves as the primary state agency responsible for developing and managing veterans' programs, policies and activities. The OVS is also charged with planning, establishing and operating the Hawaii State Veterans Cemetery on Oahu.

Hurricane Iniki

On Sept. 11, 1992, the state of Hawaii experienced the worst storm ever to strike the islands. With maximum sustained winds clocked at 145 miles per hour and gusts up to 227 miles per hour, Hurricane Iniki struck with devastating force. While all islands were touched by the storm, the island of Kauai felt the full impact as the eye swung directly over the island. Damage surveys completed the following morning showed that virtually no structure on Kauai had been left untouched.

Communications and lifeline utilities were severed. Portions of Oahu, particularly the Leeward coast, suffered damage from peripheral winds and storm surge, and isolated power outages were reported around the island. Maui and the Big Island

also reported damage, but Kauai absorbed most of the storm's impact. Hurricane Iniki caused an estimated \$1.8 billion in damages, and was billed as the third costliest natural disaster in U.S. history.

The hurricane recovery effort, dubbed "Operation Iniki," was a joint county, state and federal venture. However, the State of Hawaii Department of Defense (DOD) played a major role in the operation.

Days before the storm, Maj. Gen. Edward V. Richardson, state adjutant general and director of civil defense, and the State DOD staff began to routinely monitor the storm. On Thursday, Sept. 10, Iniki turned on a northwest track toward Hawaii. It was only 400 nautical miles south of the islands of Kauai and Oahu.

Based on this information, Richardson implemented 24-hour operations at the State Civil Defense and Hawaii National Guard Emergency Operating Centers, and directed intensified response planning. Hawaii National Guard units on all islands began preparing their vehicles and equipment.

The Hawaii Air National Guard's Aircraft Control and Warning Squadrons on Kauai and Oahu provided continuous radar information to State Civil Defense and were invaluable in successfully tracking the storm.

At 11 a.m., Sept. 11, Iniki was perilously close to Oahu and Kauai. Key Hawaii National Guard soldiers and airmen were at their stations; the Big Island's 2nd Battalion, 299th Infantry was on standby alert; and Oahu units were set to perform

evacuation missions.

At 3:15 p.m., power was reported out on Kauai as Iniki carved a destructive path through the island. A short time after the hurricane hit, emergency communication was reported out between Oahu and Kauai.

At the state emergency operating center on Oahu, Richardson briefed Gov. John Waihee on Iniki's effects and the state's contingency plans. The governor immediately issued a State Disaster Proclamation, authorizing the state response and activation of the Hawaii National Guard. The governor's action led to a Presidential Declaration of Disaster, which paved the way for federal disaster aid through the Federal Emergency Management Agency (FEMA).

At 5:30 a.m., the winds subsided and nearly 400 Big Island soldiers and airmen began deploying to Kauai aboard Air National Guard C-130 aircraft. Hawaiian and Aloha Airlines and Coast Guard aircraft also helped move troops and equipment from the Big Island.

The communications system at Lihue Airport was destroyed, and commercial airline flights were suspended for 10 days, leaving thousands of tourists stranded on the island. On Sunday, Sept. 13, the Hawaii Air National Guard, with support from Aloha, Hawaiian and United Airlines, began transporting tourists to Oahu, eventually evacuating more than 5,000 visitors.

Elsewhere on the island, more than 7,000 people were housed and over 15,000 fed at National Guard, Red Cross and Salvation

Army shelters.

Also on the 13th, an active duty military Joint Task Force made up of Army, Air Force, Navy, Marine and Coast Guard units began assisting the state and county. The Task Force provided personnel and began airlifting and shipping tons of equipment and emergency supplies.

On Sept. 15, two battalion aid stations were established at the Hawaii National Guard's Kapaa and Hanapepe armories. Medics also went house-to-house to treat injured residents. By Sept. 30, the medical teams had treated more than 1,000 patients, mostly for minor injuries, cuts and bruises.

National Guard engineers deployed on Sept. 15 with vehicles, carpentry tools and chainsaws to do house-to-house repairs for residents who could not fix their own homes.

The National Guard also set up and operated five relief distribution centers at Lihue,

Kapaa, Hanapepe, Kalaheo and Princeville, providing food, water, ice and plastic sheeting. The distribution centers, which included Red Cross and Salvation Army functions, were co-located with federal disaster assistance centers to provide one-stop, full-service programs for residents.

In mid-September, the governor tasked Richardson to coordinate the cleaning up of public schools, state facilities and highways. National Guard and active duty military personnel removed debris, patched roofs, cleaned classrooms and installed generators at 15 schools throughout the island. As a result of the emphasis on schools, Wilcox Elementary in Lihue opened on schedule, Sept. 22.

To reduce the risk of injury, infections and the spread of diseases, the governor also tasked Richardson to initiate "Operation Garden Sweep." This massive, two-phase clean-up of the entire island was a joint county, state and federal effort.

The workers collected and hauled more than 32,000 tons of household garbage and debris to existing and temporary landfill sites on the island.

For the first three weeks of the emergency response phase of Operation Iniki, more than 5,500 members of the Hawaii National Guard were directly or indirectly involved in efforts to serve and assist Kauai County.

National Guard helicopters and fixed-wing aircraft, including six C-130s from the California Air Guard, flew over 1,887 sorties, transporting more than 3,427 tons of cargo and 9,552 passengers.

On Friday, Sept. 25, the soldiers and airmen who had been on Kauai since Hurricane Iniki hit began returning to their homes on the Big Island, Oahu and Maui. Other Hawaii National Guard members deployed to Kauai to continue to provide security, clean-up assistance and outreach support until Nov. 6.

There were a number of factors that made the emergency response phase of Operation Iniki a success. First, and most important, was the fact that all agencies recognized the leadership role of the state in managing, coordinating, prioritizing and executing the emergency response effort. The federal government, namely FEMA and the active duty military, allocated resources based on priorities identified in conjunction with the state and county.

Another factor was the proactive nature of the actions taken by the State Department of Defense, even before the hurricane hit. These actions included the pre-positioning of equipment, aircraft and vehicles, as well as the decision to use Hawaii National Guard personnel from islands not seriously affected by the storm.

The third factor was the ability of the State Department of Defense to conduct joint operations. Since assuming

command, the adjutant general has directed joint Army and Air National Guard operations during weekend and annual training, as well as during special events. In the Civil Defense arena, this joint operational concept has been practiced during routine emergency response training exercises to include the private sector and county and federal agencies.

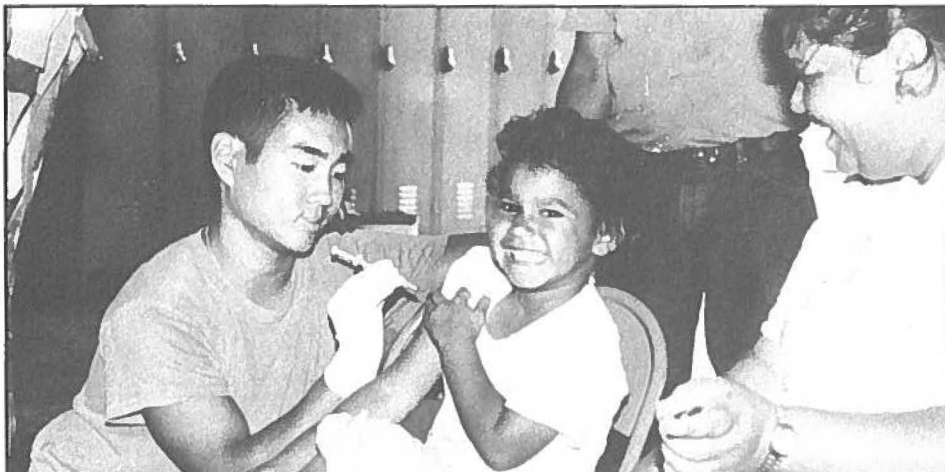
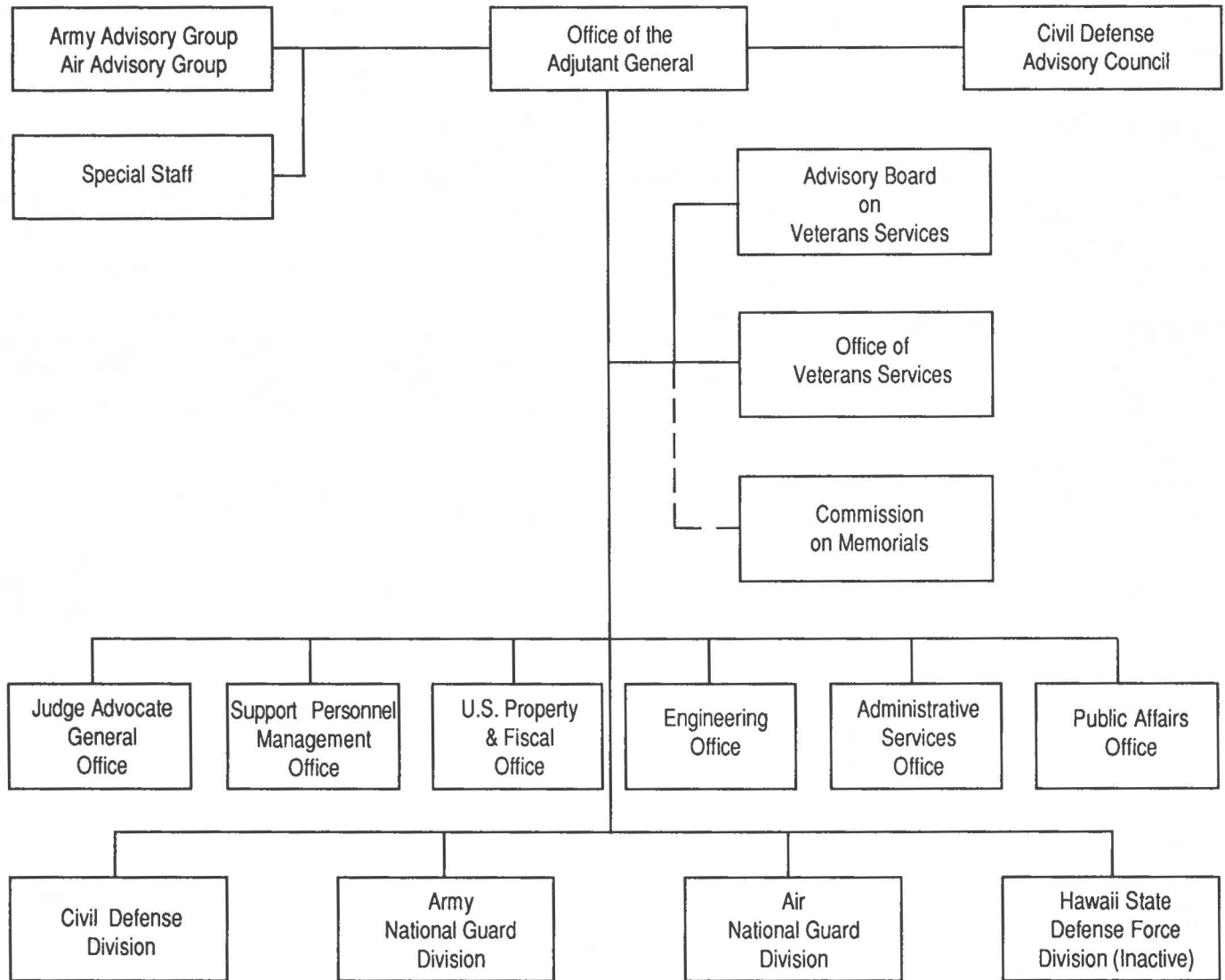
The fourth factor is that the adjutant general of Hawaii serves as both director of State Civil Defense and commander of the Hawaii National Guard. This centralizes authority, enabling the adjutant general to deploy emergency response assets and direct civil defense actions at the state level.

The department has also developed close working relationships with county and state agencies through training at all levels and a number of regional and state affiliations that promote professional as well as social interaction. This close working relationship is shared with the active military as well.

A final factor is that Hawaii National Guard personnel were placed on state active duty, allowing them to perform vital security missions and avoid restrictions under the Posse Comitatus Act, which prohibits the use of federal troops for civilian law enforcement.

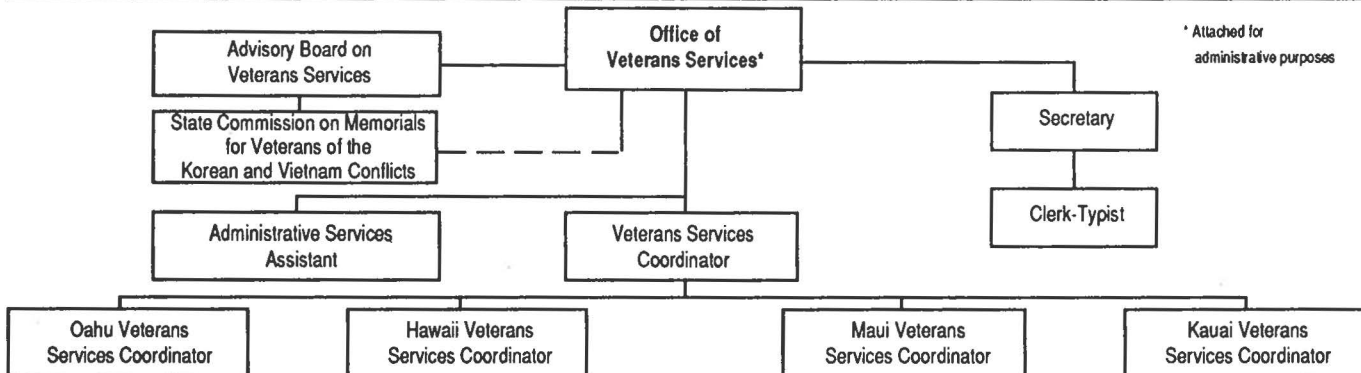
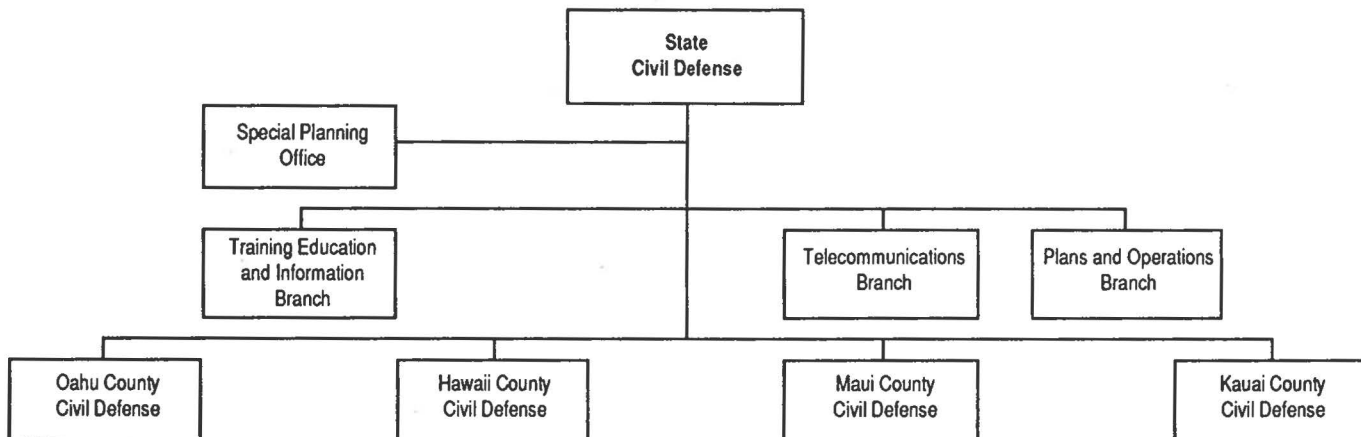
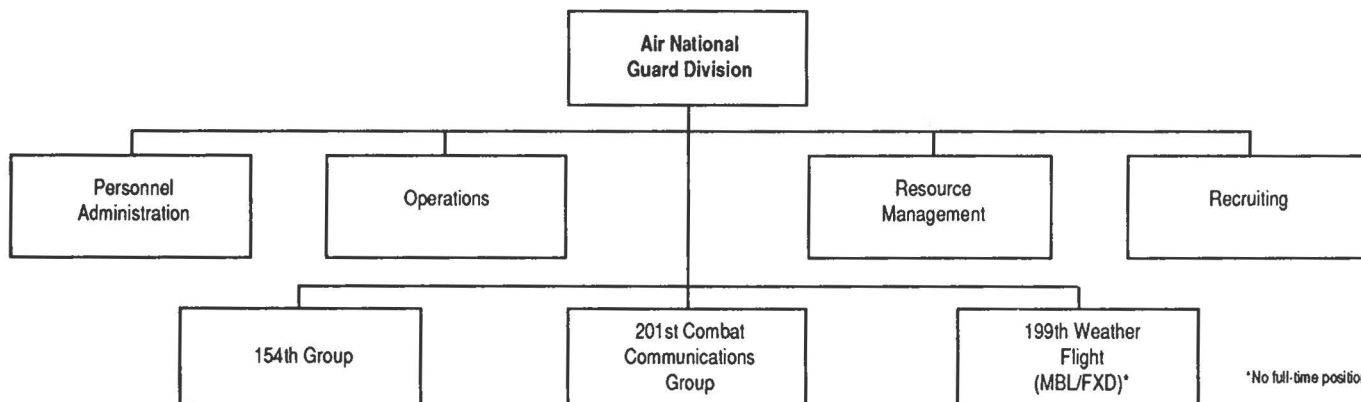
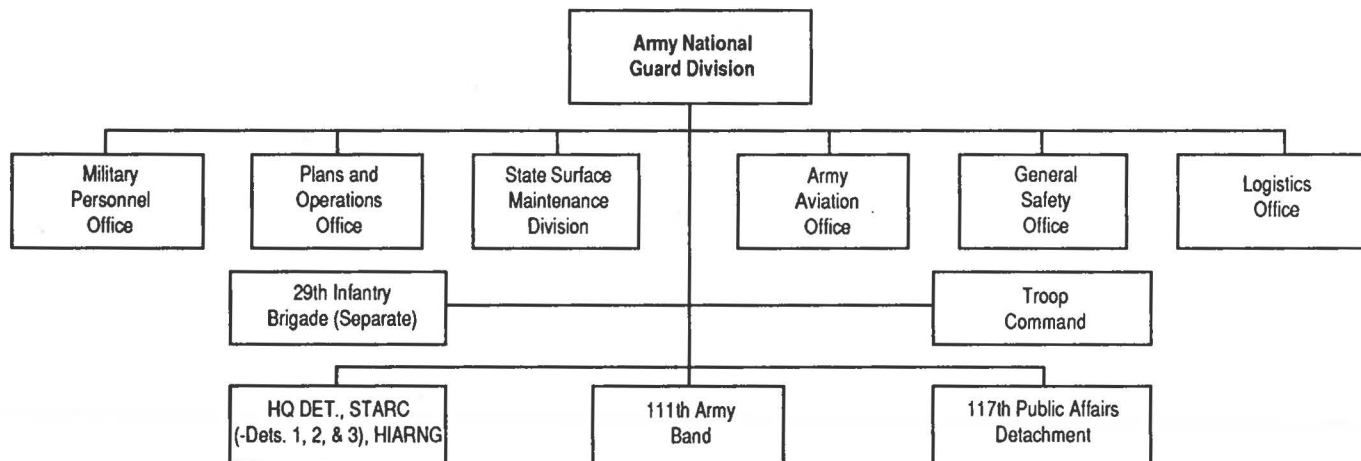

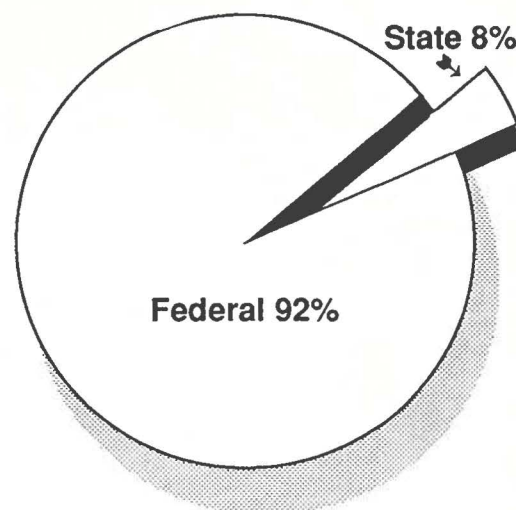

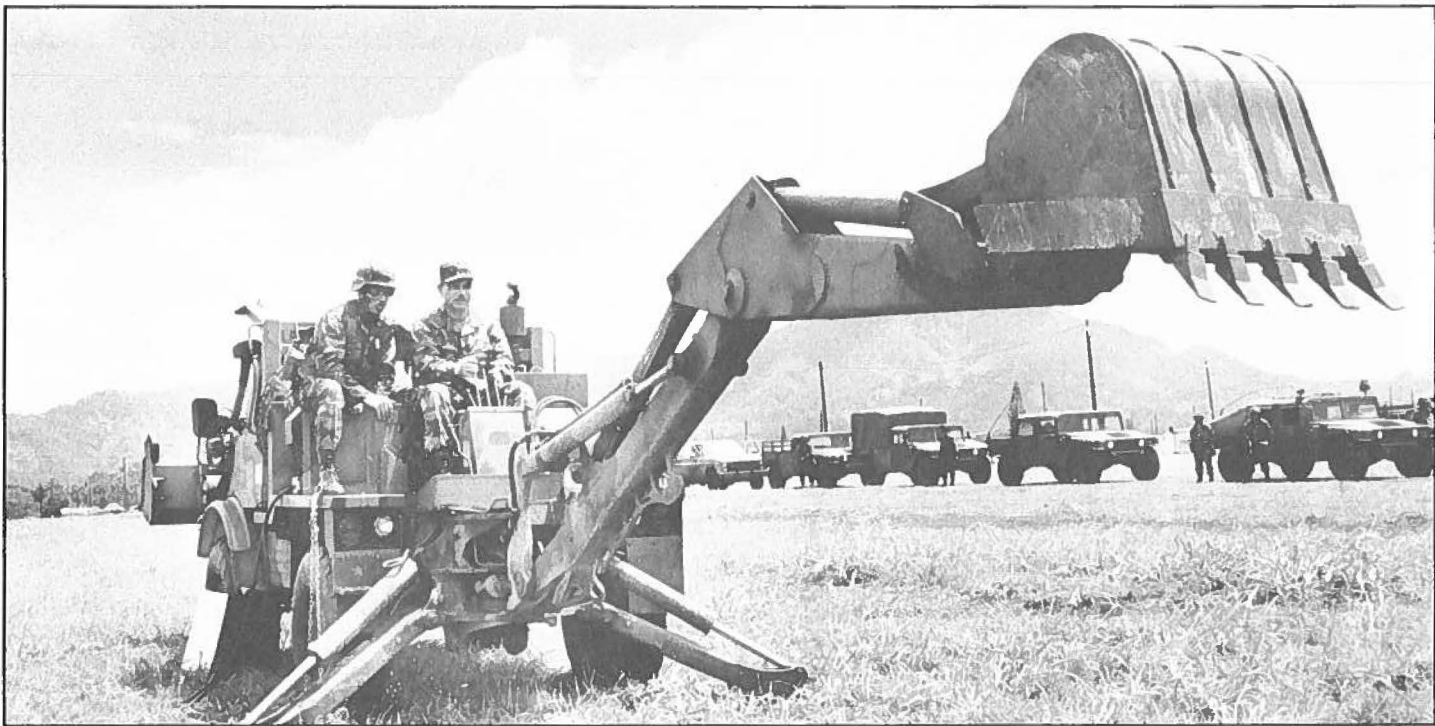

Hawaii Army National Guard

Mission

The Hawaii Army National Guard (HIARNG) continually trains to maintain its readiness for state or federal active duty. It is prepared for local or global assignments, should the governor or president order it to active duty.

Personnel

The authorized strength of the HIARNG decreased from 4,258 to 4,056 as a result of the reorganization of some HIARNG units and the activation of the 25th Infantry Division Detachment. The assigned strength of the HIARNG stood at 3,391 at the end of Fiscal Year 1993, a decrease of 109 members from the previous fiscal year and 83.6 percent of the authorized 4,056 positions. This number included 320 commissioned officers, 115

warrant officers and 2,951 enlisted personnel.

Organization

The HIARNG consists of the Headquarters, State Area Command, 29th Infantry Brigade (Separate), Troop Command, 111th Army Band, 117th Public Affairs Detachment, Hawaii Military Academy and Selective Service Section.

29th Infantry Brigade (Separate)

The largest unit in the Hawaii National Guard, the brigade is organized with units located on the islands of Oahu, Molokai, Maui, Kauai and Hawaii. The brigade trains to maintain readiness for the Guard's state and federal missions. As of Aug. 6, 1993, the brigade's assigned strength was 2,367 soldiers. This included 175 officers, 15 warrant

officers and 2,177 enlisted members.

The brigade is composed of a headquarters and headquarters company, two infantry battalions, a field artillery battalion and a support battalion. Separate units include a ground cavalry troop, a combat engineer company and a signal detachment. This mix of units and equipment provides a variety of options when the brigade is employed in either its federal or state mission. Upon federal mobilization, the brigade would receive its third "round-out" infantry battalion, the 100th Battalion, 442nd Infantry (USAR).

Troop Command

The mission of Troop Command is to provide command and control over its assigned units.

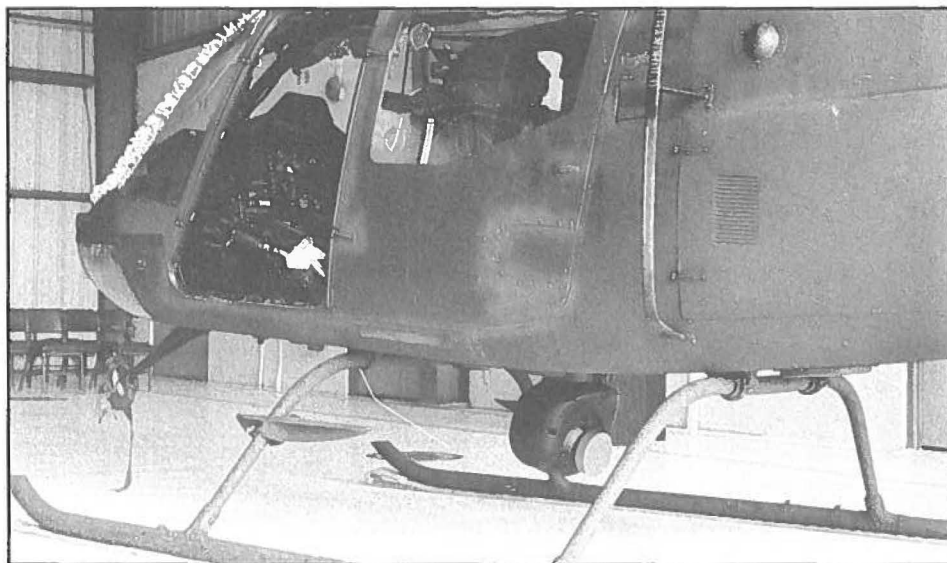
The command's assigned strength, as of July 31, 1993, was 716. This included 59 officers, 76 warrant officers and 581 enlisted members.

The Troop Command is headquartered at Waiawa Armory in Pearl City, Oahu. It is one of two major commands within the HIARNG. The Troop Command includes a combat aviation battalion at Wheeler Army Airfield, a combat service support battalion headquartered at the Waiawa Armory, two aviation detachments based at Hilo's Gen. Lyman Field, a division-level tactical rear operations cell at Waiawa Armory and an engineer detachment at Fort Ruger.

The units within Troop Command provide a broad spectrum of combat and combat-service support. The aviation detachments provide a trained pool of qualified replacement aviators. The supply and service battalion stores and issues supplies, repairs and rebuilds military equipment and maintains vehicles, weapons and sophisticated electronic equipment. The organization also provides limited field services, including renovation of light textiles. The division rear operations cell provides support of rear operations. The engineer detachment provides utilities repair and maintenance.

The HIARNG's aviation units include the Headquarters State Area Command aviation section; 1st Battalion, 193rd Aviation (Attack); 451st and 452nd Aviation Detachments; and a Reconnaissance and Interdiction Detachment (RAID).

Aircraft inventory includes 15 AH-1S Cobra attack helicopters,

nine UH-1H Iroquis (Huey) utility helicopters, 13 OH-58A Kiowa scout helicopters and a C-26B Metroliner twin-engine, fixed-wing aircraft. Two specially-equipped OH-58A helicopters were added to the inventory to support RAID missions.

The aviation units flew a total of 5,700 hours, which represents 100 percent of their annual flying hour program. These flight hours were used to accomplish mission support, proficiency training, aircrew qualification, unit training and support to civil authorities.

The two Army Aviation Support Facilities assigned to the HIARNG serve as bases for its maintenance and training programs. These training programs include aircraft qualification, nap-of-the-earth qualification, aerial gunnery training, unaided night qualification and night vision goggle qualification.

Divisions/Sections Staff

The maintenance division has 81 full-time federal technicians housed at eight support facilities on five different islands. An additional six soldiers on Active Guard/Reserve status provide automated supply support for maintenance programs throughout the HIARNG. These soldiers support 49 different units and 21 activities.

Employees of this division worked in excess of 200,000 hours during the fiscal year, performing services and installing more than one million dollars in repair parts. These efforts ensured the availability of equipment for mission support and training. The services and repairs performed by this division allowed the HIARNG to exceed the Department of the Army maintenance readiness standard of 90 percent.

The division has also assisted the Tank Automotive Command

in replacing 23 potentially defective transmissions and all hand-brake systems on the High Mobility Multipurpose Wheeled Vehicles in the HIARNG inventory. Other activities included support during Hurricane Iniki.

The maintenance program continued to keep abreast of force modernization programs through an effective training program.

Highlights and Significant Events

Operation Iniki was the greatest peacetime mobilization and deployment operation ever conducted by the Hawaii Army National Guard (HIARNG).

Hurricane Iniki devastated the island of Kauai and damaged portions of Oahu and the other islands in the Hawaiian chain, Sept. 11, 1992. HIARNG members who live on Kauai provided direct assistance to the community and to the Kauai County Emergency Operating Center prior to and during the storm.

HIARNG units from other

islands began arriving on Kauai to provide emergency disaster assistance to Kauai County, Sept. 12, 1992. HIARNG members provided security support and traffic control to the Kauai Police Department, generator support, damage assessment, communication restoration, debris removal, roof repair, food and materiel distribution, airport cargo control, medical evacuations and other humanitarian mission support from Sept. 12 - Nov. 6, 1992.

During the eight-week period following the disaster, nearly all HIARNG units sent members to Kauai. At the highest level of assistance, 3,300 Army Guard members were on duty. During this period, Guard members:

- Cleared approximately 32,000 tons of debris in joint operations with the Air Guard;
- Flew 1,014 missions;
- Served approximately 15,000 meals;
- Provided island-wide security support;
- Provided medical support to

Kauai residents at the Hanapepe and Kapaa armories;

- Staffed five full service centers;
- Cleared eight streams;
- Provided roof repair and debris removal assistance to elderly Kauai residents;
- Cleaned and repaired 13 Kauai schools.

During the Hurricane Iniki relief operation, the HIARNG worked with the Air Guard, the State Department of Accounting and General Services, U.S. Property and Fiscal Office (USPFO) and the State Department of Defense Fiscal Office to automate the state active duty pay system. As a result, Guard members were paid on a weekly basis.

This innovative process was made possible by computing pay using the military pay system at USPFO and then transferring the data via computer disks to the State Department of Accounting and General Services computer for check printing.

The HIARNG activated a new unit, the Division Rear Tactical Operations Cell (D-RTOC), Sept. 17, 1992. Upon mobilization, this unit will become part of the active Army's 25th Infantry Division (Light) at Schofield Barracks, Oahu.

The D-RTOC's primary mission is to coordinate and direct the execution of the rear security, terrain management, movement control and area damage control in support of division rear operations.

This unit provides the 25th Infantry Division (Light) with the stability that is required of a rear tactical operations center.

The HIARNG received two OH-58 Kiowa observation heli-

copters, March 16, 1993, for the Reconnaissance and Interdiction Detachment. The primary mission of these helicopters is to provide airborne scout and reconnaissance support for drug interdiction and surveillance during both day and night operations.

The HIARNG also received a great deal of new equipment, keeping pace with its active Army counterparts. One such piece is the Stinger missile. It is designed to counter high-speed, low-level ground attack aircraft and is a lethal weapon against helicopters and observation and transport aircraft.

Mobile Subscriber Equipment (MSE) replaced the tactical phone system in U.S. Army divisions, separate brigades, regiments and corps. The sophisticated communications equipment of the MSE network provides a secure, reliable and survivable telephone service for both command posts and users in vehicles.

The Hawaii National Guard is

a key player in ensuring that veterans on the neighbor islands are provided with proper military honors upon their interment. An agreement between the adjutant general and the commanders of the active services of Hawaii provided transportation aboard Hawaii Army and Air National Guard aircraft for active component members to perform burial honors on the neighbor islands. Implementation of this program began in March 1993.

Brig. Gen. John R. D'Araujo Jr., a Hawaii Guardsman, was appointed as director, Army National Guard, April 29, 1993. Simultaneously, he was promoted to the rank of major general by the Secretary of the Army.

Training

HIARNG units participated in a wide range of training activities throughout the year.

In November 1992, 41 soldiers from the 111th Army Band deployed to Port Moseby on the island of New Guinea. They participated in ceremonies marking the 50th anniversary of World War II.

In January 1993, 10 soldiers from the 29th Infantry Brigade (Separate) and two soldiers from Troop Command deployed to Camp Sendai, Japan. They participated in a joint, bilateral command post exercise co-sponsored by the United States Forces, Japan and the Japan Self-Defense Forces Joint Staff Office.

In February, 10 soldiers from the 117th Public Affairs Detachment deployed to Panama City, Panama. The unit received public affairs training through

formal instruction and on-the-job training. They produced news releases, still photographs and videotaped material for the American public and supported the command information effort for the United States forces in Latin America.

The 117th also provided public affairs support to the 25th Infantry Division (Light) during Exercise Cobra Gold in Pit-sanulok, Thailand, in May.

The 291st Maintenance Company deployed 110 soldiers to Kaiserslautern, Germany, in June. They provided general support maintenance at the National Guard's Equipment Maintenance Center in Europe.

In June, the 297th Supply & Service Battalion, 292nd Quartermaster Company and 12th Personnel Services Company performed their Annual Training at the Kahuku and East Range Training Areas on Oahu. The focus was on tactical field operations.

The 451st Aviation Detachment performed its Annual Training at Schofield Barracks, June 12-26. The unit provided aviation support for the Hawaii Military Academy during Officer

Candidate School and 11B (Infantry) training.

In June, soldiers of the 1st Battalion, 487th Field Artillery, conducted their Annual Training at Camp Guernsey, Wyo. The battalion trained with the 115th Artillery Brigade of the Wyoming Army National Guard.

The remainder of the 29th Infantry Brigade (Separate) conducted Annual Training at Schofield Barracks, July 17-31. This year, the brigade units trained on squad, section and platoon operations. Training also included live-fire exercises.

The 452nd Aviation Detachment provided aviation support to the 29th Brigade at Schofield Barracks, July 17-31.

In August, 50 soldiers from the 298th Engineer Detachment deployed to Los Santos Province, Panama. They renovated and repaired six rural schools, in conjunction with the Panamanian government's Ministry of Education.

Units of Troop Command completed Annual Training at Schofield Barracks this year.

Hawaii Military Academy

The Hawaii Military Academy

(HMA) provided training for Army National Guard units from Hawaii, Alaska and Guam in addition to U.S. Army Reserve soldiers in the Pacific area. HMA conducted training in five major areas: officer candidate school (OCS), noncommissioned officer education system (NCOES), non-prior service training program (NPS-TP), military occupational specialty qualification (MOSQ) and regional training site-maintenance (RTS-M).

In 1993, HMA graduated 13 candidates who were commissioned as second lieutenants. Phase I and Phase III officer candidates conducted their final two weeks of intensive training at Fort Huachuca, Ariz., in conjunction with state military academies from Arizona and Utah.

HMA conducted three basic non-commissioned officer (NCO) courses and one advanced NCO course, graduating over 90 NCOs.

HMA also conducted three MOSQ courses. The staff trained two soldiers and qualified them as indirect fire support specialists. Nine soldiers were qualified as chemical operations specialists, and 11 soldiers from Hawaii, Samoa, Alaska and Guam as infantrymen, including members of the U.S. Army Reserve.

HMA's First Sergeants Course qualified 13 soldiers for first sergeant positions in their units. HMA also conducted the Pre-Command Course for future company commanders and the Battle-Focus Instructor Training Course for unit trainers.

The RTS-M was established at Pearl City, Oahu, and offers maintenance courses for National Guard, U.S. Army Reserve and active military troops in the Pacific area.

Hawaii Air National Guard

Mission

Like its continental counterparts, the Hawaii Air National Guard (HIANG) serves dual missions. In performing its state mission, the HIANG provides organized, trained units to protect Hawaii's people, preserve peace and ensure public safety in response to natural or human-caused disasters. Its federal role is to provide operationally-ready combat units, combat support units and qualified personnel for active duty in the U.S. Air Force in time of war or national emergency.

Personnel

As of Sept. 30, 1993, the

assigned strength of the HIANG was 233 officers and 2,026 enlisted personnel. The total members make up 92.8 percent of the 2,434 positions authorized.

Organization

The HIANG is directed by the commander, Hawaii Air National Guard, and is comprised of the Hawaii Air National Guard Headquarters, 154th Group, 201st Combat Communications Group and 199th Weather Flight.

154th Group

The 154th Group is the largest of the HIANG organizations. It includes a headquarters, a

fighter squadron, an air refueling squadron, a consolidated aircraft maintenance squadron, two aircraft control and warning squadrons, an air control squadron and seven additional support units.

Responsibility for the state's air defense belongs primarily to the 154th Group. Located at Hickam Air Force Base, its fighter squadron is equipped with F-15A/B Eagles to provide fighter-interceptor capability for the air defense system.

The group's two aircraft control and warning squadrons operate radar sites at Kokee Air Force Station, Kauai and Mt. Kaala, Oahu. The two radars are

linked to the Hawaii Regional Operations Control Center at Wheeler Army Air Field, Oahu, and provide 24-hour surveillance of the entire Hawaiian island chain.

201st Combat Communications Group

Located on the islands of Hawaii, Kauai, Maui and Oahu, the units of the 201st Combat Communications Group (CCGP) train to provide command and control communications and air traffic control facilities and services to support Air Force requirements. Its members are prepared to deploy within 24 hours to anywhere in the world with their equipment.

199th Weather Flight

The 199th Weather Flight provides meteorological support primarily to the Hawaii Army National Guard's 29th Infantry Brigade (Separate) and secondarily to active and reserve components of the Army and Air Force. When deployed, services include continuous, 24-hour staff weather services, forecasting, observing and climatological support to the 29th Brigade's tactical operations center and a brigade airfield, drop zone, or helipad. Located at Wheeler Army Air Field, the unit provides weather information to the joint, worldwide meteorological network operated by the Air Force's Air Weather Service, the National Weather Service and the World Meteorological Organization.

Highlights and Significant Events

The past fiscal year was characterized by many signifi-

cant changes, challenges and accomplishments.

Typhoon Omar hit Guam and Japan with extremely forceful winds, Aug. 28, 1992. Responding to the devastation on those islands, personnel of the 297th Air Traffic Control Flight provided a TRN-26 tactical air navigational aid and maintenance support at Yokota Air Base, Japan, for over two months.

In December 1992, Maj. Roy A. Cornella assumed command of the 291st Combat Communications Squadron, replacing Lt. Col. Richard H. Nishimura, who retired. In February, Col. Norberto Baysa assumed command of the 154th Tactical Hospital, replacing Lt. Col. Gildo S. Soriano.

With the March 1993 retirement of Brig. Gen. Allen M. Mizumoto, Col. David M. Rodrigues, the former Chief of Staff for HIANG Headquarters, assumed command of the HIANG.

In June 1993, Lt. Col.

Norman S. Nitta assumed command of the 154th Air Control Squadron (ACS), and Lt. Col. Gary S. Nitta assumed command of the 150th Aircraft Control and Warning Squadron (ACWS).

The largest deployment conducted by the HIANG in FY 1993 involved the movement of hundreds of personnel to the island of Kauai for Hurricane Iniki relief efforts. The HIANG's C-130H, attached to the 199th Fighter Squadron, flew the first of 189 sorties related to relief efforts, Sept. 12, 1992. First off the plane were members of the 154th Services Flight, who immediately provided food service and the 154th Security Police Flight, who provided limited security to Kauai residents affected by the storm.

The 201st CCGP responded immediately to the recovery and relief effort with electrical power generators, communications equipment and over 250 personnel. Mobile generators also provided electrical power support to a hospital, schools and food distribution sites.

Generators also provided power for water pumping stations to restore the critically-needed public water system. Numerous mobile radios supported communications for command and control operations of the HIARNG and the County Emergency Operations Center, plus two food distribution sites.

201st CCGP personnel provided 24-hour instrument flight rules radar service with air traffic controllers to augment civilian controllers; a TRN-26 tactical air navigational aid to replace the U.S. Navy's damaged equipment at the Pacific Missile Range Facility, Barking Sands, Kauai; and a TSW-7 mobile control tower to the Lihue Municipal Airport to serve as an emergency backup to the damaged tower for Federal Aviation Administration air traffic controllers.

During the evening of Sept. 14, 1992, Tech. Sgt. Dennis C. Dalen, a member of the HIANG's 297th Air Traffic Control Flight,

died in a traffic accident while on his way to repair an electric generator near Hanalei, Kauai. He was interred at the Hawaii State Veterans Cemetery on Oahu with full military honors.

The pilots and crew of the C-130H continued to evacuate stranded tourists and shuttle in HIANG and other military personnel assigned to the relief efforts. A total of 2,900 civilian personnel were evacuated in the days immediately following the hurricane.

All of the units within the HIANG assisted with hurricane relief efforts. Despite the fact that many of those from the 150th ACWS and the 154th ACS on Kauai suffered property damage of their own, they still did not hesitate to volunteer for active duty in order to help their neighbors.

A week after Iniki had passed, HIANG units were activated for "Operation Garden Sweep." Tons of debris left over from the storm created a health

hazard that had to be eliminated. More than 500 HIANG personnel participated in the huge, military-led clean-up effort.

In December 1992, the 203rd Air Refueling Squadron (AREFS) received the first of five refurbished KC-135R Stratotankers. On Feb. 12, 1993, the 203rd AREFS was given federal recognition, and an activation ceremony was held in Hangar 35 at Hickam Air Force Base, the new maintenance hangar for the squadron. The operations branch of the 203rd moved into building 2155 near Hickam Tower. The inaugural flight of the first operational KC-135, "Hoku Pa'a," was conducted on March 16, 1993. The first mission included an aerial refueling operation with a C-5 Galaxy and "touch and go's" at Barbers Point Naval Air Station.

The designation of the 154th Composite Group was changed to the 154th Group, Feb. 1, 1993. The 199th Tactical Fighter Squadron was redesignated the 199th Fighter Squadron.

As a first for the HIANG, effective April 1, 1993, the 176th Combat Communications Flight (CCFT), Alaska ANG, was aligned under the 201st CCGP for operational tasking. Through the National Guard Bureau and with Headquarters, United States Air Force approval, the 176th CCFT was redesignated from an Air Combat Command to a Pacific Air Forces (PACAF) resource.

In the last quarter of 1992 and the first quarter of 1993, new AN/TRC-170 Tropo Scatter Radio sets were received by the 291st Combat Communications Squadron (CCSQ), 292nd CCSQ and 293rd CCSQ to upgrade their

communications capabilities from the older analog AN/TRC-97 tropo scatter radio sets.

In May 1993, F-15s from the Fighter Squadron began upgrading their defensive capabilities by acquiring the ALE-45 chaff and flare dispenser system.

After a full year of accomplishments demonstrating its professionalism, readiness and dedication, the 154th Group was awarded its fourth National Guard Association of the United States Distinguished Flying Unit Plaque. The Group also received the Air National Guard Flight Safety Plaque and the Air National Guard Explosive Safety Plaque for outstanding performance in 1992.

Training

As part of the combined/joint RIMPAC '92 exercises in July, the 199th Fighter Squadron flew more than 200 sorties involving dissimilar air combat training, high value asset escort and maritime operations against naval surface attack groups.

The 201st CCGP, with assis-

tance from Air Force technical advisors, sponsored and conducted a mobility survivability training course in January 1993. More than 40 members of the 201st CCGP, other HIANG units and the PACAF staff were trained. The course received many accolades from participants and units. It also saved approximately \$20,000 per class in temporary duty (TDY) expenses, versus sending personnel to this training at various other locations.

The 201st CCGP personnel participated in a number of Joint Chiefs of Staff (JCS), Joint Task Force (JTF) and PACAF exercises throughout the past year to increase their readiness posture. In February 1993, they deployed to the Republic of Korea in support of the JCS Team Spirit exercise, providing and maintaining communications systems for command and control, communications and computer operations. For the second consecutive year, they deployed to Thailand at the end of April to support the JTF '93 Cobra

Gold exercise.

In March 1993, the 154th Group successfully completed an Operational Readiness Inspection.

In April 1993, members of the 154th Resource Management Squadron deployed to Utah to cross train with their counterparts from the Utah Air National Guard.

The 201st CCGP personnel deployed with PACAF's new mobile command post, the Enhanced Crisis Management Capability system, and provided command and control operations support and training for their high frequency radio system. Air traffic controllers increased their proficiency and knowledge by participating in the Sentry Vigilance exercise on the mainland. The 201st CCGP also conducted an Operational Readiness Evaluation in May to exercise and enhance its capabilities in meeting mission taskings. These exercises increased unit type code readiness and the proficiency levels of satellite communications and systems controllers of all units.

As part of their initial training, a tanker and crew from the Refueling Squadron deployed to Midway Island in May 1993, flying a Coronet West air refueling mission. In June 1993, 203rd personnel flew training and refueling missions to Osan Air Base, South Korea, and to Misawa and Kadena Air Bases, Japan. They also flew missions to Grand Forks Air Force Base, Rickenbacker Air National Guard Base and Grissom Air Force Base on the mainland in June.

State Civil Defense

Mission

The mission of State Civil Defense (SCD) is to plan, prepare for and respond to actual or impending disaster. These actions are applied to protect life and property, restore essential services, ensure continuity of government and coordinate resource management to speed recovery.

Available resources must combat a wide range of hazards, stemming from natural and technological sources, as well as war-related hostilities. Hazard management is accomplished via four integrated phases:

Mitigation. Measures which reduce or eliminate the impact of emergencies or disasters.

Preparedness. Plans and procedures for disaster response and recovery, staff training, community education and information.

Response. Community

warning, coordination and application of agency resources for crisis response.

Recovery. Short- and long-term efforts to restore the social and economic structure of a community following a disaster.

SCD also supports Federal Emergency Management Agency (FEMA) strategies, emphasizing a comprehensive, integrated, all-hazards emergency management system. This system identifies all hazards facing a community, analyzes capabilities to manage these hazards and develops programs to overcome shortfalls.

Personnel

SCD is authorized 30 full-time employees during non-crisis periods. During emergencies, staffing is increased by mobilizing government and volunteer support agencies. The adjutant general serves as the director of civil defense. The vice director

assumes the responsibilities of the director when the director is out of state.

Organization

The civil defense system is comprised of all public and private organizations charged with emergency responsibilities. All state departments and agencies have civil defense coordinators appointed for emergency tasks. By law, each county is an element of the civil defense system. County mayors typically serve as deputy directors of civil defense for their respective counties, maintaining their county's civil defense infrastructure and operational capability.

SCD supports the statewide civil defense system by managing federal funds and disaster assistance programs. SCD also aids in developing county plans and programs, and provides technical assistance and training

programs. If an emergency depletes county resources, the county may seek assistance through SCD. If disaster impact escalates beyond state resource capabilities, the state requests federal assistance through FEMA.

State Civil Defense Advisory Council

Made up of seven members appointed by the governor, the council meets quarterly to discuss programs and projects conducted by SCD. Serving on the Advisory Council for 1993 were Reuben Yoshida, chair, Frank T.S. Kim, James McClellan, Myrna Murdoch, Tadao Okimoto, Alfred O. Souza Sr. and Richard Yonezaki.

Hawaii State Earthquake Advisory Board

Formed in August 1990, the

volunteer 13-member board meets quarterly to identify priorities for earthquake probabilities, hazard mitigation and preparedness. The board draws its expertise from the scientific, academic, engineering and emergency management communities.

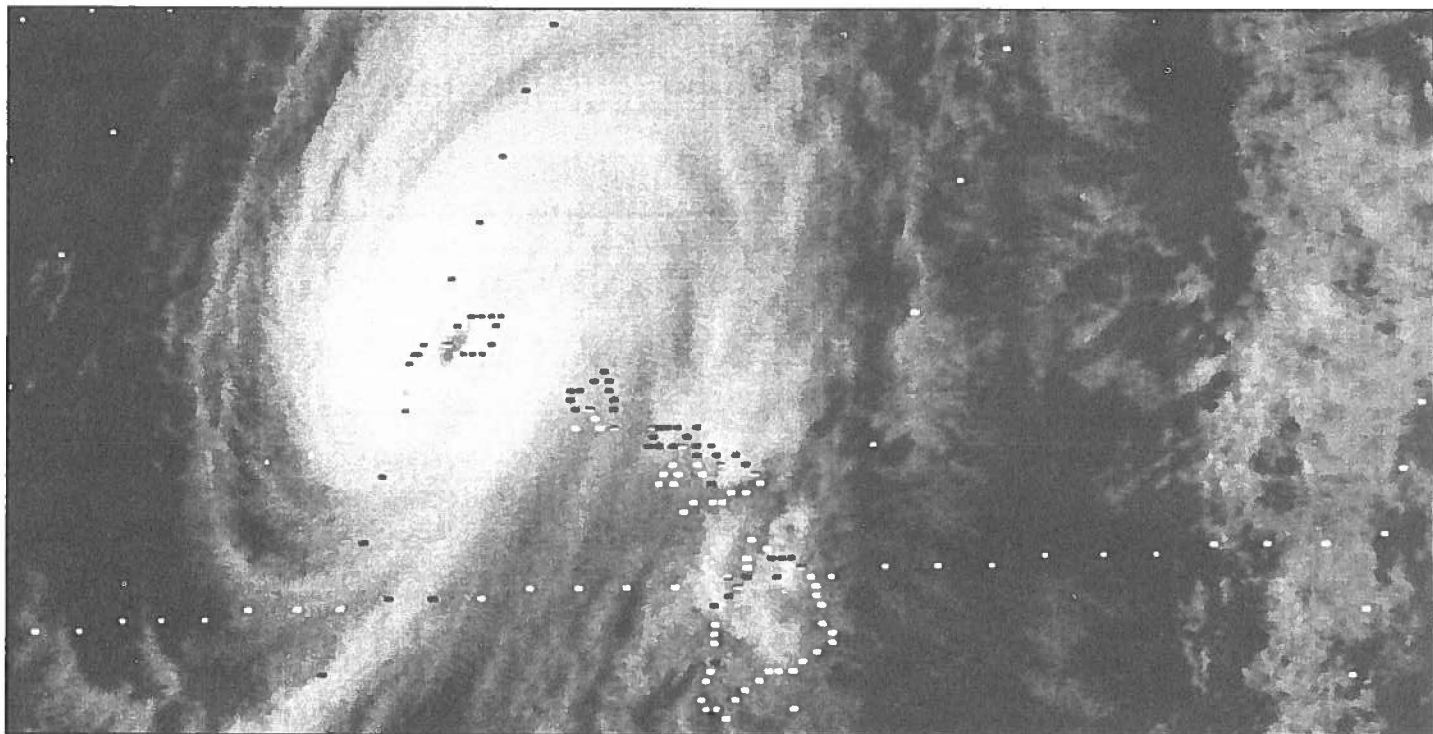
Highlights and Significant Events

Hurricane Iniki a record breaker. Damage surveys conducted on all islands confirmed the wrath of Iniki. While the northernmost portion of the state was battered by the full force of the storm, peripheral winds caused millions of dollars in damages to the rest of the island chain. In the wake of unprecedented damage and destruction, disaster response and recovery rapidly took on heroic proportions.

Gov. John Waihee issued a State Disaster Proclamation, setting in motion state response and activation of the Hawaii National Guard. All contingents had been prepared to move swiftly at the first signs of the Iniki threat. The governor's action led to an immediate Presidential Declaration of Disaster, paving the way for federal disaster aid.

Under the umbrella of the Federal Emergency Management Agency's response plan, dozens of federal agencies joined state and county agencies to help support local recovery and response organizations.

At the height of the response, over 20,000 persons were employed in disaster aid delivery. The combined federal, state and county team mounted the largest response and recovery effort in Hawaii's history.

In the weeks and months following the hurricane, the transition from response to recovery took form. As islanders returned to repair homes, possessions and businesses, the rebuilding process gained rapid momentum.

Short-term concerns however, such as social and human services, housing, employment and the economy, remained compelling issues for the people of Kauai. Coupled with the emotional stress that normally follows a disaster, a major insurance crisis brought added problems. Affordable temporary housing, contractor problems and climbing jobless rates all added to the distress.

To address these and other recovery issues, the governor formed a Hurricane Iniki Recovery Task Force in March 1993 to help keep recovery efforts balanced and positive. Maj. Gen. Edward V. Richardson, SCD director, was charged by the

governor to spearhead the task force. State departments and agencies were grouped into three major areas: housing and insurance, economic development and crisis intervention. The sub task forces worked with Kauai county and private, nonprofit agencies to maintain the recovery's forward momentum.

With the Garden Isle's economy strongly tied to tourism, employment- and visitor-related business will continue to be affected until the industry fully rebounds. While emergency unemployment compensation and temporary jobs helped ease the jobless rate, benefits and programs were due to lapse by the close of September. State agencies worked to counter the impact by offering job training and placement services, and helped to develop diversified economic strategies for the long term.

Hurricane Iniki exacerbated Kauai's housing shortage when

over one-third of the housing inventory was destroyed or heavily damaged. The scant availability of safe, affordable rentals, coupled with the need for permanent housing, led to rising rents and overcrowding. While repair and new construction has been underway for many months, affordable housing and rentals remain compelling issues. The housing solution lies with the private construction industry and state- and county-sponsored affordable and market housing projects.

In just a few short months the rebuilding process has been remarkable, but much remains to be done. By mid-year, about 40 percent of Kauai's hotel rooms were once again ready for visitors. But some major resort properties had yet to reopen and would remain closed until the end of the year or longer. As the visitor industry and related services regain vitality, Kauai's economy will see

some needed gains.

State and county agencies continue the partnership begun in the early days of Iniki to follow through with ongoing programs to boost the economic and social health of the community.

Initially heavily engaged in crisis response and coordination, State Civil Defense is currently managing public assistance projects for repair and construction of state, county and private nonprofit facilities. At the end of the fiscal year, 2,092 damage survey reports have been written

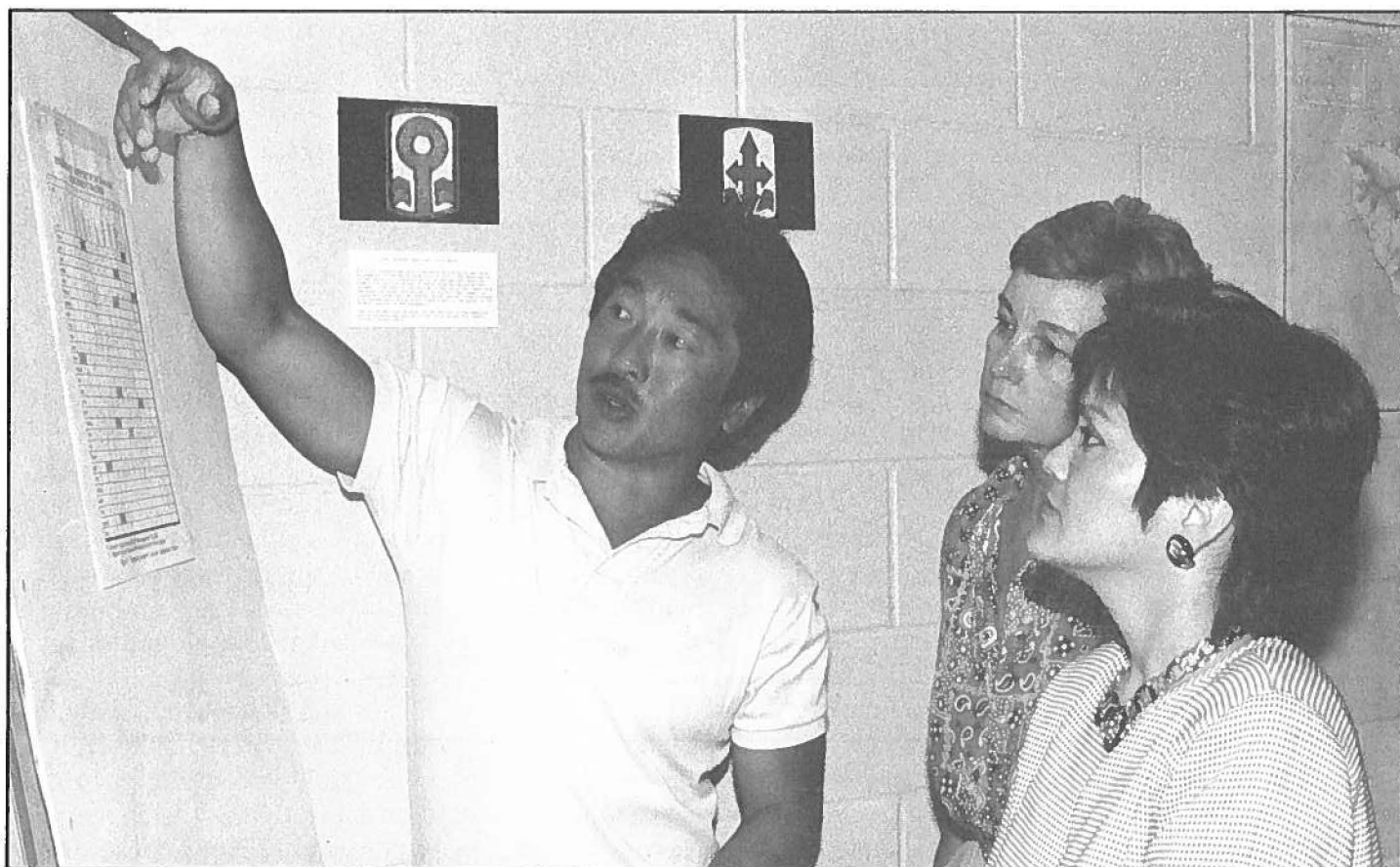
for repairs to 109 departments and agencies. Nearly \$117 million had been paid out or was pending payment. An estimated \$150 million in public property damage was recorded as the result of the hurricane.

Training

Training and exercises are key factors in maintaining the readiness of Hawaii's emergency management system. In 1993, 267 participants attended professional development courses aimed at familiarizing government agencies, local businesses

and volunteer organizations with the civil defense system and sharpening performance skills. A total of 13 training sessions were conducted statewide during the fiscal year.

Exercises also play a major part in readiness and response skills. A full-scale exercise conducted in early June helped evaluate inter-agency hurricane planning and response. Seventeen state departments and agencies took part in the half-day exercise to examine roles and responsibilities during Hurricane Iniki.

Office of Veterans Services

Mission

The Office of Veterans Services (OVS) is the principal state office responsible for the development and management of policies and programs related to veterans, their dependents and/or survivors.

Personnel

The OVS is authorized 22 full-time state employees. In November 1992, an additional full-time position was assigned to OVS by the Department of Labor and Industrial Relations (DLIR) to develop and coordinate activities pursuant to amendments to the federal Immigration and Naturalization Act, which allows Filipino veterans of World War II to enter the United States to obtain U.S. citizenship.

Organization

The OVS consists of the director, staffs of the veterans service

branch and administrative and office services staff. The Hawaii State Veterans Cemetery branch, located in Kaneohe, Oahu, is staffed by a cemetery operations manager, cemetery operations assistant, secretary, clerk typist, four general laborers and one tractor operator. The veterans services branch consists of the veterans services coordinator and veterans services units of Hawaii, Kauai and Maui, each consisting of a veterans services counselor and a clerk typist. The Oahu veterans services unit consists of a veterans services counselor and the DLIR-assigned Filipino veterans program coordinator.

Highlights and Significant Events

The dedication of the Hawaii State Veterans Cemetery was held on July 2, 1992. Shortly

thereafter the administration building and maintenance facility were completed and the staff moved from their temporary office trailer to their permanent quarters. The first Veterans Day and Memorial Day ceremonies were held with outstanding participation from veterans and communities.

On the afternoon of Sept. 11, 1992, Hurricane Iniki devastated the island of Kauai. The storm caused considerable damage to the county veterans' cemetery at Hanapepe and demolished the Kauai Veterans Center, which was under construction at the time. The Kauai OVS office received only minor damage, and the dedicated staff reopened it immediately. The veterans counselor was inundated with requests for assistance and spent the next months expediting veterans' claims.

The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts selected a memorial design after reviewing input from many veterans and the general public who had the opportunity to view and comment on the designs at several locations on Hawaii, Maui and Oahu. Kauai did not participate in the review because the Veterans Hall exhibition space was used to house Iniki refugees.

The first issue of the quarterly newsletter, *Hawaii Veteran*, was published in September 1992. It brings information and news of current events to over 8,000 individuals and organizations interested in veterans' issues.

In December, the first meeting of the Filipino Veterans Task Force convened to provide information and assistance to Filipino WW II veterans and their immediate family members; work in cooperation with the U.S. De-

partment of Immigration and Naturalization Service (INS) to facilitate the citizenship process, coordinate with other agencies to ensure that assistance is provided, develop plans and goals and propose legislation to address long-term needs.

The Handbook for Hawaii-bound Filipino WW II Veterans was developed and distributed to assist both individuals seeking citizenship and those assisting them. The Filipino veterans coordinator organized the efforts of the Filipino community and service providers, such as the state departments of Health, Human Services and Labor, the U.S. Department of Veterans Affairs and INS.

During FY 1992, nearly 25,000 veterans and dependents were served. Presentations continued to be the major means to raise visibility and publicize veterans' services. Presentations to veterans, retirees, reservists,

active duty personnel, senior citizens, school students, police recruits, partners and spouses of Vietnam veterans and the Filipino community provided information about the state's role with veterans' benefits issues.

As the primary advocates for veterans, the director and the veterans services coordinator appeared before the state Legislature to testify for needed services. They represented the governor at a wide variety of ceremonies, including Memorial Day, Veterans Day and Loyalty Day services, parades and conferences.

Counselors and other staff provided advocacy, information and referral services ranging from, but not limited to, veterans' benefits upgrades, exploration of options for veterans among the laid-off Hamakua Sugar workers, assisted-living facilities for those incapable of independent living, treatment of chemical dependencies, efforts to end housing discrimination, neighbor island cemetery renovation and upgrades; transition assistance programs for nearly 7,500 separating active duty military, establishment of a veterans organization in West Hawaii, participation in the Maui Senior Fair and a clean-up project on the Big Island, co-sponsorship with other organizations of a Veterans Benefit Resource Workshop in Hilo, a "town meeting" on Lanai and an orientation program for Filipino veterans service providers.

The staff continued monthly visits to veterans on the islands of Molokai and Lanai, as well as serving veterans and dependents in the non-urban areas of each county.

The OVS cooperated with the Department of Veterans Affairs on establishment of the Pacific Center for Post-Traumatic Stress Disorder (PTSD) in Hilo; the staff of the Kauai Primary Care Clinic and the Kauai Veterans Center to identify veterans requiring post-Iniki assistance; the Big Island Veterans Association on the Veterans Benefits Resource workshop; state and local agencies to provide support to Filipino veterans seeking U.S. citizenship; the Learning Disabilities Association of Hawaii to provide assistance to military families with children or grandchildren with special needs; the Hawaii Veterans Memorial Fund to execute the provisions of the Arthur Murakami Scholarship Fund for awards to deserving Hawaii residents; schools, veterans' organizations and military groups participating in the statewide effort to provide leis for Punchbowl on Memorial Day; veterans' organizations to honor veterans of all conflicts and to institute the tradition of flying the POW-MIA flag in all counties; the West Hawaii Veterans Association on establishment of a veterans' cemetery at Pu'u O'o; Maui's Aloha House on individualized treatment programs for the chemically dependent; the Punchbowl Task Force to study the impact of the visitor industry on the National Memorial Cemetery of the Pacific; the State Department of Defense's Engineering Office on continued development of the Hawaii State Veterans Cemetery, upgrading neighbor island veterans cemeteries, plans for the design and construction of the memorials for the casualties of the Korean and

Vietnam conflicts, and construction of the Kauai Veterans Center; and the Department of Land and Natural Resources on construction of the Maui Veterans Center.

Veterans services counselors serve as advisors to the Mayor's Veterans Advisory Committees, Councils/Committees on Aging, the Big Island Veterans Association, Kauai Veterans Association, Maui Veterans Council, and the Oahu Veterans Council.

During Fiscal Year 1993, 412 veterans and dependents were interred at the Hawaii State Veterans Cemetery. As more and more acreage was turned over to the cemetery, the staff continued to develop procedures and refine operations. Phase III of cemetery development, which includes construction of the committal shelter and additional road surfacing, was begun.

The Advisory Board on Veterans Services convened monthly to advise the director. It met in each county during the year and, in response to public demand, held an evening meeting on Oahu. Issues reviewed during the year were: selecting a site for a Veterans Hall at Rainbow Park, military relations and selection of the design for the

memorials. The board organized a committee to address the issue of building veterans' homes for Hawaii's veterans, with a priority given to homes on the neighbor islands. Members are: Walter J. Hayes, John K. Iwamoto, Louis Kaiowi, Alfred Los Banos, Barbara Ann O'Connor and Judith H. Worobe (Chair).

The Commission on Memorials for Veterans of the Korean and Vietnam Conflicts unanimously selected a winning design by Paul J. Medley. It consists of two serpentine terraced paths with granite pedestals, arranged chronologically with each bearing the name of a soldier killed as the result of the conflict. Members are: Ellsworth M. Bush (resigned 1/93), John Ching, Norbert Enos, Pat Hammon, Kurt E. Johnson, Allan J. Kellogg Jr., Herbert Kondo and Kenneth Kupchak (Chair).

Training

Staff development was emphasized this fiscal year. Staff trained in areas associated with their work, with the emphasis on communication, post traumatic stress disorder, computer literacy and safety and wellness.

Administrative Services Office

Mission

The Administrative Services Office (ASO) provides military and state administrative support to the Office of the Adjutant General. It coordinates and controls all planning, programming, budgeting and execution of departmental programs as directed by the adjutant general.

Personnel

The ASO is authorized 18 full-time state employees.

Organization

The ASO is comprised of the executive support, personnel and financial management services sections.

Executive Support

The ASO provides centralized office services and communications management, including the monitoring, review, distribution and filing of communications received from federal, state

and local governments and the civilian community. The ASO is also responsible for maintaining close liaison with Hawaii's congressional delegation and legislature, and for administering all legislation affecting departmental programs. The office prepares correspondence and testimony concerning various legislative proposals. The military component of the ASO provides executive support services to the adjutant general. It also coordinates the activities of the adjutant general's military staff, composed of members of the Hawaii National Guard (HING).

Personnel Management Services

The personnel management services staff administers the state employee personnel program which includes classification, compensation, recruitment and placement, personnel trans-

actions and records, performance appraisal, labor relations, training, workers' compensation and occupational safety and health.

Financial Management Services

The financial management services staff administers and controls state general fund appropriations, state administered federal funds and matching fund grants under the Federal Emergency Management Assistance program. The staff also provides centralized control and accounting of all state property assigned or issued to the department.

Highlights and Significant Events

There were 183 permanent state positions authorized during the year, 173 of which were filled by June 30, 1993. Additionally, 43 temporary positions were authorized and 30 were filled at

the end of the fiscal year.

During the fiscal year, the following types and number of personnel actions were taken:

With regard to performance ratings, 65 individuals received very satisfactory ratings, representing 32 percent of the state work force. From these, 17 sustained superior performance awards were submitted and approved during the fiscal year. The average monetary award amounted to \$200.

The 1993 recipient of the Adjutant General's Award for Distinguished State Service was Roy S. Iwamoto, contracts assistant with the Engineering and Facilities Management Office. The departmental nominee for the state Manager of the Year Award for 1993 was Maj. Wayne N. Yoshioka, military public affairs and education officer with the Public Affairs Office.

During the fiscal year, there were 15 reportable cases of work-related injuries involving state employees, which reflects a 60 percent decrease of reportable cases. There was a total of 129 lost workdays, or an average of eight workdays per injury, which reflects a 57 percent decrease of lost workdays.

Additionally, there were six workers' compensation injuries involving drill status National

Guard personnel, a decrease of 11 cases from the previous fiscal year. The compensation payment for these cases amounted to \$2,544, a 65 percent decrease. Due to Hurricane Iniki recovery efforts, there were 47 workers' compensation injuries of drill status National Guard personnel which amounted to \$33,610.

The ASO, through its fiscal staff, administered and controlled \$10,013,936 in state general fund appropriations and \$1,987,532 in federal fund appropriated receipts. In addition to regular operating funds, the fiscal staff administered and controlled \$5,000,000 of special federal fund appropriations for Hurricane Iniki relief efforts, of which \$4,227,066 was expended during the fiscal year.

The net general fund appropriation of \$10,013,936 was comprised of \$6,202,725 from the DEF 110 (departmental operating program), \$1,426,211 from DEF 112 (services to veterans program) and \$2,385,000 for major disasters, \$1,000,000 of which is solely used for matching federal disaster relief funds.

Total expenditures and encumbrances in both programs DEF 110 and DEF 112, less the allotted major disaster fund of \$385,000, amounted to \$9,058,984 for an expenditure rate of 94.08 percent, leaving a general fund lapsing balance of \$569,952. Federal fund expenditures and encumbrances amounted to \$1,914,730, leaving a reversion balance of \$72,802. The federal reversion balance was due to lower than expected receipts for Civil Defense federally-funded programs. Table 5 in the appendix depicts the distribution of general fund alloca-

tions, appropriated receipts and expenditures by programs, organizations and cost elements.

Additionally, the fiscal staff administered three federal fund holding and disbursing accounts. Table 6 in the appendix reflects the status of these accounts as of June 30, 1993.

The department's cash receipts for the year amounted to \$9,249,153. Of this amount, \$270,620 was credited to the state general fund, \$68,973 to the general fund operating account, \$8,909,540 to special (federal) fund operating accounts and \$50 to the trust fund. The sources and fund accounts to which they were credited are depicted in Table 7 of the appendix.

In administering the state finances for the year, the fiscal staff processed 4,296 purchase orders, 1,258 summary warrant vouchers, 89 payroll vouchers, 48 bills for collection, 79 federal fund claims invoices, 158 treasury deposit slips and 1,110 petty cash checks.

The department administered and accounted for state program funds through an in-house-developed accounting system and statewide Financial Accounting and Management Information System (FAMIS). Information is transmitted to the Department of Accounting and General Services via the department's direct on-line terminals.

Federal funds for Hurricane Iniki relief efforts from FEMA's Public Assistance Program (Public Law 93-288), amounting to \$4,512,313, were received under the department's ten separate damage survey reports and for administration of the program. In addition,

\$37,799,972 was received from FEMA and disbursed to other state departments, the counties and nonprofit organizations for public assistance. FEMA also transferred \$10,536,291 to the Department of Human Services for the Individual Family Grant Program, and \$518,267 to the Department of Health for crisis counseling.

Federal funds for Civil Defense program activities amounting to \$809,272 were received as 50-50 matching fund grants under the FEMA Program (Public Law 85-606) and the Civil Defense Maintenance and Service Program (Public Law 920); as 100 percent federally-funded contract grants for radiological instrumentation, maintenance and calibration, emergency management training, population protection planning, radiological defense planning and development and survival crisis management; and as a 50 percent funded contract grants for disaster improvement and earthquake preparedness.

Federal funds for the HING

amounting to \$1,137,454 were received under six separate cost-reimbursable operations and maintenance-service contracts negotiated between the National Guard Bureau and the State Department of Defense. These contracts provided for reimbursement of 100 percent, 80 percent and 75 percent of the authorized costs to operate and maintain buildings and grounds occupied by the federally-supported activities of the HING. Funds received under these contracts are deposited into the state treasury as appropriated receipts or as refunds of fringe benefits advanced by other state agencies.

During the year, the department added to its inventory of property 226 items valued at

\$717,249, and disposed and declassified 155 items of surplus or unserviceable property valued at \$194,042.

The fiscal staff also administered the short-term use and rental of departmental facilities by coordinating and processing 56 separate applications for use of armories and grounds located throughout the five major islands. The rental fees and utility reimbursements collected amounted to \$11,010. The department's property inventory as of June 30, 1993, is provided below.

Funds received under these contracts are deposited into the state treasury as appropriated receipts or as refunds of fringe benefit payments advanced by other state agencies.

U.S. Property and Fiscal Office

Mission

The mission of the U.S. Property and Fiscal Office (USPFO) for Hawaii is to receive and account for all funds and property of the United States in possession of the Hawaii National Guard (HING), ensure that federal funds are obligated and expended in conformance with applicable statutes and regulations, ensure that federal property is maintained and utilized

in accordance with National Guard Bureau directives, manage the federal logistics systems for Hawaii and provide the support necessary for the transition of mobilized units to active duty status.

Personnel

The USPFO for Hawaii is authorized 88 full-time federal technicians.

Organization

The USPFO is organized as follows: Administration Office, Data Processing Installation, Analysis and Internal Review Division, Resource Management Division, Purchasing and Contracting Division and Supply and Services Division.

Administration Office

This office performs administrative services in support of the

U.S. Property and Fiscal Office operations by maintaining a centralized publication library, providing reproduction services, receiving and processing office mail and providing typing and word processing services.

Data Processing Installation

The Data Processing Installation provides services to the USPFO, Hawaii Army National Guard (HIARNG), Surface Maintenance Office, Support Personnel Management Office, Standard Installation/Division Personnel System Branch and the Army Aviation Support Facilities. The installation operates a Burroughs B1955 and two UNISYS 5000/80 mainframes. Application software is slowly migrating from the Burroughs to the UNISYS system and should be completed in 1994. Installation of a Defense Data Network and electronic mail capability enables worldwide communication and data transfer.

Analysis and Internal Review Division

Internal reviews are conducted by this division to ensure federal resources are managed and utilized. Emphasis is placed on evaluating the effectiveness of internal controls and determining whether the HING is operating efficiently and economically.

Resource Management Division

Federal funds allotted to the HING from Congressional appropriations are managed by this division. Separate offices administer funds assigned to Army and Air operations.

The Army Guard office, located in the Diamond Head

Crater, is comprised of the financial manager, budget officer, staff accountant, Fiscal Accounting Branch and Pay and Examination Branch.

An assistant U.S. Property and Fiscal officer for Air (Fiscal) controls funds allocated for support of the Hawaii Air National Guard (HIANG). This office is located at Hickam Air Force Base.

Purchasing and Contracting Division

Purchasing and contracting services are provided by this office to all activities of the HING by sealed bids, competitive proposals and small purchase procedures in accordance with federal acquisition regulations. Purchases are made from commercial vendors located throughout Hawaii and the continental United States.

Supply and Services Division

This division is organized into the Stock Control, Property Management, Supply and Transportation Branches, and provides logistical support and

guidance to the HIARNG.

An assistant U.S. Property and Fiscal officer for Air (Property) provides logistical support and guidance to the HIANG. This office is located at Hickam Air Force Base.

A full-time Scheduled Airlines Traffic Office (SATO), established within the Transportation Branch, provides an entire array of transportation services, i.e., making plane and hotel reservations, writing airline tickets, handling air freight, arranging car rental reservations and other travel requirements.

Highlights and Significant Events

Federal funds used by the HIARNG during the federal fiscal year totalled \$53,423,065.

Federal funds used this year by the HIANG amounted to \$67,666,821.

Table 4 of the appendix reflects federal dollars used between Oct. 1, 1992 and Sept. 30, 1993.

Military payrolls for the HING totalled \$33,170,620 this federal fiscal year.

During federal fiscal year 1993, local purchases and contracting support of the HING units and activities totalled \$9,680,096. Of this total, \$2,612,131 represented architectural engineering services and construction contracts. There were 3,240 contracting actions for this federal fiscal year.

A total of \$5,039,837 was spent procuring supplies and equipment for the HIARNG. The Supply and Services Division maintained an inventory of \$179,576,569, which included wartime contingency stocks valued at \$4,465,083 and repair parts valued at \$975,555.

The HIANG received \$11,140,301 for supplies and equipment. The base supply operation processed 604,400 transactions in federal fiscal year 1993 -- a monthly average of

50,366. The equipment book value was \$96,233,420 at the end of the federal fiscal year.

The HIARNG Transportation Branch arranged transportation for a total of 4,542 individuals: 1,435 for military interisland and mainland airlifts, 718 for commercial trips to the mainland, 196 for foreign trips and 2,193 for commercial interisland trips. A total of 3,433 tons of cargo was shipped during the fiscal year: 2,019 tons for annual training, 22 tons for the mainland and 1,392 tons for interisland destinations. The use of SATO provided an estimated saving of \$2,324,655 for federal fiscal year 1993.

The HIANG Traffic Branch arranged transportation for a total of 1,030 individuals: 30 for military interisland airlifts, 827 for commercial trips to the

mainland, 40 for foreign trips and 133 for commercial interisland trips. A total of 68 tons of cargo was shipped during the fiscal year: 8 tons to the mainland and 60 tons to interisland destinations. The total amount of money spent to transport personnel and equipment is shown in Table 4 (Appendix).

Two UNISYS 5000/80 computer systems were installed in the Data Processing Installation. The UNISYS brings new technology and challenges to the staff and to all future users of the system. The UNISYS will completely replace the Burroughs within two to three years.

Six reviews were completed by the Analysis and Internal Review Division during federal fiscal year 1993.

Support Personnel Management Office

Mission

The Support Personnel Management Office (SPMO) is a consolidated office that provides personnel and manpower management administrative support services for all federal full-time personnel programs. The office serves as the adjutant general's single point of control for managing and administering Hawaii Army and Air National Guard personnel programs.

Personnel

The SPMO is authorized a staff of 21. The current office staff includes 15 federal technicians and three Active Guard/Reserve (AGR) soldiers.

Organization

A standard National Guard structure prescribes that the personnel office must be organized with the following operating sections: personnel management, employee services, military duty management, military duty services, equal employment opportunity, labor relations and personnel data systems. The office is centrally located, and all records and authorized staff are co-located to provide a single point of contact for personnel.

Personnel Management Section

Section staff members develop policy recommendations, procedures and plans in compliance

with the U.S. Office of Personnel Management and National Guard Bureau directives. The section is responsible for major program areas such as position management and classification, manning control, staffing, training, employee relations, performance management and recognition, incentive awards, disciplinary and adverse actions, grievances and appeals, personnel management evaluation and maintenance of the personnel data system. It furnishes technical advice and assistance to management officials, individuals and staff personnel.

Employee Services Section

This section provides a wide range of servicing to technicians

throughout their employment life cycle. Beginning with employment processing and new technician orientations, the staff furnishes information on employee benefits, processes personnel actions, maintains individual technician personnel records, ensures proper pay administration, administers the federal Workers' Compensation program and processes retirements.

Military Duty Management Section

Army National Guard AGR enlisted personnel career management and tour retention processes, recruitment and advisory services take up much of this section's time. Unlike their staff counterparts who administer the Army and Air National Guard technician programs in compliance with common directives, the AGR management staff administers the military programs based on policies and procedures established by the Army, Air Force and separate National Guard directorates.

Military Duty Services Section

This section is the point of contact for commanders, supervisors and individuals seeking AGR administrative service and assistance pertinent to pay, benefits and entitlements. The addition of a medical administrative specialist has vastly improved coordination with military and civilian medical care providers who treat AGR personnel and their dependents on Oahu and the neighbor islands.

Equal Employment Opportunity Section

The equal employment man-

ager plans, develops and administers programs for all employees (including state personnel) relative to equal employment. Programs administered include the affirmative employment programs with special emphasis on women and other minority issues, equal opportunity complaints processing, discrimination investigations and related training to departmental personnel.

Labor Relations Section

This section provides federal labor relations services within the department. Two locals from national labor organizations are exclusive representatives of non-supervisory technicians in three bargaining units. Typical tasks include contract administration, management advisory services and labor management relations training. The section also serves as the point of contact for union and other federal labor relations representatives and as management's representative in dispute resolution and contract negotiations.

Personnel Data Systems

The National Guard Personnel Data System (Civilian) was recently installed to provide automated data processing and storage for technician personnel actions. This table-driven, on-line system has the ability to process and store information on personnel actions, establish and monitor suspenses and produce reports.

Federal full-time support personnel authorizations are based on unit priorities. Although Hawaii Army National Guard (HIARNG) authorizations were reduced slightly, the personnel management section has been hard at work filling the full-time authorizations for the 203rd Air Refueling Squadron activated Feb. 12, 1993.

Twelve Hawaii Air National Guard (HIANG) and eight HIARNG technicians received merit pay increases under the Performance Management and Recognition System. Wage grade increases were effected for 153 HIARNG and 282 HIANG technicians in November 1992. Salary increases were awarded to 152 HIARNG and 304 HIANG general technicians in January 1993.

Thirty-one HIARNG full-time personnel attended training at the National Guard Professional Education Center in Little Rock, Ark. The center meets training needs on a centrally-funded basis, cost-free for AGR soldiers. Cost for the technicians attending is borne by the state.

The U.S. Office of Personnel

Management, Hawaii Joint Training Board and private sector vendors trained 58 HIARNG and 84 HIANG technicians in a variety of work-related subjects this year. Approximately \$43,684 in federal funds were expended for full-time personnel training.

Retirement and service awards luncheons were held in August 1992 and February 1993 and recognized 25 retirees, 16 length-of-service awardees and the recipients of the Adjutant General's Award (Department of Defense State Employee of the Year and Manager of the Year).

Engineering Office

Mission

The Engineering Office provides the entire spectrum of professional engineering services to the Hawaii Army National Guard, Hawaii Air National Guard, State Civil Defense and Office of Veterans Services and departmental staff sections to enable them to carry out their statewide programs.

Its responsibilities are to plan for, administer and supervise capital improvement projects, major and minor construction, consultant contract services, maintenance and repair, janitorial/custodial and ground maintenance, real property management, environmental and energy conservation, fire prevention and office paper recycling.

Personnel

The Engineering Office is

authorized 48 state, seven federal and two Active Guard and Reserve (AGR) positions.

Organization

The Engineering Office consists of seven major staff responsibilities: Office Services, Contracting and Engineering Services, Maintenance Services, Air National Guard Engineering Services, Army National Guard Engineering Services, State Civil Defense Engineering Services and Office of Veterans Services.

Repair and Maintenance Projects Awarded

Recurring minor maintenance, repairs and modifications of facilities are accomplished by in-house maintenance personnel on a time-and-materials basis, or by formal and informal construction contracts. This program is

supported by federal, state or joint federal/state matching funds through separate Army and Air Service Contracts or Army Guard Training Site Contracts. The federal contracts under the Service and Training Site Contracts for federal Fiscal Year 1993 were:

A total of \$860,000 in state operations and maintenance (O & M) funds were expended to support our department's statewide programs. In addition, \$55,000 in state O & M funds and

\$244,000 in storm damage funds were expended for special State Civil Defense projects and \$122,919 for various Kaneohe State Veterans Cemetery projects.

Minor Construction Projects

Minor construction projects include all projects for minor construction or major repair, maintenance or modification of facilities. This program is supported by federal funds, state funds or jointly with federal/state matching funds. Ongoing minor construction projects during this Fiscal Year amounted to \$228,000 for the Hawaii Army National Guard 100 percent federal funds.

Staff Judge Advocate Office

Mission

The Staff Judge Advocate (SJA) provides legal support to the adjutant general, staff elements, subordinate units of the Hawaii National Guard and the United States Property and Fiscal Office. In performing its mission, the SJA serves to:

- Prepare legal opinions on issues of federal law.
- Serve as federal litigation point of contact.

- Represent the adjutant general in federal labor-management proceedings.
- Review federal contracts relating to procurement and acquisitions and serve as the Hawaii National Guard's federal claims officer.
- Participate as legal advisor or counsel in administrative board proceedings.
- Act on behalf of the convening authority in National Guard courts-martial.

Personnel

The SJA Office consists of a judge advocate, supported by a shared clerk-typist for the Special Staff.

Organization

The SJA reports directly to the adjutant general and works closely with Guard commanders on legal issues relating to the federal mission of the National Guard.

Public Affairs Office

Mission

The Public Affairs Office plans, develops, directs and administers the department's community relations and public and internal information programs. In accomplishing its

mission, the office:

- Prepares and distributes news releases, photographs and videotapes on departmental activities to civilian and military news media locally and on the mainland.

- Responds to queries from the news media, public and other state and federal agencies.
- Provides briefings for civilian and military officials, community groups and new departmental employees to inform them of the

department's mission and its economic and educational contributions to the state.

- Publishes the semi-quarterly newspaper for distribution to present and retired Hawaii National Guard members, state and federal agencies, and other parties interested in departmental activities.
- Publishes the quarterly newsletter for the Office of Veterans Services for distribution to

veterans and veterans' organizations.

- Consolidates, edits and publishes the department's annual report.
- Prepares speeches and reports for the adjutant general.

Personnel

The office consists of a public affairs officer, three information specialists and a clerk-typist. All personnel are full-time

state employees.

Organization

The public affairs officer advises the adjutant general on public affairs matters relating to the department. The office works closely and coordinates its activities with public affairs officers of the department's major units/divisions and active military services to carry out its programs.

Senior Army Advisor

Mission

The Senior Army Advisor (SRAA) is responsible for providing advice, counsel and assistance to the adjutant general and his staff in order to strengthen the Hawaii Army National Guard's (HIARNG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to

the adjutant general.

- Represent and act as a spokesperson for the active Army in all HIARNG matters under the purview of U. S. Army Pacific.
- Render professional military advice to HIARNG commanders in military matters concerning the organization, operation, training and readiness of units.
- Monitor the use and assist in the management of federal

resources in support of the HIARNG.

Personnel

The office is staffed by an active duty Army colonel.

Organization

The SRAA reports directly to the adjutant general and works closely with Guard members on federal military missions and issues.

Air Force Senior Advisor

Mission

The Air Force Senior Advisor (AFSA) is responsible for providing advice, counsel and assistance to the adjutant general and his staff in order to strengthen the Hawaii Air National Guard's (HIANG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to the adjutant general and his senior staff.
- Represent and act as a spokesperson for the active Air Force in

all HIANG matters under the purview of Pacific Air Forces (PACAF).

- Maintain liaison with senior counterparts on the PACAF staff and ensure representation of HIANG issues, priorities and perspectives.
- Render professional military advice to HIANG commanders in military matters concerning the organization, operation, training and readiness of units.
- Maintain Instructor Pilot status and fly operational and training missions with one of

HIANG's flying units.

- Oversee and coordinate activities of all active Air Force advisors assigned to the HIANG.

Personnel

The office is staffed by an active duty Air Force lieutenant colonel currently qualified in one of HIANG's aircraft.

Organization

The AFSA reports directly to the adjutant general and works closely with PACAF counterparts and Guard members on federal military missions and issues.

Senior Enlisted Advisor

Mission

The State Command Sergeant Major (CSM) serves as the senior enlisted advisor for the Hawaii Army National Guard and is responsible to the adjutant general for a variety of matters pertaining to policies and actions relative to enlisted Hawaii Army National Guard soldiers. The State CSM's responsibilities are to:

- Advise the adjutant general

on all enlisted matters.

- Assist the inspector general in servicing enlisted problems.
- Work with the recruiting and retention office.
- Participate on boards related to enlisted soldiers to include promotion, Active Guard/Reserve continuation, selective retention and U.S. Army Pacific Non-Commissioned Officer and Soldier of the Year.
- Attend various conferences

both locally and on the mainland.

Personnel

The CSM's Office consists of a Command Sergeant Major, supported by a shared clerk-typist for the Special Staff.

Organization

The CSM reports directly to the adjutant general and works closely with Guard members on enlisted issues.

Inspector General

Mission

The Inspector General (IG) is assigned to assist the adjutant general in assessing and reporting on, in an unbiased, objective manner, areas affecting mission performance, the state of efficiency, economy, discipline, morale, esprit de corps and readiness of the Hawaii National Guard. The IG also performs other duties as required by law and regulations or as directed by the adjutant general. The mission is accomplished using the concept of a full-service IG to:

- Provide assistance to Guard

members, their families and the public in response to real or perceived issues involving the Hawaii National Guard.

- Act on adjutant general directives to conduct investigations and inquiries.
- Manage the staff/special inspection program throughout the Hawaii National Guard.
- Act as a teacher or trainer when and where possible while performing other functions.

Personnel

The IG's office is staffed by an

active duty Army lieutenant colonel and is supported by a shared clerk-typist for the Special Staff.

Organization

The IG reports directly to the adjutant general and is a member of his staff. The relationship between an IG and his commander has been referred to as one in which the commander places in him extraordinary trust and confidence "to be the eyes, ears and conscience of the commander."

Information Management Office

Mission

The Information Management Office plans, programs and manages Army National Guard automation (less the Data Processing Installation, U.S. Property and Fiscal Office for Hawaii), telecommunications re-

sources, visual information, records management, and publishing and printing. In accomplishing its mission, the office:

- Provides technical advice to the adjutant general, staff elements, U.S. Property and Fiscal Office and units of the Hawaii

Army National Guard.

- Develops and administers state information systems objectives, policies, plans and projects for supported organizations.
- Ensures adequate physical and operations security for automated information systems.

- Provides telecommunications, visual information, records management, publishing and printing and automation support to supported organizations.
- Determines automation training needs, coordinates training classes and recommends appropriate user training.

Personnel

The Information Management Office consists of the director of

information management, a computer systems programmer, a communications management specialist, a computer assistant, a support services specialist, a supply clerk and a duplicating machine operator. All personnel are federal technicians.

Organization

The Director of Information Management (DOIM) serves as the principal information man-

agement advisor on present and future requirements for automation, telecommunications, records management, publishing and printing, and visual information to the adjutant general and Hawaii Army National Guard officials. The office works with the National Guard Bureau's Information Systems Directorate, as well as with the other 53 Information Management offices nationwide to perform its mission.

State Family Program Office

Mission

The State Family Program Office manages programs designed to increase the overall preparedness of Hawaii National Guard families to cope with the unique realities of Guard service. The Family Program Office accomplishes this mission by:

- Increasing the knowledge of family members regarding the benefits, privileges and obligations of Guard service;

- Creating a family support system to assist members during separations, providing information/referral networking and enhancing Guard retention;
- Providing feedback to the command on the concerns of family members.

Personnel

The office consists of a coordinator who is the only paid staff member. A state volunteer representative assists the coordinator in managing the activities

of program volunteers throughout the state. Clerical support is provided by a shared Clerk-Typist for the Special Staff.

Organization

The state family program coordinator reports directly to the adjutant general. The coordinator works closely with the State Team, a volunteer action and advisory council and family support groups throughout the state.

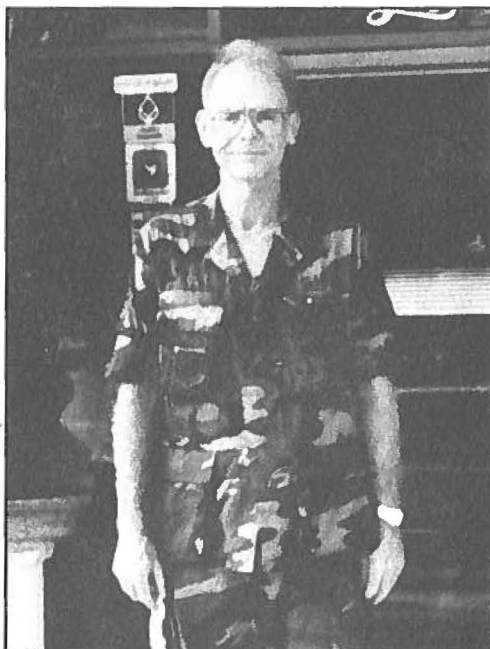

In Memory of Tech. Sgt. D. Cliff Dalen



Tech. Sgt. D. Cliff Dalen was a power production technician with the 297th Air Traffic Control Flight. Cliff was a veteran who served in the United States Air Force during the Vietnam era and served in the Hawaii Air National Guard for the past 18 years.

When Hurricane Iniki devastated Kauai, Cliff designated his largest power plants for Kauai to provide emergency generator power. Within hours, his ever-ready generators were prepared, packed and taken to Hickam to be loaded on the first available aircraft to Kauai.

Cliff made the ultimate sacrifice, Mon., Sept. 14, 1992. While on his way to repair an electric generator near Hanalei, he died in a traffic accident.

Cliff took tremendous pride in carrying out his duties. He knew his job, and he knew it well. He was responsible for providing all of the electrical

power for the unit's air traffic control (ATC) facilities (the air safety of airborne aircraft relies on ATC facilities). The power production equipment that Cliff worked with required short periods of "down time" to perform routine maintenance. The system design was unacceptable to Cliff, who overcame these limitations and modified the system to provide the airborne aircraft with uninterrupted services.

During major command inspections, Cliff was routinely identified as a professional performer. This award recognized individuals who were within the top 10 percent of the entire command worldwide.

Whenever there was a deployment or a job to do, his ears would perk up and he was the first to volunteer. His voice would echo within the halls of his shop, "Eh Bully, let's go! We're going! We've got a job to do."
