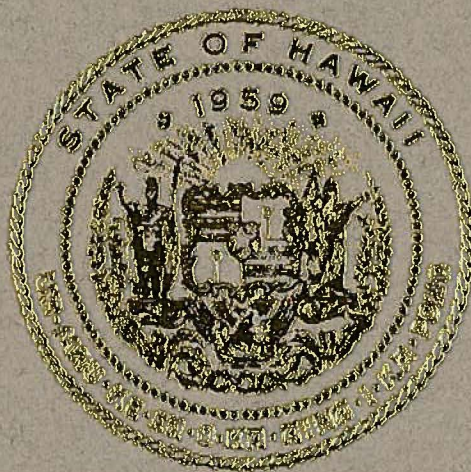

ANNUAL REPORT Fiscal Year 1994



Dear Governor Cayetano:

Fiscal year 1994 was another successful year for the State of Hawaii Department of Defense. Our department continued its important role in the defense of our country and state by upgrading and modernizing our equipment and facilities, maintaining our force structure in the face of a nationwide military drawdown and improving the quality of life for our employees.

The Hawaii Army National Guard's 29th Infantry Brigade (Separate) was selected as one of fifteen elite Enhanced Readiness Brigades in the nation. The Army Guard also received the first of sixteen CH-47 Chinook helicopters for a new medium lift company on Oahu and prepared for the arrival of four UH-60 Blackhawk helicopters for an aeromedical detachment on the Big Island. In February, the Secretary of the Air Force announced the addition of four more KC-135 Stratotankers, the addition of three more C-130 Hercules transports and the reduction of nine F-15 Eagles for the Hawaii Air National Guard.

By legislative mandate, the Adjutant General's Interim Task Force on National Guard Recruitment and Retention enabled the State Legislature to pass a bill during the 1994 session that allows Guard members to use the Montgomery G.I. Bill concurrently with the University of Hawaii tuition waiver program. In addition, a state version of the Soldiers and Sailors Civil Relief Act was signed into law, extending protection to National Guard members activated on state orders.

As the Hawaii National Guard's new commander in chief, you will be overseeing a department with a record of excellence that continues to add to its list of accomplishments.

Department of Defense

Mission

The mission of the State of Hawaii Department of Defense is to assist authorities in providing for the safety, welfare and defense of the people of Hawaii. The department continuously strives to maintain its readiness to respond to the needs of people in the event of war or disasters, whether natural- or human-caused. Upon activation by the Governor of Hawaii, the department is prepared to provide professional personnel, quality services and well-maintained equipment to assist during emergencies.

The Hawaii Army and Air National Guard also train to meet its federal mission, should it receive a presidential call to duty in times of national emergency.

The Office of Veterans Ser-

vices (OVS) serves as the single point of contact in state government for veterans' services, policies and programs. The OVS also oversees the construction and administration of the Hawaii State Veterans Cemetery and neighbor island cemeteries.

Personnel

Compared to the other state departments, the full-time force of the Department of Defense represents a varied mixture of federal, state, active duty and drill-status National Guard members. This force includes, as of Sept. 30, 1,198 full-time federal employees, 212 state employees and 5,689 drill-status Army and Air National Guard members.

Organization

The State Department of

Defense is made up of three major divisions, one inactive division, six key staff offices and the Office of Veterans Services.

The three major divisions are the Hawaii Army National Guard, Hawaii Air National Guard and State Civil Defense.

A fourth division, which is currently inactive, is the Hawaii State Defense Force. The Hawaii State Defense Force may be activated should the need arise.

The six key staff offices provide support services to the three active divisions and other activity centers within the department. The key staff offices include the Administrative Services Office, U.S. Property and Fiscal Office, Human Resources Office, Engineering Office, Staff Judge Advocate Office and Public Affairs Office.

The special staff includes the

Senior Army Advisor, Air Force Senior Advisor, Senior Enlisted Advisor, Inspector General, and State Family Program Coordinator.

The adjutant general is the executive head of the department. In addition to being a member of the governor's cabinet, the adjutant general is the commander of both military divisions and the director of State Civil Defense.

Hawaii National Guard

The Hawaii Army National Guard and Hawaii Air National Guard collectively form the Hawaii National Guard. Under the

banner of the Hawaii National Guard, the Army and Air National Guard divisions maintain, in a style unique to their military institutions, a history rich in traditions, contributions, sacrifices and high marks of excellence.

State Civil Defense

State Civil Defense has two important missions. The first is to minimize loss of life, reduce property damage and restore essential public services and facilities devastated by natural- or human-caused disasters. The second mission is to provide for

the welfare and safety of citizens, ensure the continuance and/or reconstitution of state government and mobilize and manage state resources in the event of war.

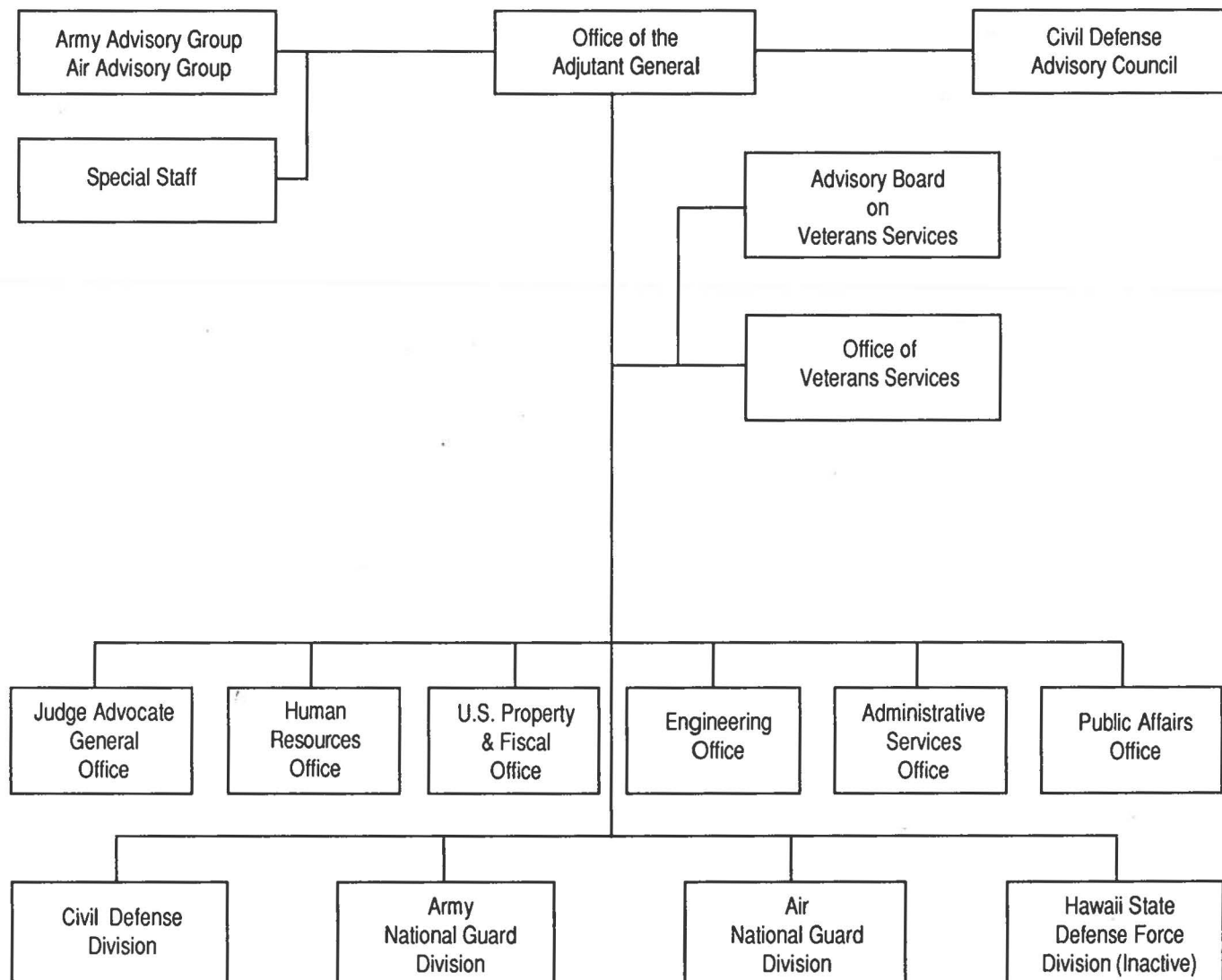
Office of Veterans Services

The Office of Veterans Services (OVS), which was administratively attached to the Department of Defense in July 1988, serves as the primary state agency responsible for developing and managing veterans' programs, policies and activities. The OVS is also charged with planning, establishing and operating the Hawaii State Veterans Cemetery on Oahu.

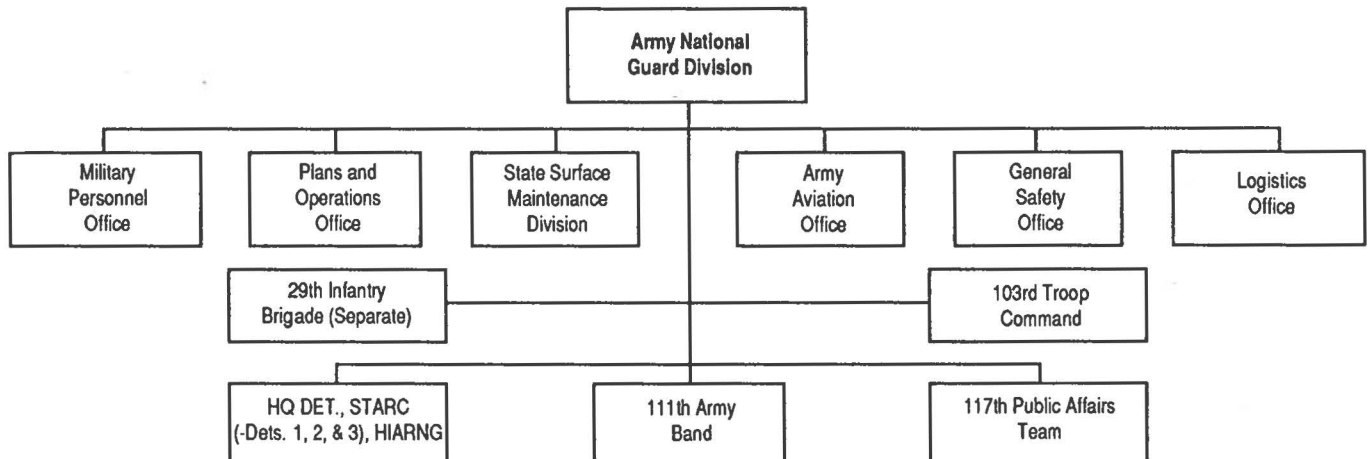

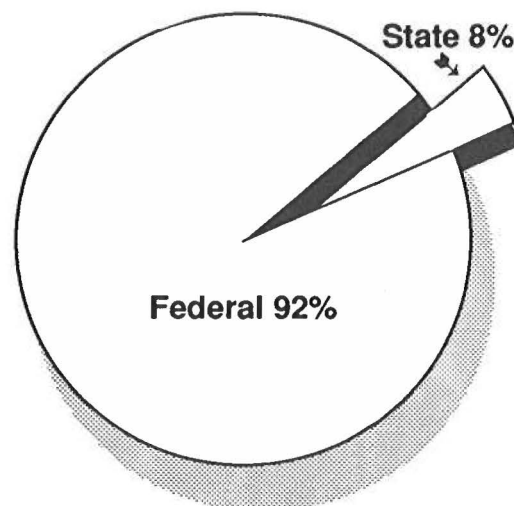

Hawaii Army National Guard

Mission

The Hawaii Army National Guard (HIARNG) continually trains to maintain its readiness for state or federal active duty. It is prepared for local or global assignments, should the governor or president order it to active duty.

Personnel

The authorized strength of the HIARNG increased from 4,056 to 4,058 as a result of a minor reorganization. The assigned strength of the HIARNG stood at 3,547 at the end of Fiscal Year 1994, an increase of 156 members from the previous fiscal year and 87.4 percent of the authorized 4,058 positions. This number included 337 commissioned officers, 118 warrant officers and 3,092 enlisted personnel.

Organization

The HIARNG consists of the Headquarters, State Area Command, 29th Infantry Brigade (Separate), 103rd Troop Command, 111th Army Band, 117th Public Affairs Team, Hawaii Military Academy and Selective Service Section.

29th Infantry Brigade (Separate)

The 29th Infantry Brigade (Separate) is the largest unit in the Hawaii Army National Guard. The brigade has units located on the islands of Oahu, Molokai, Maui, Kauai, and Hawaii. It trains to ensure its readiness for the Hawaii National Guard's state and federal missions. As of Aug. 11, 1994, 2,482 soldiers were assigned. This included 170 officers, 15 warrant officers, and 2,297

enlisted members.

The brigade consists of a headquarters and headquarters company, two infantry battalions, a field artillery battalion and a support battalion. In addition, separate units include a ground cavalry troop, a combat engineer company, and a signal detachment. This mix of units and equipment provides the brigade commander with a variety of options when employing the brigade for federal or state missions. Upon federal mobilization, the brigade would receive its third "round-out" infantry battalion, the 100th Battalion, 442nd Infantry, assigned to the U.S. Army Reserve.

During the fiscal year, the brigade successfully participated in two major exercises. From July 17 to 31, it completed

annual training at Schofield Barracks and Pohakuloa Training Area. The brigade staff deployed overseas to Japan to participate in the IX Corps (U.S.) joint command post exercise, Yama Sakura XXV, from Jan. 22 to Feb. 5.

103rd Troop Command

The mission of the 103rd Troop Command is to provide command and control over its assigned units. The command's assigned strength, as of July 31, 1994, was 687. This included 56 officers, 75 warrant officers and 556 enlisted members.

The Troop Command is headquartered at Waiawa Armory in Pearl City, Oahu. It is one of two major commands within the HIARNG. The 103rd includes a combat aviation battalion at Wheeler Army Airfield, a combat service support battalion headquartered at the Waiawa Armory, two aviation detachments based at Hilo's Gen. Lyman Field, a division-level tactical rear operations cell at Waiawa Armory, and an engineer detachment at Fort Ruger.

The units within Troop Command provide a broad spectrum of combat and combat-service support. The aviation detachments provide a trained pool of qualified aviators. The supply and service battalion stores and issues supplies, repairs and rebuilds military equipment and maintains vehicles, weapons and sophisticated electronic equipment. The organization also provides limited field services, including renovation of light textiles. The division rear operations cell provides support of rear operations. The engineer detachment provides utilities

repair and maintenance.

Aviation

The HIARNG's aviation units include the Headquarters State Area Command aviation section, with its 18-passenger C-26 aircraft; 1st Battalion, 193rd Aviation (Attack), whose units are transitioning to a medium lift helicopter company; an

aviation intermediate maintenance unit; the 451st and 452nd Aviation Detachments; and a Reconnaissance and Interdiction Detachment (RAID) that supports counterdrug operations.

Aircraft inventory includes seven CH-47D Chinook helicopters, four UH-60A Blackhawk helicopters, and a C-26B Metroliner twin-engine, fixed-

wing aircraft. Two specially-equipped OH-58A Kiowa helicopters were added to the inventory to support RAID missions.

The aviation units flew a total of 2,256 hours, which represents 100 percent of their annual flying hour program. These flight hours were used to accomplish mission support, proficiency training, aircrew qualification, unit training and support to civil authorities.

The two Army Aviation Support Facilities assigned to the HIARNG serve as bases for its maintenance and training programs. These training programs include aircraft qualification, nap-of-the-earth qualification, aerial gunnery training, unaided night qualification and night vision goggle qualification.

Surface Maintenance

The State Surface Maintenance Division has 75 full-time federal technicians employed at seven support facilities located throughout the state. An additional five soldiers on Active

Guard/Reserve status provide automated repair parts supply support for maintenance programs throughout the HIARNG. These soldiers support 49 different units and 21 activities which include active Army and Army Reserve units located on the islands of Hawaii and Maui.

Employees of this division worked more than 160,000 hours performing scheduled services and installing more than 1.1 million dollars of repair parts. These efforts enabled all HIARNG units to exceed the Department of the Army's material readiness goal of 90 percent.

This division has also assisted the National Guard Bureau in automating logistics within the Army National Guard by training and fielding the Unit Level Logistics System to units in Hawaii, California and Idaho. Other activities included support for the recent presidential visit to the State of Hawaii.

Employees of this division continued to keep abreast of force modernization programs by attending training here and on the mainland.

Regional Training Site-Maintenance

The Regional Training Site-Maintenance (RTS-M) provided maintenance and logistics training for Army, Marine, National Guard, and Army Reserve soldiers. The RTS-M conducted Military Occupational Speciality Qualifications (MOSQ), transition, sustainment, and skill qualification courses.

The RTS-M was accredited by teams from the Army's Aberdeen Proving Grounds, Md., and Fort Lee, Va. It is now considered an extension of the Training and Doctrine Command (TRADOC) total force school system.

Hawaii's RTS-M became the first school in the Pacific region to conduct the automated logistical specialist transition and MOSQ course. Soldiers who completed this 244-hour course were awarded the appropriate skill level identifier.

The RTS-M is the only school authorized to conduct the wheel vehicle recovery course. Soldiers who complete this 80-hour course are eligible for the "H8" additional skill identifier.

The RTS-M fielded the unit level logistics systems for units in the HIARNG and in Guam and Okinawa. It also provided equipment support to units within the Hawaii Army and Air National Guard and Army Reserve during their annual training.

The staff also assisted the G3 by providing training on the Army's automated training seat reservations system to Hawaii Army National Guard and Army Reserve soldiers.

Hawaii Military Academy

The Hawaii Military Academy (HMA) provided training for Army National Guard soldiers from Hawaii, Guam, and Samoa. It also trained U.S. Army Reserve soldiers (USAR) from the Pacific area. The academy conducted four major categories of training. These were Officer Candidate School (OCS), Non-

commissioned Officers Education System, Nonprior Service Training Program, and military occupational speciality qualification (MOSQ) courses.

In 1994, the academy's 12 officer candidates were commissioned as second lieutenants. Members of the graduating officer candidate class completed their final two weeks of intensive tactics training at Fort Lewis, Wash. The training was hosted by the Washington Military Academy. The programmed OCS training was consolidated with nine other academies within the 7th region. The incoming OCS class conducted Phase I OCS training at Camp San Luis Obispo and California Polytechnic State University. The training was hosted by the California Military Academy and included seven other states.

The Academy conducted three basic noncommissioned officer (NCO) courses and two advanced NCO courses, graduating over 110 NCOs.

The academy also provided skill level 1 training to 11 military policemen, five indirect fire support specialists, and 70 infantrymen in various MOSQs. Soldiers who attended the training included National Guard and USAR personnel from Hawaii, Samoa, and Guam.

The academy's First Sergeants Course qualified nine soldiers for first sergeant positions in their units. Battle-focused instructor training courses and small group instructor courses were also conducted at the academy for unit trainers.

Highlights and Significant Events

During FY 1994, HIARNG

members were tasked with a variety of missions involving military support to civil authorities (MSCA). Although none of these missions compared in magnitude to the Iniki operation of 1992, many of the lessons learned during Iniki were incorporated in the updated contingency plans and tested during the missions.

In August 1993, the HIARNG used these new MSCA plans and checklists to prepare for Hurricanes Fernanda and Keoni. Fortunately, neither hurricane struck the state. In January 1994, a HIARNG emergency operations officer was invited by the adjutant general of California to observe and assist the California National Guard in the Northridge Earthquake Relief Operations. During March 1994, members of the 1st Battalion, 299th Infantry, on Maui were mobilized for evacuation of residents and search and rescue missions in Paia and Lahaina during heavy rains. In May 1994, the Hawaii National Guard (HING) activated its Joint Emergency Operations Center as part of the state's Makani Pahili '94 Hurricane Exercise. The exercise tested the HING's ability to coordinate multiple requirements with State Civil Defense and other agencies. All of these MSCA missions and exercises served to refine and exercise the HING updated contingency plans and checklists.

Aviation units in the HIARNG continued to increase their mission capability with the receipt of new aircraft, the CH-47D Chinook and UH-60A Blackhawk helicopters.

Major mission shifts occurred because of the conversion of the

1st Battalion, 193rd Aviation, from an attack helicopter unit to a medium lift company with 16 CH-47D (Chinook) helicopters and 210 soldiers. At the close of the reporting period, the unit had received seven of its authorized 16 helicopters. The remaining aircraft were scheduled to arrive during the fourth quarter of fiscal year 1995 and in fiscal year 1996. The unit, designated as Company C, 193rd (Medium Lift), will be stationed at Wheeler Army Airfield.

The CH-47D improved the HIARNG's ability to support relief efforts during state emergencies. Each Chinook can carry a 2,000-gallon water bucket for use in fire suppression. This is the largest capacity of any helicopter based in Hawaii. Also, the CH-47s can move large amounts of supplies and equipment. These loads can be carried internally or by external slingload. This capability makes the Chinooks invaluable assets

in natural disaster relief efforts throughout the island chain.

The 451st and 452nd Aviation Detachments, housed at the limited aviation support facility at Hilo, Hawaii, are being replaced by a medical aviation detachment. The unit will be equipped with four new UH-60A Blackhawk helicopters which are replacing the vintage UH-1 "Huey" Iroquois helicopters.

In October 1993, two battalions of the HIARNG relocated their headquarters. The 1st Battalion, 487th Field Artillery, moved from the Fort Ruger area to the newly renovated Wahiawa armory. The Wahiawa armory now houses all four batteries of the artillery battalion. The Headquarters and Headquarters Detachment of the 297th Supply and Service Battalion moved from the Wahiawa armory to Fort Ruger, and Troop E, 19th Cavalry, relocated to the Kaneohe armory.

On Aug. 30, 1994, the 29th

Infantry Brigade (Separate) was officially selected as one of the National Guard's 15 enhanced readiness combat brigades. Those units will receive the best equipment, additional funds for training, and other support to guarantee that they are ready for combat within 90 days after mobilization.

On July 1, 1994, Detachment 1, Headquarters, State Area Command, Troop Command, Hawaii Army National Guard, was redesignated as the 103rd Troop Command, Headquarters, State Area Command, Hawaii Army National Guard.

Training

HIARNG units participated in a wide range of training activities throughout the year. Troop Command units used year round annual training to prepare units for new missions after pending activations. Brigade units trained at various times to capitalize on opportunities both

in and out of the state.

The 13-member 117th Public Affairs Detachment was reorganized into a five-member Public Affairs Team (PAT) in December. The team is augmented by members of the Headquarters State Area Command public affairs section. The team produces high quality video, photographs, and news releases and distributes the releases to local and national media. The 117th PAT provided public affairs support to the Hawaii Army Guard during annual training on Oahu, Hawaii, and in Oregon/Washington. They also provided support other organizations and activities including the Hawaii Air National Guard, State Civil Defense, Office of Veteran Services, World War II commemoration ceremonies, Superkids and CPR Sunday.

In January 1994, 24 soldiers from the 29th Infantry Brigade (Separate) deployed to Hokkaido, Japan. They participated in a joint, bilateral command post exercise co-sponsored by the United States Forces, Japan, and the Japan Self Defense Forces joint staff office.

In February, the 111th Army Band participated in the 50th anniversary of World War II commemoration ceremonies on the islands of Majuro, Kwajalein, and Roi-Namur in the Republic of the Marshall Islands. The band also participated in the World War II commemorations in Hawaii during July with performances at Ala Moana, parades in Waikiki and Kahului, Maui, honoring World War II veterans, and the dedication of the Korean/Vietnam War Memorials near the State Capitol.

In June, 95 soldiers of company B (Maintenance), 29th Support

Battalion, deployed to Sagami Army Depot, Japan, to perform their annual training. Their mission was to repair the war reserve equipment for U.S. Army, Japan. The unit repaired various types of vehicles as well as communications equipment and small arms.

In June, the 297th Supply and Service Battalion, 12th Personnel Services Company and 291st Maintenance Company performed their annual training at the Barbers Point Naval Air Station and South Range Training Areas on Oahu. The focus of the training was tactical field operations.

Also in June, soldiers of the 1st Battalion, 487th Field Artillery, conducted their annual training at Pohakuloa Training Area. Their objectives were to recertify their firing batteries. In August, they received new equipment training on the Initial Fire Support Automated System (IFSAS).

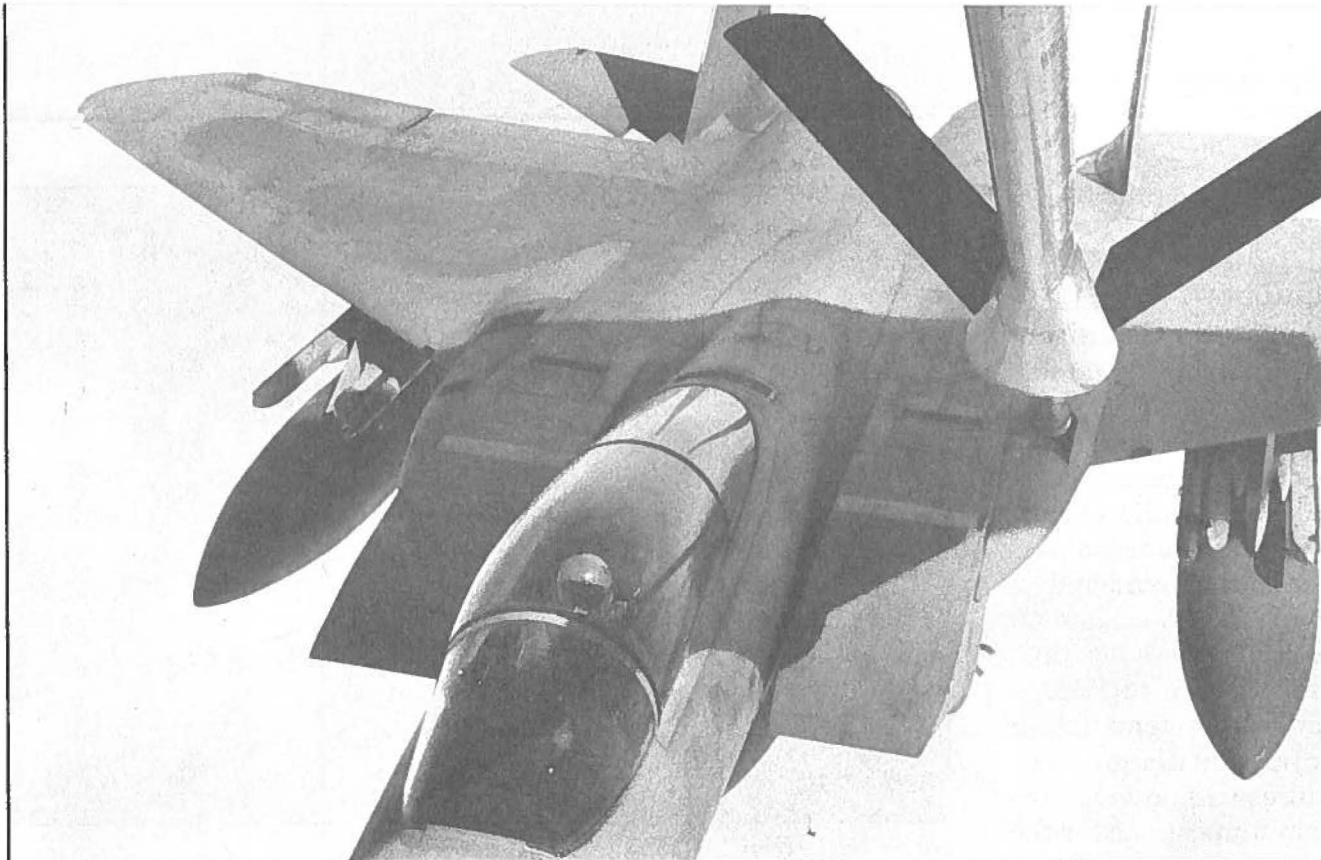
The 451st and 452nd Aviation Detachments performed their annual training at Pohakuloa Training Area, July 16-30. The units provided aviation support for

the 29th Infantry Brigade (Separate) and Troop E, 19th Cavalry.

Camp Rilea, Ore., was the annual training site for 385 soldiers of the 1st Battalion, 299th Infantry. The battalion conducted training on infantry tasks which included live fire exercises. Company D conducted a live fire exercise at the Yakima Firing Center, Wash., with five tube-launched, optically tracked, wire-guided (TOW) anti-tank missiles.

The remainder of the brigade conducted annual training at Schofield Barracks and Pohakuloa Training Area, July 16-30. The 129th Signal Detachment provided the brigade with communications support during annual training.

In late July, soldiers of the 298th Engineer Detachment performed their annual training. They constructed a warehouse office and storage shed for the USPFO-Hawaii, renovated a Hawaii State Motor Pool office and replaced light fixtures in OMS #2 service bays.

Hawaii Air National Guard

Mission

Like its continental counterparts, the Hawaii Air National Guard (HIANG) serves dual missions. In performing its state mission, the HIANG provides organized, trained units to protect Hawaii's people, preserve peace and ensure public safety in response to natural or human-caused disasters. Its federal role is to provide operationally-ready combat units, combat support units and qualified personnel for active duty in the U.S. Air Force in time of war or national emergency.

Personnel

As of Sept. 30, 1994, the assigned strength of the HIANG

was 230 officers and 1,902 enlisted personnel. The total members make up 84.4 percent of the 2,525 positions authorized.

Organization

The HIANG is directed by the commander, Hawaii Air National Guard, and is comprised of the HIANG Headquarters, 154th Group, 201st Combat Communications Group and 199th Weather Flight.

154th Group

The 154th Group is the largest of the HIANG organizations. It includes a headquarters, a fighter squadron, an air refueling squadron, a consolidated aircraft maintenance

squadron, two aircraft control and warning squadrons, an air control squadron and seven additional support units.

Responsibility for the state's air defense belongs primarily to the 154th Group. Located at Hickam Air Force Base, its fighter squadron is equipped with F-15A/B Eagles to provide fighter-interceptor capability for the air defense system.

The Group's two aircraft control and warning squadrons operate radar sites at Kokee Air Force Station, Kauai, and Mount Kaala, Oahu. The two radars are linked to the Hawaii Regional Operations Control Center at Wheeler Army Airfield, Oahu, and provide 24-hour surveillance

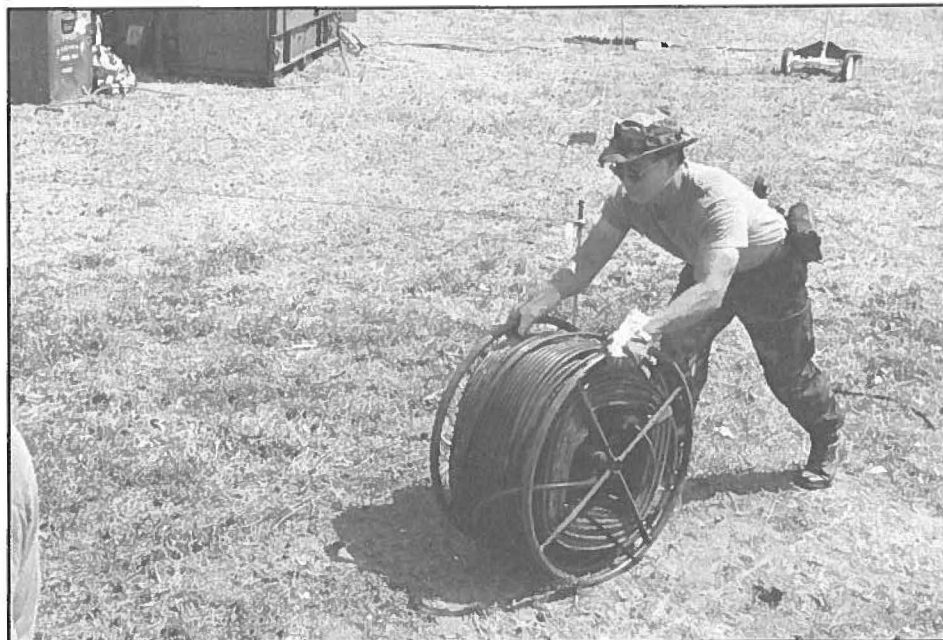
of the entire Hawaiian island chain.

201st Combat Communications Group

The 201st Combat Communications Group (CCG) is composed of a Group headquarters (HQ) and six assigned units located on the four major Hawaiian Islands and Alaska. Its primary missions are to provide command and control communications and air traffic control services for Air Force combat forces, support emergency requirements for air traffic control and communications facilities and provide tactical communications for the State of Hawaii Department of Defense in response to emergencies and disasters. When activated under call-up or mobilization authorities, communications units are able to activate their personnel within 24 hours and be ready to deploy within 72 hours. The 201st is able to sustain command and control communications and air traffic control services for 30 days with their own readiness spares packages.

199th Weather Flight

The 199th Weather Flight (WF) provides meteorological support primarily to the Hawaii Army National Guard's 29th Infantry Brigade (Separate) and secondarily to active and reserve components of the Army and Air Force. When deployed, services include continuous, 24-hour staff weather services, forecasting, observation and climatological support to the 29th Brigade's tactical operations center and a brigade airfield, drop zone, or helipad. Located at Wheeler Army Air Field, the unit pro-

vides weather information to the joint, worldwide meteorological network operated by the Air Force's Air Weather Service, the National Weather Service and the World Meteorological Organization.

Highlights and Significant Events

The past fiscal year was characterized by many significant changes, challenges and accomplishments. In July 1993, the 201st CCG conducted an Operational Readiness Exercise (ORE) to practice its initial response and employment capabilities. Beginning in August, technicians from the 291st Combat Communications Squadron (CCS) (Hilo) and air traffic controllers from the 298th Air Traffic Control Flight (ATCF) (Kauai) volunteered and participated in the Air National Guard's (ANG) ongoing Operation Steady State, a drug inter-

diction program in Central and South America. In late August, the 201st CCG deputy commander participated in the ANG Site Activation Task Force conducted for the 176th Combat Communication Flight (CCF), Kulis ANG Base, Anchorage, Alaska.

In September 1993, the 154th Group's C-130 assisted with the rescue of a downed civilian helicopter pilot in the ocean between Oahu and Molokai. The helicopter quickly sank and the pilot was adrift with only a life preserver. The quick actions of the C-130 crew in directing a Marine helicopter to the proper location helped to save the downed pilot.

In mid-September, the 201st CCG received two of three TTC-39A(A)4 Automatic Telephone Circuit Switches, and three TRC-170(V)3 Tropp Scatter Radio Sets for its combat communications squadrons. In conjunction with

these deliveries, the "last fielding" ceremony of the TRI TAC communications equipment was conducted in October 1993 at the 201st CCG headquarters with representatives from the manufacturer, a DOD communications agency, the National Guard Bureau and the HIANG participating.

In early November, the 201st conducted another ORE in preparation for its Operational Readiness Inspection (ORI) in early FY '95.

Later in November, the 293rd CCS provided its TSC-100A satellite communications equipment and five personnel to the Defense Satellite Communications System to support the

restoral project at the Naval Computer and Telecommunications Area Master Station, Wahiawa, Oahu. The Team Spirit '94 exercise in the Republic of Korea (ROK) from February through March 1994 was cancelled, marking an end to the 201st CCG's annual participation since 1976.

The 154th Group saw a number of changes in FY '94, the most significant being the robusting of the 203rd Air Refueling Squadron (ARS) and the downsizing of the 199th Fighter Squadron (FS). The 154th Group also prepared to restructure its organization to conform to the new Air Force structure.

In February 1994, the Secre-

tary of the Air Force announced that the number of KC-135R Stratotankers in the 203rd ARS would increase from five to nine; the Hawaii Air National Guard would be receiving another three C-130H Hercules transports, in addition to the one already on hand, to form a new tactical airlift squadron; and the Fighter Squadron would decrease the number of its F-15As by nine, to a total of 15. A similar loss of F-15s was experienced by all fighter squadrons across the nation, as a cost cutting measure, to bring down the total Air Force to 20 fighter wings. Positions eliminated at the fighter squadron and 154th Consolidated Aircraft Maintenance

Squadron (CAMS) were more than offset by an increase in positions at the 203rd ARS and 204th Airlift Squadron (AS). The net result of the robbing/debusting was an increase of 92 positions, and 154th Group personnel affected by the debusting of the F-15s were able to begin retraining with other squadrons.

In June, documents detailing an organizational restructuring arrived and 154th Group personnel began planning for its implementation in FY '95. The restructured chain of command will have three Groups (Operations, Logistics, Support) and their subordinate units, and one squadron (Medical) under the Group commander.

In January 1994, the 154th Group began, for a trial period, a new work schedule. The "5-4-9"

schedule allows personnel to work 80 hours over a two-week period, essentially with every other Monday off.

In March 1994, pilots with the 199th began a series of evaluations using night vision goggles. The fighter squadron pilots were the first F-15 pilots in the nation (both Guard and active duty) to evaluate the devices. Six F-15s deployed to Gulfport, Miss., in April to conduct nighttime tests while flying simulated combat missions against other Air Guard and active duty Air Force units. The evaluations showed that the night vision goggles greatly enhanced the pilots' capabilities.

By June 1994, the 154th Group had been hooked up to a Local Area Network (LAN) computer system. The LAN allows Group personnel to com-

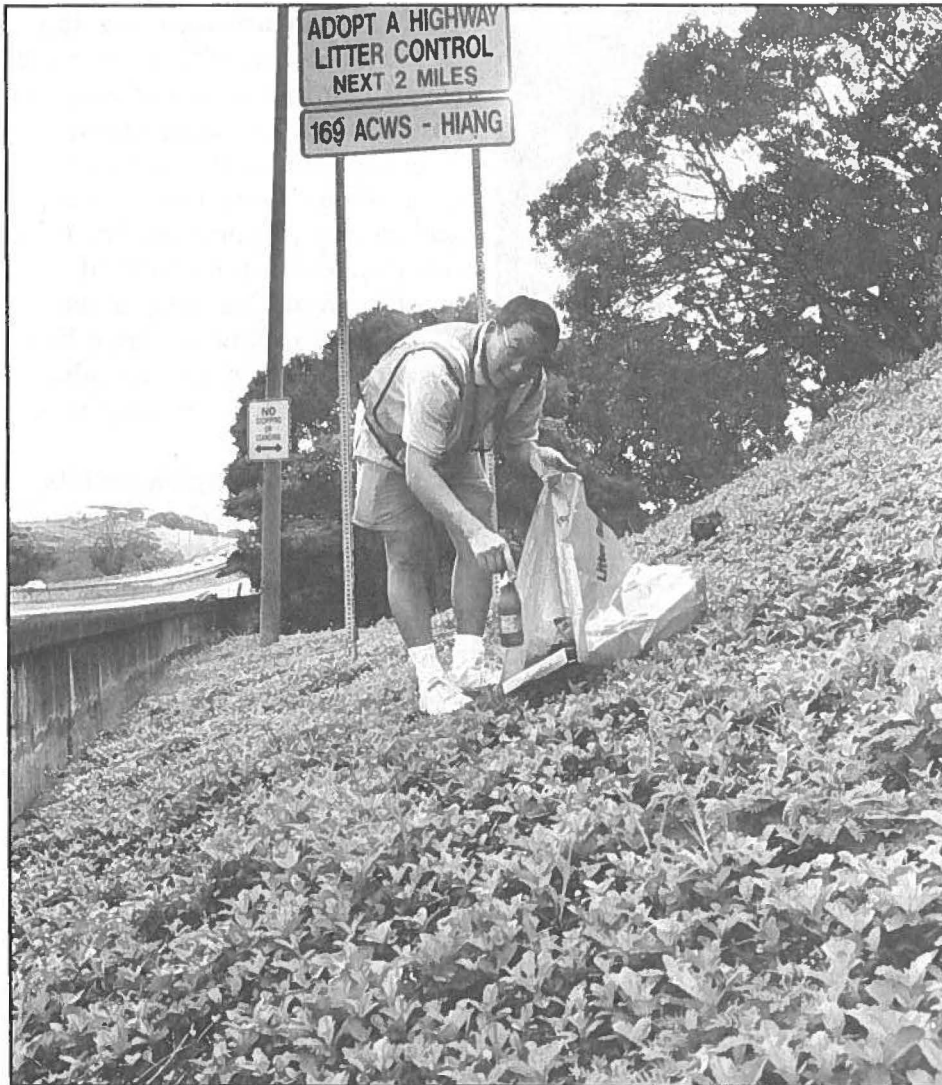
municate with headquarters HIANG and each other more efficiently.

In early March, the 201st CCG conducted another ORE at the Keaukaha Military Reservation primarily involving the HQ 201st CCG large management element/communications-electronics management staff, combat communications squadrons' communications focal points and key unit type codes. In mid-March, Sentre Vigilance, an annual exercise involving controllers from the 297th ATCF (Barbers Point, NAS) and 298th ATCF (Kauai). In late March, 201st CCG supported

PACAF in a successful test for Theater Command and Control Systems.

The Cobra Gold '94 exercise in Thailand from mid-April through May 1994 was successfully executed with the 291st CCS as the "lead" communications unit of the 201st CCG with support from other 201st units, as well as augmentation from the 162nd CCG, California ANG. From mid-May to mid-June 1994, the 292nd CCS (Maui) provided TSC-94A satellite communications equipment and one technician in support of RIMPAC and Gator Byte exercises in the Hawaiian area.

For a week in late May, four ATC radar technicians, two each from the 297th and 298th ATCF, supported HQ PACAF at Kunsan Air Base, Republic of Korea, to redeploy their MPN-14K, Landing Control Center (radar set). The

initial planning conference for Team Spirit '95, a Joint Task Force exercise in the ROK, and the middle planning conference for Cope Tiger '95, a multi-national exercise in Thailand, were attended by representatives from the 201st CCG in late June 1994.

During its deployment to the Pohakuloa Training Area (PTA) in July, the 199th WF provided continuous weather support to the state adjutant general as Hurricane Emilia, Tropical

Depression Fabio, and Hurricane Gilma approached the Hawaiian island chain. During this time, the weather unit also provided airfield and ground weather support to its primary customer, the 29th Infantry Brigade (Separate), and other active and reserve components of the Army and Air Force at PTA.

There were numerous changes of command within the 154th Group on flight and squadron levels in FY '94. In January, Lt. Col. Gervin Miyamoto re-

placed Lt. Col. Alan Fujita, who retired as the commander of the 154th Mission Support Squadron (MSS). Also that month, Capt. Phillip Radford became the new 154th Security Police Flight commander, replacing Miyamoto, and Capt. Melissa Zen became the new 154th Services Flight (SVF) commander, replacing Capt. Radford. In February 1994, Lt. Col. Myron Tong replaced Col. Norberto Baysa as the commander of the 154th Tactical Hospital (Tac. Hosp.). Col. Baysa returned to HQ HIANG as the state air surgeon. In April, Lt. Col. Jerry Matsuda became commander of the 154th Civil Engineering Squadron (CES) replacing Lt. Col. Sydney Keliipuleole, who retired from the Guard.

In June, the 154th Group was awarded its fifth National Guard Association of the United States (NGAUS) Distinguished Flying Unit Plaque. The plaque is awarded to the top five Air National Guard flying units in the nation.

Training

The 154th Group continued its impressive training schedule in FY '94. In July 1993, members of the 154th CES, 154th SVF and 154th MSS, deployed to Kadena Air Base (AB) in Okinawa for Base Recovery After Attack (BRAAT) exercises. In July and August 1993, members of the 199th FS and 154th CAMS deployed to Singapore for exercises with the Singapore Air Force. Throughout the year, the Fighter Squadron hosted units from the active duty Air Force and Air National Guard for exercises flown from Hickam Air Force

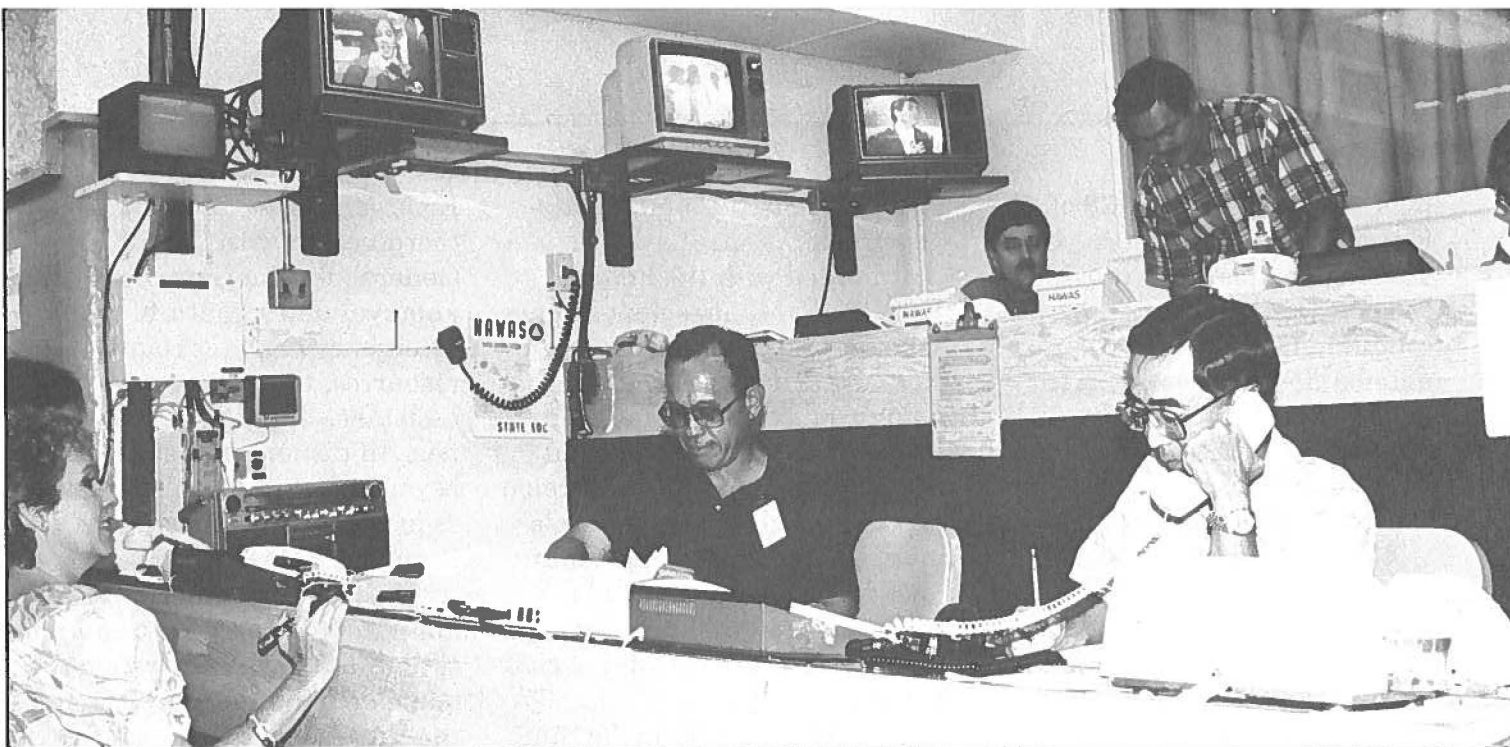
Base (AFB). In September, personnel from the 154th Tac. Hosp. deployed to Osan Air Base, Korea, to train with their active duty counterparts from the 51st Medical Group. In October 1993, several members of the 169th Aircraft Control and Warning Squadron (ACWS) deployed to Elmendorf AFB, Alaska, for Amalgam Warrior exercises. In October and November, the 203rd ARS participated in Amalgam Warrior exercises in Alaska and Cope North exercises in Japan. In April, a tanker and crew from the 203rd deployed to Keflavik, Iceland, to stand alert with the active Air Force and the Icelandic Defense Force for 17 days. The 203rd also deployed to many other locations worldwide, such as Anderson Air Base, Guam; Osan Air Base, Republic of Korea; and Edwards AFB, Calif. While at Edwards in October, the 203rd ARS refueled the new B-2 Spirit stealth bomber. In May, the 154th CES deployed to Bellows Air Force Station for bivouac training. In June, 154th Tac. Hosp. personnel deployed to Alpena, Mich., for training under field conditions.

The 201st CCG continued to train on TRI TAC digital communications equipment. In September and early October, accelerated training on TTC-39 digital switch equipment was conducted for electronics technicians of the 201st CCG in conjunction with equipment deliveries. Also in late September, terminal instrument procedures and site survey training were conducted for the 297th and 298th ATCF by trainers from a sister flight of the Washington ANG. In addition, satellite communications training assistance was provided by the 293rd CCS for three personnel from the 176th CCF, Alaska ANG. Opportunities to participate in Joint Task Force (JTF) exercises in the Pacific Theater enhanced overall training toward mission readiness. In January, the 201st CCG, with assistance from its Air Force technical advisors, hosted and conducted a two-week Mobility Survivability Training (MST) course for more than 40 HIANG personnel from various units. This intensive training course was conducted at two separate locations. The first seven days

consisted of classroom training in the HQ 201st CCG auditorium covering a broad area of responsibilities such as deployment management, first aid, buddy care, chemical warfare training, and convoy procedures. The final five days consisted of a field exercise involving troop movement to set up and secure a bare base location at the Keaukaha Military Reservation, near Hilo, Hawaii.

As part of an ongoing safety program, 201st CCG members received Hazard Communication training in areas of chemical forms, exposure hazards, and controlling and reporting chemical hazards. The HQ PACAF/QI Team provided Total Quality Management (TQM) training in late January through February for key 201st CCG personnel. These courses consisted of Train the Trainer, Unit Self Assessment, and Facilitator courses. In June 1994, Load Planners Training was hosted by the HQ 201st CCG for certifying load planners from the 201st units, as well as invitees from the 154th Group, Hawaii Army Guard, 162nd CCG (California ANG) and the 15th Communications Squadron (PACAF).

In January, the 199th WF deployed one staff weather officer to Chitose, Japan, to provide weather support to the 29th Infantry Brigade (Separate) during its preparation in Keen Edge '94. In July, the 199th WF deployed to Pohakuloa Training Area in support of the 29th Infantry Brigade (Separate). The 199th also deployed one weather forecaster and one weather observer to Camp Rilea, Ore., to support the Brigade's 1st Battalion, 299th Infantry, in July.

State Civil Defense

Mission

The mission of State Civil Defense (SCD) is to plan, prepare for and respond to actual or impending disaster. These actions are applied to protect life and property, restore essential services, maintain core government operations, and coordinate resource management to speed recovery.

Available resources must combat a wide range of natural, environmental and technological hazards, including war or terrorist related activities. Hazard management is accomplished via four integrated phases:

Mitigation. Measures which reduce or eliminate the hazardous effects or conditions of a disaster agent.

Preparedness. Plans and procedures developed for disaster response and recovery, staff training, and community education.

Response. Actions taken to alert and inform the public, and the coordination and application of agency resources for crisis response.

Recovery. Short- and long-term integrated efforts taken to aid in restoration of social and economic structure following a disaster.

This interrelated framework supports a federal, state and county partnership fully equipped to manage the full spectrum of hazards encountered in Hawaii.

Personnel

SCD currently has a staff of 43 full-time employees. The level has been increased to support Hurricane Iniki long-term recovery operations. Thirteen special contract employees are currently engaged in the inspection, monitoring and audit process for completion of repair work on

public and private nonprofit facilities. During emergencies, staffing is also increased by government liaison and volunteer agency support groups.

The adjutant general serves as the director of civil defense. The vice director oversees day-to-day operations and assumes the responsibilities of the director when the director is out of state.

Organization

The SCD is organized into three branches: Training, Education and Information Branch; Plans and Operations Branch; and Telecommunications Branch, all supported by an administrative section. A fourth branch, the Recovery Branch, is formed when needed to manage large scale recovery operations in the aftermath of a major disaster.

The SCD system is authorized

by Chapters 127 and 128 of the Hawaii Revised Statutes (HRS). This legal framework provides the mechanism for an integrated comprehensive system coordinated among key government players across all hazards. SCD also serves as the office of record for all major disasters impacting the State of Hawaii.

Under the provisions of Chapter 128, HRS, the director of Civil Defense appoints a deputy director in each county. County mayors typically take on this responsibility and are directly responsible for public safety and providing proper support to county civil defense agencies. County civil defense agencies each have an Emergency Operating Center and a small full-time staff which is partially supported by federal funds. Agency plans are approved by the mayors, county councils, and the director

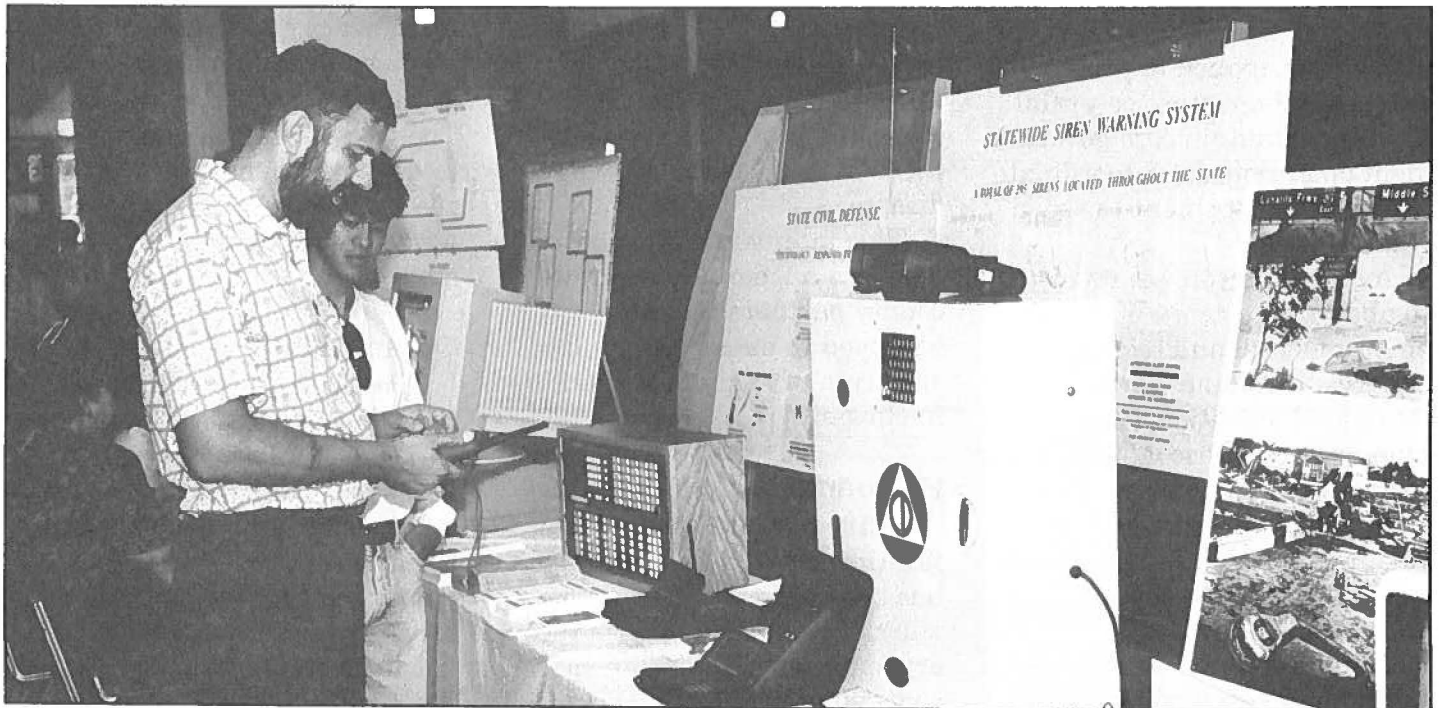
of civil defense. County Emergency Operations Plans are coordinated with the Federal Emergency Management Agency (FEMA), and other federal agencies supporting the state civil defense system. All state departments have a designated civil defense coordinator, and develop departmental plans that implement the provisions of the state civil defense plans. The plans are approved by department directors and the director of civil defense.

The DOD maintains the State Disaster Contingency Fund authorized under Chapter 127-11, HRS. The fund provides \$1 million per state disaster and an additional \$1 million per disaster for matching funds when required by the federal government if a presidential disaster is declared.

The SCD drafts all Disaster or

Emergency Proclamations, in coordination with the Attorney General, for the Governor's approval and signature. If an emergency depletes county resources, the county may seek assistance through SCD channels. If disaster impact escalates beyond state resources, the state requests federal assistance through FEMA.

With county support, the SCD maintains a statewide communications and warning system made up of outdoor sirens and the Emergency Broadcast System (EBS). Operated over radio and cable television circuits, the EBS system is voluntarily supported by the local broadcast industry. Emergency communications are redundant by design and consist of HF-SSB and HF-VHF radio systems, multiple hard wire links with the National Weather Service, Pacific

Tsunami Warning Center and all county police and civil defense agencies. The Integrated Emergency Management Information System (IEMIS) and Interim Baseline System (IBS) provide the state civil defense system with computerized mapping and modeling support. This database is used for resource, risk analysis and response applications.

State Civil Defense Advisory Council

Made up of seven members appointed by the governor, the council meets quarterly to discuss programs and projects conducted by SCD. Serving on the Advisory Council for 1994 were Reuben Yoshida, chair, Frank T.S. Kim, Myrna Murdoch, Alfred O. Souza, and Judith A. Young. New appointments were pending in July 1994.

Hawaii State Earthquake Advisory Board

Formed in August 1990, the volunteer 15-member board meets quarterly to identify priorities for earthquake mitigation and preparedness activities. The board draws its expertise from the scientific, academic, engineering and emergency management communities.

Hawaii Hurricane Advisory Board

Made up of representatives from the National Weather Service, University of Hawaii structural engineering, and civil defense, the Board held its first meeting in March 1994. The Hurricane Advisory Board has been assembled to take an in-depth look at mitigation strate-

gies, capitalizing on recent events and history in the North Central Pacific.

Pacific Caucus

State Civil Defense provides the chair, hosts and coordinates the activities of the Pacific Caucus of Emergency Managers. In addition to Hawaii, members include Guam, American Samoa, Republic of the Northern Mariana Islands, Federated States of Micronesia, Republic of the Marshall Islands, and Republic of Palau.

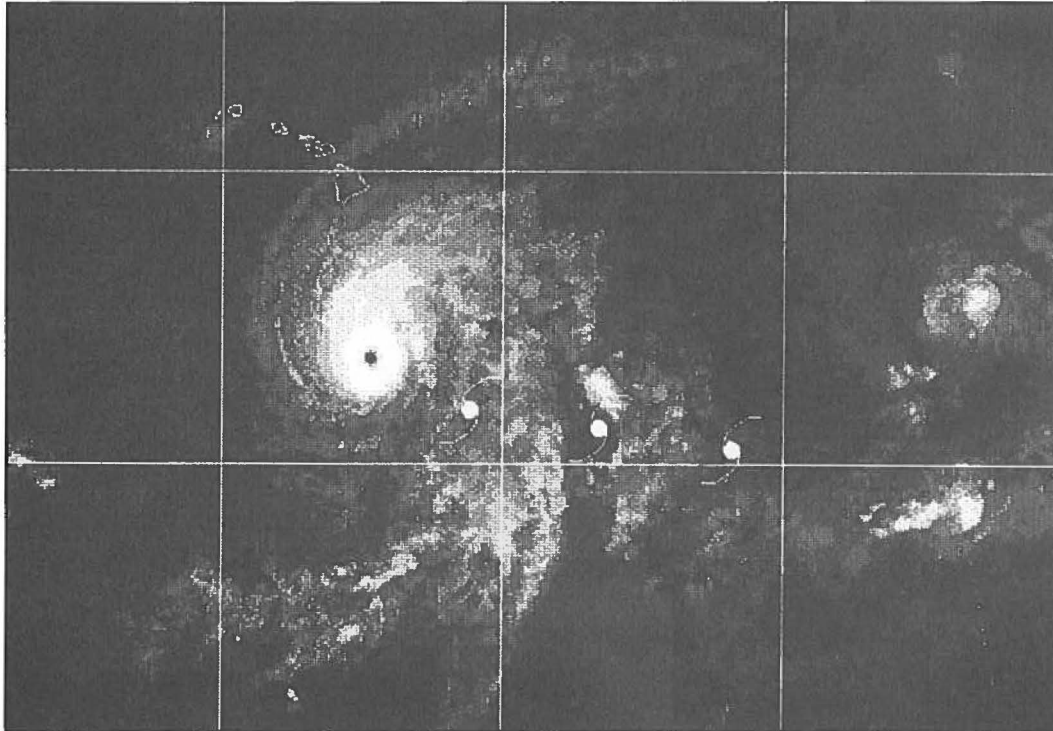
The Pacific Caucus was formed in Honolulu in 1988 to give Hawaii's Pacific island neighbors a voice and a presence in the national emergency management arena. The multinational group holds annual meetings in Honolulu and is formally recognized as a fully vested member of the National Emergency Management Association, a body representing all directors. Plans are underway to fund a full-time Caucus Executive Director and administrative support.

Highlights and Significant Events

Iniki losses top \$2 billion, recovery ongoing.

In January 1994, total losses from 1992's Hurricane Iniki topped the \$2 billion dollar mark, and by June, had edged near \$2.2 billion. Hawaii insurers bore the brunt of those costs, however, with over \$1.5 million in claims paid out on property damage. Insurance figures represent roughly 71 percent of all losses attributable to the storm. By mid-year, an estimated 92 percent of all private insurance claims had been settled.

Damage to government facilities and private non-profit agencies was also heavy, totalling over \$140 million. Some 2,169 repair projects are currently underway for 109 state and county agencies statewide. Currently, 489 projects are ready for closeout and another 1,182 are in various stages of completion. An additional

498 projects are awaiting insurance settlement. Fifty-nine private nonprofit agencies have received an estimated \$1.6 million for repairs.

As the office of record for all major disasters, SCD is currently engaged in the monitoring, inspection and audit process for long-term repair projects. Ongoing repair for damages resulting from Hawaii's most devastating storm will take years to complete. A special recovery branch has been in place since early 1993 to manage in-progress repair work.

In the nearly two years since Hurricane Iniki, long-term recovery is taking shape. For the island of Kauai, with an economy traditionally tied to tourism, the road to economic recovery hinges on the reopening of hotels and resort properties. Until the island's major employer is once

again in full swing, the Garden Island will continue to feel residual effects of the tourism downturn. Long-term development projects to help diversify the county's economy and bring needed new jobs will help ease the reliance on a vulnerable tourist market. Coupled with economic diversification efforts, development projects to ease Kauai's tight housing and rental market will also contribute to gaining a firm foothold on a brighter future.

A jittery public eyes hurricane season with unease. With anxiety still running high after experience with Hawaii's worst hurricane ever, the 1993 and 1994 tropical cyclone seasons were viewed with caution by isle residents. In mid-August 1993, Fernanda hugged the windward side of the entire state, her 125 mile-an-hour-winds prompting a

watch for the Big Island and bringing high surf to all exposed shores. While Fernanda let islanders in for a scare, the storm remained stable and cleared the northernmost portions of the archipelago. Hurricane Keoni, formed during the same August time frame, also entered Hawaiian waters but remained well south of the island chain.

The start of the 1994 Hurricane season saw a total of 14 tropical cyclones form in the eastern and central Pacific, ranging from tropical depressions to full hurricanes. During July, Hurricanes Daniel, Emilia, Fabio and Gilma entered local waters,

some with record breaking wind speeds. Packing 161 mile-an-hour sustained winds, Emilia was the strongest storm ever for the North Central Pacific. Following on the heels of Emilia, Gilma was also a huge storm carrying equal wind velocities. In mid-August, Hurricane John, with sustained winds of 173 miles-per-hour and gusts exceeding 200 mph, broke all records for the North Central Pacific. John remained south of the Hawaiian Islands but veered towards Johnston Island, posing a threat to the chemical weapons disposal site as well as personnel stationed on the atoll. Over a thousand people assigned to Johnston Island were evacuated to Honolulu prior to the storm making landfall. Military sources reported some structural damage after Hurricane John's brush with the atoll.

Training and Exercises

1994 efforts sharpen readiness for response agencies.

Training and exercises are key factors in maintaining the readiness of Hawaii's emergency management system. In 1994, 589 participants attended 26 state civil defense sponsored courses. In addition to core professional development courses, state civil defense also administers hazardous materials (HAZMAT) training for first responders. HAZMAT training responsibilities have been recently acquired from the State Department of Health, as the civil defense system has taken an active role in a statewide training program. County firefighters, police and other agencies involved in HAZMAT

incident response now have an improved and expanded resource for needed local training. State civil defense provides staffing, instructors and administrative support for all courses offered or sponsored under the civil defense umbrella.

Coupled with training courses, exercises also play a major role in developing and maintaining readiness and response skills. In June 1993, a statewide hurricane functional exercise involving 81 participants from state and county agencies provided a vehicle to further develop lessons learned from Hurricane Iniki. In May 1994, a full-scale hurricane exercise with nearly 1,340 players from government agencies, branches of the military, volun-

teer organizations and the Hawaii Healthcare Association once again focused in on hurricane response. In addition to large-scale annual exercises, State Civil Defense also conducts smaller events throughout the year that bring focus to particular response and recovery aspects.

Ongoing exercises regularly help test procedures, communications and operations, as well as build professional skills. Evaluation results play a major role in fine tuning Hawaii's civil defense system to improve delivery of vital crisis management services. The practical application of lessons learned from exercises is evident each time agencies are called upon to deal with local emergencies or major disasters.

Office of Veterans Services

Mission

The Office of Veterans Services (OVS) is the principal state office responsible for the development and management of policies and programs related to veterans, their dependents and/or survivors.

Personnel

The OVS is authorized 23 full-time state employees.

Organization

The OVS consists of the director and administrative and office services sections, the veterans services branch and the Hawaii State Veterans Cemetery branch. The veterans services branch, under the direct supervision of the veterans services coordinator, consists of veterans services counselors and clerk typists on Oahu, Hawaii, Kauai and Maui who are responsible

for veterans services in their respective county. (The Maui counselor is responsible for services to veterans on the islands of Molokai and Lanai.) The veterans services branch also includes a Filipino veterans counselor.

The Hawaii State Veterans Cemetery is solely responsible for the operation and management of the veterans cemetery located in Kaneohe on the windward side of Oahu.

Highlights and Significant Events

The OVS hired a counselor to aid Filipino WWII veterans who come to Hawaii to obtain American citizenship and establish residency. A significant number, who come with and without family members, are of advanced age and without sufficient financial resources to maintain even a

modest lifestyle. The Office of Community Services, in consultation with OVS, entered into agreements with community services providers to offer social and employment services to Filipino veterans. The Filipino Task Force continued to address veterans needs and played a pivotal role in lobbying the legislature for a burial assistance program for Filipino veterans.

As a participant in a program to centralize and relocate state agencies and services into state buildings, the OVS moved from its downtown location to a state leased building at 919 Ala Moana Blvd. The new location, which is served by a principal bus route, also has client parking. It is more convenient and accessible for clients, within walking distance to the Department of Veterans Affairs and other state agencies, and more economical.

Korean and Vietnam Memorials

Groundbreaking for the long awaited and controversial Korean and Vietnam War Memorials took place on July 27, 1993, on the grounds of the State Capitol. The solemn ceremony was well attended by veterans of both conflicts. It signified the

start of a healing process for both veterans and civilian survivors of those periods of conflict.

Cemeteries/Burial Detail

The Hawaii State Veterans Cemetery began Phase IV of its construction, with the columbarium and amphitheater scheduled for completion by

Veterans Day 1994. Since its opening, Aug. 1, 1991, 1,105 remains were interred. With the aging of the veteran population, primarily with the large number of World War II and Korean War veterans, we anticipate an appreciable increase in interments during the next five years. Roughly, 20 percent of Hawaii's veteran population was 65 years of age or older by the 1990 Census.

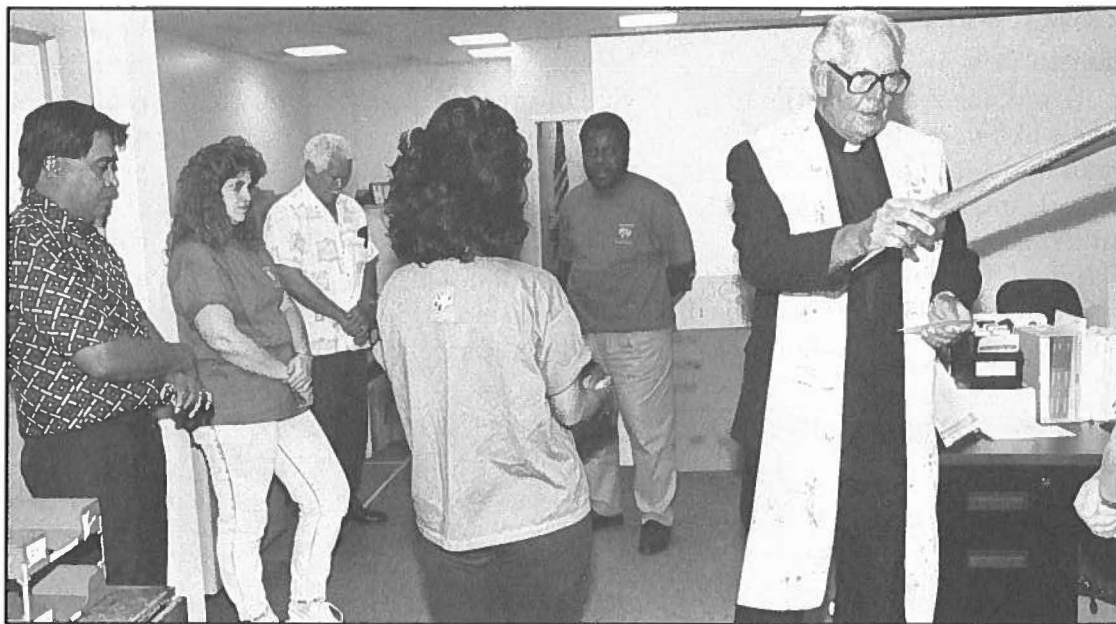
Noteworthy during this year was a commitment from the Department of Veterans Affairs (DVA) for funding to upgrade veterans cemeteries on Maui, Kauai, Molokai and East Hawaii, and to construct new cemeteries on Lanai and West Hawaii. The DVA allocated \$1,972,631 to fund Phase I, with a matching amount appropriated by the 1994 state legislature. After a review of projected burials for the next 20 years, further improvements were recommended and DVA allocated an additional \$2,264,777 for Phase II. Matching funds for Phase II will be solicited from the 1995 state legislature. If successful, a total of \$8,474,817 will be expended for veterans' burial needs on the neighbor islands.

Through the efforts of the state adjutant general, honor details are available for funerals of deceased neighbor island veterans. A Hawaii National Guard aircraft is available on a limited basis to transport active duty honor guard personnel to the neighbor islands to participate in funeral services. If the aircraft is unavailable, National Guard personnel on neighbor islands may provide these details for service members who were or

are Guard members. On occasion, veterans' groups may also provide honor guard services for deceased veterans.

Neighbor Island counselors again spearheaded the effort to obtain leis for graves at the National Memorial Cemetery of the Pacific, the Hawaii State Veterans Cemetery and neighbor island cemeteries. Counselors coordinate with schools on their respective islands and arrange for the receipt and transport of leis to Oahu for the Memorial Day services.

The director hosted the visit of

Lt. Gen. Joseph S. Laposata, executive secretary of the American Battle Monuments Commission. He viewed the World War I memorial at the Waikiki Natatorium, the World War II memorial near the Hawaii State Library, the Eternal Flame memorial and the site for the Korean and Vietnam War memorials. He also made a courtesy visit to the Hawaii State Veterans Cemetery in Kaneohe.

Veterans Benefits

A successful attempt to extend the state's Vietnam

Veterans Tuition Waiver program moved the expiration date from September 1993 to September 2003. The bill also extended participation to veterans who were awarded a campaign or expeditionary medal.

With the continued drawdown of the active military forces, participation in the Transition Assistance Program more than doubled since the previous year, although the average group size decreased. Separating service members are informed about benefits and services that are available to them as veterans; i.e., advocacy, assistance with filing disability or other claims, information and referral to employment, health care, local service agencies, etc.

The OVS continues to lobby, through Hawaii's congressional delegation and veterans organizations, for the construction of the Spark Matsunaga Veterans Medical Center. Plans for the 60-bed veterans nursing home, to be built on the grounds of Tripler Army Medical Center, appear to be firm, and funding for the

medical center is being sought through the Hawaii Congressional delegation.

The OVS sends representatives to veterans' organizational events to gain an understanding of veterans' issues from the veteran's perspective and to evaluate the veteran's impression of services and areas requiring development or improvement. Additionally, the OVS attends many ceremonies that commemorate service to the country.

Boards/Commissions

The Advisory Board on Veterans Services advises the director on veterans issues and alternative approaches to solutions, content of position statements and papers, advocacy efforts, legislative proposals and program operations. This year, the Board continued its efforts to reach out to veterans and their organizations by holding meetings on neighbor islands and in rural areas on Oahu. The Board was given a briefing and tour of the Tripler Army Medical Center and DVA's medical wards. They were advised of medical services available to retirees and eligible veterans.

Alfred Los Banos, who represents Oahu on the Board, was appointed to the American Battle Monuments Commission by President Clinton. Other members of the Board are: John K. Iwamoto (Kauai), chair; Louis Kaiwi (Hawaii), vice chair; Walter J. Hayes (Maui); and Louis Baldovi, Shirley R. Cavanaugh and Judith H. Worobe (Oahu).

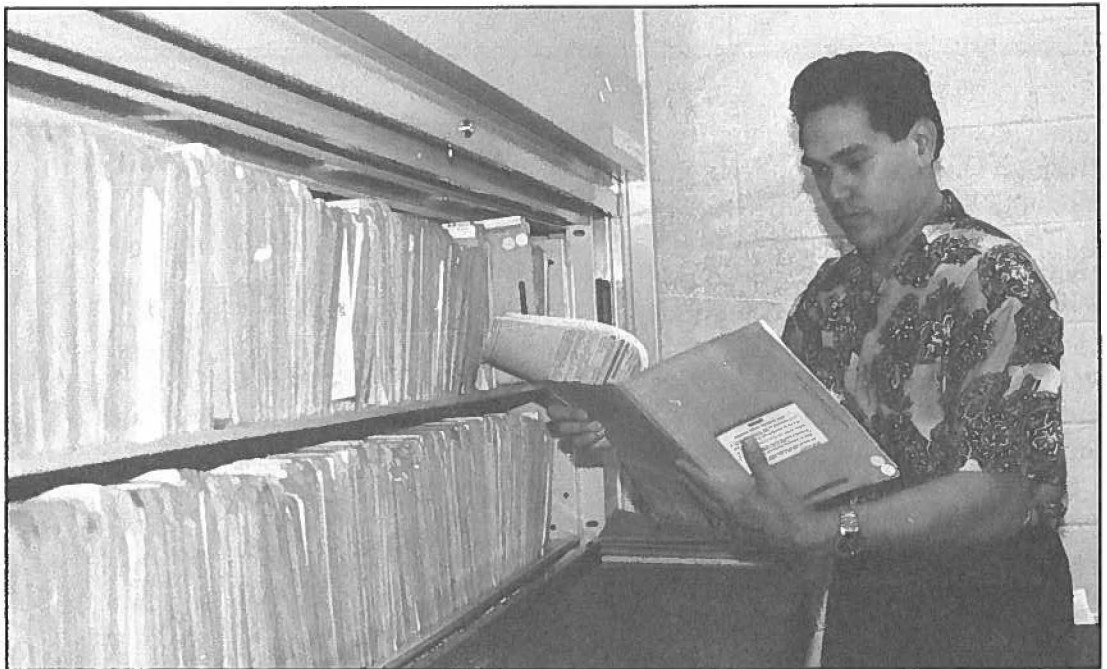

Administrative Services Office

Mission

The Administrative Services Office (ASO) provides military and state administrative support to the Office of the Adjutant General. It coordinates and controls all planning, programming, budgeting and execution of departmental programs as directed by the adjutant general.

Personnel

The ASO is authorized 18 full-time state employees.

Organization

The ASO is comprised of three primary staff elements. These are the executive support, personnel and financial management services sections.

Executive Support

The ASO provides centralized office services and communications management, to include the monitoring, review, distribution and filing of communica-

tions received from federal, state and local governments and the civilian community. The ASO is also responsible for maintaining close liaison with Hawaii's congressional delegation and legislature, and for administering all legislation affecting departmental programs. The office prepares correspondence and testimony concerning various legislative proposals. The military component of the ASO provides executive support services to the adjutant general. It also coordinates the activities of the adjutant general's military staff, composed of members of the Hawaii National Guard (HING).

Personnel Management Services

The personnel management services staff administers the state employee personnel program which includes classification, compensation, recruitment

and placement, personnel transactions and records, labor relations, employee relations, training, workers' compensation and occupational safety and health.

Financial Management Services

The state financial management services staff administers and controls state general fund appropriations, state administered federal funds and matching fund grants under the Federal Emergency Management Assistance program. The staff also provides centralized control and accounting of all state property assigned or issued to the department.

Highlights and Significant Events

There were 189 permanent state positions authorized during the year, 177 of which were filled by June 30, 1994. Additionally, 57 temporary positions were

authorized and 35 were filled at the end of the fiscal year.

During the fiscal year, the following types and number of personnel actions were taken:

With regard to performance ratings, 68 individuals received very satisfactory ratings, representing 32 percent of the state work force. From these, 13 sustained superior performance awards were submitted and approved during the fiscal year. The average monetary award amounted to \$200.

The 1994 recipient of the Adjutant General's Award for Distinguished State Service was James Y. Toyama, Military Organizational Effectiveness Analyst in the Administrative Services Office. The departmental nominee for the state Manager of the Year Award for 1994 was Lt. Col. Jerry M. Matsuda, Contracting and Engineering Officer in the Engineering Office.

During the fiscal year, there were 20 reportable cases of work-related injuries involving state employees. There was a total of 310 lost workdays or an average of 16 workdays per injury. In addition, there were four workers' compensation injuries involving drill status National Guard personnel.

The ASO, through its fiscal staff, administered and con-

trolled \$8,781,118 in state general fund appropriations and \$7,757,097 in federal fund appropriated receipts.

The net general fund appropriation of \$8,781,118 was comprised of \$6,613,169 from the DEF 110 (departmental operating program), \$1,167,949 from DEF 112 (services to veterans' programs), and \$1,000,000 for major disasters.

Total expenditures and encumbrances in both programs DEF 110 and 112 amounted to \$7,515,655 for an expenditure rate of 85.59 percent, leaving a general fund lapsing balance of \$1,265,463. Federal fund expenditures and encumbrances amounted to \$5,281,436, leaving a reversion balance of \$2,475,661. The federal reversion balance was due to lower than expected receipts for Hawaii National Guard and Civil Defense federally-funded programs. Table 5 in the appendix depicts the distribution of general fund allocations, appropriated receipts and expenditures by programs, organizations and cost elements.

Additionally, the fiscal staff administered three federal fund holding and disbursing accounts. Table 4 in the appendix reflects the status of these accounts as of June 30, 1994.

The department's cash receipts for the year amounted to \$5,817,793. Of this amount, \$275,087 was credited to the state general fund, \$19,927 to the general fund operating account, \$5,522,779 to special (federal) fund operating accounts, and \$50 to the trust fund. The sources and fund accounts to which they were credited are depicted in Table 7

of the appendix.

In administering the state finances for the year, the fiscal staff processed 4,431 purchase orders, 1,082 summary warrant vouchers, 40 payroll vouchers, 40 bills for collection, 73 federal fund claims invoices, 159 treasury deposit slips, and 1,339 petty cash checks.

The department administered and accounted for state program funds through an in-house developed accounting system and statewide Financial Accounting and Management Information System (FAMIS). Information is transmitted to the Department of Accounting and General Services via the department's direct on-line terminals.

Federal funds for Hurricane Iniki relief efforts from the Federal Emergency Management Agency's (FEMA) Public Assistance Program (Public Law 93-288) for Hurricane Iniki Relief efforts amounting to \$1,675,013 were received under the department's Damage Survey Reports and for administration of the program. In addition, \$42,770,679 for Hurricane Iniki and \$653,811 for the Kilauea Lava flow were received from FEMA and disbursed to other state departments, the counties and nonprofit organizations for public assistance.

Federal funds for Civil Defense program activities amounting to \$1,329,096 were received as 50/50 matching fund grants under the FEMA Program (Public Law 85-606) and the Civil Defense Maintenance and Service Program (Public Law 920); as 100 percent federally-funded contract grants for radiological instrumentation/maintenance and calibration, emergency

management training, population protection planning, radiological defense planning and development and survival crisis management; and as a 50 percent funded contract grants for disaster improvement and earthquake preparedness.

Federal funds for the HING amounting to \$2,123,778 were received under six separate cost-reimbursable operations and maintenance-service contracts negotiated between the National Guard Bureau and the State Department of Defense. These contracts provided for reimbursement of 100 percent, 80 percent, and 75 percent of the authorized costs to operate and maintain buildings and grounds occupied by the federally-supported activities of the HING. Funds received under these

contracts are deposited into the state treasury as appropriated receipts or as refunds of fringe benefits advanced by other state agencies.

During the year, the department added to its inventory of property 142 items valued at \$168,738 and disposed and declassified 166 items of surplus or unserviceable property valued at \$76,411.

The fiscal staff also administered the short-term use and rental of departmental facilities by

coordinating and processing 50 separate applications for use of armories and grounds located throughout the five major islands. The rental fees and utility reimbursements collected amounted to \$9,292. The department's property inventory as of June 30, 1994, is provided below.

Funds received under these contracts are deposited into the state treasury as appropriated receipts or as refunds of fringe benefit payments advanced by other state agencies.

U.S. Property and Fiscal Office

Mission

The mission of the U.S. Property and Fiscal Office (USPFO) for Hawaii is to receive and account for all funds and property of the United States in possession of the Hawaii National Guard (HING), ensure that federal funds are obligated and expended in conformance with applicable statutes and regulations, ensure that federal property is maintained and utilized in accordance with National Guard Bureau directives, manage the federal logistics systems for Hawaii and provide the support necessary for the transition of mobilized units to active duty status.

Personnel

The USPFO for Hawaii is authorized 88 full-time federal technicians.

Organization

The USPFO is organized as follows: Administration Office, Data Processing Installation, Analysis and Internal Review Division, Resource Management Division, Purchasing and Contracting Division and Supply and Services Division.

Administration Office

This office performs administrative services in support of the U.S. Property and Fiscal Office operations by maintaining a

centralized publication library, providing reproduction services, receiving and processing office mail and providing typing and word processing services.

Data Processing Installation

The Data Processing Installation provides services to the USPFO, Hawaii Army National Guard (HIARNG), Surface Maintenance Office, Support Personnel Management Office, Standard Installation/Division Personnel System Branch and the Army Aviation Support Facilities. The installation operates a Burroughs B1955 and two UNISYS 5000/80 mainframes. Application software is slowly

migrating from the Burroughs to the UNISYS system and should be completed in 1994. Installation of a Defense Data Network and electronic mail capability enables worldwide communication and data transfer.

Analysis and Internal Review Division

Internal reviews are conducted by this division to ensure federal resources are managed and utilized. Emphasis is placed on evaluating the effectiveness of internal controls and determining whether the HING is operating efficiently and economically.

Resource Management Division

Federal funds allotted to the HING from Congressional appropriations are managed by this division. Separate offices administer funds assigned to Army and Air operations.

The Army Guard office, located in the Diamond Head Crater, is comprised of the financial manager, budget officer, staff accountant, Fiscal Accounting Branch and Pay and Examination Branch.

An assistant U.S. Property and Fiscal officer for Air (Fiscal) controls funds allocated for support of the Hawaii Air National Guard (HIANG). This office is located at Hickam Air Force Base.

Purchasing and Contracting Division

Purchasing and contracting services are provided by this office to all activities of the HING by sealed bids, competitive proposals and small purchase procedures in accordance with federal acquisition regulations.

Purchases are made from commercial vendors located throughout Hawaii and the continental United States.

Supply and Services Division

This division is organized into the Stock Control, Property Management, Supply and Transportation Branches, and provides logistical support and guidance to the HIARNG.

An assistant U.S. Property and Fiscal officer for Air (Property) provides logistical support and guidance to the HIANG. This office is located at Hickam Air Force Base.

A full-time Scheduled Airlines Traffic Office (SATO), established within the Transportation Branch, provides an entire array of transportation services; i.e., plane and hotel reservations, airline tickets, air freight, car rental reservations, and other travel requirements.

Highlights and Significant Events

Federal funds used by the HIARNG during the federal fiscal year totaled \$48,277,598.

Federal funds used this year by the HIANG amounted to \$79,516,332.

Table 4 of the appendix reflects federal dollars used between Oct. 1, 1993 and Sept. 30, 1994.

Military payrolls for the HING totalled \$41,678,345 this federal fiscal year.

During federal fiscal year 1994, local purchases and contracting support of the HING units and activities totalled \$7,320,294. Of this total, \$3,595,299 represented architectural engineering services and construction contracts. There were 3,184 contracting actions

for this federal fiscal year.

A total of \$4,480,617 was spent procuring supplies and equipment for the HIARNG. The Supply and Services Division maintained an inventory of \$118,639,418.

The HIANG received \$5,357,381 for supplies and equipment. The base supply operation processed 632,504 transactions in federal fiscal year 1994--a monthly average of 52,708. The equipment book value was \$142,753,542.41 at the end of the federal fiscal year.

The HIARNG Transportation Branch arranged transportation for a total of 5,807 individuals: 1,726 for military interisland and mainland airlifts, 1,015 for commercial trips to the mainland, 137 for foreign trips and 2,929 for commercial interisland trips. A total of 3,046 tons of cargo was shipped during the fiscal year: 2,236 tons for annual training, 70 tons for the mainland and 740 tons for interisland destinations. The use of SATO provided an estimated savings of \$2,095,475 for federal fiscal year 1994.

The HIANG Traffic Branch arranged transportation for a total of 2,784 individuals: 600 for military interisland airlifts, 1,200 for commercial trips to the mainland, 146 for foreign trips and 838 for commercial interisland trips. A total of 92 tons of cargo was shipped during the fiscal year: 6 tons for annual training, 46 tons to the mainland and 40 tons to interisland destinations. The use of SATO provided an estimated savings of \$606,150.59 for federal fiscal year 1994. The total amount of money spent to transport personnel and equipment is shown in

Table 4 (Appendix).

Two UNISYS 5000/80 computer systems were installed in the Data Processing Installation. The UNISYS brings new technol-

ogy and challenges to the staff and to all future users of the system. The UNISYS will completely replace the Burroughs in federal fiscal year 1995.

Five reviews were completed by the Analysis and Internal Review Division during federal fiscal year 1994.

Human Resource Office

Mission

The Human Resource Office (HRO) is a consolidated office that provides personnel, manpower management and administrative support services for all federal full-time personnel programs. The office serves as the adjutant general's single point of control for managing and administering Hawaii Army and Air National Guard personnel programs.

Personnel

The HRO is authorized a staff of 21. The current office staff includes 15 federal technicians and three Active Guard/Reserve (AGR) soldiers.

Organization

A standard National Guard structure prescribes that the personnel office must be organized with the following operating sections: personnel management, employee services, military duty management, military duty services, equal employment opportunity, labor relations and personnel data systems. The office is centrally located, and all records and authorized staff are co-located to provide a single point of contact for personnel.

Personnel Management Section

Section staff members develop policy recommendations, procedures and plans in compliance

with the U.S. Office of Personnel Management and National Guard Bureau directives. The section is responsible for major program areas such as position management and classification, manning control, staffing, training, employee relations, performance management and recognition, incentive awards, disciplinary and adverse actions, grievances and appeals, personnel management evaluation and maintenance of the personnel data system. It furnishes technical advice and assistance to management officials, individuals and staff personnel.

Employee Services Section

This section provides a wide range of services to technicians throughout their employment life cycle. Beginning with employment processing and new technician orientations, the staff furnishes information on employee benefits, processes personnel actions, maintains individual technician personnel records, ensures proper pay administration, administers the federal Workers' Compensation program and processes retirements.

Military Duty Management Section

Army National Guard AGR enlisted personnel career management and tour retention

processes, recruitment and advisory services take up much of this section's time. Unlike their staff counterparts who administer the Army and Air National Guard technician programs in compliance with common directives, the AGR management staff administers the military programs based on policies and procedures established by the Army, Air Force and separate National Guard directorates.

Military Duty Services Section

This section is the point of contact for commanders, supervisors and individuals seeking AGR administrative service and assistance pertinent to pay, benefits and entitlements. The addition of a medical administrative specialist has vastly improved coordination with military and civilian medical care providers who treat AGR personnel and their dependents on Oahu and the neighbor islands.

Equal Employment Opportunity Section

The equal employment manager plans, develops and administers programs for all employees (including state personnel) relative to equal employment. Programs administered include affirmative employment pro-

grams with special emphasis on women and other minority issues, equal opportunity complaints processing, discrimination investigations, and related training to departmental personnel.

Labor Relations Section

This section provides federal labor relations services within the department. Two locals from national labor organizations are exclusive representatives of non-supervisory technicians in three bargaining units. Typical tasks include contract administration, management advisory services and labor management relations training. The section also serves as the point of contact for union and other federal labor relations representatives and as management's representative in dispute resolution and contract negotiations.

Personnel Data Systems

The National Guard Personnel Data System (Civilian) was recently installed to provide automated data processing and storage for technician personnel actions. This table-driven, on-line system has the ability to process and store information on personnel actions, establish and monitor suspenses and produce reports.

Federal full-time support personnel authorizations are based on unit priorities. Although Hawaii Army National Guard (HIARNG) authorizations remained unchanged, HRO has been preparing for a reorganization within the Hawaii Air National Guard (HIANG). Changes beginning July 1, 1994, include a restructuring of the 154th Group organization, downsizing of the 199th Fighter Squadron F-15 fighter aircraft, robusting of the 203rd Air Refueling Squadron (from four to eight KC-135R aircraft), and the activation of the 204th Airlift Squadron (four C-130 aircraft).

Thirteen HIANG and eight HIARNG technicians received merit pay increases under the Performance Management and Recognition System. Wage grade increases were effected for 143 HIARNG and 363 HIANG technicians in November 1993. Instead of the customary general schedule increases, the federal government implemented a locality-based pay adjustment system this fiscal year. This system does not affect those states or territories providing cost of living allowances. No increases were provided for the approximately 370 general schedule technicians in 1993.

Retirement and service awards luncheons were held in August 1993 and February 1994, honoring 28 retirees, 12 length-of-service awardees and the recipients of the Adjutant General's Award (Department of Defense State Employee of the Year and Manager of the Year).

Engineering Office

Mission

The Engineering Office provides the entire spectrum of professional engineering services to the Hawaii Army National Guard, Hawaii Air National Guard, State Civil Defense, Office of Veterans Services and departmental staff sections to enable them to carry out their statewide programs.

Its responsibilities are to plan for, administer and supervise capital improvement projects, major and minor construction, consultant contract services, maintenance and repair, janitorial/custodial and ground maintenance, real property management, environmental and energy conservation, fire prevention and office paper recycling.

Personnel

The Engineering Office is authorized 58 state, 13 federal and one Active Guard and Reserve (AGR) position.

Organization

The Engineering Office consists of seven major staff responsibilities: Contracting and Engineering Services, Maintenance Services, Air National Guard Engineering Services, Army National Guard Engineering Services, State Civil Defense Engineering Services and Office of Veterans Services.

Repair and Maintenance Projects Awarded

Recurring minor maintenance, repairs and modifications of facilities are accomplished by in-house maintenance personnel on a time-and-materials basis, or

by formal and informal construction contracts. This program is supported by federal, state or joint federal/state matching funds through separate Army and Air Service Contracts or Army Guard Training Site Contracts. The federal contracts under the Service and Training Site Contracts for federal Fiscal Year 1994 were:

Ongoing minor construction projects during this Fiscal Year amounted to \$305,000 for the Hawaii Army National Guard 100 percent federal funds.

Staff Judge Advocate Office

Mission

The Staff Judge Advocate (SJA) provides legal support to the adjutant general, staff elements, subordinate units of the Hawaii National Guard and the United States Property and Fiscal Office. In performing its mission, the SJA serves to:

- Prepare legal opinions on issues of federal law.
- Serve as federal litigation point of contact.

- Represent the adjutant general in federal labor-management proceedings.
- Review federal contracts relating to procurement and acquisitions and serve as the Hawaii National Guard's federal claims officer.
- Participate as legal advisor or counsel in administrative board proceedings.
- Act on behalf of the convening authority in National Guard courts-martial.

Personnel

The SJA Office consists of a judge advocate, supported by a shared clerk-typist for the Special Staff.

Organization

The SJA reports directly to the adjutant general and works closely with Guard commanders on legal issues relating to the federal mission of the National Guard.

Public Affairs Office

Mission

The Public Affairs Office plans, develops, directs and administers the department's community relations and public and internal information programs. In accomplishing its mission, the office:

- Prepares and distributes news releases, photographs and videotapes on departmental activities to civilian and military news media locally and on the mainland.
- Responds to queries from the news media, public and other

state and federal agencies.

- Provides briefings for civilian and military officials, community groups and new departmental employees to inform them of the department's mission and its economic and educational contributions to the state.

- Publishes the semi-quarterly newspaper for distribution to present and retired Hawaii National Guard members, state and federal agencies, and other parties interested in departmental activities.
- Publishes the quarterly newsletter for the Office of Veterans Services for distribution to veterans and veterans' organizations.

- Consolidates, edits and publishes the department's annual report.
- Prepares speeches and reports for the adjutant general.

Personnel

The office consists of a public affairs officer, three information specialists and a clerk-typist. All personnel are full-time state employees.

Organization

The public affairs officer advises the adjutant general on public affairs matters relating to the department. The office works closely and coordinates its activities with public affairs officers of the department's major units/divisions and active military services to carry out its programs.

Senior Army Advisor

Mission

The Senior Army Advisor (SRAA) is responsible for providing advice, counsel and assistance to the adjutant general and his staff in order to strengthen the Hawaii Army National Guard's (HIARNG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to

the adjutant general.

- Represent and act as a spokesperson for the active Army in all HIARNG matters under the purview of U. S. Army Pacific.
- Render professional military advice to HIARNG commanders in military matters concerning the organization, operation, training and readiness of units.
- Monitor the use and assist in the management of federal

resources in support of the HIARNG.

Personnel

The office is staffed by an active duty Army colonel.

Organization

The SRAA reports directly to the adjutant general and works closely with Guard members on federal military missions and issues.

Air Force Senior Advisor

Mission

The Air Force Senior Advisor (AFSA) is responsible for providing advice, counsel and assistance to the adjutant general and his staff in order to strengthen the Hawaii Air National Guard's (HIANG) readiness to perform post-mobilization war fighting missions. Duties and responsibilities are to:

- Serve as military advisor to the adjutant general and his senior staff.
- Represent and act as a spokesperson for the active Air Force in

all HIANG matters under the purview of Pacific Air Forces (PACAF).

- Maintain liaison with senior counterparts on the PACAF staff and ensure representation of HIANG issues, priorities and perspectives.
- Render professional military advice to HIANG commanders in military matters concerning the organization, operation, training and readiness of units.
- Maintain Instructor Pilot status and fly operational and training missions with one of

HIANG's flying units.

- Oversee and coordinate activities of all active Air Force advisors assigned to the HIANG.

Personnel

The office is staffed by an active duty Air Force lieutenant colonel currently qualified in one of the HIANG's aircraft.

Organization

The AFSA reports directly to the adjutant general and works closely with PACAF counterparts and Guard members on federal military missions and issues.

Senior Enlisted Advisor

Mission

The State Command Sergeant Major (CSM) serves as the senior enlisted advisor for the Hawaii Army National Guard and is responsible to the adjutant general for a variety of matters pertaining to policies and actions relative to enlisted Hawaii Army National Guard soldiers. The State CSM's responsibilities are to:

- Advise the adjutant general

on all enlisted matters.

- Assist the inspector general in solving enlisted problems.
- Work with the recruiting and retention office.
- Participate on boards related to enlisted soldiers to include promotion, Active Guard/Reserve continuation, selective retention and U.S. Army Pacific Non-Commissioned Officer and Soldier of the Year.
- Attend various conferences

both locally and on the mainland.

Personnel

The CSM's office consists of a Command Sergeant Major, supported by a clerk-typist shared among the Special Staff.

Organization

The CSM reports directly to the adjutant general and works closely with Guard members on enlisted issues.

Inspector General

Mission

The Inspector General (IG) is assigned to assist the adjutant general in assessing and reporting on, in an unbiased, objective manner, areas affecting mission performance, the state of efficiency, economy, discipline, morale, esprit de corps and readiness of the Hawaii National Guard. The IG also performs other duties as required by law and regulations or as directed by the adjutant general. The mission is accomplished using the concept of a full-service IG to:

- Provide assistance to Guard

members, their families and the public in response to real or perceived issues involving the Hawaii National Guard.

- Act on adjutant general directives to conduct investigations and inquiries.
- Manage the staff/special inspection program throughout the Hawaii National Guard.
- Act as a teacher or trainer when and where possible while performing other functions.

Personnel

The IG's office is staffed by an

active duty Army lieutenant colonel and is supported by a clerk-typist shared among the Special Staff.

Organization

The IG reports directly to the adjutant general and is a member of his staff. The relationship between an IG and his commander has been referred to as one in which the commander places in him extraordinary trust and confidence "to be the eyes, ears and conscience of the commander."

Information Management Office

Mission

The Information Management Office plans, programs and manages Army National Guard automation (less the Data Processing Installation, U.S. Property and Fiscal Office for Hawaii), telecommunications re-

sources, visual information, records management, and publishing and printing. In accomplishing its mission, the office:

- Provides technical advice to the adjutant general, staff elements, U.S. Property and Fiscal Office and units of the Hawaii

Army National Guard.

- Develops and administers state information systems objectives, policies, plans and projects for supported organizations.
- Ensures adequate physical and operations security for automated information systems.

- Provides telecommunications, visual information, records management, publishing and printing and automation support to supported organizations.
- Determines automation training needs, coordinates training classes and recommends appropriate user training.

Personnel

The Information Management Office consists of the director of

information management, a computer systems programmer, a communications management specialist, a computer assistant, a support services specialist, a supply clerk and a duplicating machine operator. All personnel are federal technicians.

Organization

The Director of Information Management (DOIM) serves as the principal information man-

agement advisor on present and future requirements for automation, telecommunications, records management, publishing and printing, and visual information to the adjutant general and Hawaii Army National Guard officials. The office works with the National Guard Bureau's Information Systems Directorate, as well as with the other 53 Information Management offices nationwide to perform its mission.

State Family Program Office

Mission

The State Family Program Office manages programs designed to increase the overall preparedness of Hawaii National Guard families to cope with the unique realities of Guard service. The Family Program Office accomplishes this mission by:

- Increasing the knowledge of family members regarding the benefits, privileges and obligations of Guard service.

- Creating a family support system to assist members during separations, providing information/referral networking and enhancing Guard retention.
- Providing feedback to the command on the concerns of family members.

Personnel

The office consists of a coordinator who is the only paid staff member. A state volunteer representative assists the coordinator in managing the activities

of program volunteers throughout the state. Clerical support is provided by a Clerk-Typist shared among the Special Staff.

Organization

The state family program coordinator reports directly to the adjutant general. The coordinator works closely with the State Team, a volunteer action and advisory council and family support groups throughout the state.

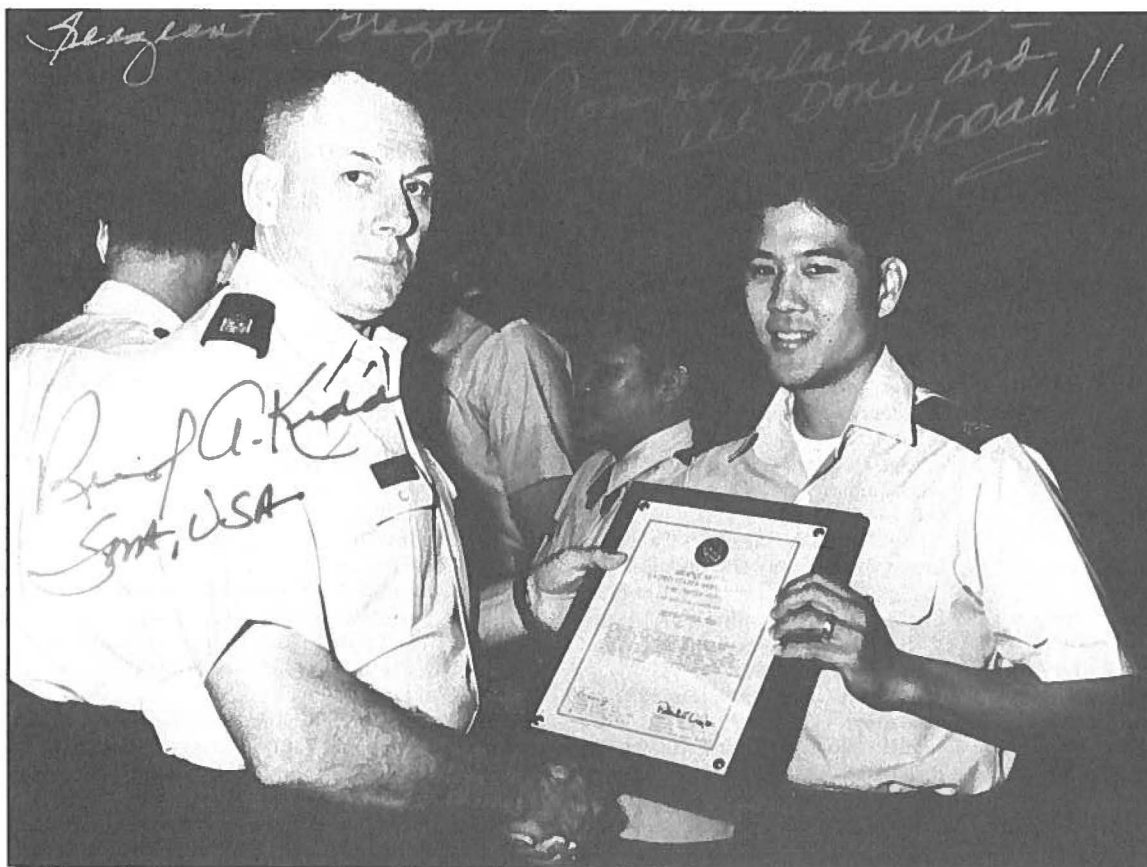
