SUBJECT: After Action Report (Operation Iniki, 6 Sep-6 Nov 92)

Reference NGR 500-1/ANGR 55-4, Military Support to Civil Authorities, 1 Oct 91.

2. General.

- Type of emergency. Hurricane Iniki was classified as a Category 4 hurricane, with sustained winds of 145 miles per hour (mph) and gusts recorded at 227 mph. It devastated the island of Kauai and also caused damage on the islands of Oahu, Maui, and Hawaii. Iniki, was by far, the most destructive storm to hit the islands and was recorded as one of the costliest natural disaster in U.S. history.
- Inclusive dates: 6 Sep-6 Nov 92. Period shown begins with the initial tracking of the storm to the final redeployment of troops from Kauai back to home station. Subsequent to 6 Nov 92, certain individuals were retained on State Active Duty (SAD) to support vehicle and equipment recovery and to complete personnel and cost-related documentation concerning the Iniki relief operation.
- c. Scope of emergency. Please refer to executive summary at encl 1. Percentage of Hawaii National Guard (HING) forces called to SAD is summarized as follows:

Hawaii Army National Guard (HIARNG) 62.1%

Hawaii Air National Guard (HIANG) 66.0%

In addition, 251 National Guard (NG) members from other states, 26 members of the State Civil Defense, and 48 members of the State Department of Defense (DOD) were also on duty during the peak days of Operation Iniki.

- 3. Operations.
- a. Strength. See daily chronological sequence of events at encl 3. Daily personnel data, summarized by component, is included.
- b. Operations summary. See encls 1 and 3 for operations summary. Missions and taskings performed during the Iniki relief operation included:
 - (1) Security.
 - (2) Transportation (ground and air).
 - (3) Debris removal and cleanup.
- (4) Disaster application center (DAC) and full-service center (FSC) manning and logistical support.
 - (5) Structure repair and reconstruction.
 - (6) Generator support.
 - (7) Humanitarian outreach.
 - (8) Other.
- c. Communications. During the hurricane, all communication with Kauai county emergency operations center (EOC) was lost, with the exception of civilian ham radio links. During the emergency relief phase, high frequency single side band tactical satellite and ham radio systems were in use. Within four days, Federal Emergency Management Agency (FEMA) satellite telephones augmented the aforementioned systems. Within seven days, commercial telephones were operating within the Kauai EOC. On island communication systems included FM radio, cellular telephone, and military subscriber equipment systems.
- d. Training. Initial units deployed to Kauai were from the 2d Battalion, 299th Infantry, from the island of Hawaii. Units of this battalion received their latest civil disturbance refresher training in Dec 91. Refresher training, including rules of engagement, anticipated missions, and weapons status,

were again conducted while units were awaiting transportation at airheads. Upon arrival on Kauai, it was apparent that the use or show of force was not required. Weapons and ammunition were secured and security missions were accomplished with riot batons only.

4. Administration.

- a. Public Affairs Office (PAO). HIARNG PAO personnel were among the first Guard members on Kauai after the hurricane hit. They accompanied local and national media representatives on one of the first flights to Kauai. PAO actions included media escorts, issue of media releases, and collection of historical information in the form of videos, pictures and interviews.
- b. Special services. Not applicable. HING has no organic special services capability. Soldier and airman morale and welfare actions were largely accomplished by the HING family support groups. An extensive welcome home ceremony was provided to returning Guard members after their return from Kauai.
- c. Morale and discipline. Overall morale was high and discipline exceptional. Many Guard members volunteered to return to Kauai to provide assistance even though their initial tours were completed. Weekly payrolls served to enhance morale and were accomplished in a joint effort between HIARNG, HIANG, State of Hawaii, and the U.S. Property and Fiscal Office (USPFO).
- d. NG injuries or casualties. One fatality and 41 injuries were documented during the Iniki relief operation. Technical Sergeant Dennis Dalen of the HIANG was killed in a traffic accident en route to repair a generator in a remote section of Kauai. Fallen power cables entangled his vehicle, causing it to crash. During the relief mission, a combination of HING medical, FEMA disaster medical assistance teams (DMAT), and civilian facilities were used.

EXECUTIVE SUMMARY

The purpose of this executive summary is to document the action taken and the support provided by the State of Hawaii DOD before, during, and after Hurricane Iniki struck the islands on 11 September 1992. Operation Iniki, as it was called, was a joint County, State, and Federal venture. No single agency could have accomplished the entire mission alone. However, the State of Hawaii DOD, which includes the HING and State Civil Defense (SCD), played a major role in the operation.

The history of hurricanes in the Hawaiian region dates back to 1950, when scientists first began tracking these violent storm systems. In the last 42 years, 3 hurricanes have hit the Hawaiian islands. Each hurricane was worse than the previous one. All three hit the island of Kauai the hardest, with the island of Oahu also sustaining damage. Hurricane Dot passed directly over Kauai in August 1959. Packing 130 MPH winds, Hurricane Dot caused about \$6 million in losses, mostly due to wind damage to Kauai's sugar cane crop. Hurricane Iwa came within 30 Nautical Miles west of Kauai in November 1982, with winds of up to 80 MPH. Hurricane Iwa caused more than \$250 million in damage, with widespread destruction due to high winds and surf on Kauai as well as Oahu.


Hurricane Iniki passed directly over Kauai on 11 September 1992. It was, by far, the most destructive storm to ever hit the islands and was recorded as one of the costliest natural disasters in U.S. history. Hurricane Iniki began as Tropical Depression (TD) 18 E on 6 September 1992. At that time, it was 1,360 NM southeast of the island chain.

Major General (MG) Edward V. Richardson, the Adjutant General (TAG) and Director of SCD, and the State DOD staff began to routinely monitor the storm. At 11 p.m., Tuesday, 8 September 1992 Iniki was upgraded to a hurricane, and continued to intensify and move west toward the island chain. SCD followed the procedures outlined in the emergency response plan, and notified Federal, State, and County agencies.


In the afternoon of Thursday, 10 September, Navy P-3 Orion aircraft reported Hurricane Iniki had turned on a northwest track toward the islands. This was confirmed by the National Weather Service (NWS), which placed the storm at 400 NM south of Lihue at 5 p.m. Based on this information, MG Richardson implemented 24-hour operations at the SCD and HING EOC. He directed intensified response planning.

HING units on all islands, including soldiers and airmen on Kauai, began preparing their vehicles and equipment. The HIANG 150th Aircraft Control and Warning Squadron (ACWS) on Kauai, and the 169 ACWS on Oahu provided continuous radar information to SCD. These units were invaluable in successfully tracking the storm.

At 4:00 a.m., Friday, 11 September, the U.S. DOD tasked the Secretary of the Army to provide disaster assistance to Hawaii. At 5:00 a.m., Iniki was 200 NM south of Kauai. At 5:30 a.m., SCD sirens sounded a hurricane warning for Oahu, closing all schools and keeping all non-emergency personnel at home.

Lieutenant General (LTG). John B. Conaway, Chief of the National Guard Bureau (NGB), authorized 6 California Air National Guard (CAANG) C-130 aircraft, with mobile communications equipment and airlift control personnel, to fly to Kauai to assist the State.

At 9:00 a.m., the HING evacuated 40 Filipino veterans of World War II from the Philippine Consulate in Honolulu to safer quarters on Kapiolani Boulevard.

At 11 a.m., Iniki was perilously close to Oahu and Kauai. Key HING Soldiers and airmen on Kauai were at their stations. On the island of Hawaii, the soldiers of the 2-299th Inf were on standby alert. Oahu units were alerted to perform possible evacuation missions. At 3:15 p.m. that afternoon, power was reported out on Kauai as Iniki carved a destructive path through the island. Sustained winds of 145 MPH, with gusts of up to 227 MPH, hammered the island. A short time later, emergency communication between SCD on Oahu and Kauai County was dependent solely on the Civil Defense (CD) Radio Amateur Civil Emergency Services (RACES) system. At the SCD EOC on Oahu, MG Richardson briefed Governor John Waihee on Iniki's effects and the State's contingency plans. The Governor proclaimed a major disaster for the State and requested President Bush to declare the State a "disaster area" under provisions of the Stafford Act.

Throughout the evening of 11 September, torrential rain and high winds trailing Iniki prevented aircraft from flying to Kauai. At 3:15 a.m., 12 September, a Presidential disaster declaration was signed and Federal help, through the FEMA, was on its way. At 5:30 a.m., 12 September, the winds subsided and nearly 400 soldiers and airmen from the island of Hawaii began deploying to Kauai aboard Air National Guard (ANG) C-130 aircraft. Hawaiian and Aloha Airlines, and Coast Guard aircraft also helped move soldiers and airmen from the island of Hawaii.

At 7:05 a.m., 12 September, HING troops landed on the devastated island at Lihue airport. They joined the Kauai soldiers and airmen already on the island and were tasked to provide security, assist police, and re-establish communications.

Throughout the day, the HIANG managed and coordinated the air flow during the initial emergency response phase. ANG C-130s flew 30 sorties on 12 September and airlifted more than 66 tons of equipment and supplies by the end of the day. That morning, Governor Waihee, Kauai Mayor JoAnn Yukimura, and key staff flew over Kauai to assess the damage wrought by Iniki. Hawaii's Congressional delegation, accompanied by MG Richardson, also went to the island. For the first time, the officials viewed the full extent of the damage caused by the hurricane.

Seventy percent of the island had been hit by Iniki.
About 5,000 electrical poles were down, totally destroying the electrical and telephone systems. Electric pumps were not operating. Crops lay in ruin and the shoreline and beaches were decimated. On the island, 14,340 homes were damaged, with 5,000 structures severely battered or destroyed. Also severely battered and flooded were the many luxury resort hotels along the coast that were also racked by wind and high surf. At least 7,000 residents were homeless, and another 8,000 were in need of food and water. Three people were killed, and, damage on Kauai was estimated at \$1.6 billion. Adding to the immensity of these problems was the destruction of the Lihue Airport tower. The tower's communication system was down, resulting in the suspension of commercial airline flights into Lihue Airport for the first 10 days. As a result, thousands of tourists were stranded on the island without food, water or shelter. More than 563 homes along the north shore of Oahu also sustained damage, and another 32 homes on the island of Hawaii were affected.

Within 12 hours after Hurricane Iniki hit, the HING had set up an EOC within Kauai County headquarters to coordinate the emergency response effort. Under the command of Colonel Edward L. Correa, Jr., HIARNG's Deputy Commander, more than 800 Guard members were providing security, safety, and outreach support, including food and water for Kauai residents.

MG Richardson, as the Director of SCD, also chaired a coordinating committee made up of key County, State and Federal leaders. The committee met daily to establish priorities and manage and solve problems. LTG Johnnie Corns (Commander of U.S. Army, Pacific (USARPAC)) served on the committee as Defense Coordinating Officer. The committee also included Mr. Wallace Stickney, Director of FEMA, Brigadier General (BG) Ralph Locurcio (Commander of Pacific Ocean Division), the HIARNG/HIANG Commanders and representatives from SCD and the Small Business Administration (SBA).

On Sunday, 13 September, the ANG, with support from Aloha, Hawaiian, and United Airlines, began transporting stranded tourists to Oahu. Eventually more than 8,000 visitors were moved to Oahu. More than 7,000 people were housed, and more than 15,000 fed at NG, Red Cross, and Salvation Army shelters. That same day, an active duty military Joint Task Force (JTF), made up of Army, Air Force, Navy, Marine, and Coast Guard units, began assisting the State and County. Under the direction of LTG Corns, the military provided personnel and began airlifting and shipping tons of equipment and cargo.

On Kauai, the 25th Infantry Division established a forward command post under BG Frank Akers (Assistant Division Commander for Operations), to coordinate the efforts of the JTF with the National Guard's COL Correa. The HIANG, meanwhile, transported 42 dialysis patients from Kauai's Wilcox Hospital to Oahu. ANG C-130 aircraft also transported supplies, food, and medical personnel throughout the weekend.

On Monday, 14 September, 290 soldiers from the 1st Battalion, 299th Infantry (1-299th Inf), joined their fellow Guardsmen on Kauai to assist in security and logistic support missions. They were augmented by Military Police (MP) from the 29th Infantry Brigade (Separate) (29th Inf Bde (Sep)), and the HIANG's 154th Security Police Flight (SPF). The HING task force on Kauai now stood at nearly 1,300 soldiers and airmen. By 16 September, active duty military forces reached 2,411. During the evening of 14 September 1992, TSgt Dennis C. Dalen, a member of the HIANG's 297th Air Traffic Control Flight (ATCF), died in a traffic accident while on his way to repair an electric generator near Hanalei on Kauai. He was interred at the Hawaii State Veterans Cemetery on Oahu with full military honors.

On 15 September, two battalion aid stations were established at the HING's Kapaa and Hanapepe armories. Medics also went house-to-house to treat injured residents. By 30 September, the medical teams treated more than 1,000 patients, mostly for minor injuries, cuts and bruises. Additional aid stations at other locations throughout the island were operated by Federal response agencies.

The 298th Engineer Detachment (298th Eng. Det), 227th Engineer Company (227th Engr Co), and the 154th Civil Engineering Squadron (CES) deployed with vehicles, carpentry tools, and chainsaws to do house-to-house repairs for residents who could not fix their own homes. The possibility of rain in the area made repairing roofs a priority mission. Restoring electrical power on the island was also a top priority. COL David Rodrigues (former Chief of Staff, current HIANG Commander and full-time Vice President for Operations at Hawaiian Electric Company) headed a power council to oversee the repair of Kauai's electrical system. He also coordinated the deployment of neighbor island as well as mainland repair crews and equipment to Kauai.

Soldiers from the 297th Supply and Service Battalion (Sup & Svc Bn) deployed 87 soldiers on 15 September to establish and operate 5 food and relief distribution centers on the island in coordination with the active Army. By Thursday, 16 September, the 5 distribution centers at Lihue, Kapaa, Hanapepe, Kalaheo, and Princeville were fully operational. Food, water, ice, and plastic sheeting were in great demand throughout the island. The distribution centers, which included Red Cross and Salvation Army functions, were co-located with Federal disaster assistance centers to provide one-stop, full-service programs for residents.

MG Richardson was tasked by the Governor to coordinate the cleaning of public schools and State facilities and highways. NG and active duty military personnel removed debris, patched roofs, cleaned classrooms, and installed generators at 15 schools throughout the island. As a result of the emphasis on schools, Wilcox Elementary in Lihue opened on schedule on 22 September 1992.

To reduce the risk of injury, infections, and the spread of diseases, the Governor also tasked MG Richardson to initiate "Operation Garden Sweep." This massive clean-up campaign for the entire island was a joint County, State, and Federal effort. MG Richardson delegated coordination of the project to BG Eugene S. Imai, HIARNG Commander. The HING centered its efforts in the Lihue area, which has the greatest population density. The Marines and active duty Army took responsibility for other areas on the island.

Beginning 21 September, more than 500 HIANG members and 1,500 active duty military troops deployed to Kauai for the 5-day cleanup. They joined the nearly 1,000 Army National Guard (ARNG) personnel already on-island. The airmen, along with workers from the County, State and private sector, collected and hauled nearly 6,479 5-ton truckloads of household garbage and debris to existing and temporary landfill sites on the island.

For the first 3 weeks of the emergency response phase of Operation Iniki, more than 5,500 members of the HING were directly or indirectly involved in various efforts to serve and assist the County of Kauai.

NG personnel from California, Alabama, Washington, Oregon, Oklahoma, Alaska, Texas, and West Virginia also provided assistance. They were on-island almost immediately to support a wide range of requirements. This was a clear demonstration of the solidarity of the NG family. The HIANG C-130, the 6 CAANG aircraft, and aircraft from Alaska and Oklahoma, flew a total of 564 sorties from 12 September to 2 October 1992. The aircraft transported more than 7,000 passengers and 1,800 tons of cargo during that period. As of 10 November, that number had increased to 873 sorties, 3,427 tons of cargo, and 9,552 passengers.

The HIARNG's C-26 and U-21 fixed wing aircraft flew more than 413 missions, carrying both passengers and cargo. ARNG helicopters were also on station on Kauai from the first day. They flew search and rescue, reconnaissance, re-supply, and command and control missions throughout the period. The active duty military worked side-by-side with the HING. Active duty military helicopters and fixed-wing aircraft flew a total of 1,388 sorties, transporting more than 7,800 tons of cargo and 8,000 passengers. Army, Navy, and Marine ships made 31 voyages, transporting 275,975 square feet of cargo and 599 passengers. Active duty personnel on Kauai peaked at 3,693 on 26 September.

On Friday, 25 September, the soldiers of the HIARNG's 2-299th Inf redeployed from Kauai. They were there since 12 September. These soldiers from the island of Hawaii were replaced by 175 soldiers from the 1st Battalion, 487th Field Artillery (1-487th FA), and Troop E, 19th Cavalry (Trp E 19th Cav).

On Saturday, 26 September, 500 ANG members who participated in "Operation Garden Sweep" left Kauai to return to their homes on Oahu, Maui, and Hawaii. An impressive homecoming at Hickam Air Force Base (AFB) was organized by the units and family support groups. On the next day, 27 September, more than 500 soldiers who had been on Kauai since Hurricane Iniki hit returned to their homes on Oahu, Maui, and Hawaii. The weekend homecoming events reunited airmen and soldiers with their families.

Following "Operation Garden Sweep", more than 660 NG members and 400 active duty troops remained on Kauai to operate DACs, provide outreach, and assist with the recovery. The forces continued to drawdown as the island's infrastructure was rebuilt.

On 13 October, at the request of the county, "Operation Garden Sweep Two", a second clean-up campaign, was directed to remove debris from private lands and dwelling areas. HING soldiers and airmen, along with the active duty military, removed over 82 tons of debris in Lihue alone and over 591 5-ton truck loads, island wide. In addition, to prevent flooding, rivers and streams were surveyed and cleared by the HING and private contractors, working under direction of the Federal Soil Conservation Service. This comprehensive clean-up concluded on 30 October.

Security and outreach programs continued to 6 November when off-island NG personnel returned to their units. The recovery had progressed to the point where assets available to the Mayor and County of Kauai were capable of handling the rebuilding effort, a monumental effort that continues today.

As of 25 June 1993, the FEMA the SBA, and other Federal and private agencies have spent and committed over \$1.5 billion for Iniki relief support. FEMA and SBA have received and processed over 34,000 applications for Federal disaster and grants. Included in the \$1.5 billion are \$200.9 million in SBA loans, \$23.1 million in temporary housing assistance grants, \$92.7 million in Damage Survey Reports (DSR) claims, and \$13.4 million in the individual and family grant program. Other assistance applications are still pending.

In retrospect, there were <u>seven primary factors</u> that made the emergency response phase of Operation Iniki a <u>success</u>.

First, and most important, was the fact that all agencies recognized the leadership role of the State, in managing, coordinating, prioritizing, and executing the emergency response effort. No single County, State or Federal agency could have provided all the support required by a natural disaster of this magnitude. The Federal Government, namely FEMA and the active duty military, allocated resources based on priorities identified in conjunction with the State and county.

The second factor was the proactive nature of the actions taken by the State DOD even before the hurricane hit. These actions included the pre-positioning of equipment, aircraft, and vehicles, as well as the decision to use HING personnel from islands that were not affected by the storm. Key decisions like these were based on lessons learned during previous emergencies and disasters. This included the response during Hurricane Iwa in 1982, as well as disasters of smaller magnitudes.

The third factor was the ability of the State DOD to conduct joint operations. Since assuming command, TAG has directed joint ARNG and ANG operations during weekend and annual training, as well as during special events. In the CD arena, this joint operational concept has been practiced during routine emergency response training exercises, to include the private sector and County, and Federal agencies. HING leaders also attend CD training with County agencies on a regular basis.

The fourth factor is that TAG of Hawaii serves as both Director of SCD and Commander of the HING. This centralizes authority, enabling TAG to deploy NG emergency response assets and direct CD actions at the State level.

The fifth factor is the close working relationship the State DOD has with County and State agencies. This has been accomplished over time through training at all levels and a number of regional and State affiliations that promote professional as well as social interaction.

As we saw during Operation Iniki, this same close working relationship is shared with the active duty military. Senior leaders from all services are invited to visit the State DOD and CD, as part of their orientation. They are briefed on the role of the State during emergencies as well as on the capabilities of the Guard.

The sixth factor is that HING personnel were placed on SAD, allowed them to perform vital security missions, thus avoiding the restrictions under the Posse Comitatus Act. The Posse Comitatus Act prohibits the direct use of active Federal troops by civilian law enforcement officers.

The seventh factor, one that is routinely overlooked, has to do with the advantages of having a NG with members who are both citizens and soldiers or airmen. Our knowledge of the community, our previous work with leaders of local government as well as private industry, the central location of our NG armories and facilities on all major islands, and our ability to relate to local residents all have a reassuring effect during emergencies and natural disasters. This, coupled with our close relationship with County, State, Federal and military agencies, enabled the successful management of resources and execution of timely assistance.

However, much of the credit for the success of Operation Iniki belongs to the people of Kauai. They demonstrated the value of the spirits of "aloha" and "ohana" or family during this very difficult period. Throughout the crisis, the people of Kauai made our NG feel as though they were a part of the community and reinforced this feeling with expressions of gratitude and appreciation. This appreciation made our jobs easier and reaffirmed our commitment to serve our neighbors in need.

On 2 January 1993, more than 470 HING members sailed to Kauai aboard the luxury liner, S.S. Constitution. The three-day, all expense-paid voyage was donated by American Hawaii Cruises. The trip marked the resumption of cruise-line service and day tours on Kauai, following the hurricane. The soldiers and airmen were from Oahu, Maui, and the island of Hawaii. They served during Operation Iniki and returned as the island's first visitors. The troops arrived on Kauai on 4 January 1993 and received a hero's welcome from Governor Waihee, MG Richardson, and other leaders. They were then bused to an appreciation rally put on by Kauai merchants, residents, and school children. It was an emotionally-charged reunion.

As Kauai's first tourists, the troops saw for themselves how far the island and its people had recovered from Hurricane Iniki. While the recovery will no doubt take years, one thing is certain. The HING has developed friendships that will last a lifetime.

In conclusion, Operation Iniki has demonstrated that the County, State and Federal governments <u>CAN</u> work together to effectively manage and execute an emergency response and recovery effort, while, at the same time, win the confidence of the people they serve.

 - 2259 All G3 staff required to report at 0600 to HING EOC.
- 2300 NWS issues hurricane warning for Oahu. NWS advisory indicates Iniki is turning more northerly and eye will be very close to Kauai and Niihau.
 - HING LO (MAJ Jahnke) reports to SCD.
- 2330 Logistics Officer (G4) confirms amount of vehicles, water trailers, Meal-Ready-to-Eat (MREs), and generators available on Kauai.
- 2340 State and County CD agencies coordinate sounding sirens at 0500 the next morning.
- 2345 TF Oahu (COL Agena) EOC set up in event hurricane hits Oahu.
- 2400 A total of 474 HING and State DOD personnel are involved in preparing for storm.



b. CHRONOLOGICAL EVENTS/ACTIONS:

- 0017 TF Kauai reports ready for hurricane.
- 0020 Mayor Yukimura and staff depart for Kauai on HIARNG U-21. Two trips are needed to complete the move.
- 0100 MG Richardson and SCD staff discuss the sounding of sirens at 0500, the closing of schools, and the need to have only essential employees with emergency duties report to work. MG Richardson notifies Governor's Administrative Director of recommendation to sound the sirens at 0500 and other required actions.
 - HIANG moves F-15 aircraft into Hickam AFB hangars.
- 0130 TF Kauai Commander (MAJ Daligdig) briefs Kauai County EOC LO (MAJ Valenciano) on his duties and provides EOP/checklist. Both meet with Mayor.
- 0200 As the hurricane approaches, Counties of Hawaii, Maui, Kauai, and the City and County of Honolulu declare emergency. All activate EOCs and implement EOPs (sirens and Emergency Broadcasting System (EBS) to be used).
 - 0300 HIANG decision made to evacuate C-130 to Hilo.
- 150 ACWS reports to MG Richardson that Iniki's eye can be seen on their radar scopes. Eye is painted 200 NM south of Kauai. Tracking continues.
- Oahu and Hawaii county coordinating with Red Cross and Department of Education on shelter openings and shelter management.
- 0320 TF Kauai LO at County EOC reports to TF Kauai Commander on status of shelters and County decision to evacuate Poipu and North Shore areas.

- 0330 Governor approves MG Richardson's recommendation to sound sirens, close schools, and have only essential employees report to work.
- 0350 TF Kauai LO (MAJ Valenciano) reports gale force winds expected by 0800.
- 0400 State and County CD agencies coordinate emergency broadcast messages.
- Report from hurricane hunter aircraft confirms storm's strength and position.
- 0530 Sirens sounded on Oahu and Kauai, followed by full broadcasting of EBS and SSB systems. All residents of shoreline areas urged to evacuate to shelters. Information on school closings, emergency work force reporting, and shelter locations disseminated.
- HING EOC updates TF Kauai EOC on hurricane progress throughout early morning.
- ESO calls State DOD staff and sets up the issuing of Hurricane Iniki-related purchase orders for emergency and relief purchases.
- Honolulu-Pacific Federal Executive Board radio broadcasts public service announcement advising Federal service nonessential employees to remain at home. Time and attendance records reflect 77 HIARNG and 66 HIANG technicians were administratively excused for the day (full 8 hours). Full-time personnel who reported to duty were released throughout the remainder of the day as deemed appropriate by command/management.
- 0535 All HIARNG units (less Kauai) notified to be prepared to mobilize for disaster relief missions.
 - 0605 HING LO to Oahu CD EOC (MAJ Chang).
- LTC Dobashi (HIANG) replaces MAJ Daligdig as TF Kauai commander and co-locates with the County CD at their EOC.
- 0630 HING units continue to prepare for hurricane, securing equipment, taping, etc.
- 0655 HIANG C-130 departs Hickam for safe haven at Hilo.
- 0700 Kauai HIARNG full-time workers released to care for their families and homes. Hanapepe Armory closed.
- MAJ Daligdig, SGT Yadao and two volunteers await hurricane at Kapaa Armory.

- 0730 B Company, 1-299 Inf commander (CPT Heim) relieves MAJ Valenciano at Kauai County EOC.
- 0800 HIARNG fixed wing aircraft (C-26 and U-21) are evacuated from Oahu to Hilo. Aloha and Hawaiian Airlines also relocate their aircraft there.
 - 0830 Kauai hit by gale force winds.
- 0900 MG Richardson talks with LTG Conaway, Chief of NGB. LTG Conaway offers 6 CAANG C-130 aircraft to be deployed to Hawaii to support immediate relief efforts.
- At a meeting with his staff, MG Richardson decides to send four personnel to Kauai with the TACSAT radio to re-establish communication between the HING EOC and the Kauai EOC.
- 0912 HIARNG's 2-299th Inf (island of Hawaii) is ordered to SAD with a report time of not later than 1700. The 2-299th Inf is given the mission to be prepared to move to Kauai for disaster relief operations.
- 0920 HIANG contacts 146 TAW (CAANG) and begins initial coordination for 6 C-130 aircraft. Additional requirements for support include MRC 108 commo equipment and TALCE personnel.
- 0930 Kauai evacuees begin arriving at Kapaa Armory, despite armory not being designated as an evacuation shelter.
- HIARNG bus dispatched to move a group of Filipino veterans from the lanai of the Philippine Consulate in Nuuanu to a shelter in downtown Honolulu.
- 1000 Governor and Lieutenant Governor arrive at State EOC and are briefed by MG Richardson and Mr. Price on the current situation.
- Both City and County of Honolulu and Kauai County report full shelters. Police and CD volunteers report very high surf on south shores of Oahu and Kauai. Coordination of response efforts with NG and State agencies who have reached full mobilization ongoing.
- 1015 The 298 ATCF AN/MPN-14H control system secured in the Pacific Missile Range Facility (PMRF) hangar.
- Acting Director of ARNG (BG D'Araujo) calls to offer support. ARNG will provide liaison team of operations officer, logistics representative, PAO, and ANG liaison.
 - Kapaa Armory has 300 evacuees.
- 1030 154 ACS full-time force sent home after all securing actions completed; tactical vehicles ready.
- All 298 ATCF personnel released to secure their homes.

- Oahu CD Administration resounds sirens, followed by full EBS briefing.
- 1050 LTC Kanja provides HIANG equipment status to TF Oahu. (Request was made by TF Oahu in event hurricane hits Oahu.)
- 1100 State CD finalizes State disaster proclamation for Governor's signature. Request for Presidential declaration finalized and submitted to Governor for signature.
- Governor informs State CD that the President of Hawaiian Airlines has offered his aircraft for disaster assistance at no charge.
 - Lihue airport closes.
- Kauai County resounds sirens, followed by full EBS briefing.
- 1130 Busload of 50 tourists dropped off at Kapaa. They are moved by 2 1/2 ton trucks to St. Catherine's Church (designated shelter). A 2 1/2 ton truck loses top due to high winds.
- 1145 Situation Report (SITREP) by radio from TF Kauai: Kealia river overflowed at 1100; KUAI radio tower lost at 1125; Lihue Airport last flight at 1045.
- 1200 RADM Donnelly, Commander of 14th Coast Guard District, offers MG Richardson use of 4 C-130s that are located on the island of Hawaii.
- LTG Corns arrives at SCD EOC and is briefed on situation. LTG Corns offers his support and assistance.
- 1210 HING EOC alerts Companies A and B of the 29th Spt Bn for possible evacuation mission on Oahu.
- 1328 Kauai Electric, as a safety measure, shuts off power. Kapaa Armory loses power.
- 1430 Hurricane force winds begin to strike island of Kauai. TF Kauai (Kapaa) loses radio contact with Kauai EOC.
- SCD communication systems on Kauai rendered inoperable except for RACES and Civil Air Patrol (CAP) volunteers.
 - 1500 TF Kauai loses telephone service.
- 1530 TF Kauai reports by radio that winds are subsiding (eye of hurricane).

- 1530 Governor proclaims a major disaster for the State of Hawaii. He also requests the President to declare the State a disaster area under the provisions of the Stafford Act, within four hours of the disaster.
- 1540 President of Hawaiian Telephone, Mr. Haruki, calls BG Imai and requests transportation of two HawTel engineers to Kauai to assist in damage assessment and restoration of telephone communication.
 - 1545 TF Kauai reports by radio winds at 100 plus MPH.
- 1600 TF Kauai reports by radio winds intensifying again.
- The mayor of each county is advised by the Governor that the State is proclaimed a disaster area. They are also advised that the Director of Budget and Finance is authorized to allocate \$1 million from the State Major Disaster Fund and another \$1 million for Federal matching funds.
 - 1745 TF Kauai loses radio contact with neighbor islands.
 - 1800 Storm passes Kapaa.
- 1840 Two HIARNG utility helicopters (UH-1s) at Wheeler Army Air field (WAAF) are designated to carry the Governor on an Oahu reconnaissance immediately after the storm subsides.
- 1900 Deputy Commander, TF Kauai (MAJ Daligdig), attempts to assess damage with Kauai Police Department personnel who stayed at Kapaa Armory. Cannot get out due to amount of debris on roads.
- 2000 154 Services Flight (SVF), (HIANG), activated to SAD.



OBSERVATIONS AND LESSONS LEARNED

PREFACE

During the period immediately after the return of soldiers and airmen from deployment to Kauai, numerous observations, comments, and recommendations were submitted by both HIARNG and HIANG units. A separate report, summarizing and analyzing these comments, is in progress. However, a consolidated list of significant observations and lessons learned, determined after a review of the detailed comments and numerous discussions with unit commanders and members, is listed and discussed in this enclosure.

HURRICANE INIKI CONSOLIDATED SIGNIFICANT LESSONS LEARNED

1. A strong SCD system:

- a. Discussion: The Hawaii SCD system is particularly strong and well-prepared due to Hawaii's unique susceptibility to numerous natural hazards, such as hurricanes, tidal waves, volcanic activity, earthquakes, flooding, and brushfires. As a result, disaster response plans are based on actual occurrences and implemented by people that have worked through similar disasters in the past. SCD takes an active role in exercising its disaster response plans on a joint basis with the NG, active military, counties, and other State agencies. A joint exercise conducted in November 1991, that included the key NG personnel from all islands, served to prepare our soldiers and airmen for the Iniki operation.
- b. Recommendation: Joint exercises and training must continue to fully prepare SCD and supporting organizations to effectively respond to future disaster missions. Plans must be continually updated and focus on the current situations.
- 2. An effective integrated CD warning and communication system:
- a. Discussion: Hawaii's unique early warning siren system proved highly effective in alerting its citizens to the impending hurricane. The original siren system was built just before World War II and became more and more important as the war went on. Since then, the system has been expanded and improved with better equipment and technology. The low level of casualties resulting from Iniki can largely be attributed to this siren system. During the preparation for Iniki, extensive use was also made of the HAWAS, interisland data system, VHF and UHF, SSB radio, IEMIS, and the RACES, to communicate with counties and emergency personnel. As a result, the citizens of Hawaii were prepared for Iniki.
- b. Recommendation: Continue to maintain, upgrade, and test the SCD emergency warning and communication systems.
- 3. Pro-active preparation measures, such as the prepositioning of equipment, vehicles, and supplies.
- a. Discussion: Prior to the arrival of Iniki on 11 September, NG personnel worked very hard to prepare equipment for the hurricane. Vehicles, equipment, and buildings were secured. Items anticipated to be utilized, such as generators,

vehicles, radios, and water trailers were fueled, topped off, and readied for employment. Aircraft were either secured at Hickam AFB or evacuated to Hilo to avoid the storm. Units that were not in the anticipated disaster area were alerted for potential disaster relief missions.

- b. Recommendation: Such proactive measures should continue and be incorporated in updated disaster response planning.
- 4. Policy to mobilize NG troops from islands or locations not affected by the hurricane:
- a. Discussion: Based on experience with Hurricane Iwa in 1982, it was decided early on to mobilize NG soldiers and airmen from islands and locations not in the disaster area. This policy worked very well on Kauai, as it allowed our Kauai-based Guard members to focus on their families and personal concerns. Many Kauai Guard members volunteered to assist the relief effort after their personal affairs were taken care of.
- b. Recommendation: The policy to mobilize members outside of the disaster area should continue for future response missions.
- 5. Cooperative relationship and attitude between all supporting agencies such as NGB, active military, HING, and other relief organizations:
- a. Discussion: The cooperative and joint attitude between all of the supporting organizations and agencies was outstanding. The common goal of supporting the people of Kauai was paramount to all participants. This attitude was a key to the success of the Iniki relief mission.
- b. Recommendation: This relationship and attitude must continue in future efforts. Joint exercises, planning, and coordination between all parties must continue.
- 6. Establishment of SCD as the primary agency to determine relief priorities:
- a. Discussion: Although SCD, by law (93-288), is the designated lead agency for disaster relief in Hawaii, many Federal relief organizations, to include the active military, were not clear as to who was the lead agency. However, once it was made clear to these Federal organizations that SCD was the lead agency, the relief effort flowed on a more consistent basis.

- b. Recommendation: All supporting organizations, including FEMA and the active military, must understand that SCD is in charge of the relief effort. SCD is the lead agency that determines relief priorities. This should be incorporated in the relief planning of all supporting agencies and exercised accordingly.
- 7. TAG's dual responsibility as Director of SCD and as the Commander of the HING:
- a. Hawaii is one of the states in which the TAG is also the Director of SCD. This dual responsibility worked very well during the Iniki mission as it eliminated an unneeded level in the chain of command. TAG's knowledge of the military support capabilities of both the active military and the NG allowed him to match the priority relief requirements, determined by his SCD staff, with the military assets on hand. This knowledge also served well during the joint daily coordination meetings with all supporting agencies to determine priorities and actions.
- b. Recommendation: TAG retain the dual responsibility as Commander of the HING and as the Director of SCD.
- 8. Daily joint coordination meetings chaired by TAG at SCD with all supporting agencies.
- a. Discussion: The daily coordination meetings included high level representatives from all supporting agencies, FEMA, active military, NG, SBA, Corps of Engineers, State agencies, and County (via conference call). This meeting reviewed all actions accomplished, problems encountered and methods to solve them, and established priorities for relief support. This daily meeting was highly successful in coordinating the effort on a joint basis and fostered the atmosphere of joint operations.
- b. Recommendation: This daily joint coordination meeting, chaired by TAG and held at SCD, should be continued in future major disaster relief operations.
- 9. Co-location of TF command and control section and action officers with Kauai County EOC:
- a. Discussion: The TF Hawaii command and control section was located in the office of the County CD coordinator. This office was directly above the County EOC, which served as the County headquarters during the emergency phase. This close proximity to the County EOC enabled the HING TF Hawaii forces to respond quicker to relief taskings from the county.

- b. Recommendation: In future disasters, locations for HING TF command and control sections must be identified and must be in close proximity to County EOCs. This must be coordinated in advance.
- 10. Keeping HING soldiers and airmen on SAD allowed them to perform certain security and control missions that other active military forces could not accomplish (Posse Commitatus Act):
- a. Discussion: Security was a key mission throughout the relief effort on Kauai. By remaining on SAD, HING members (particularly the MP and Security Flight personnel) could perform certain missions that the active component could not. This observation was also noted in the after-action reports for the Rodney King riots in Los Angeles.
 - b. Recommendation: Keep NG troops on SAD status.
- 11. Soldier and airman support in the areas of weekly payrolls, FSGs, and rotation polices served to enhance morale.
- a. Discussion: Morale was greatly enhanced as the result of weekly payrolls, rotation policies, and the support and welcome home efforts of the FSGs.
- b. Recommendation: Implementation of weekly payrolls, rotation policies, and FSG actions continue to be included in planning for future relief operations. Of particular concern is the advent of the Joint Service Software military pay system. This system is currently being implemented and will effectively prevent the accomplishment of SAD military pay at the OUSPFO. Commercial programs however, are coming available that may again provide this capability. State DOD should review, and if appropriate, procure these programs.
- 12. Airlift coordination and priority determination:
- a. Discussion: During the emergency phase of the airlift operations, there were numerous instances of SCD priority items, to include HING equipment and personnel, being bumped for active component items. Initially, it was not clear to the active military that SCD was the lead agency in Operation Iniki. Once this was made clear to the active military, and the airlift request flow was documented, these problems were, in large part, resolved.

- b. Recommendation: Airlift request flow wire diagrams, that include identification of SCD as lead agency for airlift priority determination, be included in joint planning for future operations. Active component JTF must understand that SCD is determiner of relief priorities.
- 13. Initial TF deployment needs augmentation, especially in areas of communication, logistics, transportation, and support personnel:
- a. Discussion: The initial command and control cell that was deployed on 12 September was heavily committed in handling County taskings and airhead operations within 2 hours of arrival on Kauai. The manpower and equipment were not adequate to handle the volume of requirements that was being generated by the County EOC. The arrival of the TF Hawaii headquarters section, Headquarters and Headquarters Company, 29th Infantry Bde (Sep), greatly facilitated command and control operations on Kauai.
- b. Recommendation: In future operations, the TF headquarters section be identified and deployed with the initial command and control cell to the disaster area. This unit should also be adequately equipped with commo, vehicular, and logistical support prior to deployment.
- 14. Communication to the hurricane victims must be resolved. Victims need to know what to do and where to go for assistance:
- a. Discussion: A major problem encountered on Kauai was the inability of County officials to communicate with its citizens. Commercial radio stations lost their antennas and were unable to communicate. Makeshift repairs and restoration of power still did not provide adequate communication between the County and its people.
- b. Recommendation: Available commercial or military psychological operations assets should be reviewed for potential in resolving this problem.
